The City Council of the City of North Oaks will hold a public hearing on January 15, 2026 at 7:00 p.m. in the City Council Chambers, 100 Village Center Drive, Suite 150, North Oaks, MN 55127 to consider a special assessments for diseased tree abatement. The following property and amount will be considered:

ABATEMENT TYPE: Diseased Tree Removal

AMOUNT DUE: \$3,134.50

The proposed assessment roll is on the file with the City Clerk. All interested persons will be heard at this meeting. All written or oral objections thereto by any property owner will also be considered. The City Council may adopt the proposed assessment at the meeting following the hearing.

No appeal may be taken as to the amount of any assessment adopted pursuant to Minnesota Statutes, Section §429.061, subd. 2, unless a written objection signed by the affected property owner is filed with the municipal clerk prior to the assessment hearing or presented to the presiding officer at the hearing.

An owner may appeal an assessment to District Court pursuant to Minnesota Statutes Section §429.081 by serving notice of the appeal upon the Mayor or City Clerk of the City of North Oaks within 30 days after the adoption of the assessment and filing such notice with the District Court within 10 days after service upon the Mayor or City Clerk.

Owners are advised of the provisions of Minnesota Statutes, Sections §435.193 to §435.195. The City has not adopted any deferment procedures pursuant to these Statutes for nuisance and diseased tree abatements.

ORDINANCE 1058

**AN ORDINANCE TO AMEND EXHIBITS A, B, AND C
TO THE MUNICIPAL CODE**

On the 15th day of December, 2025 the Shoreview City Council adopted ordinance 1058 amending exhibit A, utility fee schedule, exhibit B, administrative fees, and exhibit C, building permits and fees to the municipal code. On the same day, pursuant to Minn. Stat. §412.191, Subd. 4, the Shoreview City Council directed that a summary of ordinance 1058 be published.

Ordinance 1058 amends the following utility fees: water, sewer, surface water management, and street lights. It also amends the following administrative fees: edible cannabinoid license, electric vehicle charging, right-of-way permits, land disturbance permits, erosion control fees and escrows, zoning compliance letter, variances, and administrative citations. Finally, it amends the following building permits and fees: refunds and residential and commercial electrical permits. The ordinance is effective January 1, 2026. ORDINANCE 1059

**AN ORDINANCE TO AMEND CHAPTERS 2, 28, AND 30
OF THE MUNICIPAL CODE**

On the 15th day of December, 2025 the Shoreview City Council adopted ordinance 1059 amending Chapter 2, 28 and 30 of the municipal code. On the same day, pursuant to Minn. Stat. §412.191, Subd. 4, the Shoreview City Council directed that a summary of ordinance 1059 be published.

Ordinance 1059 amends chapter 2, 28, and 30 as they related to administrative citations. The ordinance moves language in chapter 28 to chapter 2. The ordinance is effective January 1, 2026.
