 AN ORDINANCE AMENDING SECTION 302, COUNCIL

The Shoreview City Council ordains that Section 302 of the Shoreview Municipal Code is amended to read as follows (**New language is underlined;** **stricken text is proposed for deletion**):

302 COUNCIL

302.010 Compensation. The Mayor and Councilmembers of the City of Shoreview shall be compensated as follows:
