Re: Freedom of Information Act (FOIA) Request #2021-934

Dear Requester:

Thank you for the above-referenced request, a copy of which is attached for your easy reference. Please be advised that your request has been partially denied pursuant to the Illinois Freedom of Information Act ("the Act") 5 ILCS 140.

The City has redacted certain responsive communications using FOIA exemption 7(1)(d)(vi), which allows withhold records from disclosure when disclosure would endanger the life or physical safety of law enforcement personnel or any other person. Here, the responsive communications detail the identities of City law enforcement personnel conducting confidential investigative efforts with federal law enforcement authorities aimed at collecting and preserving evidence related to the cybersecurity attack and wire fraud perpetrated against the City and apprehending the suspects responsible for the cybersecurity attack and wire fraud. Considering the gravity of the offenses and sensitivity of the attacks against the City and its residual impact against all parties involved, the identities of the law enforcement agents conducting these investigative efforts should remain confidential, insofar as prematurely disclosing their identities and investigative efforts would endanger their lives, as well as endangering the lives of other law enforcement personnel and people impacted by these matters. Accordingly, the City maintains that these communications have been properly redacted from disclosure pursuant to FOIA exemption 7(1)(d)(vi).

The City has also redacted certain responsive communications using FOIA exemption 7(1)(d)(vii), which permits withholding information when disclosure would obstruct an ongoing criminal investigation by the City and federal law enforcement entities assisting the City. As mentioned, certain responsive communications here detail confidential investigative efforts of City and federal law enforcement personnel to collect and preserve evidence related to the cybersecurity attack and wire fraud perpetrated against the City and apprehending the suspects responsible for those criminal acts. Considering the nascent stage of the investigative efforts, the gravity of the offenses and sensitivity of the attacks against the City and its residual impact against all parties involved, both the City and the federal law enforcement agents participating in the investigation maintain that premature disclosure of these investigative communications would obstruct the ongoing criminal investigation conducted by the City by permitting the suspects, who have not yet been identified, to potentially evade law enforcement authorities

and attempt to destroy or conceal relevant evidence regarding these criminal matters. Accordingly, the City maintains that these communications were properly redacted pursuant to FOIA exemption 7(1)(d)(vii).

The City has also redacted certain responsive communications using FOIA exemption 7(1)(f), which exempts preliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed, or policies or actions are formulated, except that a specific record or relevant portion of a record shall not be exempt when the record is publicly cited and identified by the head of the public body. The exemption provided in this paragraph (f) extends to all those records of officers and agencies of the General Assembly that pertain to the preparation of legislative documents. In response to this request, the City identified certain communications responsive to this FOIA request contain pre-decisional and deliberative information that are exempt under FOIA. Specifically, the communications contain drafts, notes, recommendations, memoranda and advice which are pre-decisional, that is, preliminary in nature and conveyed before the adoption of a final City decision, policy or course of action concerning the cybersecurity attack and wire fraud perpetrated against the City. These communications are also deliberative, insofar as City personnel and its attorney's express opinions, thoughts and recommendations concerning proposed City policies and actions to respond to the cybersecurity attack and wire fraud perpetrated against the City. Insofar as the City's responsive communications are pre-decisional and deliberative, and not publicly cited or identified by the City's mayor, the City maintains that these communications were properly redacted pursuant to FOIA exemption 7(1)(f).

The City has also redacted certain responsive communications using FOIA exemption 7(1)(m), which exempts communications between a public body and an attorney or auditor representing the public body that would not be subject to discovery in litigation, and materials prepared or compiled by or for a public body in anticipation of a criminal, civil, or administrative proceeding upon the request of an attorney advising the public body. Certain communications responsive to this FOIA request contain confidential and privileged communications between City personnel and its attorneys. Within these communications, the City's attorneys render legal advice to City personnel regarding the legal ramifications of the cybersecurity attack and wire fraud perpetrated against the City, and City personnel expressly communicate with its attorneys for the purpose of requesting legal advice regarding these matters. Insofar as these communications are expressly exempt under FOIA section 7(1)(m) and because these communications would not be subject to discovery in litigation, the City reiterates that these communications were properly redacted pursuant to FOIA exemption 7(1)(m).

The City has also redacted certain responsive communications using FOIA exemption 7(1)(o), which exempts administrative or technical information associated with automated data processing operations, including, but not limited to, software, operating protocols, computer program abstracts, file layouts, source

listings, object modules, load modules, user guides, documentation pertaining to all logical and physical design of computerized systems, employee manuals, and any other information that, if disclosed, would jeopardize the security of the system or its data or the security of materials exempt under this Section. Several responsive communications here contain information regarding software, operating protocols, computer program layouts, the physical and logical design of computerized systems, which if disclosed, would jeopardize the security of the City's cybersecurity systems or its data. Accordingly, the City reiterates that this information is properly redacted from disclosure pursuant to FOIA exemption 7(1)(o).

The City has also redacted certain responsive communications using FOIA exemption 7(1)(s), which exempts any and all proprietary information and records related to the operation of an intergovernmental risk management association or self-insurance pool or jointly self-administered health and accident cooperative or pool. Insurance or self-insurance (including any intergovernmental risk management association or self-insurance pool) claims, loss or risk management information, records, data, advice or communications. Here, certain responsive email communications contain privileged, proprietary and confidential advice, communications, and risk management information shared by the City's risk management personnel with the City's cyber insurance company regarding claims and reports made regarding the cybersecurity attacks and wire fraud perpetrated against the City. Accordingly, the City maintains that these communications were properly redacted pursuant to FOIA exemption 7(1)(s).

Lastly, the City has also redacted certain responsive communications using FOIA exemption 7(1)(v), which exempts vulnerability assessments, security measures and response policies or plans that are designed to identify, prevent, or respond to potential attacks upon a community's population or systems, facilities, or installations, the destruction or contamination of which would constitute a clear and present danger to the health or safety of the community, but only to the extent that disclosure could reasonably be expected to jeopardize the effectiveness of the measures or the safety of the personnel who implement them or the public. Information exempt under this item may include such things as details pertaining to the mobilization or deployment of personnel or equipment, to the operation of communication systems or protocols, or to tactical operations. Several responsive communications to this FOIA request contain information regarding the City's security measures and response policies and plans designed to prevent and respond to attack's upon the City's cybersecurity systems. The destruction, damage or breach of these systems constitutes a clear and present danger to the health and safety to the City, its employees and its residents. Therefore, disclosing the City's communications regarding its security measures and response policies and plans related to prevent and ameliorating cybersecurity breaches could be expected to reasonably endanger the effectiveness of the City's preventative security response measures or the safety of the personnel who implement those measures.

Dear Carol, Amanda:

Under the Illinois Freedom of Information Act, 5 ILCS 140, I am requesting an opportunity to inspect or obtain copies of public records including:

- Any insurance claim(s) filed for city losses related to a cyberattack and/or wire-fraud.
- Any emails sent between city employees and the city's insurance company between Sept. 1,
   2020 and today regarding cyber-attack and/or wire-fraud related losses.
- Any emails sent from a contractor to city employee(s) requesting a change of payment information sent between Sept. 1, 2020 and Jan. 1, 2020.
- Any emails between Finance Director Carol Barnes and city employees regarding a cyberattack and/or wire fraud sent between Sept. 1, 2020 and now.

Response to this FOIA request by PDF is acceptable.

I understand that the Act permits a public body to charge a reasonable copying fee not to exceed the actual cost of reproduction and not including the costs of any search or review of the records. 5 ILCS 140/6. However the law allows you to impose a waiver or reduction of fees when information is sought in the public interest, as is the case for this request. I'm requesting this information as a reporter for the Dispatch-Argus/Quad-City Times for fact-verifying and news gathering purposes.

If you choose to deny this request, please provide a written explanation for the denial, including a reference to the specific statutory exemption(s) upon which you rely.

If portions of our request are to be denied, based on an ongoing investigation and/or pending litigation exemption, we ask that such denials be addressed individually. In other words, as an example, the filing of an insurance claim obviously would not be protected under either exemption, whereas we can see it is possible that email by contractors <u>could</u> qualify.

We also would note that neighboring Rock Island County also was the victim of a cyberattack. Its investigation began in late July. Two weeks later, while the investigation was underway, Rock Island County disclosed the theft of public funds. Similarly, LeClaire was working with federal investigators when the city publicly disclosed it too had been a victim of cyber theft.

I look forward to hearing from you in writing within five working days, as required by the Act 5 ILCS 140(3). Thank you for considering and responding to this request.
