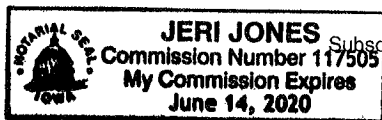

AFFIDAVIT

I, the undersigned state that the following facts known by me or told to me by other reliable persons form the basis of my belief that the Defendant committed these crimes.

On the above date, time, and location the victim was at Stephen Newport's law office to discuss a civil case in which Newport was representing her. While the victim was in Newport's private office, with the office door locked, Newport exposed his genitals to her after talking about a implanted medical device in his scrotum. Newport took the victim's left hand, without her permission, and placed it on his bare scrotum to feel the implanted device. Newport was also playing with his penis at the same time. The victim pulled her hand away and quickly gathered her things to leave his office. Later that same day Newport called the victim about her case and indicated that in lieu of payment for his legal services she could give him oral sex or undress in front of him. On 2-7-18, 10:50am, the victim made a recorded phone call via speaker phone to Newport in my presence. During the recorded call Newport made statements confirming the victim's statement in regard to Newport requesting oral sex in lieu of payment for his legal services. On 3-14-18, 10:00am, a search warrant was served on Newport for photographs to be taken of his office and his body. Those photos showed his office was laid out just as the victim described. The photos also showed Newport has a large surgical scar on his lower abdomen and reddish colored pubic hair just as the victim described. During an interview with me on 3-14-18, 11:14am, Newport denied all of the victim's allegations. Newport did not know how the victim would have known about his implanted device. In regard to what he said on the recorded phone call with the victim, Newport felt he was just asking her a question about what she was talking about when she brought up payment options and sexual favors.
