

**INSTRUCTIONS TO THE VOTERS
VOTING RIGHTS**

Any voter who can't mark a ballot because the voter has a physical disability or can't read, may ask any person he or she chooses to help the voter vote.

Any voter may ask for instruction in the proper procedure for voting.

Any voter at the polling place prior to 7:00 p.m. is allowed to cast a ballot.

If your voting rights have been violated, you may call the person in charge of the election at 394-2153, the Secretary of State at 888-703-5328, or your state's attorney.

Any person who is convicted of a felony on or after July 1, 2012, loses the right to vote. However, any such person may register to vote following the completion of the person's felony sentence.

Any person who is convicted of a felony on or before June 30, 2012, and who receives a sentence of imprisonment to the adult penitentiary system, including a suspended execution of sentence, loses the right to vote. Any such person so sentenced may register to vote following completion of the person's sentence. Further information is available at www.sdsos.gov.

ELECTION CRIMES

Anyone who makes a false statement when voting, tries to vote knowing he or she is not a qualified voter, or tries to vote more than once has committed an election crime.

RESOLUTION CREATING RAPID CITY DESTINATION TAX INCREMENT FINANCING DISTRICT

CITY ATTORNEY EXPLANATION:


The City Council approved a Tax Increment Financing District (TIFD) to support a major mixed-use development north of Mall Drive, featuring commercial, entertainment, and residential components. This economic development TIFD covers about \$125 million in project costs, including site improvements, financing, public infrastructure, and related commercial development costs. When a TIFD is created, the existing assessed property value, known as the base value, continues to generate property tax revenue for the city, county, and school district. For up to 20 years, the revenue from the increase in value above the base value will be used to reimburse eligible project costs rather than fund general government operations. The developer is responsible for funding any upfront costs of the site improvements in the TIFD. The current base value of properties in the district is approximately \$8 million, while the assessed value of the district is projected to reach around \$585 million within 20 years. It is anticipated the City will also receive additional sales tax revenue from the new development. Without the TIFD, the developer may choose to discontinue or significantly scale back the project, leading to future valuations and tax revenues being lower with more limited infrastructure improvements for the area.
