On May 19th, 2019 I Officer [REDACTED] was in full duty uniform patrolling my scheduled shift on the Rosebud reservation in a marked patrol car. I was advised by dispatch that the adult correctional facility is requesting an officer due to an unresponsive male.

Upon arrival I observed the medics and correctional officers bringing a male out to the sally port and place him in the ambulance. One of the medics advised me that the male was Derrick Scott and that he had coded out on them. I notified the On Call Special Agent [REDACTED] and advised dispatch that I would be enroute to the emergency room to follow up. Upon arrival I made contact with Correctional Officers [REDACTED] and [REDACTED] and they advised that the male had turned himself in last night and said that he was being chased and that someone was trying to shoot him. [REDACTED] also advised that the Derrick had assaulted an elderly male in their cell while he was asleep and broke his jaw. [REDACTED] continued to say that while he was placed in the restraint chair and that while he actively resisting and that he had taken off into the sally port. [REDACTED] advised the medics showed up and that he was still awake and talking and that he just went limp and stopped breathing.

Derrick Paul Scott, date of birth 11/14/1985 was incarcerated in the Rosebud Adult Correctional Facility, when he went unresponsive, in the presence of EMS personnel, for an unknown reason.

Manual and machine assisted CPR were performed for an extended period but SCOTT was unable to be revived.

In furtherance of the investigation an autopsy was requested. The body of Scott was transported to Sanford hospital in Sioux Falls, SD, for autopsy.
