Jail Population Average Daily Population and Admissions

- Average Daily Population (ADP) between December 2019 and December 2020:

Active Warrants

- As of January 1, 2021, there were 7,003 total active warrants.
 - Of the unique individuals, 53% were Native American and 36% were White

Warrant Resolution

- As of December 2020, there have been 1,249 warrants resolved for 1,087 (87%) individuals.
 - Of the unique individuals, 41% were Native American and 39% were White
- Outreach efforts for warrant resolution occurred by the Tribal Outreach Team, who attended multiple community events in the three neighboring reservation communities
- A 1-800 number was created to allow people to call in and speak to the State's Attorney's Office. Since launch, 265 warrants have been resolved via the 1-800 number.

Public Safety Assessment (PSA)

- There were 8,682 PSAs completed for 5,723 unique individuals (66% of total)
 - 4,875 individuals received a PSA at Booking Intake (or 56%)
 - Of those, 1,956 (or 40%) were released via PR
 - 3,807 (or 44%) of the PSA's were completed ahead of the individual's initial hearing
 - 1,660 (or 44%) were released via PR at the Initial Hearing
- Of the 5,723 unique individuals who received a PSA, 2,944 were Native American (or 51%) and 2,369 were White (or 41%)

Low-Level Offender Court

- 174 individuals have been identified for Low Level Offender Court
 - 143 (or 82%) were Native American and 25 (14%) were White
 - Of the 143 Native Americans that participated in the Low-Level Offender Court, 106 (or 74%) reached case disposition at their Initial Appearance.
- *There have been zero individuals referred to Low-Level Offender Court since April 2020 due to COVID-19*

24/7 Indigent Fund

- 83 individuals have received 79 vouchers as of December 2020
 - 53 (or 68%) were Native American and 24 (31%) were White

Pretrial Monitoring Program (PMP)

- 19 individuals were referred to PMP between July 2020 and December 2020
 - 13 (or 69%) were Native American and 5 (26%) were White

Pretrial Electronic Monitoring (EM)

- There were 1,707 total referrals to the Pretrial EM Program. 717 were duplicate referrals and 990 were unique (or one-time) referrals.
- Of the 990 unique individuals referred to Pretrial EM, 58% were Native American and 34% were White.

Community Work Program (CWP)

- There have been 425 referrals to the CWP, 277 of which were unique individuals.
- Between August 2018 and December 2020, there were 7,207.5 community service hours completed.
- Of the 277 unique individuals referred to the CWP, 60% were Native American and 33% were White.

Care Campus

- As of December 2020, the Care Campus served 54,563 individuals.
- Of the Care Campus referrals, 42,427 (or 79%) were Native American and 6,348 (or 11%) were White.

Jail Review Team

- As of December 2020, the Jail Review Team has staffed 1,168 cases, saving 4,991 jail bed days.
 - Of the individuals staffed, 761 (or 65%) were Native American and 375 (32%) were White

SAO Diversion Programs

- Adult Diversion Program (ADP)
 - Of the 144 unique individuals referrals to the ADP, 46 (or 32%) were Native American and 74 (or 51%) were White.
- Domestic Violence Diversion Program (DVDP)
 - Of the 60 unique individuals referred to the DVDP, 34 (or 54%) were Native American and 27 (or 43%) were White.
- Drug Diversion Program (DDP)
 - Of the 437 unique individuals referrals to the DDP, 240 (or 55%) were Native American and 167 (or 38%) were White.
- Young Adult Diversion Program (YADP)
 - Of the 1,046 unique individuals referred to the YADP, 359 (or 34%) were Native American and 582 (or 56%) were White.
- The State's Attorney's Office served 1,690 unique individuals between all four diversion programs, of which, 679 (or 40%) were Native American and 850 (or 50%) were White.

I.Am.Legacy Classes and Discussions

- Between January and December 2020, there were 298 classes or discussions held at I.Am.Legacy or via zoom (107 female-specific and 191 male-specific).
- Between that same timeframe, there were more than 27 events held at I.Am.Legacy or within the Rapid City Community

Seven Directions

- In 2019, there were 41 individuals that attended a Seven Directions Program within the jail setting. Of which, 26 (63%) graduated from the Program.
- In 2020, groups within the jail, for drug diversion participants, and for the community began.
 - Due to COVID – these classes weren't able to be consistently held within the jail setting or in person.
- Two 10-week Seven Directions Programs took place in 2020 virtually.
 - A male and female group was held for diversion participants beginning on May 3, 2020 and went through July 5, 2020.
 - A male and female group was held for diversion participants beginning on September 13, 2020 and is scheduled to conclude on November 15, 2020.
