

RESOLUTION NO. 4775

**A RESOLUTION UPDATING PRECINCT BOUNDARIES TO REFLECT ANNEXATIONS
IN TOWNS FOLLOWING ADOPTION OF THE 2013 LEGISLATIVE DISTRICTING PLAN**

WHEREAS, on February 12, 2013, the Montana Districting and Apportionment Commission adopted the final Legislative Districting Plan and filed the plan with the Montana Secretary of State; and

WHEREAS, the Montana Secretary of State filed the submitted plan on February 12, 2013; and

WHEREAS, after proper public notice the Commissioners met with the Ravalli County Clerk and Recorder on March 27, 2013 to review and take public comment on the proposed redistricting and precinct in Ravalli County; and

WHEREAS, after this public meeting the Commissioners, by unanimous decision, voted to adopt the redistricting and precinct map in Ravalli County showing the boundaries of the precincts that had been completed after the 2013 Legislative District Plan was filed; and

WHEREAS, on March 13, 2013 the Commissioners passed Resolution No. 3049, which was recorded with the Clerk and Recorder's office on April 13, 2013 as Document No. 666200; and

WHEREAS, MCA 13-3-103 requires a resolution changing the boundaries of an election precinct and delivery of a written legal description and map showing the border of all precincts in which elections are held within the county to the election administrator; and

WHEREAS, boundaries within the incorporated areas of the Town of Stevensville and City of Hamilton have been changed by annexations and need to be updated on the precinct map and in the voter database;

NOW THEREFORE BE IT RESOLVED THAT:

- The maps attached as Exhibit A shall be incorporated into the precincts for the City/Town affected by the annexations;
- That legal descriptions for all of the precincts and house districts shall be attached as Exhibit B;
- These changes shall be updated in the statewide voter database;
- The new precinct boundaries will become effective for all elections conducted after March 1, 2026.

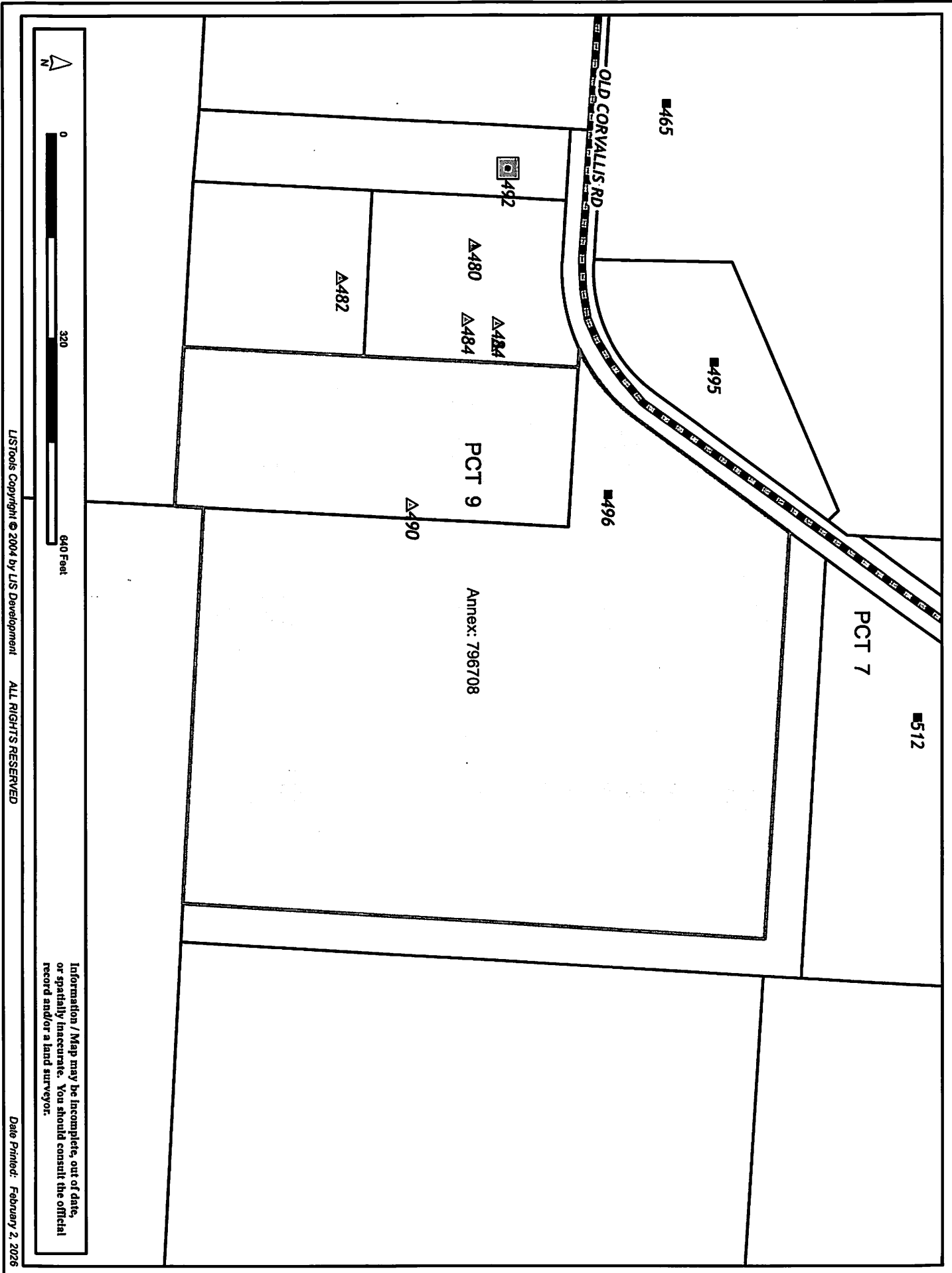

EXHIBIT B
RAVALLI COUNTY
PRECINCT BOUNDARY WRITTEN DESCRIPTION
(following the February 12, 2013 final adoption of the
Legislative redistricting and apportionment changes)

PRECINCT 1 – SULA AND WEST FORK

This precinct includes the South portion of Ravalli County. Starting at the east border of Ravalli County, the north boundary of the precinct is the line between Township 3 North and 2 North and crosses Range 17 and 18, then proceeds $\frac{3}{4}$ of the way across Range 19; thence at this point the line proceeds directly South between Sections 4 & 5, 8 & 9, 16 & 17, 20 & 21, 28 & 29 and 32 & 33; thence westerly on the line between Township 2 North and 1 North, then South along that same line to Highway 93, thence North along Highway 93 to the intersection of Highway 93 and West Fork Road. South along West Fork Road to Chaffin Creek Road; thence West along Chaffin Creek Road to Chaffin Creek, following Chaffin Creek to the West border of Ravalli County.

PRECINCT 2 – CHARLOS AND DARBY RURAL WEST

All of the land lying North of Precinct 1 and West of Highway 93 up to where Old Darby Road begins north of the Town of Darby. From this point, the East boundary of Precinct 2 follows Old Darby Road to Highway 93; then North on Highway 93 to Lost Horse Creek; thence East along Lost Horse Creek to the River; thence northeasterly to the boundary of the Hamilton/Darby School Districts line. From this point, the East and North boundaries of the Precinct follow the Hamilton/Darby School District lines. This precinct does not include any land within the Town of Darby.

PRECINCT 3 – TOWN OF DARBY AND DARBY RURAL EAST

All of the land North of Precinct 1 and East of Precinct 2 lying within the Darby School District. Includes the Town of Darby.

PRECINCT 4 – HAMILTON RURAL

Includes all of the rural area in the Hamilton School District lying outside of House District 86.

PRECINCT 5 – HAMILTON WEST

All of the rural are in House District 86 lying West of Highway 93, the City of Hamilton, Skalkaho Highway and Ponderosa Drive.

PRECINCT 6 – GRANTSDALE

This precinct includes rural land in House District 86 around the Grantsdale area. The West and South boundary is Precinct 5. The North boundary is Golf Course Road. The East boundary is South on Grantsdale Road from the Golf Course Road intersection to Rose Lane; thence East on Rose Lane to Grant Lane to Fish Hatchery Road, then follow Fish Hatchery Road to Skalkaho Highway, East on Skalkaho Highway to North Shoshone Loop. Then follow North Shoshone Loop to the East boundary of House District 86.

PRECINCT 7 – HAMILTON EAST

All of the rural land in House District 86 lying East and North of Precincts 5 and 6.



PRECINCT 8 – CITY OF HAMILTON SOUTH

All of the land within the City of Hamilton lying South of West Side Road and Main Street on the West side of Highway 93 and lying South of Fairgrounds Road on the East side of Highway 93.

PRECINCT 9 – CITY OF HAMILTON NORTH

All of the land within the City of Hamilton lying North of West Side Road and Main Street on the West side of Highway 93 and lying North of Fairgrounds Road on the East side of Highway 93.

PRECINCT 10 – CORVALLIS WEST

The entire area located within the Corvallis School District and House District 85 lying West of Eastside Highway. It does not include the Town of Pinesdale.

PRECINCT 11 – CORVALLIS SOUTHEAST

The entire area located within the Corvallis School District and House District 85 lying East of Eastside Highway. The North boundary of the precinct begins at a point where Willow Creek Road touches the Southeast boundary of House District 87; thence east on Willow Creek Road to Honey House Lane; thence South on Honey House Lane to Bass Lane; thence East on Bass Lane to Willow Creek Cross Road; thence North on Willow Creek Cross Road to Willow Creek Road; thence East on Willow Creek Road to Willow Creek until it reaches Forest Service property. From this point it follows census blocks through Forest Service property North to the North boundary of the Corvallis School District.

PRECINCT 12 – CORVALLIS NORTHEAST

The entire area located within the Corvallis School District and House District 85 lying Northeast of Precinct 11.

PRECINCT 13 – CORVALLIS

The entire area located with the Corvallis School Districts lying within House District 86.

PRECINCT 14 – TOWN OF PINESDALE

Area located entirely within the boundaries of the Town of Pinesdale

PRECINCT 15 - VICTOR WEST

The area located entirely within the Victor School District. The East boundary line of the precinct begins at the intersection of the Southern boundary line of the Victor School District and Highway 93, North on Highway 93 to 3rd Avenue, West on 3rd Avenue to Chief Victor Road, North on Chief Victor Road to Sweathouse Creek Road, West on Sweathouse Creek Road to Iroquois Trail, North on Iroquois Trail to Curlew Orchard Road, West on Curlew Orchard Road to Indian Prairie Loop, North on Indian Prairie Loop to St Mary Road, North on St Mary Road to the North boundary line of the Victor School District.

PRECINCT 16 – VICTOR EAST

The area located entirely within the Victor School District lying East of Precinct 15.

PRECINCT 17 – STEVENSVILLE WEST

The area located entirely within the Stevensville School District in House District 87 lying West of Eastside Highway. This precinct also includes area east of Eastside Highway lying North of Groff Lane, North and West of Homeacres Road, South of Willoughby Lane, West of South Sunset Bench Road, South and West of Winters Lane.

PRECINCT 18 – STEVENSVILLE EAST

The area located entirely within the Stevensville School District in House District 87 lying East of Precinct 17.

PRECINCT 19 – STEVENSVILLE

All of the rural area located within the Stevensville School District lying in House District 88.

PRECINCT 20 – TOWN OF STEVENSVILLE

The area located entirely within the boundaries of the Town of Stevensville.

PRECINCT 21 – LONE ROCK SOUTH

The area located within the Lone Rock School District lying in House District 87.

PRECINCT 22 – LONE ROCK NORTH

The area located within the Lone Rock School District lying in House District 88.

PRECINCT 23 – FLORENCE EAST

The entire area within the Florence Carlton School District lying East of Highway 93 from the North boundary of the Florence Carlton School District South to the intersection of Highway 93 and the area lying North and East of Eastside Highway.

PRECINCT 24 – FLORENCE WEST

The entire area within the Florence Carlton School District lying West of Precinct 23.
