# VERIFIED COMPLAINT for VIOLATION OF PLAINTIFFS CIVIL RIGHTS and JURY DEMAND

NOW COMES PLAINTIFF, Randy A. Bishop, through his attorney David J Gilbert (P56956), upon information and belief and for his complaint states:

There are no other cases pending in this court and the venue is correct for litigation in excess of \$25,000.00.

The events giving rise to this complaint involve the alleged wrongful conduct of certain Antrim County officials and election officials revolving around the Presidential Election for 2020.

#### STATEMENT OF FACTS

- 1. Plaintiff RANDY A. BISHOP is an adult resident of Antrim County Michigan
- 2. SHERYL GUY, individually and in her official capacity as Clerk of Antrim County is a resident of Antrim County Michigan.

- 3. JARRIS RUBINGH, individually and in his official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 4. JOSHUA WATROUS, individually and in his official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 5. KAREN BARGY, individually and in her official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 6. EDWARD BOETTCHER, individually and in his official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 7. TERRY VANALSTINE, individually and in his official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 8. BRENDA RICKSGERS, individually and in her official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 9. DAWN LAVANWAY, individually and in her official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 10. JASON HEIWIG, individually and in his official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 11. CHRISTINE MARCUS, individually and in her official capacity as County Commissioner and is a resident of Antrim County Michigan.
- 12. James Rossiter, individually and in his official capacity as County Prosecuting Attorney and is a resident of Antrim County Michigan.
- Daniel S. Bean, individually and in his official capacity as County Sheriff and is a resident of Antrim County Michigan.

- 14. Each of the above-named defendants are/were required to swear an oath of office part of which requires each defendant to "support and defend" the constitution of the United States of America.
- 15. In the 1972 decision in <u>Dunn v. Blumstein</u>, Justice Marshall stated, "In decision after decision, this Court has made clear that a citizen has a constitutionally protected right to participate in elections on an <u>equal</u> basis with other citizens in the jurisdiction." And again in the 1974 <u>Richardson v.</u>

  <u>Ramirez</u> case, Justice Rehnquist wrote: "Because the right to vote 'is of the essence of a democratic society, and any restrictions on that right strike at the heart of representative government,'... voting is a 'fundamental' right."<sup>1</sup>

<sup>1</sup> The 15th Amendment gave African American men the right to vote in 1870. But many weren't able to exercise this right. Some states used literacy tests and other barriers to make it harder to vote.

The 19th Amendment, ratified in 1920, gave American women the right to vote.

The 24th Amendment, ratified in 1964, eliminated poll taxes. The tax had been used in some states to keep African Americans from voting in federal elections.

The 26th Amendment, ratified in 1971, lowered the voting age for all elections to 18.

The Civil Rights Acts created some of the earliest federal protections against discrimination in voting. These protections were first outlined by the Civil Rights Act of 1870 and were later amended by the Civil Rights Acts of 1957, 1960, 1964

The Voting Rights Act of 1965 prohibited voter discrimination based on race, color, or membership in a language minority group. It also required certain places to provide election materials in languages besides English.

The act also placed limits on certain states with a history of voter discrimination. These states had to get federal approval before passing voter restrictions. A 2013 Supreme Court decision struck down this rule.

The <u>Voting Accessibility for the Elderly and Handicapped Act of 1984</u> required polling places to be accessible to people with disabilities.

The Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) of 1986 allowed members of the U.S. armed forces and overseas U.S. voters to register and vote by mail.

The <u>National Voter Registration Act (NVRA) of 1993</u> created new ways to register to vote. It also called for states to keep more accurate voter registration lists.

The <u>Help America Vote Act (HAVA) of 2002</u> authorized federal funds for elections. It also created the <u>U.S. Election Assistance Commission (EAC)</u>. The EAC helps states comply with HAVA to adopt minimum standards on voter education, registration, and ballots.

- 16. On or about November of 2020 and during the election cycle, Clerk SHERYL GUY intentionally deleted cast ballot information from polling machines. (See Transcript Exhibit #1)
- 17. Defendant SHERYL GUY also failed to secure the polling machines and allowed Peter Garwood, Antrim County Administrator unauthorized unfettered access to the voting machines used during this election.
- 18. Because some ballots were deleted, Plaintiffs vote/s was/were not counted as an equal ballot as to ALL the ballots cast and ALL of the ballots that should have been tabulated accurately.
- 19. There are specific dates and timing deadlines in fulfilling the Duties of the County Clerk during elections.
- 20. Defendant Clerk SHERYL GUY failed to meet these standards by deleting votes from voting machines.
- 21. Defendant Clerk SHERYL GUY allowed PETER GARWOOD Antrim County Administrator unauthorized unfettered access to voting machines
- 22. Part of the county clerk's responsibility during an election is to ensure the security and process of an election.
- 23. Plaintiff RANDY BISHOP advised the Antrim County Commissioners of the County Clerks Alleged Conduct by constructive legal notice on January 20, 2022.

The Military and Overseas Voting Empowerment (MOVE) Act of 2009 improved access to voting by military and overseas voters.

- 24. Antrim County Commissioners have oversight of the County CLERK SHERYL GUY.
- 25. The Antrim County Commissioners failed to take any action.
- 26. Plaintiff BISHOP advised Defendant Antrim County Prosecuting Attorney JAMES ROSSITER of the County Clerks Alleged Conduct.
- 27. Antrim County Prosecuting Attorney JAMES ROSSITER has the authority to investigate wrongdoing.
- 28. Plaintiff BISHOP advised defendant Antrim County Sheriff DANIEL S. BEAN of the County Clerks Alleged Conduct.

#### **COUNT I**

#### **VIOLATION OF PUBLIC TRUST**

- 29. PLAINTIFF incorporates all prior paragraphs.
- 30. Defendant Prosecuting Attorney JAMES ROSSITER failure as a Public Officers to institute an investigation into the admitted wrongdoing of Clerk SHERYL GUY is considered a Breach of the Public Trust the exercise of discretion is a failure of their ministerial duties and a violation of the Faithfull Performance.
- 31. Antrim County Sheriff DANIEL S. BEAN'S failure as a Public Officers to institute an investigation into the admitted wrongdoing of Clerk SHERYL GUY is considered a Breach of the Public Trust the exercise of discretion is a failure of their ministerial duties and a violation of the Faithfull Performance.
- 32. Antrim County Commissioners failure as Public Officers to institute an investigation into the admitted wrongdoing of Clerk Guy is considered a Breach of

the Public Trust the exercise of discretion is a failure of their ministerial duties and a violation of the Faithfull Performance.

- Public officials have a Ministerial duty refers to the official duty of a public officer wherein the officer has no room for the exercise of discretion, and the performance being required by direct and positive command of the law.
- 34. The powers and duties of public officers are, in general, classified as ministerial and discretionary. The character of a duty as ministerial or discretionary is to be determined by the nature of the act to be performed, and not by the office of the performer. Official duty is ministerial when it is absolute, certain, and imperative, involving merely execution of a specific duty arising from fixed and designated facts; that a necessity may exist for the ascertainment of those facts does not operate to convert the act into one discretionary in its nature. #### **COUNT II**

# **VIOLATION OF EQUAL PROTECTION.**

- 35. PLAINTIFF incorporates all prior paragraphs.
- 36. The United States Constitution and the 1963 Constitution of Michigan guarantee equal protection.
- 37. Defendant SHERYL GUY'S treatments in handling ballots gives certain ballots priority and gives other ballots no priority and are not counted in the election results.

- 38. Antrim County Commissioners failed to correct the situation.
- 39. Antrim County Prosecuting Attorney JAMES ROSSITER did not investigate.
- 40. County Sheriff DANIEL BEAN did no investigate.
- 41. Public officials have a Ministerial duty refers to the official duty of a public officer wherein the officer has no room for the exercise of discretion, and the performance being required by direct and positive command of the law.
- 42. The powers and duties of public officers are, in general, classified as ministerial and discretionary. The character of a duty as ministerial or discretionary is to be determined by the nature of the act to be performed, and not by the office of the performer. Official duty is ministerial when it is absolute, certain, and imperative, involving merely execution of a specific duty arising from fixed and designated facts; that a necessity may exist for the ascertainment of those facts does not operate to convert the act into one discretionary in its nature. [State ex rel. School Dist. v. Ellis, 163 Neb. 86 (Neb. 1956)].

#### **COUNT III**

# **VIOLATION OF ELECTION LAW PA 116 OF 1954.**

- 43. PLAINTIFF incorporates all prior paragraphs. (See Exhibit #2)
- 44. Clerk SHERYL GUY altered the value Mr. BISHOP'S vote in the November 2020 election by altering or deleting other ballots.

- 45. Plaintiff's right to a Republican form of government was destroyed when the Clerk negated Plaintiffs vote.
- 46. Public officials have a Ministerial duty refers to the official duty of a public officer wherein the officer has no room for the exercise of discretion, and the performance being required by direct and positive command of the law.
- 47. The powers and duties of public officers are, in general, classified as ministerial and discretionary. The character of a duty as ministerial or discretionary is to be determined by the nature of the act to be performed, and not by the office of the performer. Official duty is ministerial when it is absolute, certain, and imperative, involving merely execution of a specific duty arising from fixed and designated facts; that a necessity may exist for the ascertainment of those facts does not operate to convert the act into one discretionary in its nature. [State ex rel. School Dist. v. Ellis, 163 Neb. 86 (Neb. 1956)].

#### **COUNT IV**

#### **VIOLATION OF OATH OF OFFICE**

- 48. PLAINTIFF incorporates all prior paragraphs. (See Exhibit #2)
- 49. Defendant's negligence to perform when a known wrong was perpetrated is a violation of the Public Trust and Defendants Oath of Office.

# WHEREFORE plaintiff request the following relief:

- A. Award Plaintiff actual, nominal, or any other damages available to him in excess of an amount of One Million Dollars (\$1,000,000.00) or more;
- B. Enter an order compelling Antrim County Officials having any function with the 2022 elections to carry out duties as required;
- c. Enter and order directing Antrim County Clerk's office to assign a Deputy Clerk to any documentation regarding Plaintiff RANDY A. BISHOP;
- D. Award Plaintiff all costs and attorney fees;
- E. Any other relief deemed fair and equitable under these circumstances.

It was doing my job, getting my numbers certified as the Canvasser certified in total — [0:02:30] - reporting to the State Board of State Canvassers. So, I can tell you, I trust Dominion. I can honestly say the training was not adequate. I can tell you that every — [0:02:45] — Dominion machine is covered under contract for all maintenance for the first five years of usage. The second five, the townships pay their portion. I have a tabulator as a backup. [0:03:00] If a tabulator goes down, I ship my machine to Banks Township. They put their tabulator card in my machine. So, it's the programming in the cards. [0:03:15] So, if you want to call it "fraud," it's me. But it's not fraud; it's getting the job done right and getting those numbers in every single cell without — [0:03:30] — um, without double publishing because that's why our numbers were inflated. We double published because we didn't know we weren't just replacing; we had to delete a whole record. CHAPTER 15. PUBLIC OFFICERS AND EMPLOYEES BONDS OF STATE OFFICERS AND EMPLOYEES Act 10 of 1969 AN ACT to provide uniform bond coverage for officers and employees of state departments and agencies; and to repeal certain acts and parts of acts. History: 1969, Act 10, Imd. Eff. May 7, 1969. The People of the State of Michigan enact: 15.1 Uniform bond coverage; state officers and employees; exceptions. Sec. 1 Notwithstanding the provisions of any other law, officers and employees of all state departments and agencies that are required by statute or in the discretion of the director of the department covered, or otherwise to furnish bonds conditioned for their honesty or faithful discharge of their duties shall be covered by a blanket bond or bonds as a departmental group or as a state group by corporate surety companies as approved by the director of the department of administration. Treasurers and tax collectors by whatever title known may be covered by individual bonds. History: 1969, Act 10, Imd. Eff. May 7, 1969. 15.2 Bonds; conditions, coverage; departmental problems. In determining adequate coverage, the department of administration is authorized to obtain bond coverage with provisions relative to departmental problems of a unique nature, including loss deductible or coinsurance provisions.
