The undersigned is informed and believes that:

**COUNT 1**

On or between November 1, 2016 and November 30, 2016, in the County of Santa Barbara, the crime of ORAL COPULATION OF A PERSON UNDER 16, TO WIT: ORAL COPULATION OF DEFENDANT BY JOHN DOE #1, in violation of **PENAL CODE SECTION 288a (b)(2)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully, being over the age of 21 years, participate in an act of oral copulation with JOHN DOE #1 (DOB: 9-3-01), a person under the age of sixteen years.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.067**.

"NOTICE: Pursuant to the provisions of **Penal Code Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

**SPEC ALLEG – SERIOUS/VIOLENT/REGISTERABLE SEX OFFENSE FELONY**

It is further alleged AS TO COUNTS 1 THROUGH 31 that the above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and/or a violent felony described in subdivision(s) of Penal Code section 667.5 and/or an offense requiring registration under the provisions Penal Code sections 290 et seq, pursuant to Penal Code section 1170(h), that the defendant is ineligible for a state prison sentence to be served in the county jail.

"NOTICE: Pursuant to Penal Code section 1170(f), notwithstanding any other provisions of this section, for purposes of subdivision (h) of section 1170, any allegation that a defendant is ineligible for a state prison sentence to be served in the county jail due to a prior or current conviction, or sentence enhancement, or because he or she is required to register as a sex offender, or because the legislature specifically excluded the offense, shall not be subject to dismissal pursuant to §1385 PC."

On or between November 1, 2016 and November 30, 2016, in the County of Santa Barbara, the crime of ORAL COPULATION OF A PERSON UNDER 16, TO WIT: ORAL COPULATION OF JOHN DOE #1 BY DEFENDANT, in violation of **PENAL CODE SECTION 288a (b)(2)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully, being over the age of 21 years, participate in an act of oral copulation with JOHN DOE #1 (DOB: 9-3-01), a person under the age of sixteen years.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.067**.

"NOTICE: Pursuant to the provisions of **Penal Code Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

## COUNT 3

On or between November 1, 2018 and November 30, 2018, in the County of Santa Barbara, the crime of SODOMY OF PERSON UNDER 18, in violation of **PENAL CODE SECTION 286(b)(1)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully participate in an act of sodomy with JOHN DOE #1 (DOB: 9-3-01), a person under the age of eighteen years.

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). **Penal Code Section 1202.1**."

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.067**.

On or between November 20, 2015 and November 19, 2016, in the County of Santa Barbara, the crime of LEWD OR LASCIVIOUS ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(a)**, a Felony, was committed by GREGORY SCOTT RAY, who did willfully, unlawfully, and lewdly commit a lewd or lascivious act upon or with the body or certain parts or members thereof of JOHN DOE #2 (DOB: 11-20-2002), a child under the age of 14, with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of the said defendant(s) or the said child, to wit: TOUCHED VICTIM 2'S PENIS OVER CLOTHING.

It is further alleged that the above offense is a violent felony pursuant to **Penal Code Section 667.5(c)(6)**.

It is further alleged that the above offense is a serious felony within the meaning of **Penal Code Section 1192.7(c)(6)**.

It is further alleged that the Court shall prohibit all visitation between defendant and the child victim(s) pursuant to **Penal Code Section 1202.05(a)**.

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

#### **COUNT 7**

On or between November 20, 2015 and November 19, 2016, in the County of Santa Barbara, the crime of **ORAL COPULATION OF A PERSON UNDER 14**, in violation of **PENAL CODE SECTION 288a(c) (1)**, a Felony, was committed by GREGORY SCOTT RAY, did unlawfully participate in an act of oral copulation with JOHN DOE #2 (DOB: 11-20-2002), a person under the age of fourteen years and more than ten years younger than defendant.

"NOTICE: Pursuant to the provisions of PC Section 293.5 the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

It is further alleged that the above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) (6).

It is further alleged that probation shall not be granted to, nor shall the execution or imposition of sentence be suspended pursuant to Penal Code Section 1203.065 and Penal Code Section 1203.066.

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). **Penal Code Section 1202.1.**"

"NOTICE: Pursuant to the provisions of **Penal Code Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

On or between November 20, 2015 and November 19, 2016, in the County of Santa Barbara, the crime of LEWD OR LASCIVIOUS ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(a)**, a Felony, was committed by GREGORY SCOTT RAY, who did willfully, unlawfully, and lewdly commit a lewd or lascivious act upon or with the body or certain parts or members thereof of JOHN DOE #2 (DOB: 11-20-2002), a child under the age of 14, with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of the said defendant(s) or the said child, to wit: LICKED VICTIM 2'S ANUS.

It is further alleged that the above offense is a violent felony pursuant to **Penal Code Section 667.5(c)(6)**.

It is further alleged that the above offense is a serious felony within the meaning of **Penal Code Section 1192.7(c)(6)**.

It is further alleged that the Court shall prohibit all visitation between defendant and the child victim(s) pursuant to **Penal Code Section 1202.05(a)**.

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.067**.

COUNT 11

On or between August 15, 2014 and August 14, 2015, in the County of Santa Barbara, the crime of ORAL COPULATION OF A PERSON UNDER 16, TO WIT: ORAL COPULATION OF JOHN DOE #3 BY DEFENDANT, in violation of **PENAL CODE SECTION 288a (b)(2)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully, being over the age of 21 years, participate in an act of oral copulation with JOHN DOE #3 (DOB: 8-15-2000), a person under the age of sixteen years.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.067**.

"NOTICE: Pursuant to the provisions of **Penal Code Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

COUNT 12

On or between August 15, 2014 and August 14, 2015, in the County of Santa Barbara, the crime of SEXUAL PENETRATION BY FOREIGN OBJECT, in violation of **PENAL CODE SECTION 289(i)**, a Felony, was committed by GREGORY SCOTT RAY, being over the age of 21 years, committed an act of sexual penetration against JOHN DOE #3 (DOB: 8-15-2000), who was under the age of 16 years.

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

"NOTICE: To defendant and defendant's attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant."

COUNT 13

On or between August 15, 2014 and August 14, 2015, in the County of Santa Barbara, the crime of SODOMY OF A MINOR AGE 14 OR OLDER, BY USE OF FORCE, in violation of **PENAL CODE SECTION 286(c)(2)(C)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully participate in an act of sodomy with JOHN DOE #3 (DOB: 8-15-2000), a minor age 14 or older, and did accomplish said act against said victim's will by means of force, violence, duress, menace or fear of immediate and unlawful bodily injury to said victim or to another.

It is further alleged that the above offense is a serious felony within the meaning of **Penal Code Section 1192.7(c)(6)**.

It is further alleged that the above offense is a violent felony pursuant to **Penal Code Section 667.5(c)(4)**.

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

It is further alleged, a full, separate and consecutive term shall be imposed pursuant to **Penal Code section 667.6(d)** and **Penal Code section 667.6(e)(4)** where the crimes involve separate victims or involve the same victim on separate occasions.

COUNT 14

On or between August 15, 2014 and September 4, 2015, in the County of Santa Barbara, the crime of DISSUADING A WITNESS FROM REPORTING A CRIME, in violation of **PENAL CODE SECTION 136.1(b)(1)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully attempt to prevent or dissuade JOHN DOE #3 (DOB: 8-15-2000), a victim or witness of a crime from making a report of such victimization to a peace officer, state or local law enforcement officer, probation, parole, or correctional officer, prosecuting agency, or judge.

It is further alleged that the above offense is a Serious Felony within the meaning of **Penal Code Section 1192.7(c)(37)**.

"NOTICE: Pursuant to the provisions of **Penal Code Section 293.5**, the pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

#### COUNT 15

On or between July 6, 2011 and July 5, 2013, in the County of Santa Barbara, the crime of SODOMY OF PERSON UNDER 18, in violation of **PENAL CODE SECTION 286(b)(1)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully participate in an act of sodomy with JOHN DOE #4 (DOB: 7-6-95), a person under the age of eighteen years.

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.067**.

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

On or between July 6, 2011 and July 5, 2013, in the County of Santa Barbara, the crime of SEXUAL BATTERY, in violation of **PENAL CODE SECTION 243.4(a)**, a Felony, was committed by GREGORY SCOTT RAY, who did willfully and unlawfully touch an intimate part of JOHN DOE #4 (DOB: 7-6-95), against the will and for the specific purpose of sexual arousal, sexual gratification or sexual abuse.

"NOTICE: To defendant and defendant's attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant."

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure is a crime."

COUNT 18

On or between October 21, 2007 and October 20, 2009, in the County of Santa Barbara, the crime of SODOMY OF PERSON UNDER 18, in violation of **PENAL CODE SECTION 286(b)(1)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully participate in an act of sodomy with JOHN DOE #5 (DOB: 10-21-91), a person under the age of eighteen years.

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

"NOTICE: Conviction of this offense will require the court to order you to submit to a blood test for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency Syndrome (AIDS). **Penal Code Section 1202.1**."

"NOTICE: To defendant and defendant's attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant."

**SPEC ALLEG-STATUTE OF LIMITATIONS-SEX CRIMES**

It is further alleged, pursuant to **PENAL CODE SECTION 801.1(a)**, that notwithstanding any other limitation of time described in this chapter, prosecution for a felony offense described in section 261, 286, 288, 288.5, 288a, or 289, or Section 289.5, as enacted by Chapter 293 of the Statutes of 1991 relating to penetration by an unknown object, that is alleged to have been committed when the victim was under the age of 18 years, may be commenced any time prior to the victim's 28<sup>th</sup> birthday.

COUNT 19

On or between October 21, 2007 and October 20, 2009, in the County of Santa Barbara, the crime of ORAL COPULATION OF A PERSON UNDER 18, in violation of **PENAL CODE SECTION 288a(b)(1)**, a Felony, was committed by GREGORY SCOTT RAY, who did unlawfully participate in an act of oral copulation with JOHN DOE #5 (DOB: 10-21-91), a person under the age of eighteen years.

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.067**.

"NOTICE: Pursuant to the provisions of **PC Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

"NOTICE: To defendant and defendant's attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant."

COUNT 20

On or between June 24, 2015 and June 23, 2016, in the County of Santa Barbara, the crime of SENDING HARMFUL MATTER, in violation of **PENAL CODE SECTION 288.2(a)(2)**, a Felony, was committed by GREGORY SCOTT RAY, who did, with knowledge that a person is a minor, or failing to exercise reasonable care in ascertaining the true age of a minor, unlawfully and knowingly distribute, send, cause to be sent, exhibit and offer to distribute or exhibit harmful matter to a minor, with the intent of arousing, appealing to or gratifying the lust, passions or sexual desires of defendant(s) or of a minor, and with the intent or for the purpose of seducing a minor, TO WIT: JOHN DOE #6 (DOB: 6-24-99).

"NOTICE: To defendant and defendant's attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant."

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

COUNT 21


