12.a 201 TOWN CENTER WEST - DOWNTOWN PERMIT FOR HERITAGE WALK LOFTS

The City Council will consider a recommendation of the Planning Commission to review a Downtown Permit (DT2022-0018) for The Vernon Group to convert an existing 84,000-square-foot structure to a two-story 104-unit residential use on a 1.3-acre site in the Town Center District of the Downtown Specific Plan. (Director of Community Development)

On February 15, 2023, the Planning Commission voted 5-0 to approve the project and recommended that the City Council review and approve a Downtown Permit for the Vernon Group.

<u>Environmental Notice:</u> This project qualifies as a Class 32 (In-Fill Development Projects) Categorical Exemption by Section 15332 of the State California Environmental Quality Act Guidelines. The project would not result in significant effects to water quality, air quality, traffic, or noise. No further environmental review is required.

RECOMMENDATION:

Items not on the agenda may not be discussed or acted upon except under emergency circumstances. (Government Code Section 54954.2).

Copies of the staff reports or other documentation relating to each item of business referred to on the agenda are on file in the Office of the City Clerk and available for public inspection

during City Hall business hours the Friday before the meeting. Any written correspondence or documents provided to a majority of the City Council after distribution of the Agenda will also be available for public inspection in the Office of the City Clerk. If requested, the agenda and supporting documents shall be made available in alternative formats to persons with a disability. The City Clerk's Office will answer any questions regarding the agenda.

The City of Santa Maria welcomes orderly participation at its meetings from all members of the public. Orderly participation means speaking only on items of City business or on subjects within the City's control. Though the City Council wants to hear your concerns and values your input, it is inappropriate to defame, yell, use profane language, interrupt, or disrupt the meeting. All cellular telephones are to be turned off or set to vibrate, and signs are not to be displayed in a manner that violates the rights of others or prevents others from watching or fully participating in the Council meeting.
