The Petitioner-Appellee, the Belle of Sioux City, L.P. ("the Belle") respectfully requests this Court for leave to exceed the 25 page limit allowed for attachments for its resistance to IRGC's Motion to Stay and/or to Vacate and Motion for Temporary Stay; IRGC's Application for Appeal in Advance of Final Judgment; and SCE Partners, L.L.C.'s Petition for Writ of Certiorari and Request

for Immediate Relief under Rule 6.1002(4) ("the Combined Applications"). In support of this request, the Belle states as follows:

- 1. On Thursday, December 18, 2013, the above-referenced Combined Applications were filed with this Court and served on the Belle.
- 2. The Court has ordered the Belle to file its Resistance to the Combined Applications by noon on Tuesday, December 24, 2013.
- 3. Iowa R. App. P. 6.1002(2) provides that the Belle may support its Resistance with "other relevant portions of the record, but that such attachment shall not exceed 25 pages unless otherwise ordered by an appellate court."
- 4. The Belle requests leave to include more than 25 pages in attachments to its Resistance. Specifically, in order to provide this Court with the Polk County District Court record in this matter, the Belle requests permission to attach relevant portions of the record (the district court briefing of both parties as well as related exhibits) from which Judge Robert B. Hanson's temporary stay ruling was issued. In addition, the Belle also intends to attach an affidavit from counsel relating to the district court activities regarding the Combined Applications. While the attachments are not yet finalized given the expedited time frame, the Belle estimates the attachments to be included with its combined resistance will not exceed 135 pages.

- 5. The Combined Applications to which the Belle is responding includes approximately 63 pages, including matters from the below record as well as additional affidavits with exhibits not in the record.
- 6. Thus the Belle requests that this Court enter an order allowing it to include attachments to its Resistance not in excess of 145 pages.

WHEREFORE, for the reasons stated herein, the Belle respectfully requests that this Court issue an order pursuant to Iowa R. App. P. 6.1002) allowing it to include attachments to its resistance to be filed on 12/24/2013 not in excess of 135 pages.
