Count 3: SEXUAL ABUSE IN THE THIRD DEGREE
Count 4: SEXUAL ABUSE IN THE THIRD DEGREE
Count 5: SEXUAL ABUSE IN THE THIRD DEGREE
Count 6: SEXUAL ABUSE IN THE THIRD DEGREE
Count 7: SEXUAL ABUSE IN THE THIRD DEGREE
Count 8: SEXUAL ABUSE IN THE THIRD DEGREE
Count 9: SEXUAL EXPLOITATION OF A MINOR
Count 10: SEXUAL EXPLOITATION OF A MINOR

Committed as follows:

Count 1

Said Defendant, on or about the 1st day of April, 2013 to on or about the 31st day of December, 2013, in Woodbury County, Iowa, performed a sex act with a person, M.D., who was fourteen or fifteen years of age and the Defendant was four or more years older than M.D., the Defendant and M.D. not at the time cohabiting as husband and wife, all in violation of Iowa Code section 709.4(2)(c)(4).

Count 2

Said Defendant, on or about the 1st day of April, 2013 to on or about the 31st day of December, 2013, in Woodbury County, Iowa, performed a sex act with a person, M.D., who was fourteen or fifteen years of age and the Defendant was four or more years older than M.D., the

Defendant and M.D. not at the time cohabiting as husband and wife, all in violation of Iowa Code section 709.4(2)(c)(4).

Count 3

Said Defendant, on or about the 1st day of April, 2013 to on or about the 31st day of December, 2013, in Woodbury County, Iowa, performed a sex act with a person, M.D., who was fourteen or fifteen years of age and the Defendant was four or more years older than M.D., the Defendant and M.D. not at the time cohabiting as husband and wife, all in violation of Iowa Code section 709.4(2)(c)(4).

Count 8

Said Defendant, on or about the 1st day of April, 2013 to on or about the 31st day of December, 2013, in Woodbury County, Iowa, performed a sex act with a person, M.D., who was fourteen or fifteen years of age and the Defendant was four or more years older than M.D., the Defendant and M.D. not at the time cohabiting as husband and wife, all in violation of Iowa Code section 709.4(2)(c)(4).

Count 9

Said Defendant, on or about the 1st day of April, 2013 to on or about December 31, 2013, in Woodbury County, Iowa, used, persuaded, induced, enticed, coerced, solicited, knowingly permitted or otherwise caused or attempted to cause a minor to engage in a prohibited sex act, knowing, or having reason to know, that the act might be photographed, filmed or otherwise preserved in a visual depiction, all in violation of Iowa Code section 728.12(1).

Count 10

Said Defendant, on or about the 1st day of April, 2013 to on or about May 13, 2014, in Woodbury County, Iowa, knowingly possessed a visual depiction of a minor engaging in a prohibited sex act, all in violation of Iowa Code section 728.12(3).
