71906 NOTICE OF AVAILABILITY OF A SECTION 4(F) DE MINIMIS DETERMINATION FOR THE SONOMA 1 CULVERT REHABILITATION PROJECT - NORTH

The California Department of Transportation (Caltrans) proposes to replace 27 culverts from 0.2 mile north of Miller Creek (Post Mile [PM] 41.2) to 0.1 mile north of Vantage Road (PM 54.6) at various locations (Project). Additional work includes improving or restoring associated drainage features including: rock slope protection, headwalls, flared end sections, drainage inlets, and ditches.

WHY THIS AD? This public notice is to tell you of Caltrans' intent to adopt a U.S. Department of Transportation Act Section 4(f) de minimis finding and of its availability for you to review and provide comments.

Section 4(f) of the U.S. Department of Transportation Act of 1966 seeks to protect publicly owned parks and recreation areas, wildlife refuges, and historic sites that are eligible for the National Register of Historic Places. Provisions to carry out this evaluation are recorded in 23 Code of Federal Regulations (CFR) 774.17, Section 4(f). As part of the Safe, Accountable and Efficient Transportation Equity Act - A Legacy for Users (SAFETEA LU ACT) of 2005, the legislature established the de minimis finding process, in which determinations are made regarding 4(f) resources when no adverse effects would occur. De minimis impacts are defined as those that do not adversely affect the activities, features and attributes for which the property qualifies as a 4(f) resource.

Caltrans has determined that the Project will require temporary construction easements (TCEs), and a permanent drainage easement (PDE), and/or transfer of jurisdiction (TOJ), that extend beyond Caltrans right of way (ROW) and onto a Section 4(f) property owned by the California Department of Parks and Recreation (State Parks) at Salt Point State Park. Caltrans has preliminarily determined that the TCEs and permanent TOJ are necessary for preventing further damage of the drainage systems and maintaining the structural integrity of the highway. Caltrans has also analyzed the use that the Project would have on the Section 4(f) property and determined that construction-related activities occurring from the Project at Salt Point State Park would have a de minimis use on the Section 4(f) property.
