Bacteriological Monitoring Requirements Not Met for Westminster Woods Camp During March 2021

Our water system recently violated a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what happen, what you should do, and what we did to correct the situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During November 2020 we did not meet all monitoring requirements for coliform bacteria and therefore cannot be sure of the quality of our drinking water during this time.

What should I do? You do not need to boil your water or take other corrective actions.

Below lists the contaminant we did not properly test for during November 2020, how many samples we are required to take and how often, how many samples we took, when samples should have been taken, and the date on which follow-up samples will be taken:

Contaminant: Total Coliform Required sampling frequency: 1 per month Number of samples taken: 0 When all samples should have been taken: Monthly through 2020 When samples will be taken: April, 2021 (and monthly from here on).

If you have other health concerns related to the consumption of this water, you may wish to consult your doctor.

What happened? What is being done? During November 2020 we did not meet all monitoring requirements for coliform bacteria and therefore cannot be sure of the quality of our drinking water during this time. We now have a system to remind us to take in a water sample monthly to the testing lab only.

We anticipate resolving the problem within: This will be resolved by January, 2021.
