This ordinance to Require the Licensure of Tobacco Retailers to Regulate the Sale and Distribution of Tobacco Products to Protect Minors. The ordinance limits the number and type of establishments that may sell tobacco products, and provides a local licensing system for tobacco retailers to ensure that retailers comply with tobacco control laws and business standards of the City to protect the health, safety, and welfare of our residents.
