NARRATIVE

About 1:17am, on Tuesday, 07/16/25, Officer Rosario-Garcia assigned to the A436A was flagged down for an Investigate Motor Vehicle at Beacon st & Bowdoin St, Boston.

Assisting Units: A435A (Li), Massachusetts State Trooper Duff Badge #4881.

Upon arrival at the intersection referenced above, Officer Rosario-Garcia was making a left turn on to Bowdoin St from Beacon St when he was flagged down by a bystander, [REDACTED]

Upon approaching the scene, Officer Rosario-Garcia observed the rear tail lights and the front head lights illuminated of Vehicle #1, a GMC Yukon [REDACTED] Officer Rosario-Garcia observed that the

driver's side of Vehicle #1 appeared higher than the passenger side as if the car was leaning to one side. Upon exiting Boston Police marked cruiser #6504, Officer Rosario-Garcia observed extreme damage to the passenger side front wheel. The officer observed the front wheel on the passenger side turned to an extreme degree not consistent with normal vehicle operations.

Officer Rosario-Garcia that while driving on Hancock Street, he observed a motor vehicle crash involving Vehicle #1. [REDACTED] stated that Vehicle #1 struck a legally parked vehicle, Vehicle #2, a white Toyota Tundra [REDACTED] as a concerned citizen, followed Vehicle #1 as it drove away from the accident scene, as [REDACTED] continued following Vehicle #1, when he observed Vehicle #1 run a stop sign at Hancock & Mt. Vernon Streets and another stop sign at Mt. Vernon & Joy Streets.

██████████ observed Vehicle #1 make stop at a red light at the intersection of Joy & Beacon Streets, where he got out of his vehicle in an attempt to speak with the driver of Vehicle #1, but he drove off making a left turn onto Beacon St when the light turned green. ██████████ got back in his vehicle and continued to follow Vehicle #1 as he turned northbound onto Beacon St. ██████████ followed the driver of Vehicle #1 to the intersection of Beacon St & Bowdoin St where he observed Vehicle #1 park on the left side of Bowdoin St. ██████████ stated that the operator of Vehicle #1 was sitting in the driver's seat, having never exited the vehicle.

As Officer Rosario-Garcia approached Vehicle #1 On the driver's side, he identified the operator as suspect John J. Lawn, [REDACTED] Upon requesting the suspect's driver's license and registration, [REDACTED] Officer Rosario-Garcia detected a strong odor of an alcoholic beverage emanating from the suspect. He further observed that the suspect's eyes were glassy and bloodshot, and his speech was slurred.

At this point, Officer Li issued an exit order to the suspect. As the suspect stepped out of the vehicle, Officer Rosario-Garcia noted that he had difficulty maintaining his balance. Officer Rosario-Garcia again asked the suspect for his license, and as he attempted to retrieve his license from his wallet, he dropped his license and one of his credit cards on the ground.

Officer Li went to check Vehicle #2 and found it parked in front of 67 Hancock St. Officer Li observed damage to the driver side rear door and passenger side bed of the vehicle. Officer Li also observed car parts, consistent with the color of Vehicle #1, located on the driver side of Vehicle #2 near where the damage occurred. Officer Li took a photo of the car parts with his department issued cell phone and seized the parts as evidence. Officer Li also spoke with a witness, [REDACTED] who stated that he woke up to the sound of a motor vehicle accident and observed a "big dark colored Suburban" type vehicle. A Suburban is the Chevy version of the GMC Yukon. Back at Beacon St and Bowdoin St, Officer Li observed that the front passenger side bumper was missing pieces consistent with those found at 67 Hancock St.
