EXISTING LAWS

HISTORY:

AFFECTED: M.G.L. c. 18C; c. 71; c. 119; c. 209A § 1; c. 265 § 43A; c. 272

PROPOSED
LEGISLATION:

 Requires the Office of the Child Advocate to develop and implement a comprehensive educational diversion program designed for adolescents on the consequences of sexting and posting indecent visual depictions online.

- Requires the Department of Elementary and Secondary
 Education to encourage school districts to implement
 instruction on age-appropriate media literacy skills and to use
 content from the Office of the Child Advocate's
 comprehensive educational diversion program for educational
 programs on the topic of sexting and posting indecent visual
 depictions online.
- Defines "coercive control" as a single act or a pattern of behavior intended to threaten, intimidate, control or compel compliance of a family or household member that causes a fear of physical harm or a reduced sense of physical safety.
- Requires the diversion of a child alleged to be a juvenile delinquent for violating laws prohibiting the possession or dissemination of certain explicit visual material unless the court finds that failure to proceed with the arraignment would result in the substantial likelihood of serious harm to a member of the community.

- Increases the allowable fine for the crime of criminal harassment from \$1,000 to \$5,000.
- Establishes a new criminal offense for the unlawful distribution of certain visual material depicting another person who is nude, partially nude or engaged in sexual conduct without their consent.
- Establishes a new juvenile offense for the unlawful possession or dissemination of certain explicit visual material.

This legislation has no cost to the Commonwealth.
