OBJECTION

Based on the information in the attached affidavits, complaints made to the Secretary of the Commonwealth and personal inquiries of individual signers, I assert that signatures on an as yet indeterminate number of petition blanks designated 1E were fraudulently obtained. I therefore object to the certification of Initiative Petition 1E and its transmittal to the Legislature.

Paid signature gatherers at Trader Joe's in Hanover, Market Basket facilities in Plymouth, Whole Foods in Weymouth and in parking lots around Gillette Stadium in Foxborough have misled voters with respect to what they were signing and thus obtained signatures fraudulently. Among the misleading statements were assertions that the law proposed on the petition blanks they were signing would get fentanyl off the streets, provide affordable housing in their communities or fund public parks. Each of these assertions would be apt with respect to one or more of the other initiative petitions approved by the Attorney General, but have nothing to do with Initiative Petition 1E. More specifically: Fentanyl is a subject dealt with in petition numbered 10 by the Attorney General and labelled 1D by the Secretary; Petitions numbered 15 and 16 by the Attorney General and labelled E and F by the Secretary deal with parkland; and petitions numbered 21 by the Attorney General and labelled D by the Secretary and first numbered 03 by the Attorney General and then labelled Z by the Secretary deal with housing related issues.

The paid signature gatherers in question often provided voters only the backside of Petition 1E to those whose signatures they obtained. The backside does not bear the summary of the proposed law. All those circulating the signatures for payment were assigned numbers that would enable them to be identified and collected signatures from multiple cities and towns.

All signatures collected in the manner described above, whether by the particular individuals who gathered signatures at the locations described above or by other circulators are the subject of this objection.


