- 1. Description of the arrest: FELONY COUNTERFEIT, FELONY FRAUD, FELONY DRUG POSSESSION PARAPHERNALIA
- 2. Date, Time, Reporting Officer: Wed Jun 05 02:32:29 2024 D IVERSON P218

Probable Cause Statement:

On today's date, I observed a black passenger car traveling north on Bluff Street near Main and Bluff. I watched as the vehicle was traveling in the outside number two lane and immediately turned right onto Main Street from from the through travel lane at a high rate of speed. The turn signal was not activated and the vehicle performed an improper right turn by turning from the through travel lane and not utilizing the right turn lane. The car turned into the inside number one lane on Main St and not the outside number two lane designated for the right turn. I activated my overhead lights and the vehicle again failed to signal, making an abrupt right turn into the Denny's parking lot from the inside number one lane causing confusion for a vehicle in the outside number two lane who did have their turn signal activated to make a right turn in to the Black Bear Diner parking lot. The black passenger car then came to an abrupt stop taking up two parking spots on the south side of the Denny's. I made contact with the driver identified as Nicole LeCou by an expired California ID card she provided to me. I explained to her the reason for the stop. She apologized stating she was not from the area and she stopping at Denny's to get something to eat as she and her friend later identified as Holly Hankinson were just arriving from Las Vegas for the weekend. I gathered information and while waiting for Nicole to locate any sort of insurance information I requested K9 Officer A Ott to respond to my location. It took some time for Nicole to locate any real information on the car as the state return out of California showed the vehicle had not been registered since 2016, expiring in 2017. Ofc Ott arrived and deployed his K9 Emma and then advised me, Emma provided him with a positive indication for the odor of illegal narcotics coming from the car.

A probable cause search was conducted and I located in a bag later determined to belong to Nicole, a piece of tin foil with a brown tar like substance consistent with my training and experience to be black tar heroin. There was a straw smoking style device in the same location with what appeared to be suspected heroin residue. While searching the vehicle, officers including myself located many items consistent with counterfeiting, that included (9)\$100 bills in Nicole's wallet that were obviously counterfeit, printers, computers, templates, currency that had been "washed" to be used for making larger denomination bills, chemical agents consistent with the kind used in the manufacture of counterfeit bills, and other electronic and mechanical devices consistent with the production of counterfeit money. I located in another bag later determined to belong to Nicole, syringes with suspected heroin residue, a rubber container with several grams of suspected black tar heroin and other tooter straw smoking style devices consistent with heroin use. Post Miranda Nicole admitted to being the sole owner of the drugs and paraphernalia, admitted to the counterfeiting devices, equipment, chemicals and passing of counterfeit bills while in Mesquite Nevada. It was determined Holly was not involved

with the counterfeit production, or having any ownership of the drugs and related paraphernalia. After reviewing Nicole's criminal history, There are multiple convictions of dangerous drugs in recent years and the heroin charges are enhanced to a 3rd degree felony. Because of the number of items located, felony charges for counterfeiting will be broke down in to groups as follows:

- 1-Paper Cut-outs / Counterfeit Templates Approx. 102
- 2-Counterfeit Templates containing \$100.00 Bills 9
- 3-Transparent Counterfeit \$100.00 2
- 4-Forgery Misc. Supplies 6
- 5-Washed Bills 80
- 6-Watermark Maker / Template 1
- 7-Cricut Light Board / Counterfeit Template 1
- 8-Blank Counterfeiting Paper 20
- 9-Epson Printer 1
- 10-Epson Ink Cartridges 12
- 11-Chrome Book Computer 1
- 12-Counterfeit \$100 bills from Nicole's purse. 9

Nicole is being charged with (12) 3rd degree felony counterfeit charges, 2 3rd degree felony drug possession charges for heroin and suspected methamphetamine, 1 paraphernalia charge for multiple items of drug related paraphernalia, driving in suspended/revoked with priors, and improper right turn. *****Nicole meets the statute and could be charged with (244) separate felony counterfeiting charges*****

************ Nicole was learned to have reserving a room at the Econolodge Inn here in St George. She has no ties to the St George area, and was believed to be here specifically to commit counterfeiting related crimes. She has who she stated was a boyfriend in Las Vegas and it is believed Nicole will flee to Nevada and then possibly California as soon as she is released. Please consider based on the totality of the crimes she is being charged with, the felonies she could potentially be charged with and her flight risk concerns and place a NO BAIL hold on Nicole. ***********
