That your affiant has reason to believe:

Affiant believes the property and evidence described above is evidence of the crime or crimes of Wanted person David Scott Mooneyham with active NCIC and Utah Statewide warrants for possession of firearms and dangerous weapon by restricted person. Informant disclosed wanted person is staying here to avoid detection. Informant also disclosed in the past there are firearms at this location.

The facts to establish the grounds for issuance of a Search Warrant are:

I attended Weber State Police Academy in 2003. I have worked as a Peace Officer within the State of Utah since 2004 for LaVerkin City Police and Kane County Sheriff's Office. During my time as a Peace Office I have arrested multiple people for driving under the influence of alcohol and/or drugs. I have been trained on Standardized Field Sobriety Tests and the Intoxilizer. In my experience I have dealt with hundreds of intoxicated people at different levels of intoxication.

Hurricane City Police Officer S. Johnson contacted me with information related to a wanted person. Officer Johnson notified me he is looking for David Scott Mooneyham (DOB) 06/25/1979. Mooneyham has an active NCIC and Utah Statewide warrant for his arrest. The two warrants are for 3 counts of possession of a firearm by a restricted person (felony 3), as well as 3 counts possession of a dangerous weapon by restricted person (Class A Misdemeanor) and 8 counts violation of a protective order (Class A misdemeanor). Officer Johnson had information indicating Mooneyham is trying to avoid arrest in Washington County and is staying at his family's cabin on their ranch in rural Kane County. Officer Johnson received creditable information by a family member (informant) who has detailed knowledge of the cabin the firearms inside where Mooneyham is staying has firearms inside of it. I'm confident that information to be creditable and that Mooneyham is in violation by being in possession of a firearm by having access or possession. Officer Johnson described Mooneyham as driving a 2022 Blue, Ford, F350, Pickup, Utah License Plate 11DC7, VIN # 1FT8W3BT8NED89846, Registered Owner Davis Mooneyham. Officer Johnson also informed me Mooneyham in the past has had someone lock him in a gunsafe to avoid capture when being sought by police.

A local records check showed Mooneyham filed a complaint with Deputy Hoyt in 2021 related to people trespassing on his property located near SR9 MM49. This description is consistent with the address of 7050 W Highway 9. On 09/2022 Sergeant Cole Brown was sent to this same property to look for Mooneyham.

On 12/10/2022 I was able to observe fresh tire tracks on the roadway pulling off SR9 to this property. I was able to view this property from a distance and observe a vehicle matching the description of the blue ford F350 parked on the Southwest corner of the Cabin/Residence, Further indication of the Cabin/residence being occupied by Mooneyham I observed a light on in the residence Top floor window facing South at 20:00 hr.

Given the active warrants and the previous involvements at this location with Mooneyham, as well as the fact a vehicle matching the description of the one he is driving is parked at the cabin. Also the activity of fresh tire tracks in the road leading to the cabin/residence and lights on in the top window facing south I believe there is enough evidence to support a search warrant to enter this residence to arrest Mooneyham on the active warrants. I believe with the information from the informant talking to Officer Johnson telling of firearms at this Cabin/residence further support a search for firearms at this residence and in Mooneyhams vehicle listed above

WHEREFORE, your affiant prays that a Search Warrant be issued for the seizure of said items at any time of the day or night because there is reason to believe it is necessary to seize the above-listed property prior to it being concealed, destroyed, damaged, or for other good reasons, to wit:

Kane County Sheriff's Office intends to serve this during daytime hours. If circumstances dictate I request the warrant be able to be served during night time hours. Due to the fact wanted person Mooneyham has 3rd degree felony warrants for his arrest for possession of firearm by restricted person..

I declare under criminal penalty of the State of Utah that the foregoing is true and correct.
