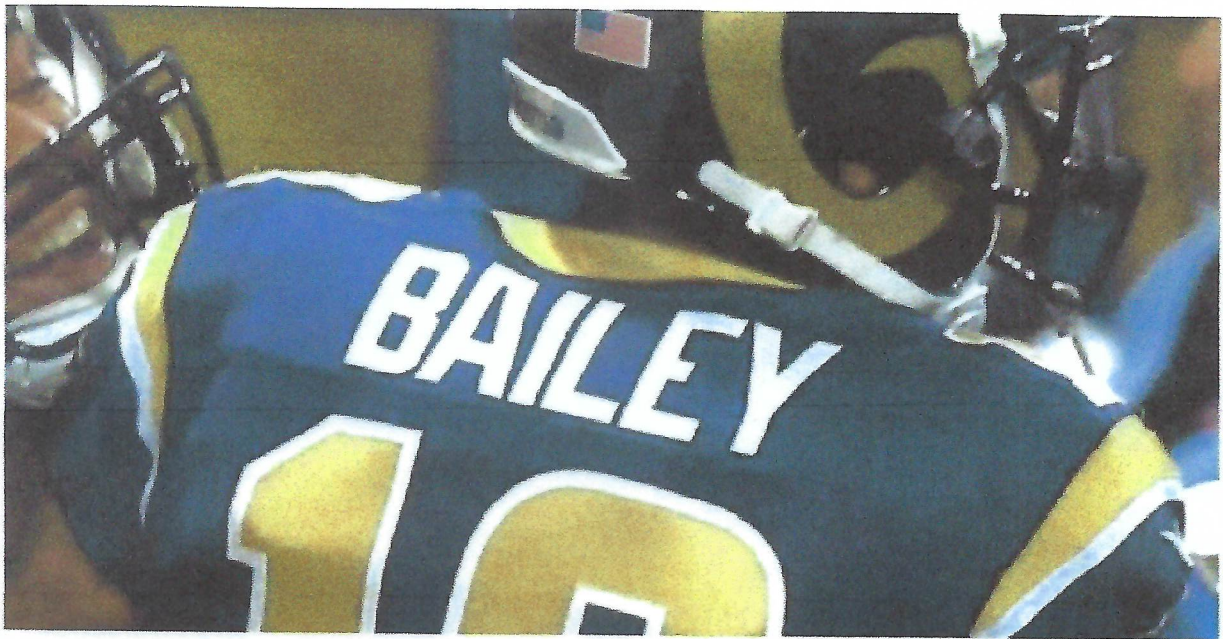

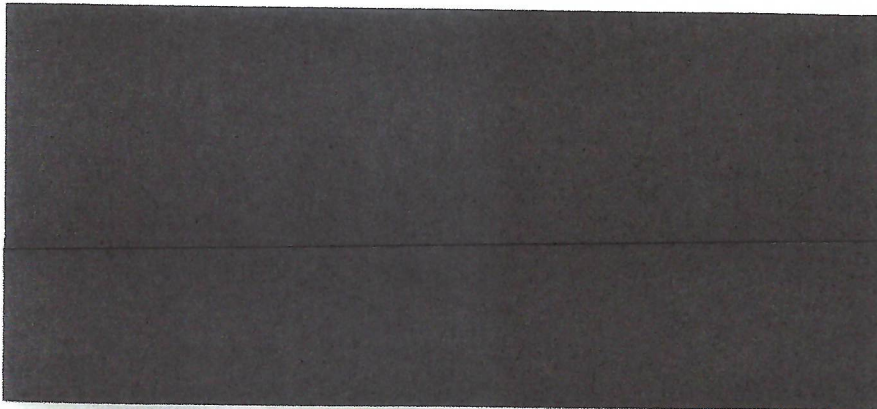

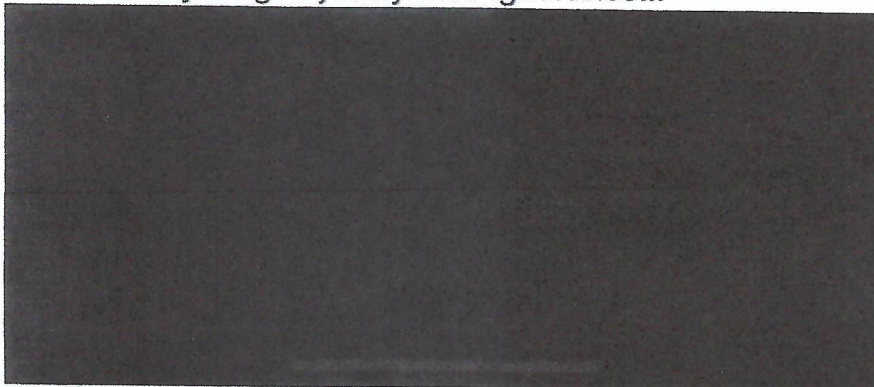

## Incident summary:

The complainant wrote on his COB form the involved officer racially profiled him for speeding and issued him numerous traffic and equipment violations that were improper. The officer never provided a reason for stopping him and informed him his tickets would be in the mail. Also, the involved officer posted an incriminating post on Facebook relative to his complaint. The Facebook post provided by the complainant revealed nothing that impeaches the actions of the officer. Also, the complainant provided photographs of his car that revealed the rear license plate was illuminated; however, the photographs were not date/time stamped.

## Notes:

- Numerous unreturned calls were made to the complainant.
- A certified letter was sent on May 2, 2018.
- The complainant contacted the Internal Affairs Division (IAD) on June 12, 2018, after receiving the certified letter. He left a message stating he works from 5:30 a.m. to 6:00 p.m. and would contact this office on his lunch break at 12:00 p.m. on June 13, 2018.
- On June 13, 2018, the complainant contacted the Internal Affairs Division and scheduled an interview for June 14, 2018. The COB was informed of the scheduled interview.
- On June 14, 2018, IAD and COB investigators met to interview the complainant. He failed to arrive at the scheduled time and left a voice message stating that he could not find the building. He was re-contacted and told the correct address and stated he was in the area; however, he never arrived or re-contacted IAD.

It is alleged that the involved officer is in violation of Special Order SO 1-04, "Prohibition of Bias-Based and Racial Profiling." POLICY: The St. Louis Metropolitan Police Department will respect and protect the constitutional rights and dignity of all individuals during law enforcement contacts and/or enforcement actions. In the absence of any specific information, the race, ethnicity, age, gender, gender identity, national origin, sexual orientation, religion, economic status or cultural group of any person will not be a consideration for traffic contacts, field contacts, investigations, detention, interdiction, asset seizure, forfeiture efforts or other disparate treatment of an individual by any member of the Department.

No further internal action will be taken, and this matter will be considered closed due to the complainant failure to assist with the investigation.
