**NARRATIVE:**

Natalia Morozova and Konstantin Morozov are married, but currently separated. They are both originally from Russia. They have one child together, 8-year-old [REDACTED] is in second grade at Pine Grove Elementary. Due to the similar last names, all subjects will be referred to by their first names.

Narrative: On 12-21-15, at about 1330 hours, I met with Natalia Morozova at the Santa Maria station. Natalia was crying and scared, as she intended to serve her husband, Konstantin, with divorce papers later in the week. Natalia explained that although they still reside together at their residence at 1295 Holly Springs Road, they have been separated for about six months and stay in different bedrooms.

On 12-18-15, Natalia and Konstantin went into the backyard of their residence to talk. During that time, Natalia asked Konstantin what they should do about their marriage, but Konstantin did not have an answer. Natalia suggested going through with a divorce, something that they had talked about in the past. Konstantin became angry and told Natalia that if she divorced him, he would make her life miserable. Konstantin told her he would force her to go back to Russia and that he would not support her financially. He stated that if Natalia did not have any finances, then she would not be able to support [REDACTED] which would make her a bad mother.

Although she felt his comments were threatening, Natalia stated Konstantin never threatened any violence towards her and there is no history of domestic violence between them.

Natalia said Konstantin was to be served with divorce papers in the coming week. She requested a report be made for documentation purposes, in case something should happen to her or to [REDACTED]

Natalia recently learned that Konstantin has been looking at online Russian dating sites and at Russian real estate

sites. She fears that Konstantin will leave the United States and take [REDACTED] with him after being served. To keep [REDACTED] from leaving the country, Natalia took both her and [REDACTED] passports and is keeping them in her possession. \*

Natalia said Konstantin recently took her cellular telephone from her and a friend gave her one to use. Natalia has no access to their money and believes Konstantin will take her car away to prevent her from leaving after he is served with the divorce papers.

I advised Natalia of child abduction laws and advised her that although Konstantin could not take [REDACTED] out of the country legally, she could not either. Natalia stated she understood this. She added that she would contact law enforcement if necessary.

Due to the similar last names, all subjects will be referred to by their first names.

#### NARRATIVE:

On 2-6-16, at about 1130 hours, I spoke with Natalia Morozova by telephone. She explained that she had filed for a divorce and Konstantin had been served with the divorce papers. Konstantin would not allow Natalia to have an attorney, so she was forced to handle everything on her own, yet he hired an attorney for himself. Even though they had money, Konstantin was keeping all of their assets from her. Natalia wanted to report an incident that had occurred earlier in the week. Natalia stated she was sitting in the bathroom at her residence, working on financial documents that she needed to give to Konstantin's attorney the following morning.

Natalia had spread her documents out on the counter in the bathroom when Konstantin walked in and inquired as to what she was doing. Natalia told him what she was doing and Konstantine began to take pictures of her documents and then shuffled the paperwork around, messing up the order of the paperwork. Natalia said she called Konstantin's attorney and told her what was happening. The attorney asked to speak with Konstantin, but Konstantin hung up the telephone.

Natalia asked [REDACTED] to get the telephone from the kitchen so she could call again. [REDACTED] did get the phone and gave it to her, but Natalia placed the phone on the counter and Konstantin picked up the phone and put it in his pocket. When Natalia asked for the phone, Konstantin told her she could not have it, because she did not pay the bill. Natalia attempted to take the phone from his pocket, but Konstantin pushed her away with his thigh.

I spoke with [REDACTED] by telephone. [REDACTED] stated the only thing he remembered was Natalia asking him to get the telephone. He did not remember anything more because he was too busy watching television when this occurred.

Natalia said she was afraid to return to her residence and had moved to a shelter in Santa Maria with [REDACTED]. She was going to seek further assistance through other resources. I contacted DVERT who advised they would follow up with Natalia to see if they could provide any resources to her.

**Relationships:** Konstantine Morozov and Natalia Morozova are married, but are going through a divorce. They have an 8-year old son, [REDACTED]

For ease of reading they will be referred to by their first names.

**Narrative:** On Thursday, December 15, 2016 at approximately 0647 hours, I was dispatched to 1295 Hollysprings Lane, in regard to a theft of a purse.

I responded and contacted the reporting party, Natalia Morozova who told me the following: Natalia and her husband Konstantine are going through a divorce. Natalia stays in a room downstairs and Konstantine stays upstairs. On the morning of Thursday, December 15, 2016 at approximately 0630 hours, Natalia went upstairs into the kitchen. While she was in the kitchen, Konstantine left the house without saying anything to her. Natalia stated that during this time, she could not find her purse, so she called to report that Konstantine had taken her purse when he left the house.

At approximately 1600 hours, Konstantine came to the Sheriff's Department Santa Maria sub-station and told me the following: Konstantine had gone to the store to get cold medicine for his son, [REDACTED] and when he returned no one was at the house. Konstantine heard the message from me on his cellphone. Konstantine checked the car and found Natalia's purse and clothes in the back of the car. Konstantine gave me the purse and cellphone and requested I return the purse and cellphones to Natalia. Konstantine stated that he did not know Natalia's purse was inside the car when he took it in the morning.
