Report:

On the date listed above, at around 2240 hours, I responded to 2415 Parkwood Dr (Southeast Georgia Health System)

While en route, dispatch advised me that someone in wanted to make a report on the hazing that occurred somewhere on St. Simons Island. Dispatch had no information after that.

Once at the hospital, I walked to I observed a white male lying motionless on a hospital bed hooked up to a ventilator, surrounded by Mark Lehrkamp (Father), (Sister), and the Stepmother. I walked to the nurse's station and spoke to Dr. and Nurse stated that around 830pm to 843pm, a white Jeep wrangler four-door pulled up to the ER. Three occupants got out of the Jeep, saying that the male in the back seat, later identified as Trenton Lehrkamp, was unresponsive after drinking vodka and antidepressants. went to the rear of the Jeep and opened the door, and found Trenton lying unresponsive with shallow breathing. observed that Trenton's clothes were soaked with urine. Trenton had spray paint all over his body and hair, with a small bruise on his left shoulder. As got Trenton out of the vehicle the three occupants, identified as kept asking if they were free to leave. asked them if they could write their name and phone number on a sheet of paper in case had any more questions. All three agreed and then got back into the Jeep and drove off. stated that Trenton's breathing was six times per minute. Trenton could not breathe independently, so they had to sedate him and put him on a ventilator. also noted that Trenton's blood alcohol level was at .464.

I first spoke to Mark, who stated that the last time he saw Trenton was earlier in the day, at 4:52 pm. Trenton was "Perfectly Fine" and went to his friend's house. Later that day, around 8:40 pm, told Mark that something had happened to Trenton and that he might be at the hospital. Mark called the hospital and asked if Trenton had been dropped off. The hospital staff informed Mark that Trenton was drooped off and Mark needed to get there "Immediately." When marked arrived, he saw that Trenton was on a ventilator. Mark stated that this was not the first time Trenton had gone to and returned hurt. Last Friday, on the 17th of March, Trenton came home covered in WD-40, vomit, paint, glue, egg yolk, and spray paint. Mark stated that Trenton seemed high or drunk and two weeks prior. Mark had to take Trenton to the emergency room because he came home with a severe laceration above his left eye that required stitches. Mark says that whenever Trenton goes to house, "he never returns home normal." Mark states that the reason why Trenton goes over to is that Trenton has no other friends. When Trenton is at house, he is accepted and with people he thinks cares for him. Mark also believes that since they are younger than Trenton, he might think they look up to him. Mark also said that Trenton would not fight or defend himself against or any of the other juveniles because Trenton knows that since they are

minors if he hurts them he will get in serious trouble. Mark also states that

photos and videos of all the past incidents where Trenton has come home from
house hurt or covered in objects. Mark also has a picture of the
location where Trenton's phone was pinging, which shows
house.

I then spoke with who stated that the last time she talked to Trenton was on the phone at 5:48 pm for 43 seconds. Stated It was about a missing minions toy she was trying to find for their little brother. Trenton said he would return it to him, then hung up suddenly. It didn't think anything of it and carried on with her day. Two hours later, at around 8:39 pm, she got a message from on Snapchat stating, "Nigga Omg I know you're sick of hearing it but like I wasn't there but like Trenton is fucking dying apparently" asked where and he replied "Take a guess Motherfucking basement". Then checked her brother's iPhone location, and it showed that it was pinging at the hospital. While was en route to the hospital with her father and mother, she got a voice message from stating what had happened to Trenton and that had told what they did.

Mark was able to give me video and photos of past incidents with Trenton returning from house. provided me with a picture of the Snapchat message from and the voice message she was given while en route to the hospital. As of 12:19 am, March 22, 2023, Trenton is still on a ventilator and moved to ICU. No charges have been given at this time. Video and photos uploaded to evidence.com
