proposed Lawrence #2 Operation The 176.5-acre operation is located in Lawrence Township, Clearfield County located directly to the southwest

of the intersection of State Road SR-2005 (a.k.a. Erie

Pike Road) and Township Road T-566 (a.k.a.. Proud Road) on the properties of David W. & Heather L. Fox Harry D. & Gloria Rowles, Michael T. & Shannon D Henry, Kram Realty, LLC and others. The area is located on the Glen Richey U.S.G.S. Quadrangle map, 17.5

inches north and 14.5 inches west from the bottom righthand corner of the printed map. Treated waste waters will be discharged into Unnamed Tributaries to West Branch Susquehanna River and West Branch Susque-

hanna River. The application includes permission to conduct auger mining and blasting and to change the postmining land use from forestland to unmanaged natural habitat.

The operator is requesting permission to mine within the 100' barrier to T-566 (Proud Road) beginning approximately 350 feet from the intersection of T-566 and T-581 (a.k.a. Lawrence Grange Road) and extending to the north, on the western side of T-566, for a distance of approximately 400'.

The operator is requesting permission to mine within the 100' stream barrier to Unnamed Tributary #2 (U.T. #2) beginning approximately 1,500 feet east of the confluence of U.T. #2 and West Branch Susquehanna River

and extending on both sides up-gradient for a distance of approximately 1,350 feet. The operator is also requesting permission to temporarily relocate a portion of Unnamed Tributary #1D (U.T. #1D) beginning approximately 550 feet northwest of the point of origin on the channel and extending down-gradient for a distance of approximately 450 feet. Finally, as part of the mine plan

the operator is requesting permission to reconstruct a portion of U.T. #2 with the West Branch Susquehanna River and extending up-gradient for a distance of approximately 850 feet.
