2022 BLOUNT COUNTY PRIMARY: ASSESSOR OF PROPERTY

The Blount County Assessor of Property is required by the Tennessee Constitution to list and value all property subject to being taxed "according to value." The assessed value of taxable property is a percentage of "fair market value" or "use value." Commercial property is assessed at 40 percent of "fair market value; residential improvements, 25 percent of "fair market value"; and residential land, 25 percent of "fair market value" or "use value." supervisor. I've held a Tennessee Real Estate Affiliates Broker license as of 2016 and have served as my HOA's president since the same year. I am currently employed as a project manager for a home improvement contractor and am a member of the International Association of Assessing Officers. In addition to serving as the Blount County Democratic Party's District 7 representative, I volunteer for an equine rescue and have just begun my first year as a tnAchieves college mentor."

WHY ARE YOU RUNNING FOR THIS POSITION?

"Full-time career posts with six-figure salaries such as property assessor disserves the public by being a partisan position. Leading a highly impactful office tasked with establishing property values requires a skill set and experience which may not always coincide with a Republican or Democratic affiliation. In Blount County's current political climate, 30 percent of the electorate are voting Democrats, yet Democrats hold 4 percent of partisan political positions because most can't risk disclosing their political affiliation that means qualified candidates are not utilized. A chancellor is a judge who presides over a chancery courts and hears a variety of issues, including lawsuits, contract disputes, application for injunctions and name changes. Divorces, adoptions and workers' compensation can be heard in either chancery or circuit court. The 4th/5th Judicial District includes Blount, Cocke, Grainger, Jefferson and Sevier counties. The debt is down to \$139 million and will be down to around \$120 million by June. Improvements take time to accomplish. Other than my family, being mayor and working for the people is my passion."

WHATRELEVANT EXPERIENCE DO YOU HAVE? "In every job, it has always been my top priority to be fiscally responsible with taxpayers' money. As mayor, we have increased the county's general fund balance from \$6.3 million to \$35.7 million, debt service fund from \$13.2 million to \$22.4 million; eliminated all variable rate debt, consolidated departments, invested into our employees of the county, invested into needed technology improvements, long-term general county capital and school capital improvements. I have used state/federal funding where possible, which saves local tax dollars. Blount County government is the benchmark for other county governments across the state."

WHAT MAKES YOU DIFFERENT FROM THE OTH-**ER CANDIDATES FOR OFFICE?** "My entire career has been in public service. I represent all the people. Tough decisions are required and sometimes aren't pleasing to everyone. I hope I've earned the trust of our citizens and that they know my decisions are with the best interests for all of Blount County. My family has been blessed by Blount County for 200 years. Every day I feel it's my responsibility to give back to the community that I treasure. I want future generations to have the same opportunities — safe community, great education, great job opportunities, and a great place to raise your family."

The county commission serves as the legislative body of county government. The county commission adopts an annual county budget, sets the county property tax rate, makes certain appointments, and adopts ordinances and resolutions. DISTRICT 1, SEAT A



SCHOOLS BOARDS NOW PARTISAN ELECTIONS

The Republican and Democratic parties in Blount County have called for a primary election for both county and city (Alcoa & Maryville) school board elections. The primary for county school board seats is on May 3, 2022. The primary for Alcoa & Maryville City school board seats is August 4, 2022. YOUR VOTE. YOUR LIFE. YOUR TIMES.

To vote or not to vote? The reasons people vote or abstain

s a political scientist, I see my role as answering — in the most rigorous way possible — questions that have been formulated as clearly as possible. One of the questions to which I have devoted the most time and effort in my nearly 50-year career is this: why do some people vote in elections and others don't?

It's the kind of question I love — a straight-forward one, about simple citizen behavior. It appeals to my populist side. I'm always curious to understand what motivates people around me to make the kind of small decisions that speak volumes about who they are and what they are passionate about.

Hundreds of factors affect the decision to vote or abstain from voting during an election and these vary from voter to voter. The researcher's goal is not to create an exhaustive inventory of all these factors. Rather, it is to systematically examine certain hypotheses about them.

A MORAL DUTY

In 2000, I wrote "To Vote or Not to Vote? The Merits and Limits of Rational Choice Theory." Rational choice theory, which was developed by economists, was popular in political science at the time and was being used to explain everything from the legislators' to voters' behavior.

In the case of voters, the theory was paradoxical. The "rational" voter realizes that in an election with millions of voters, the probability that his or her vote will change the outcome is infinitesimally small. In sum, the anticipated gain is minimal and most likely greater than the anticipated cost, i.e. the time spent deciding who to vote for and getting to the polls.

From this point of view, abstention seems to be the rational option. However, we see that most people do decide to vote, at least in national elections (the average turnout is now around 65 to 70 percent). The facts seem to contradict the theory.

So I spent a few years reading and re-reading the research on voter turnout and conducting new studies of all kinds. These were mostly surveys, which remain the preferred instrument for understanding individual behaviour, but I also analyzed election results, conducted semi-structured interviews and even did an experiment to see how students react when presented with rational choice theory.

My conclusion was that when it comes to understanding voting behavior, rational choice theory is not very useful. When deciding whether to vote or not, most people do not do a cost/benefit analysis. In fact, many people vote in an election primarily because they feel it is a moral duty to do so. Ethical considerations outweigh "rational" ones.

I would add, however, that some voters are sensitive to how much time it takes to vote, and that turnout is somewhat higher when the outcome of the election is uncertain. So rational consid-

erations do come into play somewhat. Rational choice theory should not be rejected entirely, even if its contribution is limited.

QUESTION OF MOTIVATION

More recently, I wrote with a former student of mine "The Motivation to Vote: Explaining Electoral Participation". The thesis is clear and simple: the decision to vote or not is above all a matter of motivation. If I am interested in politics, it is more or less self-evident that I will want to vote in an election. In the same perspective, if I am not interested in politics, the "normal" thing to do is ... nothing, i.e. not vote. Unless, of course, I believe that voting is not only a right but also a civic duty, in which case I would feel guilty for not voting.

In the book we show that interest in politics and a sense of duty are the two attitudes that most strongly correlate with the decision to vote or not. We then refer to research showing that these two attitudes are very stable and change little after the age of 20. Ultimately, values acquired early in life, one's taste (or not) for politics and one's conception of civic duties in a society are what most influence the decision to vote or not.

HABIT AND RESOURCES

Our work questions the validity of influential theories of voter turnout.

One of these theories is that people vote or abstain out of habit. We show that this explanation is not convincing. It is true that there is stability in behaviour about voting; a person who votes (or abstains) in one election is likely to do the same in the next.

But if it were a habit, one would expect to find that the values (such as interest in politics) that influence participation have a weaker impact on older people (who are more habitual and therefore less influenced by their values). The data show that this is not the case. The determinants of voting are basically the same for the young and the old. So the habit hypothesis is invalidated.

Our interpretation also casts doubt on another influential interpretation, that of resources. It is often argued that poorer and less educated people vote the least and that this is essentially because they have fewer political resources. While it is true that voter turnout is correlated with education and income, it should also be noted that this correlation is not very strong.

Moreover, it is far from clear that this is explained by a lack of resources, since the vast majority of citizens find it easy to vote. Resource theory is useful for explaining more demanding modes of participation, but it does not really apply to voting.

Some of my detractors will say that I take great pleasure in refuting popular explanations. There may be some truth to that. My motto is "Not Convinced," as my students kindly reminded me at a conference in my honour. But isn't the role of the researcher to subject both scientific theories and common sense to rigorous scrutiny, starting with healthy skepticism?

GET INVOLVED WITH THE PROCESS BY SERVING AS A POLL WORKER

SIGNING UP: Complete the poll worker application and mail, email, fax, or hand-deliver it to the Blount County Election Commission. In order to be appointed to work in a Primary election, poll workers must select which Political Party they represent. Independents will only be appointed in General elections.

APPOINTMENT: Poll Workers are appointed by the Election Commission no more than sixty (60) days prior to Election Day. An appointment letter is emailed to the


Poll Worker and a response is required. Poll Workers are compensated \$150 for Election Day.

TRAINING: Poll Workers attend one mandatory training. Training classes are conducted usually no more than thirty (30) days prior to Election Day and are held on a day and time set by the Election Commission.

POLLING PLACE ASSIGNMENTS: You must appear at your assigned polling place at approximately 7:15 a.m.

The Officer of Election dismisses the Poll Workers at the precinct after the polls close at 8 p.m. after all tasks are completed.

EVALUATIONS: An evaluation for each Poll Worker is completed by the Elections Officer at each polling place. Poll Workers who are not able to meet the standards for job performance, maintain non-partisan behavior, follow all election laws, or fulfill the duties properly and efficiently will not be appointed in future elections.
