



## Conspiracy to Murder Freeport City Councilman Jeff Pena Complaint

#### Narrative:

1. On 06-09-2025, I, Texas Ranger Aaron Arizmendi, was contacted by Texas Department of Public Safety (DPS) Criminal Investigations Division (CID) Special Agent James Sears and advised of an audio recording where the Freeport City Manager, Jerry Lance Petty (W/M, DOB: [REDACTED]) threatened to have Freeport City Council Member Jeffery Michael Pena (H/M, DOB: [REDACTED]) killed. I advised Special Agent Sears to contact DPS CID Special Agent Anthony Luna. Special Agent Luna was assigned to the DPS Threat to Life unit that covers Freeport.
2. On 06-10-2025, I, Texas Ranger Aaron Arizmendi, was contacted by Texas Ranger Joshua Benson and was advised that attorney Cordt Akers reported the same threat to Ranger Benson. I forwarded Special Agent Anthony Luna's contact to Ranger Benson to share with attorney Akers.
3. On 06-11-2025, I spoke with Special Agent Luna by phone. I learned that the recording was a conversation between the Freeport Police Department (FPD) Chief

Jennifer Howell and Freeport City Manager Lance Petty that was audio-recorded by Chief Howell without Petty's knowledge. Special Agent Luna advised me that he spoke with Pena on 06-10-2025, and Pena emailed Special Agent Luna the recording (Exhibit P1.1) and a transcript of the recording (Attachment A1.A). Special Agent Luna forwarded me the email (Attachment A1.B) and noted that Pena's name was not mentioned in the recording. I reviewed the transcript and observed numerous notes made by Pena and conclusory statements supporting an alleged conspiracy to murder Pena. Special Agent Luna advised that he did not see a law violation at that time, but was still looking into it and would contact Chief Howell.

4. I also learned that this recording was from a conversation on 11-18-2024. Sometime following, Petty tried to terminate Chief Howell, citing numerous allegations that resulted in an administrative investigation. The investigation resulted in the reinstatement of Chief Howell, the discovery of Petty's alleged threat, and the resulting termination of Petty by the City of Freeport City Council.
5. On 06-13-2025, Company "A" Texas Ranger Major Kip Westmoreland contacted me and advised me to look into the allegations further.
6. On 06-16-2025 at approximately 9:45 AM, I met with Freeport City Councilman Jeff Pena and his attorney, Chris Duncan, at the Brazoria County District Attorney conference room, 237 E. Locust, Angleton, Texas. Duncan provided me with a document on Duncan Law Firm letterhead addressed to Brazoria County District Attorney Tom Selleck and referenced a recorded statement made by Lance Petty (attachment A1.B). The document included, but was not limited to, the following allegations. "More than probable cause, there is no reasonable doubt that Lance Petty clearly confesses to the commission of crimes in these audiotapes."
7. Pena reported that this threat has caused him to be in fear for his life and that he wishes to have Petty arrested for all applicable charges.
8. Pena provided Petty's phone number as [REDACTED]. He also reported that Freeport Mayor Jerry Cain spoke with Petty regarding the threat. Pena reported Cain's phone number as [REDACTED]. Pena said Freeport Council Member Jarvis Davis found the recordings and may have spoken with Chief Howell. Pena reported Davis's phone number as [REDACTED]. Pena said that in the past, Petty encouraged Freeport Council Member George Matamoros to assault Pena. Pena gave the phone number 9 [REDACTED] for Matamoros. Pena also reported that former Freeport Mayor Brooks Bass was named in the recordings as telling Chief Howell that security was not wanted at the council meetings. Pena provided [REDACTED] for Bass.
9. Pena provided me with a transcript (attachment A1.C) of the alleged death threat that appeared to be the same as one previously emailed (attachment A1.A), except this one had more notes and conclusory statements. Pena also gave me a copy of the associated audio recording known as Exhibit P1.2.
10. Pena also provided me with another attachment, A1.D, consisting of a transcript of another recorded conversation between Chief Howell and Petty that contained notes and conclusory statements as well. This transcript relates to the audio recording Pena provided me, which will be known as Exhibit P1.3.

11. This document contained the alleged statement by Petty: "His Day is Coming anyway. Either the DA's getting him or I will fucking get 'em!" I believe the use of capitalization and punctuation in the transcription is prejudicial and/or dramatized to fit Pena's note regarding this statement, which was "assault reference or murder plot reference". Pena said in the interview that Petty encouraged Matamoros to assault Pena. I reviewed the recording and transcript. Petty referenced a conversation he had with Matamoros after the assault on Pena, not before; therefore, there was no encouragement. Petty claimed to have told Matamoros he couldn't believe Matamoros got up, walked all that way, and didn't do anything. Petty later says, "Oh, he should have fucking throttled him," which Pena claims to be Petty encouraging the assault against Pena, which could not be, considering it was after the incident.
12. Pena provided me with attachment A1.E, which consisted of a transcript of an audio-recorded conversation between Chief Howell and Petty that continued with alleged threats to assault Pena. Inserted in the transcript were conclusory statements that Petty's remarks constituted threats of assault. The transcript was from the audio recording provided by Pena, which will be known as Exhibit P1.4.
13. Attachment A1.F consisted of a transcript of an audio-recorded continuation of a conversation between Chief Howell and Petty, provided to me by Pena. Pena also gave me the associated audio-recorded conversation that will be known as Exhibit P1.5. It appeared that the exhibit was what Pena was referencing in the interview when he said that former Freeport Mayor Brooks Bass was named in the recordings as telling Chief Howell that security was not wanted at the council meetings as part of the conspiracy. I reviewed the recording, which appeared to be a separate conversation from the alleged threat. Petty said it was a bad look for the city and that Council Member Matamoros, Mayor Cain, and Bass were not thrilled with officers being at the meeting. I later learned from Chief Howell that this was a result of the behavior and threats between council members, including physical assaults. Chief Howell said that Petty was never a party to any of the assaults or threats in meetings that constituted her decision to add officers for security due to the meetings not being safe.
14. Pena reported that this threat was discovered due to an administrative investigation regarding Petty wrongly terminating Howell. Chief Howell was put on administrative leave pending the outcome of the investigation. Pena provided me with a digital copy of the investigative report from BRT Consulting, LLC (attachment A1.G). Pena said that Petty made multiple allegations against Chief Howell. Chief Howell turned over four audio recordings to BRT Consulting that she made of conversations with Petty that disputed the allegations. The recordings were included in the investigation by BRT Consulting, which was turned over to the city and provided to the city council. One of those recordings was alleged to capture Petty conspiring to murder Pena.
15. On 06-16-2025 at approximately 2:30 PM, I, Texas Ranger Aaron Arizmendi, met with Freeport Police Department (FPD) Chief Jennifer Howell at the Brazoria County District Attorney conference room. I learned the following from Chief Howell.
16. Chief Howell and Petty typically met at 10:00 AM on Thursdays for city business. Chief Howell heard from numerous people that Petty planned to get rid of her. Whenever she didn't do something he wanted, she would hear that he wanted to fire her.

Freeport Fire Chief told Chief Howell that Lauri, the public works secretary, heard at a meeting with Petty that he was getting rid of Chief Howell.

17. Chief Howell believed Petty was angry and venting when he spoke of the alleged threats to Freeport City Councilman Jeff Pena on 11-18-2024. Petty "shot off at the mouth" all the time in day-to-day operations, according to Chief Howell. Chief Howell did not think Petty would ever commit a murder. He talked about whipping someone's "ass" weekly. Petty was proper around Pena but talked threateningly behind his back.
18. Chief Howell turned over part of four audio recordings between her and Petty because they directly related to Petty's complaints against her that were being investigated by BRT Consulting. Chief Howell said the recordings proved the allegations against her were false.
19. Chief Howell told me that if she had thought there was a viable threat to Councilman Pena, she would have acted on it in November after the conversation.
20. On 06-23-2025, Howell gave me a digital copy of 24 audio-recorded conversations between Howell and Petty. I placed the recordings in the digital storage for this investigation. The 24 recordings will be referred to as Exhibit P1.6. Chief Howell also provided a copy of rough draft transcripts of the 24 recordings (attachment A1.H)
21. On 06-23-2025, I called Lance Petty to schedule an interview. Petty said he would prefer to speak to me over the phone then. I learned the following from Petty.
22. Pena went to Petty's office and told him he was unhappy with Petty. Look at how long Tim Kelty (former city manager) took to find a job and sell his house, and the strain on his family. Pena told Petty he should resign because Pena would come after him in any way possible. Petty listed several people Pena had gone after, and Pena told Kelty that once he got rid of Petty, all of Kelty's people would be gone.
23. Petty had a buddy who was pissed off and wanted to come down and beat Pena up. Petty reported that the man he referred to in the recording was his friend from high school, Ricky Morgan. Morgan would fight anybody he could fight. They called him "goon" cause he acted like a goon. Morgan called Petty and asked if he needed to drive down there and beat Pena up. Petty told Morgan to shut up; they aren't in high school anymore. Morgan was deceased before 11-18-2024, when the recorded conversation happened. Petty was referring to a conversation with Morgan in which Morgan narrated the scenario to Petty. Morgan told Petty he would drive down, wear his Domino's Pizza shirt, carry an empty pizza box, and knock Pena out. Petty told him no. In the recording, when Petty talked about someone being "dead", he was referring to his friend, Morgan, who was dead. He was not referring to Pena in any way.
24. Petty said he had only been in one physical altercation in his life, and that was in high school. He said he was just pissed off and vented to his assistant city manager, Chief Howell.
25. Morgan followed Petty and the City of Freeport on social media. Something he read made him angry regarding Pena, so he called Petty. Petty at no time solicited Morgan or anyone to assault Pena. Petty sent me a screenshot from Biggers Funeral Home

with a photo of a white male wearing a cowboy hat next to a young female child. The photo had the name Richard "Ricky" C. Morgan Jr. and the dates 07-31-1971 to 12-09-2023. I found the web page for Morgan on the Biggers Funeral Home website. The obituary indicated Morgan resided in Fort Worth, Texas.

26. Petty said Pena filed charges against City Councilman Matamoras, and the charges went away. Pena claimed Matamoras touched him. Pena also filed charges against former Mayor Brooks Bass, and they went away. It's a continuous thing with Pena, according to Petty.
27. On 06-24-2025, Petty's attorney, Clay Thomas, emailed me three audio/ video recordings labeled "PenaThreatAmanda.mov", "Pena Video1.mov", and "Pena Video2.mov". I saved the videos to the digital storage for this investigation in a folder that will be considered Exhibit P1.7.
28. I reviewed the audio/video recording Pena Video1. The initial conversation sounded like Pena speaking with an unknown female. Based on the context of the conversation, she may have been the city's CFO. Petty then briefly entered the conversation regarding contracts before it ended. Petty and Pena were cordial in the recording.
29. I then reviewed the audio/video recording Pena Video2 that appeared to be recorded by Petty and started before Petty entered the conversation in Pena Video1. Pena and Petty appeared to go into a room alone. Pena told Petty that he wanted a change in the city hall because he had lost all confidence in the city hall and in Petty. Pena accused former city manager Tim Kelty of losing \$345,000, and Petty of losing more than that, which Petty denied. Pena stated that as a result, Kelty never resigned and had a harder time finding a job and selling his house. Petty said he would not be resigning. Pena said he would ask for Petty's resignation at the right time. Pena appeared to be intimidating Petty into resigning. If it was warranted, it should be immediate, but based on Pena's saying at the right time, it seemed to be part of an alternative motive. Pena said he would be bringing additional information forward that he had but would not share with Petty, claiming it's not going to be fun, and that Pena took no pleasure in this, but he just wanted to share that with Petty. Pena did not share any specific concerns with Petty; therefore, it appeared to be intimidation tactics.
30. Pena then said that Kelty was always professional when dealing with Pena, in council meetings and through emails. He told Petty he had always done the same and hoped to continue working together. Petty agreed but said he did not like the videos that Pena was putting out. Pena said they were necessary to let people know what was going on in city hall.
31. The conversation appeared to be sometime after the 11-18-2024 recording of the alleged conspiracy and/or threats of assault. Petty told Pena it was unprofessional for Pena to go to the Chief and tell her to get ready because I'm going to come down hard on Lance (Petty), so you can take over. Pena said it was professional. Pena again stated that he had other stuff that won't look good, but he does not state what that was. Pena told Petty to do the right thing and resign, but he would leave that to Petty. Pena said he would make sure the public had all the information he had.

32. Petty accuses Pena of going into executive session with the city council and then coming out and posting it on social media. Pena says it is his editorial line, that he has a right to his opinion, and that he presents facts from the meetings.
33. On 06-18-2025, I received Petty's city-issued cell phone, described as a Samsung SM-S921U with serial number RFCX71VLEMZ in a black case, from Chief Howell, who was also acting city manager. Chief Howell also gave me Petty's tablet, a Samsung SM-T227U with serial number R9PW407DYWB, in a black case. See attached Evidence Receipt (attachment A1.I). On 06-23-2025, Howell signed a Consent to Search on behalf of the city of Freeport (attachment A.I). I secured the phone and tablet in my office until 06-24-2025, when I submitted them to the Brazoria County Sheriff's Office digital forensic lab for extraction. See attached BCSO lab submission form and digital forensics lab request form (attachment A1.J). Investigator Kent Nielson advised me that he could not do an extraction due to security software placed on the phone by Freeport. As a result, on 07-16-2025, I picked up the phone. See attached BCSO evidence submission form for chain of custody (attachment A.K). I conducted a manual search of the phone. There was very little on the phone, as if Petty did not use it much. I did not locate anything that could be associated with this investigation. The phone was secured at my office pending its return to the city of Freeport.
34. Chief Howell provided me with the entire, un-edited recording between Chief Howell and Petty from 11-18-2024 that was included in Exhibit P1.6. I listened to the recording and completed a transcription of the conversation (attachment A1.L).
35. On 09-09-2025, at approximately 11:00 AM, I interviewed Freeport City Mayor Jerry Cain at my office, 237 E. Locust, Angleton, Texas. Cain had been the Mayor since May 2024 and had been on the city council for five years before that.
36. Cain and Petty have a working relationship. Cain has had minimal interaction with Petty outside of work. Cain said that whenever Petty would say something about going after Pena, Cain took it as going after Pena through the court of law, never physically.
37. Pena puts a lot of pressure on people until they slip up and do something like Petty did, and then Pena runs with it. Petty never said anything to Cain to lead Cain to believe that Petty would ever cause physical harm to Pena.
38. Cain has faith that Chief Howell knows her job. Cain asked Howell directly if she felt Petty's statements on the recordings were a threat, and Howell said, "Absolutely not". Cain has had limited interactions or conversations with Petty since his termination, during which Petty did not make threats against Pena.
39. Cain has never seen Petty act out with physical violence, nor has Cain ever known of him assaulting anyone. Pena posts information from council meetings and executive sessions on Pena's personal social media accounts; none of it is authorized by the city or on authorized city social media accounts.
40. In conclusion, it had been approximately seven months since the recording was made (11-18-2024), and we received this complaint (06-09-2025), indicating no immediate urgency or immediacy to this alleged threat or conspiracy. During this time, Petty was

also terminated and has not taken any known acts towards assaulting Pena. Even with Petty's termination of Chief Howell, Chief Howell still stated that she did not think Petty committed any viable threat or criminal law violation. During my interview with Pena, he said that he was confident in Chief Howell's leadership in all aspects and supported her reinstatement to Chief, which led me to believe Pena believed Chief Howell would make the right decision in the absence of action taken in a crime as serious as conspiracy to commit murder.

41. Petty made these statements privately, not expecting them to become public or even disclosed to Pena. He did not place them on social media or state them amongst a crowd. This showed the statements were not made to solicit a response by law enforcement and would not have been known to exist if not made public by the city council after an administrative investigation into the termination of Chief Howell.
42. Allegation against Petty in the document requesting an investigation from Duncan Law Firm (attachment A1.B) was that Petty committed criminal solicitation to commit aggravated kidnapping when Petty solicited and entered an agreement with his Fort Worth friend (Ricky Morgan). Petty did not say that he solicited his friend and told me that his friend (Morgan) called him angry and gave the scenario to assault Pena, as noted earlier.
43. Texas Penal Code Section 15.03, CRIMINAL SOLICITATION, states that (a) A person commits an offense if, with intent that a capital felony or felony of the first degree be committed, he requests, commands, or attempts to induce another to engage in specific conduct that, under the circumstances surrounding his conduct as the actor believed them to be, would constitute the felony or make the other a party to its commission.
44. It goes on to say that a person may not be convicted under this section on the uncorroborated testimony of the person allegedly solicited, and unless the solicitation is made under circumstances strongly corroborative of both the solicitation itself and the actor's intent that the other person act on the solicitation.
45. I could not corroborate that Petty ever solicited Morgan to commit any crime, and Petty did not state in the recording that he solicited Morgan. Pena assumed that the statement indicated Petty solicited Morgan. It also could not be corroborated that Petty intended Morgan to act on the supposed crime. I did not find evidence that Petty actually requested Morgan or any other person to kidnap Pena or had any intent for someone to carry out the kidnapping as required by law.
46. In count 2 in attachment A1.B, Pena and his attorney alleged Petty committed criminal solicitation to commit aggravated kidnapping when he asked Chief Howell to turn off the cameras. Petty's statement in the recording was that Garivey (former police chief) would have turned the cameras off for him. Again, his buddy had already deceased, no agreement can be found or proven, and he did not ask Chief Howell to turn off the cameras, but pointed out what he believed the former Chief would have done if requested.
47. The complaint (attachment A1.B) continues with counts three, four, and five being criminal solicitation to commit murder. Again, for the same reasons previously detailed, Petty's statements do not constitute solicitation. Furthermore, if Morgan,

Chief Howell and former Chief Garivey stated that were solicited, it would still not be enough due to the statute stating that, a person may not be convicted under this section on the uncorroborated testimony of the person allegedly solicited and unless the solicitation is made under circumstances strongly corroborative of both the solicitation itself and the actor's intent that the other person act on the solicitation.

48. Count seven of attachment A1.B alleged that Petty conspired to commit multiple crimes against Pena, including kidnapping and murder. Petty's private recorded conversation without any corroboration of the facts is insufficient to support charges against Petty.
49. Petty's conversation of concern referred to a Fort Worth friend. Petty stated in the recording that his buddy "would have". In the interview, Petty said his buddy called him and was referring to assaulting Pena, not killing him. Petty told his buddy no. Petty's buddy died in 2023, before Chief Howell recorded the conversation, and no proof could be found that there was ever an agreement. Petty's statement in the recording is insufficient to stand alone as a conspiracy to commit a crime. Furthermore, Petty clarifies in his interview that he did not conspire to commit a crime against Pena or intend to harm Pena, which cannot be disputed.
50. In attachment A1.C, Pena has in his transcription, "Fucking buddy told me he would. He (Pena)(woulda) fucking died". The audio is, "He fucking died". Petty was referring to his buddy's death. Petty confirmed this in his interview and provided the obituary for his buddy, Ricky Morgan.
51. Petty said a buddy told him, but Petty did not solicit him. His statement, "I should have had it done," indicates he did not agree to it. Furthermore, He acknowledges his buddy had already died, so there could not have been an agreement in place at the time of the statement.
52. The complaint (attachment A1.B) alleged in count seven that Petty committed obstruction or retaliation, violating Texas Penal Code 36.06. Again, Petty failed to meet the culpability requirements of "intentionally or knowingly" harm or threaten to harm another by an unlawful act in retaliation for or on account of the service or status of another (Pena). Petty had the conversation in private with no intention for Pena to be aware of the conversation, which indicates Petty had no intention for Pena to feel threatened, which would be required to complete the offense of retaliation or obstruction. Even if you considered Petty's comments reckless, that is not one of the culpable mental states of the statute.
53. In attachment A1.B, count eight, nine, ten, eleven, and twelve allege Petty committed a terroristic threat, PC 22.07. Statements made by Petty were in a private conversation with no intent for anyone else, including Pena, to hear. If Chief Howell had not recorded it and the administrative investigation had not been conducted, the conversation would not have been known, which negates all of the subsections of the terroristic threats statute.
54. The allegations of terroristic threat cite the following statement Petty made to Chief Howell: "I told Jerry last night when he came over for a while. I said, Look, I'm gonna tell you one motherfucking time, you better control that motherfucker. I said, cause I ain't lots of these people around here when I get up to go, I'm going to get him". On



09-09-2025, I interviewed Freeport Mayor Jerry Cain. Cain did not recall Petty making the above statement to Cain. Cain did not recall Petty threatening violence to cause a reaction from Cain.

55. Petty's conversation could be viewed as unprofessional, inappropriate, and concerning. However, I could not find proof of a criminal violation.
56. It appears that there is a division within the Freeport City Government. One side consists of Petty, Councilman Matamoros, Former Mayor Bass, and current Mayor Cain, while the opposing side consists of Council Members Pena and Jarvis Davis. Their difference in direction for the city results in some of them failing to control their emotions, and in one instance, physical control over themselves.
57. On 09-17-2025, I picked up the Samsung SM-T227U tablet with serial number R9PW407DYWB from the BCSO digital forensic lab. See attached Brazoria County Sheriff's Office Non-Narcotic Submission Form (attachment A1.L). BCSO Forensic Investigator Nielson also provided me with a copy of the tablet extraction files that I placed in the digital file for this investigation (Exhibit P1.8). I reviewed the download, and there was very little data on the tablet, as if Petty did not use it much. I did not locate anything that could be associated with this investigation.
58. On 09-17-2025 at approximately 12:25 PM, I returned Petty's previously issued Samsung cell phone and tablet to Donna Fisher with the City of Freeport. See the attached evidence receipt (attachment A1.M).
59. On 09-18-2025, I presented this investigation to the Brazoria County Grand Jury. The Grand Jury returned a decision of no action. This concludes this investigation.
