

Jensen Memorial Library in Minden will hold its annual Used Book Sale June 5-7.



# Looking Back: My Life-Changing Year as an Exchange Student in Minden, Nebraska

Over four decades ago, I had the life-changing opportunity to spend a year in Minden, Nebraska, as a Rotary Exchange Student hosted by the Minden Rotary Club. It was 1983, and I was just a teenager from Mexico, full of curiosity and a desire to explore the world beyond my borders. What I didn't know at the time was how profoundly that year would shape my life.

During my stay, I was welcomed with open arms by two incredible families: the Becks and the Roberts. Their warmth, generosity, and patience made me feel at home from the very beginning. They weren't just host families—they became lifelong friends and role models. Through them, I experienced firsthand the values of kindness, community, and hard work that define so much of American culture.

Living in Minden introduced me to a different way of life. I went to high school and participated in classes and extracurricular activities that were completely new to me. I learned how the American education system worked and admired how much emphasis was placed on creativity, independence, and participation. These experiences helped broaden my perspective and planted the seeds for my personal and professional growth.

Perhaps one of the most transformative parts of that year was working on the farm. Coming from a city background, farm work was entirely unfamiliar—and challenging. But as I helped with chores, fed animals, and rose early to start the day, I began to understand the true meaning of discipline and responsibility. That phys-

ical labor, combined with the steady rhythm of rural life, was humbling and grounding. It gave me resilience, and it opened my heart to the value of honest, hard work.

Just as important was learning English. At the beginning, I could hardly hold a conversation. But little by little, through everyday experiences and with the patient support of my host families and classmates, I improved. English became more than a second language—it became an essential tool for my future. Today, it plays a key role in my work and allows me to connect with people from around the world.

And just this past April 10, 2025, I had the great joy of returning to Minden. After 41 years, I was reunited with my American families. The visit was incredibly emotional and joyful—filled with laughter, warm hugs, and memories that came flooding back as if no time had passed. Walking the streets of Minden again, seeing familiar faces, and feeling the same welcoming spirit reminded me of how much that year meant to me. It was a beautiful homecoming that reaffirmed the lifelong bonds formed through cultural exchange.



# **Cats and Falcons Give Their All at State Track**

A year after a co-state track and field championship, Axtell's boys again performed very well at Omaha Burke at the State Meet on May 23-24. But the 2025 Wildcats had to settle for being the Class D runners-up to Dundy County-Stratton. Axtell scored 62 points to trail DC-S's 87. Ironically, the Cats' points were six more than they scored last year in sharing the top team spot with McCool Junction, but DC-S was just too strong. Second place at state is an exemplary accomplishment and this is the third straight top two finish for Axtell as the 2023 team was a tri-runner up.

The top six team scores: DC-S 87, Axtell 62, Nebraska Christian 34, Riverside 30, Amherst 27, Medicine Valley 25.5. Wilcox-Hildreth scored two points thanks to senior Graiden Ritner's seventh place finish in the 100 meters.

The Cats' medal haul included two golds, three silvers and three bronzes. Senior Luc Lopez repeated as the 'D' 800 meter champ and senior Jake Halvorsen earned gold in the 110 hurdles.

Placing second were Lopez (400 meters), junior Cayson Havranek (long jump), and the 1600 relay with Havranek, Halvorsen, senior Brandt Modlin and Lopez. Only a meet and class record by Central Valley (Greeley, North Loup-Scotia) bettered the Cats' time and place in the 1600 relay.

The third place medalists were Modlin (high jump), Halvorsen (300 hurdles) and the 400 relay with senior Elijah Bergstrom, Halvorsen, Modlin and Havranek.

Three Axtell school records were set at the meet. Lopez's 1:58.28 800 bettered Matt Huffman's 1:58.83 from 2004; The 1600 relay crew's 3:28.73 surpassed the 3:29.7 set by Eric Gustafson, Warren Carmoney, Eric Hinze and Huffman in 2005; and the 400 relay foursome's 43.79 went lower than the 43.8 time run by Drew Sayer, Dustin Schuster, Andrew Olson and Jared Jacobs in 2002.

As previously mentioned, W-H's Ritner scored for the Falcons in the 100 (7th) for his first state medal, concluding a fine multisport athletic career for him.

Other Wil-Hil state competitors were junior Thomas Donley in the pole vault and 400 and senior Grant Henery in the 1600.

Senior Fletcher Clausen in the 3200 was an additional Axtell state meet athlete.

Camryn had been the 'D' high jump leader for most of the season after a school-record jump of 5'4 1/4 in an earlier meet. She actually tied for the top cleared height at State but a Palmer girl got the gold in a tie-breaker over Camryn. Both went over the bar at 5'3.

One other competitor for the Falcon girls was senior Katelyn Bunger in the 100 hurdles.

Competing for the Axtell girls was junior Emily Danburg in the triple jump.





After two innings, Minden had already taken a 6-0 lead. The team did not let their foot off of the gas and added another four runs in the fourth inning to solidify their first victory of the season. LF Kade Dorszynski and SS Beau Bonifas each finished the contest with multiple hits and one RBI.

2B Cade Harsin proved to be a difficult outing for Wood River once got on base as the second baseman finished with three stolen bases. Dorszynski also contributed two stolen bases as Minden racked up eight total.

P Logan Clark earned the victory on the mound for the seniors after two innings that did not see a single hit recorded for Wood River. Clark ended the evening with four strikeouts and three walks. P Jose Cuellar earned his first victory of the season after four strong innings bolstered by eight strikeouts. Cuellar allowed one hit, no runs and three walks. Harsin got the relief call for the final three innings of the ballgame to secure a save. He struck out four while allowing four hits, one run (1 ER) and one walk.

Closing out the weekend, First Bank saved their biggest fireworks for Ogallala as the offense exploded for 19 total runs. Ogallala took a two run lead in the first but that was short lived as Minden powered 12 runs onto the scoreboard. Another seven runs in the third inning was enough for the mercy rule to come into play as First Bank earned their third victory by a score of 19-2.





# **Kearney County Extension News**

Have you heard of the "butterfly effect"? It is an idea from chaos theory that suggests that a tiny change can lead to large consequences. For example, a butterfly's wing beats cause a hurricane on the other side of the world. That is quite unlikely and probably impossible, but it gives you the idea.

Is there a butterfly effect in community development? I believe that there is and I can give you an example. This is a real-life example but I am keeping the participants in the story anonymous. Ten to fifteen years ago a woman and her husband received a \$50,000 loan to purchase some screen printing and embroidery equipment. It was just to be a side job and make some extra funds. There was no large press release, in reality I'm not even sure if the local economic development organization even knew this small business purchase took place. Over the years the owners of this business have reinvested in their community and have really made a difference.

After successfully starting and expanding the screen-printing business they obtained a bicycle shop. They moved locations and bought a building. They improved the empty lot next to their building. One owner joined the downtown association and eventually became president. The downtown association worked to improve the downtown and through both local government and local business owner investment have remodeled and reinvigorated the downtown area.

Eventually these business owners who started with a \$50,000 investment now own 5 downtown businesses and a handful of buildings including a strip mall worth over \$9 million. They have over 70 employees in the businesses. Imagine someone like that coming into your community. Many communities would fall all over themselves for a multimillion-dollar investment with 70 employees, but this happened with a little \$50,000 loan and no fanfare.

So what's the point? The point is that we never know what investment or what business owner is going to be the catalyst for huge change in our communities. Each time someone wants to invest in even a small business, help them to assess the risk, learn about their industry and encourage them to take the chance if possibilities exist.

I have seen communities where the banks and the local economic development people do not support small businesses. Getting a startup business in those communities is nearly impossible. Those communities rarely grow, and if a business does start up in them, they have no loyalty to the community because they didn't receive any support or encouragement. I have also seen communities where entrepreneurs are supported and encouraged. Small business startups abound, and they are loyal to the community when expansion opportunities come. Most communities fall somewhere in between where sometimes entrepreneurs are supported and sometimes, they are not.

It is important for communities to support small businesses whether they are small or large. Support can be shown in many ways. Maybe it is through providing space, financial backing through loans or grants, financial support through shopping at the business, or simply through encouragement of the business owner. Any of these things can be what an entrepreneur needs. You never know when that coffee shop...or screen-printing shop is the catalyst for a multimillion-dollar busi-

ness and the revitalization of your entire downtown. The community development butterfly effect may already be starting in your community. Show your support to those small business owners, you never know where they will be in 10 years.

Linda was born on September 14, 1955 in Newman Grove, NE to Dale and Cora Larson and graduated from Newman Grove High School in 1973. After several moves and career





# Minden High School Honor Roll 2024-25 Spring Semester




