

## New Directors, Same Sense of Community

Libraries are a vital resource in any town not only for the access to books and information, but as a place to come together and build community. Connections and community are the top priority for new Hildreth Public Library Director Amber Harms and Axtell Public Library Director Tara Schneider.

Harms left her home in South Dakota and eventually settled in Hildreth with her husband and two young daughters. Although she doesn't have previous experience working in a library, she has experience with the written word that gives her a unique perspective on libraries.

"They kind of took a leap of faith when they hired me," Harms said. "I enjoy reading books and I've written a few so I understand books to a certain extent which I think is cool when you go into a library. Also I have kids and a library is for kids. So I'm leaning on my experience as a mom and my experience as an author and as a reader."

Before taking on the role as library director, Harms worked as a para at Wilcox-Hildreth Public Schools. That position served as a good entry into the community, but her new career promises to grow on that foundation.

"I just really like books. The idea of a library seems almost magical," Harms said. "So the love for reading is what made me apply, but I also just wanted to do something more. Not that being a para isn't enough, but I just felt like I was better suited for something more professionally."

She got started in her new role in early December. Retired library director Vicky Casper has been on hand to help guide Harms through the administrative side of the position and answer any questions as she gets settled.

"She is a Godsend. What I didn't realize was as the director for this library specifically, I'm everything top to bottom. CEO, secretary, all of it. So Vicky is so, so, so good to me and the community wanting to make sure it goes smoothly and in the right way," Harms said.

# Hastings College to Feature Two World Premieres, 119 High School Students at Annual Honor Festival

(Hastings, Nebraska) – Hastings College will hold its 62nd Annual Honor Band and 54th Annual Honor Choir concert on Monday, January 19, at 5:30 p.m. at First Presbyterian Church in Hastings (621 N Lincoln Avenue). The concert is free and open to the public, and will be live-streamed on the Hastings College YouTube channel.

The Hastings College Honor Band and Choir (HHBC) festival is the longest-running high school music honor ensembles sponsored by a college in Nebraska and features some of the best high school musical talent

throughout the region. This year, 119 students were selected from Nebraska — with 68 selected to be part of the choir and 51 selected for band.

Student check-in for both ensembles is Sunday, January 18, with rehearsals happening until later on Monday when the groups move to the church to prepare for the concert.

The honor band is directed by Dr. Drew Dickey, director of athletic bands and assistant director of bands at the Texas Christian University School of Music. The choir is directed by Dr. Raoul Carlo (Miggi) F. Angangco, assistant professor of music and director of choral activities at Hastings College.

Among other works, the Honor Choir will be premiering pieces by two Hastings College graduates: "Alebrijes" by Hugo Madera '19, and "I Know..." by Hannah Jensen '15. Madera is a composer, conductor, educator and clinician, and director of the choral ensembles at Adams Central High School. Jensen-Heitmann is a composer, performer and educator, and executive director of the Hastings Community Music Academy.

While a fondness for books played a large part in prompting her to apply, the community involvement piece is what she looks forward to the most.

"I get overwhelmed as a mom so having somewhere for my kids to go has always been something that is really important, especially in a small community where there's not a lot to offer for activities and for kids and for families. So I'm really excited to really build on what Vicky's already done and continue to grow a place where families can send their kids or come with their kids or come without their kids or be whatever they need," Harms explained.

As she works to master all the duties of her position, Harms plans to maintain the activities and events established by her predecessor. She invites everyone to come in and find a book to read and participate in the programs they have come to expect. In the future she hopes to introduce a low maintenance book club for busy adults who don't have time to read a specific book each month as a way to connect. She would also like to begin some intergenerational programs as well.

"I have plans of getting little kids involved with some people in the older generations to build connections with them. Really just pull everyone together and create this really big sense of community that they've already created in Hildreth and build off of that," Harms said.

Sheila Carmoney retired as the Axtell Public Library Director last summer. Schneider filled the vacancy in August excited to find a local job that allows her to plan and lead fun activities for kids.

"I love interacting with all the kids and planning the events. The kids coming in for Bingo just absolutely makes my day," Schneider said. "I love interacting with the community as they come in and seeing everybody."

With no prior experience, Schneider still picked up quickly on what her duties entailed with some guidance from Carmoney. She has kept a full calendar of programs ready and rolling every month taking extra care to ensure the library is ready to host the youth of Axtell any time school is not in session.

"I have two kids myself so they come in and have something to do after school. I love doing all the events with the kids and seeing how much they love coming to the library. We went from having six kids come into Bingo to almost 30 the other day," Schneider said.

Keeping a full roster of programs has made the library a hub of activity and the place to be for residents of all ages.





# MPS Says a Sad Farewell to Four Instructors, Hires One New

After approving the excused absence of Justin Glanzer, the Minden Public Schools Board of Education dove right into start of the year business at the January 12 regular meeting.

No changes were made to board operations as Rusty Rhynalds, Glanzer, and Kevin Raun were reelected as Board President, Vice President, and Secretary respectively. The board upheld tradition approving Scott Johnson as district treasurer, Perry Law Firm and KSB as district legal counsel, Minden Exchange Bank and First Bank as depository banks for the district, Minden Courier as the district newspaper, and the current board policies and regulations.

Board committees will be appointed by Superintendent Jim Widdifield and conflict of interest forms were distributed to the board to complete and return. With these actions complete, the board got down to regular business starting with the consent agenda.

Widdifield reported the district is in good shape with expenditures to revenue. Most of the larger expenses for the month relate to heating and cooling, but the budget was built to accommodate maintenance of the aging equipment. A brief discussion was held among the board regarding payment to the school resource officer as the district is responsible for a majority of his salary, but the salary is set by the City of Minden. With a better understanding of the SRO agreement, the board approved the consent agenda including minutes from

the December 8 meeting, financial reports, and expenditures and claims for payment.

C.L. Jones Middle School Principal Nathan Strasburg added to his report to the board by expressing thanks to the three teachers retiring from CLJMS for their years of service and noting they are leaving some big shoes to fill. East Elementary Principal Sandy Pohl brought Media Specialist Kim Olson to the meeting to highlight all the great things happening in the East Elementary library.

The board reviewed the first reading of amendments to Policy 3131 Procurement Plan and Policy 3132 Internal Controls. The amendments reflect changes in the dollar amounts set in the policies to reflect updates as set by law.

Cody Krull shared with the rest of the board that MEA negotiations went well. There was quite a bit of back and forth, but an agreement was reached that satisfied both parties. The biggest change is in sick days and PTO. Additionally, the agreement removed several extra duties that are obsolete while giving administration the authority to add duties and extra curricular assignments as needed. Likewise, additional positions like junior high FFA advisor were added. Minden is number one for teacher base salary in its array of schools.

Raun noted the cost of insurance went up again this year and that is reflected in the overall package. He said the give and take from the negotiations committee and the teachers is good and the process is very smooth. The

board approved the 2026-27 agreement with the Minden Education Association for a 4.02% total package increase and a base salary of \$41,950.00.

High School Principal Don Hosick requested the board approve Rachel Tagtmeyer as the high school Language Arts teacher for the 2026-27 school year. Tagtmeyer has been teaching in Holdrege, but lives in Minden. Hosick noted they had three great interviews to fill the position, and believes Tagtmeyer will do a fantastic job. The board approved the new certified staff contract with Tagtmeyer for the 2026-27 school year.

Four resignation letters were presented to the board for consideration. Bob Carlson, Barb Jacobsen, Michelle tenBensel, and Colleen Thatcher each submitted letters of resignation effective at the end of the 2025-26 school year. The instructors have more than 130 combined years of service to MPS. The board approved with regret all four resignations.


The Minden Public Schools Foundation has made great strides in the past several years to become the resource it was meant to be for the district. With this in mind, the board approved the transfer of Kendall Peterson Scholarship funds to the Foundation in accordance with IRS regulations and guidance. This won't change the scholarship, but only moves the funds from the Activities Fund to the Foundation to be managed by the 501c3 organization.

A master services agreement with ESU# 11 for the 2026-27 school year was approved. This action is taken annually. The agreement with ESU #11 provides a number of benefits to the district including collaboration, efficiency in buying power, services, and support.

Winding down the meeting, the board approved CMBA as architect for the facilities project including a new PK-3 elementary school facility and renovations to the existing high school and middle school. The agreement locks in the rates agreed on during the 2021-22 school year for the duration of the project. The district's legal counsel has advised this agreement is good for the district.

The final piece of business for the meeting was approval of a resolution to authorize financing of the voter-approved facilities projects. The documents approved by the board are tied to the lease agreement planned for the project that allows the district the flexibility of running the project through the Special Building Fund.

With business concluded, the board meeting was adjourned. The next regular school board meeting will be held on Monday, February 9 at 7 p.m. in the Minden High School Media Center.

## Kearney County Extension News

It's January again. Did your community improve over the last year? Did it stay the same? Did it decline? Motivational speakers like to announce that if you aren't getting better, then you're getting worse.

What steps forward has your community taken this past year? What steps have you personally taken to make your community better this year? Did you meet a new neighbor? Did you help others clean up after a storm? Did you volunteer with a group or for an activity? Did you just drive into your garage and shut the door and take the trash out on trash day?

Being an active participant in your community makes it better for everyone. Long time volunteers get a rest when new people come in to help. Participating in the local economy by shopping in your community helps to keep stores open and helps store owners to make a living. Big box stores like Walmart don't care if you spend \$50 more each month, but your neighborhood grocery store would notice.

So how does a community get more people involved? One possible solution is RPN's ECAP program. We do a community survey, on paper and online so everyone can participate. Then we do a series of community meetings, starting with a meeting to set priorities based on the survey results. The following meetings give people a framework and time to work together on the priority issues that are meaningful to them. Perhaps it is childcare, broadband, or the park system. These meetings continue and give the community a starting point to move into the future. Each of these meetings are facilitated by RPN Educators.

Another similar program is Marketing Hometown America. This is a program where RPN trains the community to do the program themselves. There is no survey, it is just the participants in the meetings choosing their project and objectives. This program helps build the leadership capacity in the community.

because of the training provided for the team leaders. RPN will train the leaders and provide them with materials to lead the project locally.

If your community is looking for a catalyst like these but can't commit to several months of meetings, give your local RPN educator a call and see if they can come do a presentation at a community gathering to get started. You might be surprised about what can come from a simple one-hour chat. Sometimes these simple presentations are all that is needed to spark a community change. Other times, the larger programs are needed to build buy in and involvement in the community.

As we begin this new year, it's time to start thinking about the future. Did you know that this year is the 250th anniversary of the Declaration of Independence, sometimes referred to as the U.S. Semiquincentennial. Is your community planning a giant celebration? Are there time capsules that need opened...or buried? RPN could even facilitate a meeting to plan the celebration. Facilitated meetings are a way to let every voice be heard without one person or group of people controlling the conversation.

If any of these ideas have struck you as something that your community needs, take the first step. Tell someone about your idea. Get a group together and start moving forward. Call a local RPN Educator. If your community isn't getting better....is it getting worse? Very rarely do things stay the same. People come, people go, and change is always knocking at the door. Will that change be good or bad? That is up to you. Encouraging more people to get involved and share ideas may help you find a new direction for your community and be a good roadmap for the future.


