This year's participating nonprofits include:


### Christmas Abendmusik Dec. 7

**Minden Schools Foundation:** The Minden Schools Foundation enriches student learning by funding educational opportunities, supporting teachers, and advancing initiatives that strengthen the future of Minden Public Schools. The Minden Schools Foundation is a nonprofit organization committed to expanding opportunities for every student in the Minden Public Schools system. Guided by a dedicated volunteer board, the Foundation strengthens academics, supports teachers, and helps ensure students are prepared for bright futures. Current initiatives include developing a year-round

FFA greenhouse to enhance hands-on agribusiness education, providing classroom grants that allow teachers to bring innovative ideas to life, and raising funds to hire a program director who will expand community engagement and grow the Foundation's long-term impact. Through generous donor support, MSF continues to create transformative opportunities that empower students and enrich the entire Minden community.

**Minden Senior Center:** Every weekday, the Center serves healthy, nutritious meals to local seniors, nearly 8,000 meals last year alone. With a suggested donation of \$5 for dine-in and \$5.50 for to-go, they make sure everyone 60+ can enjoy a warm, balanced lunch. (And younger guests are welcome too!) But the Center is so much more than lunch. It's a gathering place filled with books, puzzles, games, social activities, and wellness tools... plus space for community events and the home base for RYDE Transit. This incredible resource relies on grants, community support, and donations, but still needs to raise \$20,000 each year to keep operations going strong.

**Paws Up Kearney County**: Founded in March 2024, this volunteer-driven group is already making a huge impact by providing food, vet care, spay/neuter services and rehoming support for lost, abandoned and relinquished animals right here in our community. They're also working to reduce feral cat populations and improve conditions at "Doggie Jail." But their biggest dream? Building Minden's first humane animal shelter. A place with indoor/outdoor space for pets, areas for recovery and quarantine, and even future plans for daycare and boarding to help sustain the shelter long-term. Purchasing and remodeling a building would cost around \$350–\$400k, while building from scratch could be closer to \$850k+ They're currently fundraising to make this life-changing resource a reality.

**The Closet Thrift Store & Food Pantry:** This volunteer-powered thrift store does so much more than offer affordable clothing and household items. Every quarter, every dollar, every gently-used treasure helps lift up families right here in Kearney County. From emergency food support and rental/utility assistance... to RYDE passes for medical care... to pool passes, school supplies, winter coats and the Caring Tree, they make sure no neighbor goes without the essentials.

The official Day of Giving will be held on December 12, but donations can be made anytime leading up to that date. Individuals can visit GiveBigMinden.com to learn more about the participating non-profits and submit donations. For those looking to give to more than one organization, the website allows one transaction to be split between the groups selected. The website allows for donations as little as \$10 and all money raised goes directly to those nonprofits.

Donations can also be brought to the Minden Opera House during the social event scheduled for December 12 from 3-6pm. Appetizers and drinks will be available during this event. Sponsors and anyone who donated on the website or in person are encouraged to attend. Anyone who donates during 'power hours' on December 12 will be entered into a drawing and the random person chosen will have a generous donation made on their behalf from the power hour sponsor to the organization they supported. Several local businesses have already signed up to be sponsors helping make this event a success before it even begins.

## Minden Mom Grateful to Be Home After Burn and Brain Injury Recovery

MINDEN, Neb. — This Thanksgiving, Alyssa Kahle, 35, is celebrating more than turkey and family gatherings. After a devastating car accident in August, she is finally returning home to her loved ones, walking, independent and full of gratitude.

A stay-at-home mom before the accident, Alyssa's days were filled with chauffeuring her children to sports, dance and other activities, and caring for her family while her husband worked long hours as a truck driver. On August 15, near Funk, Nebraska, her life changed in an instant when a drunk driver caused a multi-vehicle collision. She sustained serious injuries, including burns covering 35% of her body, multiple fractures and a traumatic brain injury.

Rushed first to Good Samaritan Hospital in Kearney and then to the University of Kansas Medical Center, Alyssa spent nearly seven weeks undergoing life-saving surgeries, skin grafts and stabilization before transitioning to Madonna Rehabilitation Hospitals for specialized burn and traumatic brain injury care.


"At first, I would get super dizzy if I was sitting up," Kahle recalls. "I had double vision and had pain from the femur fix and the burns. I couldn't walk or use my arms properly. But the staff made me feel like I was at home and it's a huge relief to be able to go home and know that I'll be okay."

At Madonna, Alyssa's physician-led care team guided her through daily therapy focused on burn care and training, rebuilding strength, improving mobility, vision and walking. Her team helped her manage burn dressings, scar care and skin graft recovery while improving coordination and balance using state-of-the-art technology such as the Are-Tech ZeroG Gait and Balance System. She progressed from needing assistance for nearly every activity to walking with a cane, navigating stairs and regaining vision clarity.

"She was walking longer distances. Her wounds looked

really good," Emily Adams, OTR/L, CBIS, Madonna's occupational therapist, said. "She was very motivated and wanted to do everything she could to get home to her kids and her husband. She really needed that sense of pride and her progress gave her a lot more comfort going home."

This Thanksgiving, Alyssa can celebrate with her husband and children and be grateful not only for the season but for her journey of recovery and the dedicated care team who became her friends.

## Potter's Wheel

We have many Christmas season traditions in common: gift giving; decorating houses, churches and other public places; secular music and favorite hymns playing on car radios and in stores; school programs; and the "Light of the World" pageant at the Kearney County Courthouse and Christmas Eve church services where we remember the original story of Jesus' birth.

Yet, Christmas is unique to every family - each person, really - because no two have had exactly the same history or experiences. Sometimes the most important parts of Christmas are simple things like small ornaments on a tree, the memory of a particular voice singing "O Holy Night" or sprinkles on sugar cookies.

Important family history also is recorded on handwritten cards in our mothers' and grandmothers' old recipe boxes. While the recipes are for all kinds of foods and all seasons of the year, desserts are in the spotlight now.

I was reminded of the importance of family food history recently when my Hildreth niece Shelly Garrett brought me supper. We talked about our favorite desserts made by my mom/her grandma Ruth Potter.

Shelly had a particular dessert in mind, but no recipe. I couldn't help because my twin sister Lisa Parish inherited Mom's recipe boxes. I only had two Pleasant View Christian Church cookbooks with a few of our family's recipes, but not the one Shelly wanted.

Since I don't cook much or bake and she didn't have either cookbook, I gave her mine after making copies of the Pleasant View Church history pages in the 140-page 1995 "Recipes and Remembrances" cookbook.

The other cookbook, compiled by women in the church's

HEO (Helping Each Other) Club, has 36 pages and a green paper cover. There's no publication date, but the names on the recipes are from my grandparents' generation, so it might have been printed in the 1930s or early 1940s.

Mom's Christmas baking featured sugar cookies with sugar sprinkles - no frosting. Some sugar and gingerbread cookies were in the shapes of stars, trees or snowmen, with some having red hots or tiny round silver candy as buttons.

The spritz cookies were kind of flower shaped and also decorated with a dusting of red or green sugar and/or a tiny candy on top.

Mom made decorated cakes for special occasions, but not for Christmas.

Lisa and I always had individual birthday cakes as kids that were shaped and decorated like animals or other characters. Mom made more traditional sheet or tiered cakes for older folks' birthdays, anniversaries and special occasions such as graduations.

Some of her Christmas desserts were things we enjoyed throughout the year: apple, peach or rhubarb/strawberry crisp; custard served in "special" crock bowls; pumpkin pie and even pumpkin ice cream; and Grandma Tena Dunn's thick rice pudding with raisins. Those recipes included nutmeg because they came from grandma, who learned them from her German and Swiss immigrant parents.

I submitted my Grandma Alice Potter's recipe for boiled raisin cake for the 1985 Pleasant View cookbook. Its molasses and related spices also made it a good fit for the holidays.

Also on Mom's year-round desserts list were a great chocolate sheet cake, her version of a Rice Krispie bar with peanut butter replacing the marshmallows and a similar bar with a crushed graham cracker base and coconut filling. All three were topped with melted dark chocolate chips.

We weren't marshmallow people. I remember seeing only a few tiny ones floating on hot chocolate and a few more in what we called "That Apple Salad," which also had

grapes, celery, walnuts and a mayo dressing.

The Pleasant View history pages in the 1995 cookbook reminded me of more than the two older generations whose names are on the recipes, yummy potluck dinners at the church and the many church moments from my youth that remain special today as memories or continuing traditions.

The HEO history page has examples of the women's activities that reflect the importance of heartfelt charity, kindness and friendship at Christmas and all year. Not just to family and friends, but also to strangers in need..

"Alice Potter entertained the ladies March 1,1943, and they spent all day sewing for the Red Cross. They donated \$5 to the Red Cross. Ethel Schepler was hostess March 29,1943, and the club voted to send \$10 to help with Franklin County Day at the North Platte Canteen. Chickens were sent to Child Savings Institute."

On Oct. 14, 1943, \$5 was donated to the war relief fund. On June 8,1944, the women spent the afternoon making dresses for the Christian Children's Home in Holdrege.

I expect they also made desserts and other foods special to their families to share with others. Many of those will be enjoyed again this Christmas because our mothers and grandmothers wrote down the recipes to hand down to future generations in recipe boxes and church cookbooks.

As we stood watching a fire devour our family's combine, we felt a humbling reminder of our own helplessness in the face of Mother Nature. Even more humbling was the immense act of service we witnessed as some forty volunteer firefighters from eight surrounding communities engaged in an extraordinarily coordinated and professional effort to contain it. At one point, one of them observed, "Ain't America great?" It most certainly is.

So are small communities that rise up to support each other, especially those small-town heroes who take on dangerous work and in return receive only the satisfaction of coming together as a "tight-knit family" to help someone in crisis.


On this particularly windy October Saturday, they had already responded to numerous fire calls that such conditions bring. For some of those volunteers, it was their third of the day. Yet here they were, sacrificing their Saturday night to contain a fire that almost certainly would have claimed much more of our family's farm.

A simple thank you seems so inadequate, but the very nature of volunteerism is that it's offered without cost. So, all we can really give back is our gratitude and profound admiration for their incomparable dedication to serving others in need.





Tom was born to Jim and Kay Meisenbach on July 11, 1957. He attended Minden schools and graduated from Minden High School in 1975.



  - \*A request for payment by cash, gift card or wire transfer. Scammers love gift cards.

#### How to protect yourself from this scam

\*Search online watchdogs like

Charity Navigor, CharityWatch and the Better Business Bureau's Wise Giving Alliance.

- \*Contact your state's charity regulator to verify that the organization is registered to raise money there.
- \*Pay attention to the charity's name and web address. Scammers often mimic the names of familiar, trusted organizations to deceive donors.
- \*Keep a record of your donations and regularly review your credit card account to make sure you weren't charged more than you agreed to give or unknowingly signed up for a recurring donation.
- \*Don't click on links in unsolicited email, texts or fundraising messages on social media platforms; they can unleash malware.
