Minden School Board Met Oct. 13

The October 13 regular meeting of the Minden Public Schools Board of Education was joined by a group of special guests as several East Elementary first grade students helped lead the Pledge of Allegiance.

Minden High School and C.L. Jones librarian and media teacher Collin Nichols delivered a presentation about the high school and middle school libraries. Nichols explained the importance of a staffed school library with a diverse collection that meets the needs of the students. He explained steps he has taken during his time at MPS to increase student engagement and the use of the library space and resources.

In his report to the board, Superintendent Jim Widdifield noted it was national principal's month and gave thanks to the school principals and administration for the work they do throughout the year.

Getting down to business, the board approved the consent agenda including minutes from the September 8 meeting, financial reports, and expenditures and claims for payment. The board was informed the district has received the handicap van and student transport van that were purchased previously.

Second reading of amendments to two policies was approved. Amendments to Policy 4221 Leaves of Absence creates consistency among all employees in the district and aligns with new legislation. Amendments to Policy 3132 Internal Controls also align the policy with changes in legislation.

The board took action on 2026-27 capacity limits for Policy 5006. This action used to be taken in March, but school districts are now required to set capacity limits much earlier. Capacity limits are based on the square footage of space available. Numbers for East Elementary are based on the smallest space available due to option enrollment standards. The 2026-27 capacity limits for Policy 5006 were approved as presented.

With no further business, the meeting was adjourned. The next regular meeting of the MPS School Board will be held on Monday, November 10 at 7 p.m. in the MHS Media Center.

The Rotary Club of Minden will hold its annual fund raiser, Pints for Polio, at Thunderhead Brewing Company in Axtell on Thursday, October 30th, 2025, from 5:00 to 7:00 pm.

Rotary started its quest to eradicate polio worldwide in 1979 in the Philippines. Rotary volunteers have administered over 3 billion vaccines around the globe since that time.

"Polio is a paralyzing and potentially deadly infectious disease that most commonly affects children under the age of 5," quoted project chairman, Luke Poore. "In the 1950s parents in the United States were keeping their children from going to parks for fear of contracting the disease. Today, there are only a handful of cases detected each year, primarily in Pakistan and Afghanistan where Rotary volunteers have limited access. If our work were to stop tomorrow it is estimated that 200,000 children would be paralyzed every year."

Poore went on to explain that the Gates Foundation provides a 2 to 1 match for every dollar raised. "One vaccine costs about \$3" said Poore. "That means if we raise

Potter's Wheel

On a perfect fall day Oct. 10, my friend and former Kearney State College journalism teacher Glennis Nagel and I drove from Kearney to Red Cloud to set up rooms at the Hotel Garber for the Nebraska Press Women Fall Conference.

As we traveled Highway 10 through Kearney and Franklin counties, and Highway 136 from Franklin to Red Cloud, we enjoyed seeing fields of soybeans and corn already harvested or with harvest still in progress. Large trucks were arriving and leaving grain elevators in towns, and we slowed down for a few miles behind a tractor pulling a grain cart north of Minden.

We also marveled at how green the pastures were that late into fall. Contented cattle of various sizes, shapes and colors were in many of them.

The scenery reminded me of growing up on a Franklin County farm 11 miles southeast of Wilcox. And also of the decades I spent as a Kearney Hub reporter-photographer covering agriculture, natural resources and rural community issues that included crops, irrigation, water compacts and conservation, livestock, ethanol, rivers, groundwater, endangered species, farming history, and new technologies.

I also interviewed local leaders, including state senators and officers of state or national farm organizations. I lost count of how many times I caught up with former Nebraska Farm Bureau President Steve Nelson at his farm south of the KAAPA Ethanol plant and at ag events. I also invited myself to ride along in his truck so we could talk during harvest while he hauled corn to area elevators.

Great American Desert

The Red Cloud road trip also reminded me of a story I recently read about the long-lived "Great American Desert" label given to Nebraska and much of the Great Plains by early explorers and settlers. It's in the Summer 2025 issue of Nebraska History, the quarterly magazine of the Nebraska State Historical Society that my brother James edited and contributed stories to during many of his 49 years at the historical society.

Writer H. Jason Combs, an instructor in South Dakota State's Department of Geography and Geospatial Science, said Major Stephen Long's early 1800s expedition set the tone for many reports about the "Great American Desert."

Even President Thomas Jefferson, at the time of the Louisiana Purchase, called what's now the Great Plains "an immense area" filled with "trackless deserts," despite a lack of information about the place.

After Long led another early 1820s expedition west, he wrote that the entire country was "wholly unfit for cultivation" and "uninhabitable by a people depending upon agriculture for their subsistence."

John C. Fremont, who led five western expeditions from 1842-1854, gave mixed reviews. "The valley of the Platte was like a garden; so rich was the verdure of the grasses, and so luxuriant the bloom of abundant flowers," he wrote.

Francis Parkman wrote in 1849 about the mix of landscapes, with areas beyond the river - the Sandhills - still fitting the "Great American Desert" description.

Changes came after the Civil War as railroads, small towns and other promoters tried to entice more people to head west. However, Combs wrote that the "Great American Desert" remained a popular phrase for more than a century after its first use.

Garden Now

Our Nebraska ancestors who arrived in the mid- to late 1800s and early 1900s, and



decided to stay, learned by observation that some years are too dry and some are too wet. The explorers made short visits and decided that's how every year must be.

So their opinions depended on the particular year. Was it dry like 1935, extremely wet like early spring and summer in 2019 or something in between?

Today's weather records span all or parts of centuries. Meteorologists are usually right with their seven-day forecasts and even with seasonal expectations based on El Nino or La Nina features and other data. Continuing climate change makes their forecasts and our expectations more uncertain each year.

Technology advancements in irrigation, from siphon tubes to pipe to pivots; plant hybrids; planting methods, from horse-drawn plows to tractors to no-till to field mapping; and measurements of soil components, water quality and uses, and plant

nutrient needs have aided farm management, helped to protect natural resources, and often improved soil and water quality and sustainability.

It would be interesting if Major Long or others who took a quick look at Nebraska all those years ago and saw a desert could return to watch farmers finish the 2025 fall harvest.

Obituaries

Norris John aka 'Norry' or 'Poke' Christensen



Norris "Norry" John Christensen of Minden was born to Martha and Chester Christensen who farmed east of Minden on October 25th, 1925. Norry died on Tuesday, March 1st, 2022 at the age of 96. We as a family decided we would give our bodies to UNMC in Omaha for medical education. It has been three years and it's time for a Celebration of Life memorial service for Norry that will be held at 2:00 p.m. on Friday, October 24th, at the Bethany Lutheran Church in Minden, with a military service at the Minden Cemetery directly following. We will be celebrating the life and 100th birthday of a wonderful son, father, husband and a friend to all.

When Norry was 14 years-old, the almost impossible life of working a small farm during the dirty '30s forced the Christensen family to move into Minden in 1939. Norry was baptized at the Christian Church in Minden

on August 8, 1940. He was then confirmed into the Bethany Lutheran Church on December 18, 1955. I think wife Norma had something to do with that. Norry graduated from Minden High School in 1943 where he had become a very good athlete. He was contacted by area colleges and a couple minor league teams about playing baseball but as he was making up his mind. Uncle Sam came calling and Norry enlisted into the Navy and was stationed on the troop transport carrier the USS General E.T. Collins. Their assignment for the next three years was to distribute roughly 4,000 soldiers per trip to different fighting "Hot Spots" in the Pacific Theatre and then pick up all the wounded and dead on the way back to headquarters in Hawaii or the USA. When he wasn't dodging bullets, planes and torpedoes, he played on both the men's baseball and basketball teams in the service league. Norry attained the rating of 3rd Class Petty Officer and his main duty was fire control. When the war ended they were sent to collect troops that were still abroad. When finished with this enormous task Norry was decommissioned from the Navy in Seattle, Washington in 1946. He had traveled over 134,000 miles on his tour of duty.

When he returned to Minden he married Norma Jensen, the girl of his dreams since they started dating at the age of 14, and they remained sweethearts to the end. Through this marriage were born three boys: Robert, Mark and Jim. After returning from the war Norry had very little money so he found a job for awhile in house construction until he bought the milk delivery service in the Minden area from Vic Silvrants and it became "Norry's Delivery", and was the first pasteurized milk sold in Minden. The "Milk Man" continued delivering milk for over 20 years. During this time he continued to play baseball and basketball for Minden in the Kansas-Nebraska League and town team ball. Area teams would recruit him for tournaments and play-off games. Norry was a competitive golfer as well and had many thrilling tournaments against friends old and new. At times his temper got the best of him and at one tournament he was seen climbing a tree to retrieve his putter. He got pretty good at climbing trees.

In 1972 Norry and Norma were hired to run the Pioneer Village Motel. In 1982 they decided to visit their boys who all worked in or around Casper, Wyoming. They ended up staying for 11 years. They joined Our Savior's Lutheran Church and Norry became their "handy man/janitor" for the entire church and pre-school. They made a million friends and truly loved Wyoming.

Norry decided to retire and they moved back to Minden to rekindle old friendships

and live out the rest of their lives. He played a lot of golf, cheered on the Whippets and the Huskers every weekend, and enjoyed painting on canvas as well as houses. He did this well into his 80s and played golf until he was 92.


Norry also loved music, had a good voice and liked to sing. He sang in school and then in the Navy. He sang for the Bethany Lutheran Church choir, a barbershop quartet, and the Minden Chorus who were fantastic and entertained thousands in south central Nebraska and were loved by all who heard them sing. There were many things going on in Norry's life and these were but a few.

At the end of Norry's life he would sit by his picture window and gaze at the sky, the trees, his lawn, the neighbors working and playing outdoors, the kids coming and going to and from school and watching them play on the school playground. In his eyes you could see him looking back on 96 years of life. And what a life. I couldn't imagine a better father.

He was preceded in death by his parents, Chester & Martha Christensen, his wife Norma Jensen Christensen, his sister Luann and husband Roger Johnson, two sons Bob and Jim, his daughter-in-law Janet Christensen, his grandson-in-law Shawn Duncan, his great-granddaughter Kristian Duncan Morgan, and his childhood dog Rover, who after 90 years he still cherished and brought a tear to his eye when he told stories of their years and journeys together on the farm.

Family left to cherish his memory include his son and daughter-in-law John Mark & Jane (Jensen) Christensen of Minden; daughter-in-law Karla Fandry and husband Jim of Grand Island; granddaughter Heather Thesenvitz and husband Tom and their children Kylie, Tarah, Tucker Norris, Elizabeth, Max and Molly, and great-great grandsons Bently and Austin and great-granddaughter Amelia; granddaughter Megan Duncan and great-granddaughters Ariah and Madison; granddaughter Dana Fetters and her husband Donnie, and great-grandchildren Mary and her husband Alex, James, Ruth and Anna, all from Colorado; granddaughter Brooke Graham and husband Eric, and their children Elijah and Isaac; granddaughter Robin Mortenson and husband Ty, and their children Ryleigh and Brynlee; grandson Jon and wife Maddie and daughter Murphy; and daughter-in-law Eddie Christensen and son John, all of Wyoming. Also many Bogaard, Christensen and Jensen cousins in the USA and Denmark, as well as numerous friends.

Dr. James "Doc" Robert Madsen was born on January 20, 1947 to Robert and Marjorie Madsen in Minden, Jim was the only child of Robert and Marjorie. He was baptized and confirmed at the United Methodist Church in Minden. Jim received the highest honor in the Boy Scouts, which is Eagle Award. Jim loved golf so he helped organize a golf team in 1963 for Minden High School with Coach Sam Somerhalder. The team went on to win the Nebraska Class B State Championship for Minden in 1964. To this day Minden has not had another boys' team win the championship for the school. Golf always remained a lifelong passion in Jim's life.

Jim was so proud of his parents; Bob was a mason and laid the bricks in the front of Pioneer Village back in the 1950's. His mom Marge was the secretary to the Chamber of Commerce for over 26 years. They also owned a shoe store in Minden for many years.

Jim attended the University of Nebraska for a couple years before enlisting in the United States Marine Corps in September of 1967. He became a member of the 3rd Tank Battalion for the 3rd Division and served 10 months on tour duty in Vietnam. He served as a field radio tech.

After returning to the United States, Sgt. Madsen married his lovely wife, Iola Gregg, in March of 1970 in Las Vegas, NV. Jim, Iola and her son Clark were sent to New Mexico for burial duty for the Marine Corps.

Sgt, Madsen also was involved with the Marine Corps Reserve Training Center until 1971 when he received his honorable discharge. On January 29, 1972, Jim received the terrible news that his father had passed at the young age of 49 years old.

In 1973 Jim enrolled in the pre-veterinary program at the University of Nebraska in Lincoln. Besides his studies, Jim had many part time jobs in Lincoln to help him get through the program, along with lola working too.

In 1977, Jim enrolled at the graduate school of Veterinary Medicine for another three years of studies at Kansas State University in Manhattan, KS.

Lady Whippets Secure State Title in Undefeated Season

They did it! STATE CHAMPS! The Whippet girls are atop the Class C golf world for the first time in 11 years and their 2025 win was quite sweet as the recent spate of three straight runner-up finishes came to an end. There was no drama this season as there was in 2024 when Wayne beat Minden by one stroke. The girls were undefeated as a team this year.


The margin of victory at the meet at the Lake Maloney course near North Platte on October 13-14 was a resounding 63 strokes. Minden led by 34 strokes after the first day (Monday) and added 29 more to the margin on Tuesday. The Whippets 649 two-day score is Class C's all-time best. The previous best was also a Minden foursome (675 in 2003).

The team championship was Minden's 12th, tied for second for any class all-time. Previous titles came in 1979, 1980,1994,1996,1998, 2002, 2003, 2004, 2006, 2013 and 2014. Senior KayLynn Jorgensen's individual class title was the sixth in school history and followed Jan Houston in 1979 and 1980, Kristen Kosch in 2002 and 2003 and Kara Suchsland in 2024.

KayLynn had rounds of 74-69(143) on the par 72 course to finish at one under par and was the only golfer in any of the three classes to break par. She bettered Kosch's previous school record 36-hole score of 153.

Her Tuesday round included an eagle on a par 5 and her 32 on the front nine was a career-best. The 143 is tied for the third best Class C round ever and in top 10 all-class

all-time. The 69 is one of only six rounds ever in any class to go under 70 at State. Her State finishes previously had been 3rd, tie-4th, tie 2nd.

This is arguably Class C's best team ever. There are some apples-to- oranges comparisons (different courses, different weather conditions) but its hard to dispute that this might be the cream of the crop. And the heroes went well beyond KayLynn.

Freshman Macy Jorgensen had already emerged as a name to watch in future years and her second place finish at 78-76(154) certainly cemented that assertion.

Senior Shelby Nelson's back-to-back rounds of 82-79 (161) for the sixth place medal were personal bests and a huge boon to the prolific effort put forth by Minden.

Seniors Lauren Starkey (94-98-192, tie-36th) and Isabelle Martin (100-97-197, tie-46th) played some of their best golf of the season at a most opportune time.







The top individual girl was Scout Bell of Gothenburg in 20:00. Minden was led by




The Minden girls had an excellent season and were anticipating a return trip to State but they fell a few points short of moving on.






