# City of Minden Celebrates Ribbon Cutting of New Upper-Story Housing on Historic Courthouse Square

The long-awaited revitalization of a cornerstone downtown Minden building is now complete. On Friday, January 30, 2026 at 2:00 pm, the public is invited to celebrate the ribbon cutting and tour the five newly constructed upper-story apartments at 345 N Colorado Avenue, now known as Zu Haus Flats. In conjunction with the event, 52 Taphouse on the main level will host an open house in celebration of their recent opening.

In 2023, the City of Minden was awarded \$802,500 in 2023 from the Nebraska Department of Economic Development – Nebraska Affordable Housing Trust Fund following a highly competitive grant process. This funding supported the creation of five modern upper-story housing units within the historic building, constructed in 1887. After sitting vacant for many years, the property was primed for redevelopment as a partnership through a public-private partnership between Longshot Property Development, South Central Economic Development District, Inc. and the City of Minden emerged.

This project was made possible with a collaborative and community approach with additional financing support from the Minden Investment Club and Center for Rural Affairs. Together, the owner’s investment of Longshot Property Development, Jacob & Emily Rafert, provides needed additional

rental housing while also energizing the downtown district for years to come. The completion of Zu Haus Flats—features three modern 2-bedroom apartments and two 1-bedroom upper-story units. The new 52 Taphouse business opened earlier in January. Jacob Rafert, Owner, said, “Conversations are in progress for a possible new commercial tenant on the south side.”

“The Zu Haus Flats project breathes new life into one of Minden’s oldest buildings, turning it into modern housing and commercial space that supports downtown vitality, preserves local history, and invests in the future of our community. This project adds much needed housing to Minden in a way that we have not seen before while simultaneously increasing traffic in our historic downtown square,” said Michael Krings, City Administrator/Economic Development Director, City of Minden.

# Council Approves Funding Agreements and Easements

The council and public were invited to a ribbon cutting and open house for Zu Haus Flats during the January 20 Minden City Council meeting. The event is a celebration of the completed remodel of the new apartments at 345 N. Colorado Avenue and the opening of 52 Taphouse beginning at 2:00 p.m. on January 30.

Getting to business, the council approved payments to Klein, Brewster, Brandt & Messersmith in the amount of \$562.50 and Remboldt Ludtke LLP in the amount of \$3,731 for legal services. These services related to a nuisance situation the City is dealing with that would be a conflict of interest for the City Attorney to handle.

Funding agreements with the Minden Development Corporation, Minden Chamber of Commerce, Minden Senior Center and American Legion were approved. The Minden Development Corporation serves as the economic development arm of the City utilizing resources to impact projects and recruit businesses, families and individuals to Minden. The funding agreement includes a development fee from Minden Mining that is paid to the City annually.

The Chamber of Commerce serves as the marketing agency of the City promoting local businesses in Minden. The funding agreement was increased to \$25,000 this year contingent on award of a grant from the Nebraska Tourism Commission. The Chamber has a committee working on new events and activities for Minden's 150 year anniversary in 2027 and plans to create a committee to enhance the Christmas traditions celebrations this year.

The Minden Senior Center served over 7,700 meals last year and served as the base for RYDE Transit in Kearney County. Despite the name, there is no age limit for those who receive meals from the Senior Center whether they dine in or take the food to go. A survey of guests last year revealed high overall satisfaction in quality and service. The City will once again provide \$5,000 to the Senior Center to assist in its operations for the year.

American Legion Post #94 runs the American Legion Baseball program including maintenance of the Bjorklund Memorial Field complex owned by the City. In exchange for this maintenance, the City provides \$5,000 of support. This year Minden will host the American Legion Baseball Juniors regional tournament.

As discussed at the previous meeting, Fill N Chill in Minden is planning to construct a new building west of the existing location. For this to be accomplished the City will need to vacate the alley behind the current building. Temporary easement agreements with PSK LLC and Hoff Brothers Inc. were approved to ensure the City and NPPD will continue to have access to overhead electric lines while the new store is being built. The electric lines will be moved as part of the project at which point the easements can be removed.

With the easements in place, the council approved ordinance #1314 vacating the alley behind Fill N Chill. The council opted to waive the three readings and adopted the ordinance by title.

Two proposals were received for the City's water/water system planning grant study. The council completed a scoring sheet for the proposals from JEO and Olsson during the meeting and the totals were calculated. JEO clearly outscored Olsson and was awarded the planning study project.

In other business the council: Approved January 5 minutes. Approved bills and claims. Approved cafeteria plan reimbursements. Approved December 2025 treasury report. Approved December 2025 budget report.

# Stop Signs Coming to V Road

More regulatory signs are coming to a county road intersection after the January 20 meeting of the Kearney County Board of Commissioners. Highway Superintendent Joe Anderson explained the need for the signs.

During a paving project on V Road, Anderson noted intersections with 34 and 36 Roads were missing stop signs. One intersection did have yield signs. He had Oak Creek Engineering complete a road study and their findings supported Anderson's belief the intersections should have stop signs. With this information, the board approved a resolution for the installation of permanent stop signs as discussed.

Continuing with road business, the board approved an interlocal agreement with Franklin County for the 40 Road overlay project. The agreement outlines the scope of both Counties' projects and the responsibilities of each County in regard to the projects. Because Franklin County won't address the project bids until February 3, the board tabled any action to award bid of the project until the same date.

Minden Lawn and Sprinkler will fertilize and treat the courthouse lawn per an agreement approved by the board in December, but the company is no longer offering mowing services. The County received mowing bids from Phillips Mowing and from Craig Bros Mowing for 2026. The board approved the lower bid from Craig Bros Mowing for \$110 per week.

Gravel bids for 2026 were received from Mid-Nebraska Aggregates for \$14.55 per cubic yard, Ed Broadfoot & Sons Sand & Gravel for \$14.25 per cubic yard, and Southwest Gravel Products for \$13.50 per cubic yard. All bids were accepted.

In other business the board: Approved January 8 minutes. Approved bills and claims. Approved duplicate General Fund checks 2505149 for \$57.75, 25090022 for \$20, and 25100112 for \$190.70. Approved election SuperMicro CSE-73li-404B system agreement. Approved Nebraska Department of Ag Weed reports. Accepted County Treasurer semi-annual report for July 1, 2025 to December 31, 2025. Approved contract with Ace/Eaton Metals for 2026 culverts. Approved estimate from Wilson Flooring for new carpet for the courthouse assembly room and sent request for the same square foot pricing to replace flooring in the County Attorney's office.

The Kearney County Board of Equalization also met on January 20. The board approved December 16 minutes. County Assessor Jennifer Pittner presented seven tax list corrections which were approved as presented. The board reviewed a request for reassessment due to significant damage to property in Axtell. Deadline for the report was July 15, 2025, but the report wasn't received by the County until December. Missing this deadline tied the board's hands and led to a denial of the request. With no further business, the meeting was adjourned.

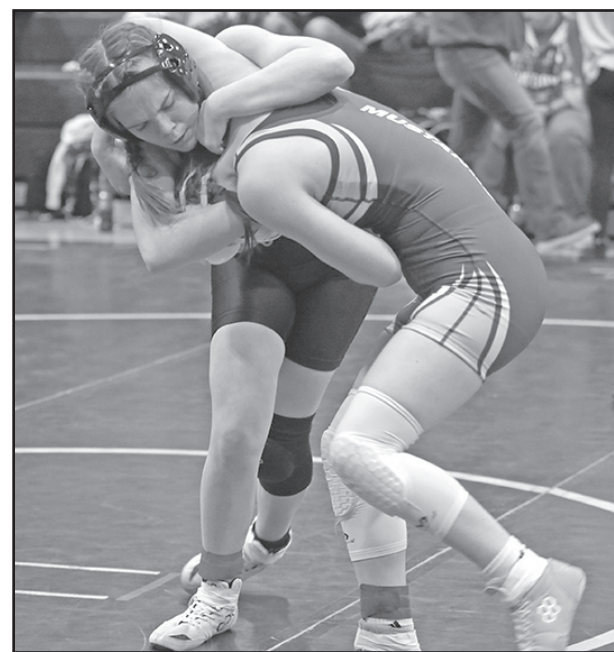

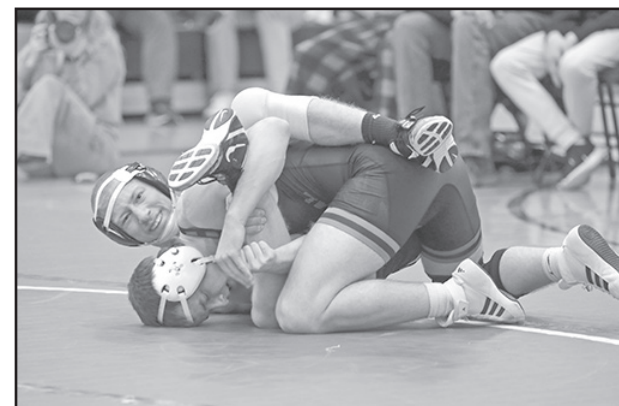

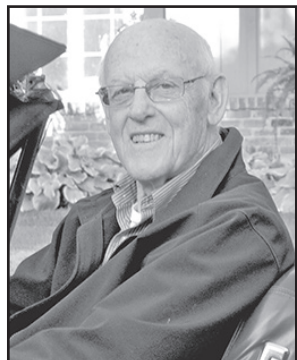
