The Lincoln City Police Department investigated two separate incidents this past week involving potential social media threats to the Taft Schools. The second inci-



dent resulted in the arrest of a juvenile. During the afternoon on Sept. 22, the Lincoln County School District (LCSD) was made aware of a potential threat found on social media regarding the Taft Schools.

The LCSD then alerted the Lincoln City Police Department and after investigating the post they determined that it was not a credible threat for any of the Lincoln City

"The threat was determined to be referring to a school in a different part of

Man missing at sea, Coast Guard suspends search

The Coast Guard suspended its search for a man early Monday morning after more than 11 hours of combined searching in the vicinity of Whale Cove near Depoe Bay. Now his family is searching for closure.

Hoang Tran, of Clackamas, Ore., was last seen Saturday, Sept. 28 by a bay tower watchstander at Coast **Guard Station Yaquina Bay** heading north at approximately 7 p.m. in the vicinity of Cape Foulweather.

According to Tran's family, he is no stranger to sailing his vessel, the Kiwanda, which was launched from Newport Saturday. After setting sail in the morning, Tran was due back home that night, according to his daughter Andrea Tran.

"We have tried calling

him on his cellphone but it goes directly to voicemail," Andrea, a recent graduate

of Portland State University said. "My mother and baby brother, age 8, are

completely distraught and devastated. This is not like my father; he is a counselor at Franklin High School in Portland, Ore.

He always communicates with us with his whereabouts and is always home at the time that he specifies."

The Tran family then informed the Coast Guard station in Newport about a possible man missing at sea. Coast Guard Sector North Bend then coordinated eight combined searches, which were conducted by an MH-65 Dolphin aircrew from Air Facility Newport, a 47-foot Motor Lifeboat crew from Coast Guard Station Depoe Bay and Lincoln County Rescue.

"All searches resulted in negative results," stated the Coast Guard.

Coast Guard watchstanders at Sector North Bend received a report at 11:42 a.m. Sunday from a source on land that sighted vessel debris in the vicinity of Whale Cove, approximately one-mile south of Depoe Bay.

A 47-foot MLB crew and a Dolphin helicopter crew launched and arrived on scene to commence searching at 12:10 p.m.

At 12:47 p.m. Lincoln County Rescue and a Station Depoe Bay ground party arrived at Whale Cove and launched a drone to survey from above.

The reported floating debris field was located by responders, and the debris found was confirmed to be from the overdue sailing vessel Kiwanda. Coast Guard crew members recovered several items from the area including: wood, a life jacket, part of a marine

State officials say stop vaping now

State officials are urging people to immediately stop using all vaping products after Oregon Health Authority confirmed a second vaping-related death in Oregon.

The death was the second among five previously reported illnesses, part of a nationwide outbreak of severe lung injuries reportedly linked to vaping and e-cigarette use. The first vaping fatality in the state was reported Sept. 3.

In both fatal cases, cannabis vaping products were purchased from licensed retails stores. State health officials said the most recent death was an individual who was hospitalized with respiratory symptoms after vaping cannabis products.

Oregon's first victim died in July after battling lung failure for five weeks. That person reportedly vaped oils infused with THC that was purchased at two retail stores. Federal health officials say 13

people have died in 10 states from vaping-related illnesses.

"If you vape, whether it's can-

nabis, nicotine or other products, please quit," state health officer Dr. Dean Sidelinger said. "These

are addictive substances, and we encourage people to take advantage of free resources to help them quit. If you haven't started vaping, don't start."

Democratic Gov. Kate Brown is asking state attorneys to explore legal options including a temporary ban on all vaping products. The governor called on Oregon Health Authority to recommend steps for protecting the public. Brown has also urged Oregonians to stop vaping.

Vaping product sales in Oregon are plummeting according to cannabis industry research by New Frontier Data that showed a 62-percent downturn in September.

Nationally, there have been more than 800 cases of vapingrelated illnesses reported in 46 states and one U.S. territory, primarily among youths and young adults. Those who have fallen ill in Oregon have been hospitalized after experiencing worsening symptoms, including shortness of breath, cough or chest pain.

A cause of the illnesses has not been determined, but all cases have reported e-cigarette use or vaping. Investigators and local public health authorities continue to urge clinicians to be on alert for signs of severe respiratory illness among patients and report any

State health officials are working with the federal Centers for Disease Control and Prevention and the Food and Drug Administration to determine the cause of deaths and illnesses in Oregon and across the nation.

Before the new illness reports, Oregon Health Authority was already concerned about the health risks of vaping products. A recent report by the agency details the health risks for the products including nicotine addiction, exposure to toxic chemicals known to cause cancer and increases in blood pressure.

Individuals who have recently vaped and are having difficulty breathing should seek medical attention immediately.



sanitation device and a strobe light with the name of the vessel written on it.

Although Hoang Tran has not been located at this time, his family hasn't lost

"My brother is eight years old and the thought of not having a father to help be a key role model to guide my brother in life is unthinkable," Andrea Tran said. "We are pleading with the community if anyone can volunteer their time to help us search for my father. He could still be alive on the sea or washed up on shore.'

Hoang Tran is described as an outdoorsman, approximately five foot five inches tall, average build, about 145 pounds. Hoang is a married father of two, and just recently celebrated his 25th wedding anniversary with his wife. He is a Vietnamese American who fled Vietnam in 1975 along with his seven brothers and one sister, states his family.

"He loves his community and is loved by his fellow students and teachers," Andrea said. "He regularly organizes cultural events and volunteers his time to help his

the state and that area's law enforcement agency is conducting that investigation," stated the Taft Schools Administration.

Sue Graves, safety coordinator for the LCSD, said the school district went through their emergency protocols then contacted local law enforcement.

"In the case of the social media post, there were no immediate protective measures necessary and we did not know who made the potential threat, so we notified Lincoln City Police and our District Leadership," Graves said. "This started the investigation."

Graves responded to the police department to support their investigation and was a liaison between the police and the school district leadership. This helps keep clear and open communication during any kind of investigation and allows them to share all relevant information between the agencies.

"The Lincoln City Police Department was able to determine in just a few hours that there was no credible threat to our Lincoln

The Lincoln City Police school resource officer and detectives opened an investigation into this matter, subsequently identifying the juvenile responsible for creating the social media posts.

This subject was taken into custody by Lincoln City Police and detectives at about 1:30 a.m. and Lincoln County School

District staff were notified of the arrest.

The juvenile was charged with one count of Disorderly Conduct in the First Degree and later lodged at the Lincoln County Juvenile detention

Through the Lincoln City Police Department's investigation, it was determined that the involved juvenile was not a student of Taft 7-12, and there is no longer a concern for safety.

The LCSD would like to remind the community that they participate in the Oregon School Safety Tip Line called SafeOregon, which is a place for students to report safety concerns involving school such as threats, violence, bullying, drugs, self-harm or cyber-bullying.



Broadband Internet is critical tool for rural communities

Oregon policymakers have worked hard to ensure that all areas of our state, including coastal and rural areas, have access to the latest and best infrastructure. Like roads, bridges and utilities, access to broadband internet is critical for rural communities. As new technologies like next-generation 5G wireless networks are realized, it will be more important than ever to ensure that all Oregonians have access to a reliable high-speed internet connection.

High-speed internet can facilitate many opportuni-

ties for rural residents in areas like healthcare and education. Applications make it possible for patients to be monitored remotely by their physicians and consult specialists from different parts of the state or country, saving on the costs and logistical challenges of getting to far-away appointments. For students, having access to the internet at home is critical not only for completing homework assignments, but also for taking advantage of online learning opportunities.

I recently had the chance to participate in a panel discussion at the Oregon Legislature's Coastal Caucus Economic Summit in Flor-

ence. The panel, "Broad-

band Infrastructure on the Coast – Do Rural Communities Have Access to the Services they Need?" looked to a number of individuals in the technology and legislative arenas to not only provide an overview of the current state of broadband in rural Oregon, but also to look at the needs of rural communities. Most importantly, we discussed the best policy solutions to help meet those needs.

One critical initiative is ensuring accurate broadband mapping by the Federal Communications Commission. Having access to the latest data about which communities have solid access to high-speed internet can help inform state and federal policymakers, as well as Internet Service Providers, who can work together to make decisions about when and where to incentivize and make network investments.

Continuing to encourage and incent broadband providers to bring their upgraded networks to the rural areas of our state is another





Back surgery leads to vitality in retirement for local woman



Kathy Cleary has led a full and active life, working as a dental assistant, a receptionist and a housekeeper for the musician John Denver before opening Toujours Boutique in Newport, a store she ran for 21 years.

She also keeps and rides horses. That's how she first injured her back when she was thrown off a

"I hit a fence," Cleary recalled. "I think that started the process."

Arthritis and aging did the rest. But thanks to successful surgery to repair spinal stenosis, a painful condition caused by wear and tear, Cleary is now enjoying retirement and is back to riding.

Cleary first had spinal fusion, a type of back surgery to fix problems with the bones in her spine, in 2012. After several years of relief, her lower back pain returned in 2018. Two factors complicated matters.

First, Cleary's previous surgeon had retired. Second, she wanted to avoid an adverse reaction to anesthesia, which she had following her first surgery. So, Cleary did what a lot of people do. She went online and read patient reviews. She liked what she saw about J. Christopher Noonan, MD, of Samaritan Neurosurgery in Corvallis.

"You know, I'll give him a try," she said.

At her first appointment, Dr. Noonan listened attentively.

"When you go in, it's very scary," Cleary recalled. "He was very reassuring."

Cleary talked about her post-operative cognitive dysfunction symptoms and her problems with balance and speech after the last surgery.

"We'll figure this out," Dr. Noonan assured Cleary.

He reviewed her medical records and referred her for neuropsychology testing. He also arranged for Cleary to meet with an anesthesiologist.

"He was very proactive in figuring this out," Cleary said. "I was over-the-top impressed."

The surgery was a success.

"Everything went swimmingly," Cleary said.

She was prepared to take up to two weeks off work. But she was back in just six days. At age 72, Cleary was looking to slow down. And with her recovery complete, the timing for retirement felt right.

"It really was time to retire," she said. So, she recently closed shop and moved to Phoenix.

"Life is good," Cleary reports from her new home in the desert sunshine.

While she hopes she never has to have back surgery again, without hesitation she recommends Dr. Noonan and Samaritan Neurosurgery.

"Besides his extreme talent as a surgeon, he listens to you," Cleary said. "I really appreciate that."

Increase in controlled burns expected statewide this fall

Cool, rainy weather across much of the state has allowed the first controlled burns to be lit in parts of Oregon.

New rules governing smoke may allow more of these burns than in the past. Oregon Department of Forestry officials believe increasing the amount of burning will help landowners reduce the public safety risk from the buildup of fuels in forests and improve forest health.

Known as prescribed fires, these regulated burns are lit when weather conditions will minimize smoke getting into smoke-sensitive receptor areas (SSRAs) and Class I wilderness areas, such as Crater Lake National Park. According to ODF records, out of 2,964 units burned in 2018 only 18 about half of one percent - resulted in smoke entering an SSRA.

"The prescribed burns the public may see in coming weeks are done only when weather conditions are favorable for burning," Nick Yonker, ODF Meteorology Manager said. "We look to burn on days where air movement will disperse the smoke so public health is protected."

New rules implemented this spring still require that burners not exceed federal air quality standards for particulate matter from smoke. But they no longer classify small amounts of smoke entering an SSRA as an intrusion.

"The old standard used to be zero visible smoke in an SSRA," Yonker said. "This made it difficult to burn brush near populated areas, the very places where burning built-up woody fuels would improve public safety the most."

Yonker expects that burners will now be more confident about starting burns when conditions are reasonable rather than only when they are perfect.

"If the weather cooperates, a conservative estimate is that we might get from 10 percent to 20 percent more burning done than last fall," he said.

Last year, controlled fires were set on 185,702 acres out of Oregon's more than 30 million forested acres. That was about 16,000 acres above the 10-year annual average of 169,779 acres burned. Estimates are that those fires burned almost 1.3 million tons of woody debris.

Officers began the initial scene investigation and Lincoln City Police detectives responded for further assistance. During the investigation several persons were interviewed and evidence was collected at the scene.

Subsequent to the investigation, a 43-year-old female from Siletz, identified as Sonya Rae Foster, was taken into custody for probation violation. She was later transported to the Lincoln County Jail and lodged there.



Lincoln County School District ushers in new reading curriculum

New Districtwide school reading programs in the Lincoln County School District are getting rave reviews from students and teachers.

This is the first Districtwide adoption of the new reading curriculum in approximately 14 years according to Administration. A committee formed last year to select an appropriate and engaging curriculum that aligned with Common Core standards and the choice for K-6 is National Geographic Learning's Reach for Reading program. The curriculum includes colorful textbooks, classroom sets of novels and picture books, like those available at bookstores, National Geographic Explorer magazines, videos, and computerized literacy games.

For grades 7-10, the adopted program is Pearson myPerspectives literacy program.

Pearson explains on their website that, "myPerspectives is a brand new English language arts curriculum for Grades 6–12 that values the perspective of the learner, collectively and individually, and provides next-gen learning experiences that promote higher achievement and develop the competencies needed for college and career readiness. Interactive learning blends print and technology in a student-centered,

teacher-inspired classroom. This dynamic Pearson program creates an interactive, engaging, and relevant learning environment through readings, meaningful activities, and purposeful performance tasks. myPerspectives encourages social collaboration as well as student ownership of learning through goal setting, choice, and reflection."

Besides fitting in better with Common Core, the District chose the myPerspectives and the National Geographic program because they are multicultural.

"The new reading curriculum

has a robust selection of nonfiction and informational reading passages from a wide variety of authors, allowing students to experience fresh perspectives," said Dominic Scharp, a Waldport High School English teacher.

Marcy Doyle, the Reading Specialist at Crestview Heights Elementary who is also a National Board Certified Teacher and a 2019 Oregon Regional Teacher of the Year and Oregon Teacher of the Year Finalist said Reach for Reading provides teachers, students, families and schools with a vital link and strong connection to

powerful learning progressions, all focused on building a strong reading life.

"Reach for Reading provides teachers and students with a comprehensive curriculum - where our "arrows" are all shooting in the same direction with purpose and accuracy," Doyle said. "It provides teachers with an array of strategies and targeted skill work aligned to the Common Core State Standards, infused with collaborative learning strategies, filled with opportunities for student questioning, powerful discussions and connections to learning, all to assist us in growing our life-long, joyful readers.

"I look forward to utilizing the intervention lessons to help students access grade-level content collaborate with classroom teachers and help to build strong readers and writers. Teachers are working furiously to read, digest, implement and enhance all the learning opportunities provided throughout the Reach for Reading program."

Shelley Moore, Principal of Sam Case Elementary in Newport said the school appreciates the new reading material because it allows them to integrate other subjects together during reading instruction.

"It also allows us all to align with reading curriculum and with regard to professional learning to our teachers," Moore said.

Another teacher who uses the curriculum, Rachel LaMarche, Fifth Grade Teacher and TAG Coordinator for Taft Elementary said the curriculum offers stories that students can connect with.

"I also love the fact all my materials are ready to go and easily adaptable to classrooms," LaMarche said. "This program will provide a rigor and expectation that students will be successful with. I can't wait to see the growth we will gain as a district in reading."

The District reached out to Aimee Thompson, Recycling Coordinator for Thompson's Sanitary Service for suggestion on how best to take care of the old materials. Thompson found a vendor out of McMinnville, AllBooks213, who will be coming to pick up all the old materials at no cost to recycle or reuse them thereby saving the District money, labor, and helping the planet, too.

The total spent on the new materials was \$816,000. MyPerspectives (Grades 7-10) was \$164,806; \$73,668 from the district's State School Fund allocation (general fund) and \$91,138 from Measure 98 High School Success funds.

Reach for Reading (Grades K-6) is \$651,223; \$189,590 from the district's State School Fund allocation (general fund) and \$461,633 from the district's Federal School Improvement Grant.

Set number two was all Taft, as Hatton delivered another string of 10 plus points and senior Corey Van Damme controlled the Tiger offense. Taft won set two easily,

Taft let loose in the third and final set as sophomore Keeara Harmon and junior Jordan Ramsey teed up crushing shots to the Clatskanie defense to complement their stellar serving. Taft cruised to a 25-7 set win and a 3-0 sweep to

win their second game in a row.

At the midway point in the season, Taft has already matched their league win total from last year and surpassed their overall win total at three games. However, Hart foresees plenty more opportunities for victories in the second half of the season.
