Lincoln City Parks & Recreation is expanding their free outdoor fitness

options beginning this week. In addition to "Outdoor Air Fitness LIVE" Monday, Wednesday, and Friday at 11 a.m., LCP&R will host running and walking groups on Tuesdays, Wednesdays, and Thursdays.

Every Tuesday and Thursday, start-ing at 11 a.m., the new adult walking group "Coastal Cruisers" will discover different routes around the Lincoln City Community Center. Leashed dogs are welcome to participate as well.

Also on every Tuesday and Thursday, starting at 4 p.m., the new Lincoln City Youth Running Club starts. Youth runners of grades 5-8 are encouraged to stay fit and explore Lincoln City while running trails and streets. Runners will warm up together and begin their group run at 5:10. Be sure to dress for the weather, as the program will run rain or shine.

Every Wednesday, starting at 5 p.m., the new adult running group "Lincoln City Runs" welcomes runners, walkers, strollers, and pets of all abilities.

The activity starts at the Lincoln City Community Center for warm ups. Participants may run or walk at your own pace.

All group activities will be required to maintain 6 feet social distance and wear face coverings when social distancing is not possible.

No registration is required for these outdoor fitness activities. LCP&R staff will conduct a pre-screening for all participants onsite.

Lincoln County puts Phase 2 on hold

The Lincoln County Commission voted 3-0 Monday to delay the County's application to enter Phase 2 until September 29.

Additionally, at the regularly scheduled Board meeting, the Lincoln County Board of Commissioners received reports from Public Health Director Rebecca Austen, Vice Chair of the Lincoln County Public Health Advisory Committee Co-Chair Gary Lahman on the County's COVID-19 status, and an update from Oregon Health Authority Director Patrick Allen in response to questions about how and when the State will measure metrics that must be met to move forward to Phase 2 of the Oregon Reopening Plan Framework.

Austen began the discussions by providing a local update of the COVID-19 numbers. As of Sept. 1, Lincoln County had 463 positive cases, 23 hospitalizations and 13 deaths. A couple of weeks ago, Lincoln County was at a 10 percent testing positivity rate, according to Austen. The numbers for the past two weeks have yet to be finalized.

Otis fire destroys trailer, City Council remains against 24-hour lodging hold

At approximately 11:53 a.m. on September 1, North Lincoln Fire and Rescue (NLFR) responded to a report of a vehicle fire on Deer Drive in Otis.

According to NLFR Chief Rob Dahl man, the victim reported she was sitting in her fifth wheel travel trailer when she heard a loud 'pop' noise and then noticed her electric fan had shut off. The trailer was powered by an extension cord that connected to a nearby shop and after suspecting an electrical shortage, the victim walked outside to inspect the electrical cord. At that point, Dahlman said she noticed there were flames coming out from underneath the trailer.

"She said she tried to use her hose to knock down the flames, but that wasn't working, so she went back in the trailer, grabbed her dog and called 911," Dahlman said.

NLFR responded shortly after the call, but at that point, the trailer had been completely engulfed in flames. It was a total loss and everything inside was also destroyed, according to NLFR. The flames also extended to some of the surrounding brush but was quickly knocked down by fire crews.

The Oregon Department of Forestry

(ODF) responded to make sure there wasn't any threat of a wildfire and the Red Cross responded to help the victim find a place to stay.

"Thankfully nobody was hurt and we were able to surround the flames quickly to prevent its spreading,' Dahlman said. "ODF responded because they have been very concerned with potential spread given the histor-

As droves of people flood Oregon coastal towns on a weekly basis, there has been a rising concern among community leaders as it pertains to COVID-19 (Coronavirus).

This concern stems from a pair of out-breaks in Lincoln City at local hotels, Inn at Spanish Head and Surftides. Because of this, the Lincoln City City Council decided this week to revisit the topic of a 24-hour hold rule for lodging business

The Lincoln County commissioners along with the cities of Lincoln County had previously approved a 24-hour mandatory wait period for lodging staff to clean a room after it has been occupied by a visitor. Lincoln City later rescinded the rule at a June 19 meeting.

The City Council held a special meeting on Sept. 2, and allowed community members to speak, or write in comments, on the potential of reinstating the rule in town. Local representatives such as Lori Arce-Torres, Executive Director of the Chamber of Commerce, urged the council not to reimplement the rule, stating that there has been conflicting reports about how long the virus can actually live on a surface. Arce-Torres said "it's illogical to conclude that the 24-hour hold will have any positive barring on preventing the spread of the virus.

understand that the number one goal is to lessen the spread of the virus. However, we need to consider the financial impacts to the businesses who are trying hard to recover from the shutdown," Arce-Torres said.

Also speaking at the meeting were representatives from the Captain Cook Inn, who said the 24-hour hold will be financial burden for both businesses and employees of those businesses. The local business owners acknowledged the current outbreaks in Lincoln City but stated they are very limited and mostly in the food service portion of the businesses.

City Manager Ron Chandler said the Council received 53 comments since the agenda packet was published and all comments were from the lodging industry, who were not in favor of reinstating the 24-hour rule.

Councilor Judy Casper kicked off the council's discussion by addressing the conflicting information regarding the virus on surfaces, lack of data and lack of current information from health officials. However, she also stated it's better to be

New modeling shows downward trend of virus transmission in Oregon

Oregon continues to make progress this week in the fight against COVID-19 (Coronavirus), state leaders announced.

During a Sept. 4 press conference, Oregon Governor Kate Brown was joined by Oregon Health Authority (OHA) Director Pat Allen and Dr. Dean Sidelinger, health officer and state epidemiologist, to discuss the current virus trends.

OHA director Pat Allen said the state is on a clear downtrend of daily COVID-19 cases statewide. In the latest data, OHA reported a 30 percent drop in weekly cases as compared to the peak of the pandemic in Oregon.

"That's a really encouraging sign and it's validation that more people are taking seriously the guidance to wear face coverings, practice physical distancing and to limit gatherings," Allen said. Efforts of Oregonians

are working, says Allen, but they will need to keep up the pressure in order to open school classrooms for students and allow businesses to recover from the closures. Allen said social gatherings continue to be main cause of spreading the virus

"We simply cannot celebrate Labor Day, and all the holidays coming up in the fall and winter, the way we have celebrated them in the past," Allen said.

Gov. Brown urged Oregonians to make smart choices when it comes to virus, stating that three times Oregon has seen spikes in COVID-19 after a holiday weekend since the pandemic began.

Both Gov. Brown and Allen hope Oregonians will stay local as much as possible and stay in small groups. If you do plan to be

> physical distance cannot be maintain, and continually wash your hands.

Oregon has accounted for over 27,000 COVID-19 cases and 475 deaths so far. However, last week marked the fourth consecutive week that case totals have dropped, at a 8.6 percent drop from the previous week.

Testing positivity is also down to 4.4 percent, the first time since June that it has been below five percent. Below five percent is the figure needed to reopen classrooms. Allen said they are encouraged by the figures, but wants Oregonian not to lessen up.

"Any lapse in our collective vigilance or in our individual judgement can have far ranging impacts on us, our families and our communities," Allen said. "It's not just about flattening the curve, it's about keeping it flat.'

Dr. Sidelinger spoke about the newest OHA modeling that has also provided some encouraging signs. The modeling shows that each case is generating less than one other case, which

is a reason for the daily case number decrease. However, Dr. Sidelinger said there is still work to be done.

"The virus is extremely contagious, spreads very quickly and it wouldn't take much for cases to spike again," Dr. Sidelinger said.

At the current transmission rate, Dr. Sidelinger said they could see a substantial drop in daily case numbers by the end of September. As a result of the progress, the state is looking at reopening some lower risk activities, such as public pools and playgrounds. But the continued progress will depend on others' individual efforts to follow the safety guidelines.

"It's on every one of us to maintain the progress we've made to stop COVID-19 and together I know we can do it and get through this holiday weekend and keep the pressure up on COVID-19 in Oregon," Dr. Sidelinger said.

Casper also spoke about the safety concerns housekeeping staff have expressed to them. However, Councilor Mitch Parsons said he recently spoke with about 15-20 local housekeepers to poll their concern level and found that "most are more worried about their economic situation than the virus and don't wish to lose hours or work," said Parsons

Out of those individuals, Parson said only one was worried about the virus, and most felt comfortable that they had what they needed to protect themselves.

Councilor Diana Hinton spoke about a recent Lincoln County Public Health report that stated Restaurant and food service cases doubled during a one week period in August, rising from 10 to 20. Hinton said Public Health believes the virus is moving north as Newport's cases are dropping and Lincoln City's cases are rising. Hinton also noted that the Hispanic population has accounted for 52 percent of cases in

Lincoln County. "I think that's where our hard work needs to be directed, our residents that fit that ethnicity category," Hinton said.

Mayor Dick Anderson also cited some updated statistics, say that through contact tracing, the average number of individuals a positive case came into contact with was six in Newport. In Lincoln City it is 15 individuals per positive case.

"What that means is, for some reason, our folks who are positive (in Lincoln City) do a lot more socializing," Mayor Anderson said. "Add that to where outbreaks are occurring and it really doesn't surprise me...

"I don't think it's workplace, I think it's social dinners, socializing, and living conditions. I think there's a lot more to this

story. I'm encouraging us to think that this is not necessarily workplace related.'

Mayor Anderson, instead of reinstating the 24-hour rule, urged the city and the lodging industry to provide additional public service announcements to discourage extra socialization.

The council agreed to take that approach, but plans to revisit the the 24-hour hold discussion prior to Lincoln County's move into Phase 2 of reopening. The discussion will likely occur at the Sept. 24 meeting, according to the council.







Superintendent Update

The following is another update on the status of education in our school district and our plans for the Fall 2020 school year. I will use the same numbered format as the last time for clarity.

1. WHEN DOES COM-PREHENSIVE DIS-TANCE LEARNING (CDL) AND EDMEN-**TUM BEGIN?**

The answer to this question is different for elementary and secondary.

Elementary CDL -Sept 14-Sept 25 is when teachers and families will be getting together to talk about Comprehensive Distance Learning and what each student needs to be successful. The whole group lessons start Monday, Sept 28. Students will be provided instructional materials for students that will be accessed online for the Sept 14-25 time period.

Secondary (7-12th grade) CDL - Sept 10-11 is when teachers and students will be gearing up for Comprehensive Distance Learning and the students will be logging on. Instruction begins Monday, Sept 14, because high school students need to log in many hours of instruction to receive credit.

Edmentum, the K-12 fully online program our schools offer, begins instruction on Sept 14 for all grades. There will be an orientation for elementary students using the Edmentum learning platform on Sept 10-11. More information on this to come soon.

2. HERE ARE THE DE-**SCRIPTIONS OF THE TWO EDUCATIONAL MODELS THIS FALL:**

Comprehensive Distance Learning (CDL)

"Since about mid July, our positivity rate has been climbing, to the point where a couple weeks ago we were at 10 percent... that's not good," Austen said. "We need to be at five percent to meet the metric. We're not seeing a decline yet, which is something we'd want to see before we make any moves to open up any further."

The age demographic of positive cases is led by individuals in their 20s, with the second most being 80 years old and up. Austen said those cases have been likely spread through workplaces (younger age) and assisted living facilities (older age). On a positive note, Austen said through contact tracing they have noticed that sporadic cases (unknown source) have dropped.

Commissioner Kaety Jacobson asked Austen about contact tracers, as the Public Health sent out a call to action

moving too fast," Lahman said. "We are glad that you have slowed down a bit. It seems like you have. And, we follow very closely what the Commissioners are going to do moving into Phase 2."

An email to the board from Oregon Health Authority Director Patrick Allen, indicated OHA wants to see the positivity rate stable or decreasing. He said it is also "necessary that all six metrics be met, though there is still room for judgement calls."

The County does not currently meet all six metrics in the Phase 2 Reopening Criteria.

After careful consideration of the County's current situation, the likelihood of increased concerns over the busy labor day weekend, the convergence of the flu season with the continued spread of the disease in the County and the desire to proceed cautiously to assist the reopening of schools to in person education, the Board voted unanimously to delay the request to move Lincoln County into Phase 2 until September 29, 2020.

"I will move that we delay our application until 29th which will be consistent with our twenty-four-hour hold period," Commissioner Doug Hunt said. "We can go backwards and move that date backwards if we want, but this will give us time to gather additional data, to look at the impact of Labor Day, look at the impact of flu season and to try and get our schools open."

Commissioner Jacobson added she would like to add a friendly amendment to Commissioner Hunt's motion.

"The week before our September 29 meeting we try and have our Board of Commissioners Meeting with the Oregon Health Authority's Director Allen or a person of his choosing, so that we are not in the situation of trying to understand if we meet the criteria," Jacobson said.
