

NOTICE OF ADOPTION

The Charter Township of Huron Code of Ordinances has been amended as follows:

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CHARTER TOWNSHIP OF HURON BY AMENDING SECTION 530-34(C), SECTION 530-35(B) AND (C), AND SECTION 530-38(B) BY ELIMINATING PERMITTED PRINCIPAL LAND USES AND SPECIAL LAND USES FOR WAREHOUSING AND MATERIAL DISTRIBUTION CENTERS AND TRUCKING AND TRANSIT TERMINALS AND RENUMBERING THE REMAINING SECTIONS

The Charter Township of Huron ordains:

Section 1. Ordinance Section 530-34(c) shall read:

Subsections (C)1-15 shall remain the same; Sections (C)16 and 18 shall be omitted; former Subsection (C)17 shall become (C)16, and Subsections (C)19 to 21 shall be renumbered (C)17, 18, and 19, respectively.

Section 2. Ordinance Section 530-35(B) and (C) shall read:

Subsections (B)1 through (B)7 shall remain the same; subsection (B)8 is omitted; former Subsection (B)9 through (B)11 shall be renumbered Subsection (B)8, 9, and 10, respectively. Subsection (C)18 is omitted and subsection (C)19 is renumbered to (C)18.

Section 3. Ordinance Section 530-38(B) shall read:

Subsections (B)1 through (B)16 shall remain the same; Subsections (B)17 (a) and (b) shall be omitted; former Subsections (B)18 and 19 shall be renumbered to Subsections (B)17 and (B)18, respectively.

Section 4. Severability. If any article, section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity of such article, section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

Section 5. Repealer. All ordinances, resolutions, or orders, or parts of ordinances in conflict with the provisions of this Ordinance to the extent of such conflict, are hereby repealed.

Section 6. Effective Date; Publication. This Ordinance was approved and adopted by the Township Board of the Charter Township of Huron, Wayne County, Michigan, on September 9, 2020. This Ordinance shall be effective seven (7) days after a "notice of adoption" has been published in The News Herald, a newspaper having general circulation in the Township.
