Siuslaw cross country capture state title

"It doesn't get old," Head Coach Chris Johnson said.

For the eighth time in program history, Siuslaw's boys cross country team hustled its way to the top of the podium as state champions. The seven-person squad of Henry Stone, Bentley Nelson, Ezra King, Camden Linton, Kale Jensen, Sailor Jensen, and Yair Brito Xilot earned a state title, scoring 88 points, the first time atop the state since 2022.

The 3A OSAA State XC Championships were held at Lane Community College in Eugene on Nov. 8, and for the Vikings, competing at the highest level is nothing

"These guys have been there before; it's not a novelty for us to get over there," Johnson said. "It's a little bit different to go over there when you're supposed to win. It's a whole different mindset, and a little different level of stress when you're the favorite. But also, it's pretty comforting, because you'd never trade an inferior team for a better team."

Johnson said the team

Berkner Trial postponed again

Though scheduled for trial Nov. 13, Keith W. Berkner, of Florence, will likely stand trial in Lane County Circuit Court on charges of sodomy and sexual abuse of children sometime in 2026.

Berkner was arrested Dec. 27, 2024, after Florence Police Department received and investigated a report of possible sexual abuse of a juvenile.

"From that investigation, Keith Berkner was developed as a suspect in the case," a Florence Police Department release stated after his arrest. "On [Jan. 22] a search warrant was executed on Berkner's residence, where Berkner was placed into custody and later transported to Lane County Adult Corrections."

Berkner is charged with Sodomy in the First Degree and Sexual Abuse in the First

Charter School begins renovating future home

Siuslaw Valley Charter School Directors and volunteers have already begun working to rebuild the former Rite-Aid building at 35th Street and Highway 101 into Whitmore Classical Academy with the goal of opening next fall.

Inside the building on November 11, Director Chuck Trent showed the layout as currently planned, with a central area for assemblies, surrounded by classrooms. The central area already has a raised ceiling with a lot of space below. **SVCS** Chief Operating Officer Jennifer Waggoner said the area

will have many uses. "We will use that for

our morning assembly, and then we will use it for any kind of indoor play, when our classes are full we might do art in there and have a rotating schedule with music, PE and Spanish, so we haven't fully defined how

Medicare Annual Wellness Visit Wrap-up

Success! This brings back memories of watching the crime fighting "A Team" on TV. When they wrapped up their weekly case, we could always depend "Colonel Hannibal Smith", one of the main characters to exclaim, "I love it when a plan comes together!" I feel exactly the same way with finally clarifying what we patients should expect when going to our healthcare provider for the Medicare Annual (FREE) Wellness Visit...in PeaceHealth's own words. Actually, it is basically the same as I suggested in my last article about it...only respond to your provider to answer their questions which will be coming from the Medicare Wellness document. That

will keep your Wellness Visit (FREE). When your provider is finished with those questions, you may proceed with asking questions/concerns YOU may have regarding YOU.

My suggestion is to keep this article from the Siuslaw News for future reference in answering questions about how the Medicare Annual Wellness Visit (AWV) is handled by PeaceHealth in Florence. Now I will add several qualifying statements: This is the status as of November 11, 2025, as I write this. Also, expect slight personal variations in administering it. Our healthcare providers are not robots and we are not trying to make robots out of them.

With that introduction. here is what to expect. First, for the patients who have experienced a previous AWV, you will be waiting a full year before becoming eligible for your next one. That will be me, since I had my first AWV this past January.

For those who have not had their initial AWV you may be invited to enroll in it two ways: One would be a phone call from PeaceHealth and the 2nd would be upon walking into your provider's examining room for something else that brought you to see him/her. Either way you should get the same information.

Now, using myself as the patient and using a script that PeaceHealth provided to staff involved in conducting the AWV, I walk into my doctor's examining room with a complaint for him to diagnose/treat. He greets

me and continues: "I see you are here today for hip problems, and I also noticed you're due for your Medicare Annual Wellness Visit. We can take care of both concerns today if that works for you. The Wellness visit is a yearly check-in where we focus on prevention, screenings, and your longterm health goals. Then, we'll shift to talk about the specific concern (hip problems) that brought you in today. Just to clarify, Medicare fully covers the AWV. However, since we're also addressing your medical concern today, that part will be billed separately, depending on your health insurance coverage. We want to make sure both your preventive care and current needs are addressed properly."

These words spoken by my doctor shows he knows how to handle each visit in one appointment – preventive care (Wellness) and current needs. I would tell my doctor to get all the information he can and to proceed with both. Now, here is a real live up-todate AWV. I went with Marianne today, Nov. 11, 2025 for her initial AWV. The doctor's assistant of course came in first. Marianne had some concerns of her own, so the assistant clarified that she wanted to do both visits today. After doing her regular visit preliminaries, he proceeded to ask questions from the AWV. This only took about 5-6 minutes and included questions like weight, hours of sleep, exercise, hearing, vision, servings

of vegetables per day, etc. With that, he left to get the doctor for the current issues Marianne needed to talk about. That was the gist of the AWV.

When her doctor came into the room, he went straight to her concerns and never mentioned the AWV. Good job – one appointment - two sessions – one FREE for Medicare – one for personal concerns.

Additional scripting for staff reminds them to educate patients on the benefits of AWV. "Explain the benefits of AWVs to patients, emphasizing comprehensive care and preventive measures. Make sure they understand that addressing both wellness and problem-based issues in one visit can be beneficial."

Hundreds of Siuslaw High School students gathered respectfully and attentively in the school gymnasium on the morning of November 7 to honor local veterans. About 40 veterans joined

the students in the gym. Planning for the event began early in the school year, according to leadership teacher Sara Mann. Many of the students in the leadership class were involved in the planning, with senior Danin Lacouture assuming primary responsibility. Junior Stella Duman worked closely with Lacouture with the expectation that she will be the lead coordinator next year.

The ceremony began with the presentation of the colors by the U.S. Coast Guard. KCST broadcaster and military veteran Wayne Sharpe then asked all veterans in attendance to stand and be recognized based on the branch of the military in which they served. Among those recognized were several Siuslaw High School staff members.

Coast Guard Veteran Jay Nilles lit the candle on a special 'Fallen Comrade' table that had



The table was small and round, representing the frailty of one person alone against their oppressors and the fact that concern for them is never ending. The white tablecloth showed the purity of the men and women who answered their country's call to duty, while the empty chair representing all who could not be there. There was also a red rose as a reminder of the families left behind, a yellow ribbon for the everlasting hope of a joyous reunion, a slice of

lemon for the bitter fate of those lost, and salt for the tears of their families. An upside-down glass served as a reminder of all who were not there to join in

a toast. Devin White, U.S. Army Veteran and Assistant football and wrestling Coach at Siuslaw High School, spoke passionately about the many benefits of military service: the power of purpose, education and career opportunities, leadership, belonging, and the development of values such as integrity and courage. A scow was used to float the piano from Acme to the South Slough, which proved easy enough. From there it was loaded onto a wagon to be pulled by horses to the lake. As lookouts and helpers, men followed the wagon on foot, singing and whistling while guiding the cargo on the narrow, bumpy road. At the lake, a second scow awaited. With incredible effort, balance and careful

steps, the men transferred the piano from the wagon to the second scow. After a short trip on the lake the scow was docked at the homestead's wharf. A make-shift sled was hitched to a team of horses prepared for the final walk to the homestead. However, it became immediately clear the wharf and hilly path were too narrow for the team of horses. Once again, the men hoisted the piano and managed to carry it step by step onto the sled. Finally reaching the homestead, the piano was safely carried into the house. A celebration of triumph with food, music, friends and neighbors went on for hours. And that is how with neighbors helping neighbors, the pioneers overcame what first appeared to be an almost impossible task.

As we approach the upcoming Holiday, we are reminded to be thankful for family, friends and neighbors who make up the best part of our lives.

First Stamp gives back

"Experiencing other countries in person gave us a new level of knowledge and appreciation." That was the sentiment unanimously expressed by seven Siuslaw High School students who have each participated in a twoweek, all expenses paid trip to Europe. The local organizer is Faiza Serang, a thirdgrade teacher at Siuslaw Elementary School. She attended school in Reedsport with Ms. Fagnan and is now involved in recruiting local girls as well as helping to plan and lead some of the trips.

In Oregon, the schools included in the program are in Florence, Reedsport, Mapleton, Powers, North Powder and Baker City. The Siuslaw High School girls are Lilyana Clemons, Charley Johnson, Ezra Haberly, Emma Meier, Kortni Todd, Abby Jones and Danin Lacouture. The process, as they described it, was to attend an informational meeting at Siuslaw High School and then apply for the program. Once selected, they began preparing by getting passports, learning about the countries they would be visiting, and acquiring

the necessary travel items (many of which were supplied by First Stamp).

Students from all three states met in Texas where they met, formed friendships, and prepared to travel overseas. They were joined there by mentors and trip leaders from Trinity University. The girls then traveled to Paris, and one other location: London, Dublin or Rome. Their itineraries were filled, but there was also time for unexpected adventures. Highlights of the trip for the Siuslaw girls included meeting new people (fellow travelers, mentors, and residents of the countries they visited); forming new friendships and long-term bonds; trying new foods and experiencing different cultures; learning how others view America and sharing their own experiences as Americans with others. The girls also learned to coexist with people they

didn't know well, and to solve unexpected problems as they arose.

In the previous years, most of the girls who applied were selected. This year could be different. The number of interested girls has grown, and the organizers may have to make difficult decisions among qualified applicants. The introductory meeting for Siuslaw students was held on the evening of November 4 in the school library to a full crowd of parents and students. The application period opened on November 15 and closes on January 15. Each girl will complete an application form and make a video of herself. Those fortunate to be selected will be fully funded for the trip, including airfare, lodging, meals, activities, and even spending money, making this a truly unique opportunity. Degree, both felonies. If convicted, the maximum sentences for the two

offenses are 70 months (25 years) and 75 months (10 years) in prison. Since his arrest, he has remained in custody at Lane County jail.

According to court records, Berkner entered a not guilty plea to the indictment on Jan. 29.

At the time of arrest, Berkner was listed online as the owner of Keith Berkner Home Daycare, a license-exempt childcare provider in Florence.

At a Feb. 27 pretrial conference, Berkner waived his 60-day trial right and that a new pretrial conference date was

set for April 7, alongside a trial date of June 24. A postponement motion was filed on June 18 and the trial was set to begin at 9:30 a.m., Sept. 9 in Lane County Circuit Court, but was postponed again on Nov. 13.

Court Calendar staff say the trial date has not been set officially but will most likely be held over until next year.

we are going to have that flow," she said.

Trent said the bathrooms would be placed according to the current plumbing in the north west corner of the building, rather than cutting and installing pipe across the concrete floor.

Waggoner said it was initially thought that kindergarten classrooms would be best by the front door, but said it was instead decided to have them at the rear of the building closer to the bathrooms and a proposed back door drop off area.

While discussing the lack of other adequately-sized commercial buildings in the Florence area,

Waggoner said the former Rite-Aid location wasn't on the radar at first.

"Initially we said, 'probably not,' but then we came over and looked at the number of ingress and egress points and how the building could be laid out for a school and thought, this really does make sense," she said.

Trent remarked that the new activity in and around the building has generated a stream of visitors, curious about what was happening there.

Still inside the building are a variety of shelves and display cases, which Trent said will be for sale. If interested, contact Kay King at 541-999-0067.

MORE, SOONER

While it was recently announced that the school would open hosting kindergarten through third, Trent explained that it may be better to build fourth

of the new school. and fifth grade classrooms at the same time.

"Our original thought was that we would only build these classrooms out because we were going to do K through 2nd," Waggoner said. "Then we added in 3rd... and the more we looked at savings, and the cost of doing everything at once, we think we are going to build out 4th and 5th, not anticipating having 4th and 5th on the first year." She said that plan will give extra flexibility, as well as a year to fine-tune operations and extracurricular activities like music and art classes.

SVCS's long-term plan is to teach classical education up to 8th grade, but no plans have been disclosed to expand to high school education. At full buildout, the new building is expected to only hold K-5 classrooms.

"We'll get K through fifth grade in here, and then we can either add on,

which I think is way too expensive, [or] I think we would really look at lease space for sixth seventh and eighth [grades]," Trent said, "because that would be smaller, I think we'd have better opportunities to find a commercial space."

With the entrance on the top right, this drawing shows the planned layout

Trent said several parents pushed for the school to open with K through 3rd grade classes, rather than the originally-planned K-2. After looking at timing and buildout costs, it was decided that would work best, he said. At another meeting last month, it was noted that K through 3rd would also be better for parents who may have more than one child around that age, rather than dividing them up.

"It also works well for next year when we bring in fourth grade, because we have all these students together, moving up a grade," Trent said. "When we stopped and thought about it, it was 'that makes

the most sense,' so I think it's going to work out

PLAYGROUND

The outdoor playground is expected to be built on the south side of the building in the wider parking area. Waggoner said that on the map, the playground area will seem small, but in person, it seems more than adequate.

"Half of it will be covered and the other half will have the equipment," Waggoner said. "This will probably be phase 2 or part of a separate capital campaign. For now, it will be a fenced-in safe area."

"That's about \$1.8 million to do all the exterior, signage, plus the playground and the covered structure," Trent added.

"We've put lots of thought into this, but it's getting revised every week," Waggoner said, showing prospective drawings of the exterior and layout. Trent said they have been regularly meeting with builders to fine-tune plans regarding class sizes, amenities and interior flow.

TRAFFIC MANAGEMENT

Trent said a traffic study is being done and information is being sent to the City of Florence, but until the scope is agreed upon, it won't be known. It's expected that traffic may file in on 34th Street. as well as Pine Street. A drive-through window on the west side will be removed and could serve as an entry for some kindergarten students and Special Education students. Trent and Waggoner said the building has more than enough parking to allow parents to park in the lot and walk their kids into the building.

According to the approved contract between SVCS and Siuslaw School District, a student may obtain transportation on district buses, only if those buses directly pass Whitmore Academy.

Waggoner said that in talking to other charter schools, many are not able to provide transportation.

"They haven't found that they really needed it, for the most part," Trent added, noting that the dynamic may change when more grades are added. However, for kindergarten through third grade, most parents typically drop their children off in person, he

When asked, Trent said a traffic guard will be posted at the location during pick-up and drop-off times.

"That's where we would really like to use volunteers from the community to help us out," Trent said, noting that the expected traffic volumes will be far below those experienced at Siuslaw Elementary School.

Trent remarked that Waggoner should don the DayGlo vest and stop sign on the first day.

"I literally cannot wait for the day where I can go out there and open car doors and welcome kids," Waggoner said. "I can't wait."

At the beginning of the cross country season, it almost seemed the Vikings might not field a girls' team. It looked like theweight of taking on both soccer and cross country might make it impossible to field a team.

"This year, most of the girls coming up were all cross country runners and soccer players who just weren't sure they wanted to do both. So we were really worried about having a complete team," Head Coach Chris Johnson said. 


"The lessons they learned throughout the year were far more significant than winning or losing playoff games,



of the day and say I gave everything I had to this football team and I'm proud of that, no matter what happened at the end of the year.

The teams traded oneyard touchdowns in the first quarter, each punching in the two-point conversions to make it 8-8 through the first stanza. Jaxon Chiang punched in the Vikings' score, matching Gervais' Johnny Mariano.

But there wouldn't be much matching Mariano for long. The senior running back for Gervais proved to be a wrecking ball out of the backfield, punching through the Viking defense time after time, and he racked up six touchdowns on the day.

For their part, the Vikings never gave up. Will Johnson scored a 90-yard kick return in the second quarter to tie the game up at 14s before Mariano answered to put the Cougars up 22-14 going into half. In the second half, Will Johnson and Micah Blankenship both caught touchdowns from Jericho Lake, but it was ultimately Gervais' day, and they advanced to take on Douglas in the quarterfinals.

The game was a battle in the trenches, with both teams fighting to out-physical the other. For Johnson, it was impressive to see another team put in the dirty work like the Vikings usually do.

"There aren't many teams that are willing to play the brand of football that they were willing to play on a Friday night," Johnson said. "It's unsexy football, where in today's day and age people don't really want to dink and dime you for five yards here, five yards there."

Over Johnson's

seven-year tenure at the helm, he has prided his team on playing hard-nosed, blue-collar foot-ball. Johnson said his team is happy to chip away at teams and wear them down, willing to take three-yard chunks one at a time until they earn a first down. In this particular game, though, Gervais was content to go right back at Siuslaw with that same style.

"They were able to do that to us. Our kids kept battling and battling, and it's weird because it was a fun game to be a part of, because you're watching two really hard-nosed teams go at it," Johnson said. "Not many teams and coaching staffs are willing to do that. So, it's a huge kudos to their coaching staff for getting 40 young men to buy into the same message that we try to give our kids every year."

Gervais won with a gritty, "unsexy" approach, and Johnson credited the Cougars for controlling the line of scrimmage throughout the game.

Johnson said that when the final whistle sounded, it was emotional to think about the season ending. Part of what this conclusion tough was the goodbye to the program's seniors that the loss signified.

"I have had incredible groups of seniors come through Siuslaw for the last six years. This senior class was a little different. They were really good football players, really talented, and there's a huge group that is getting college offers," Johnson said. "The thing that I'm going to miss that sunk in really quick, Friday night, was the type of people they are and the culture we've been trying to build since I got the job here."

Johnson said this group was integral not only in getting the team back into the playoffs each season and instilling a winning culture on the field, but also in creating a framework for the team off the field for life beyond football.

"We've tried to take it one step further inside our program to make sure we're graduating really good kids, that we're academic all-state every single year, that we're teaching kids the right way to operate in life," Johnson said. "That's what sunk in, was what a great job they did for the last 10, 11 months of doing that, and cultivating a culture within our locker room that will far outlast them."

The team's motto this season was "brother-hood over outcome," and Johnson said the team lived up to that refrain. Though the team was in tears after the loss, it wasn't just the chance at a championship they were mourning; it was also the loss of time to practice or play together.

For Johnson, one thing

he'll remember from this group is the way they took advantage of every chance they got together. Johnson had the privilege of coaching his little brother, Will Johnson, with this group, and he'll cherish that experience.

"It was my little brother's senior year, and so it was really easy for me to be in the moment because you show up every day and you're hanging out with a group of kids that grew up at your house when I was in high school," Johnson said. "And that, going forward, is just making sure we're not looking at next week, we're not looking at the end of the year, we're not looking at the playoffs or a rivalry game three weeks away. We're living on a Monday in the mud together, and embracing that. And I think that's the biggest takeaway I'll take away from this team: they taught me to live in the moment better than I ever dreamed I could."

Pain Persists Around Puncture Site After Medical Procedure

DEAR DR. ROACH: Nine days ago, I had a medical procedure under general anesthesia. One of the lines was put in the artery in my left wrist. Aside from deep bruising that went halfway up my forearm, it seems that there is some nerve damage. I have constant pain from my thumb, through my wrist, and up to about 3 inches on my arm. Overnight, the pain becomes intense and radiates all the way up to my shoulder

Tylenol and an arthritis sleeve only provide minimum relief. Should I request to see a neurologist, or is there another type of doctor to seek out for a diagnosis? This has become life-altering, and I'm hoping it will eventually be healed. — B.F.

ANSWER: I suspect that the bruising on your forearm was caused by bleeding from the puncture site of the artery in your wrist. (This type of line is used to measure blood pressure accurately and instantaneously.) The hematoma (blood collection) inside the wrist might be compressing the median nerve in your carpal tunnel, which causes a neuropathy very much like carpal tunnel syndrome.

If I am right, then the condition should improve as your body absorbs the blood, which takes pressure off the nerve. However, there are case reports of permanent damage to the nerve from complications of an arterial puncture. In general, if the nerve compression is serious enough to cause weakness, it needs to be acted upon urgently.

The doctors who performed your procedure need to know about this complication, and a neurologist is exactly the right person to see. A simple nerve test could confirm my suspicion or disprove it by finding a different cause if your

symptoms persist.

DEAR DR. ROACH: I'm an active 60-year-old who took a soccer ball to the groin some time back. After a few months, I noticed a change in my sexual organ. Narrowing and bending of my organ developed, and it seems to be getting worse.

My general doctor seems to think it's Peyronie's disease. After researching this, I started taking vitamin E and COq10 supplements. I scheduled a urologist exam but was hoping for some insight on this.

ANSWER: I suspect your general doctor is correct, and an evaluation by a urologist is certainly indicated. Peyronie's disease is often triggered by trauma in a person who is genetically susceptible to the condition. (Your trauma was very clear, but it isn't always clear in everyone what the trauma might have been.)

The diagnosis is made by an examination showing a bend in the penis, along with plaque that can be felt during an examination in most cases. Some men, but not all, will have pain.

In men who are in the active phase of the disease (where the curvature is getting worse), urologists will often prescribe pentoxifylline for three to six months in hopes of stabilizing the condition and preventing the curve from worsening.


Vitamin E was not found to be superior to a placebo treatment. CoQ10 was found to have a benefit in a small trial, and since it is very safe, this was a reasonable treatment for you to try.

Depending on your symptoms and degree of curvature, there are several options for treatment. Medication can be injected directly into the penis; men treated with this were found to have about a 34% improvement in curvature. Traction therapy is also frequently used.

In men with more severe disease that does not respond to the previous options, surgical treatment can be considered. This should be done in men whose sexual function is affected by the disease and in cases where medical treatments have failed to improve their symptoms adequately.




