On April 28, 2015, Southern Illinois University Carbondale received your Freedom of Information Act request for a police report.

However, portions of the information you requested are expressly exempt from disclosure.

Pursuant to Section 7(1)(b) of the Freedom of Information Act (5 ILCS 140/7(1)(b)) certain portions of the documents have been redacted because they are “private information” as defined by the Act, including without limitation social security numbers, personal addresses, personal telephone numbers and the like.

Pursuant to Section 7(1)(c) of the Freedom of Information Act (5 ILCS 140/7(c)) dates of birth have been redacted because provision of that information is considered an “unwarranted invasion of personal privacy.”

You have the right to have the response to your request reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. (5 ILCS 140/9.5(a)). You can file your Request for Review with the PAC by writing to:



Please note that you must include a copy of your original Freedom of Information Act request and this response letter when filing a Request for Review with the Public Access Counselor.

Offense / Incident Narrative

On 04/23/2015 at approximately 13:09 hours, SIU College of Engineering Office Manager, Lori A. Williams (W/F D.O. B.) reported a disturbance in progress located in the Engineering Building Room E102. Officer Bryant, Sergeant Willmore and I, Officer Tuthill responded to the call.

Upon arrival, the disturbance was over and the involved parties had been separated. Officer Bryant and I spoke with SIU Associate Professor Alan J. Weston (W/M D.O.B.) . Weston stated that he was instructing a class that SIU student Ryan L. Wynne (B/M D.O.F.) was giving a presentation in. Weston stated that Wynne was going too fast and he advised Wynne that he needed to slow down. Weston continued, stating that Wynne raised his voice and tried to speak louder showing disrespect. Weston decided that he and Wynne needed to leave class and report to the Dean's Office. While walking to the Dean's Office, Weston stated that Wynne became verbally aggressive and approached Weston. Weston stated that Wynne was approximately five inches from his face and at this time Weston leaned forward closer to Wynne. Weston said he then backed away and continued to the Dean's Office. Once in the Dean's Office, Weston stated that Wynne approached SIU Professor Frances J. Harackiewicz (W/F D.O.B.) . Weston stated that Wynne got into Harackiewicz's face and he decided he needed to separate them. Weston said he placed his hand in front of Wynne and told him that he was disrespecting a female. At this time, Weston stated that Wynne pushed him and he fell over the desk. Weston stated that he was not hurt and did not require any medical attention.

Sergeant Willmore spoke with SIU Student Ryan L. Wynne. Wynne stated that he was in design class giving a presentation when Dr. Weston began being rude and clapping his hands.

Wynne said that he was advised by Weston to go to the Dean's Office. Wynne stated that on the way to the Dean's Office, Weston approached him and got into his face. Wynne stated that he continued to the Dean's Office where he met Harackiewicz. He then continued saying that with Harackiewicz's permission he began to tell her what happened. Wynne then demonstrated to Harackiewicz how Weston had approached him and got in his face. At this time, Wynne stated that Weston jumped up and yelled "your talking to a lady" and violently pushed him down into a chair. Wynne stated that he reacted to this action by pushing Weston back causing Weston to fall over the desk.

SIU student Blake C. Jerrells (W/M D.O.B. [REDACTED]) witnessed the altercation. Jerrells stated that he was working in the Dean's Office when Weston and Wynne arrived. He stated that Harackiewicz came into the office and that Wynne began explaining to her what occurred. Jerrells stated that Wynne was demonstrating how Weston had gotten into his face. Jerrells then stated that he observed Weston push Wynne into a chair that was placed behind him. Jerrells stated that Wynne reacted by pushing Weston back and that Weston flipped over the desk and onto the floor. Jerrells then stated that they separated Weston and Wynne until the Police Department arrived.

Wynne, Weston, and Jerrells were given voluntary statements to complete. Statements were completed and are attached to this report. Wynne requested to pursue charges on Weston as a result of the incident. Weston was asked to leave the Engineering Building with Sgt. Willmore, Officer Bryant and I. Once outside the Engineering Building, Weston was taken into custody and charged with Battery. Sgt. Willmore placed handcuffs on Weston, they were checked for proper fit and double locked for Weston's safety. Sgt. Willmore performed a search incident to arrest. At approximately 1410 hours, Weston was transported to the SIU Police Department for processing.

At approximately 1509 hours, I read Weston his Miranda Right's. Weston stated that he understood the rights and signed the form. Weston was photographed, fingerprinted and issued citation number 10703 for Battery. Weston posted One Hundred and Sixty Dollars cash for bond and released from the SIU Police Department. At 1635 hours the bond money collected was placed in the second shift box as instructed by Sgt. Russell. Weston was given an SIU Unpaid Administrative Leave notice upon his release and advised that he was banned from any SIU property. Weston acknowledged that he understood and signed the attached letter.

BATTERY

On Friday 04/24/2015 at approximately 1105 hours, Officer Bryant and I, Officer Tuthill reported to the Engineering Building Room E102 to perform a follow up investigation of Weston's previous behaviors.

As we approached room E102 we were met by SIU Associate Dean Lizette R. Chevalier (W/F D.O.B.) I explained to Chevalier that I was investigating the behavior of Weston prior to the battery incident. Chevalier invited Officer Bryant and I, into her office. Chevalier stated that she had documented concerns about Weston's behaviors. Chevalier said the concerns were reported by some of the students that Weston was teaching. Weston also stated that she had received an e-mail from SIU Student Austin P. Peterson (W/M D.O.B.) Chevalier provided a copy of the e-mail to me to be included with this report (see attached e-mail). Chevalier also identified SIU student Jared W. Wagoner (W/M D.O.B.), SIU student Jacob W. Kreeb (W/M D.O.B.), SIU student Edward J. Kretch (W/M D.O.B.), and SIU Researcher Adam W. Sims (W/M D.O.B.) as the people that reported the behavior to her. Chevalier stated that these students were getting ready to start a class if we would like to speak with them. At this time we left Chevalier's office in an attempt to make contact with these students. Chevalier, Peterson, and Wagoner returned to her office at this time. Chevalier stated that she would contact the other students and have them report to her office. Peterson and Wagoner were separated and placed in separate rooms.

Peterson stated that he understood and would provide a statement if needed. Peterson explained that on 04/22/2015 during his 1100 hours class, that he observed Weston acting abnormal. He stated that Weston talked about cheating and expulsion. Peterson said that Weston continued talking about moles causing sink holes and killing people. Peterson reported that Weston continued talking about astronauts in space and how the government could listen and watch him through antennas in his thumbs. Peterson also stated he witnessed Weston become angry when a student displayed a cell phone. Peterson stated that Weston said he would break it and that the student could break his nose climbing stairs. Peterson said that Weston stated something about a bomb being on a plane and that everything Weston said was random and unusual for him. Peterson stated that he was concerned

There after, even clapping my hands together to get his attention but he continued to talk and did so with ~~as~~ a high tone of voice, at that moment I asked him to come w/ me to Mr. Dean's office, accordingly he proceeded up the steps and by having complained over *loud voice speech (but nothing wrong with it)

being clapped at he started getting more and more aggressive as time went on. By the time we made it to the twin doors at the top of the double deck of stairs he was verbally aggressive and telling me that I was out of order and ("totally") disrespectful to him, he sort of menacingly stood intruding upon my comfort zone so when his face was about five inches from mine. At that point I raised my head and asked him if he understood what respect was as I inched forward towards him, in self-defense - I backed off --

... and said "let's just go to the Dean's office, this is kinda like high school." So we walked together to the Dean's office and took seat in the reception area where he sat by the door and I sat to his right. I got my right over. After a minute or so, Dr. Harackiewicz entered the Dean's office and the project manager (sometimes I can't remember names so well). He stood up facing Dr. Harackiewicz and started raising his voice toward Dr. Fran Harackiewicz (Fran, is my co-teacher in Engineering Senior Design classes), he started getting louder and got right up to Fran's face and was really about 4-5 inches from her face while complaining about having been disrespected. So, I stood up and placed my right hand between him and Fran to stop him and asked him to move back. At which point he shoved and punched and I fell back and back-flipped (sort of) over the receptionist's desk, then tumbled and off the front of desk of student worker whom was sitting at the desk and stood back up, whereupon the SIVC PD officers were called to the Dean's office complex.

Alan very swiftly got out of his chair and pushed Ryan by his shoulders back into the chair saying she's a lady. Ryan pushed Alan saying I told you not to touch me and sent him over the desk. I called 911 to report a fight. It had escalated very rapidly.

about the behavior and that after class he reported it to Chevalier. I asked Peterson if he had observed any of this behavior previously and he replied "no" that Weston is normally a pretty nice guy but on this day he was really out of character and that it happened all at once. I then spoke with Wagoner.

Wagoner stated that on Wednesday 04/22/2015, Weston began class by banging on the table. Wagoner stated that Weston had never done this before. Wagoner continued saying that Weston began talking about cheating and how if the students wanted to, they could sell the exams and fund gangs in Chicago. He continued stating that Weston made what sounded like a threat to a student that had a cell phone out. Wagoner said Weston stated that the student might break his nose. Wagoner said Weston talked about gods, moles, angels and growing up in France. Wagoner then said he observed Weston slap his own butt multiple times. Wagoner stated that Weston spoke about antennas in human thumbs and that Weston spoke about a bomb on an airplane and people being dead. Wagoner stated that he had not observed Weston having this kind of behavior prior to this class and was unsure what was going on.

Jacob Kreeb was the next student that I spoke with. Kreeb said that while in class on Thursday 04/23/2015, Weston made statements about a presentation that Kreeb had given. Kreeb stated that Weston's comments were unrelated and that the tone of Weston's voice became harsh and angry. He said Weston stated that vehicle headlights were made to look at license plates and get in people's eyes. He said that at one point in the class Weston quickly approached the group making him and others feel uncomfortable. Kreeb stated that when his class had ended he decided to sit in on the next presentation. Kreeb said that during this presentation, Weston started clapping and yelling at the project manager. Kreeb stated that Weston and the project manager eventually exited class to report to the Dean's Office. Kreeb stated that he had never observed Weston behave like this prior to this day and is not sure what was causing the behavior. Kreeb stated that another student Edward Kretch was also present during the initial class.

Kretch stated that on Thursday 04/23/2015 he was involved in a group presentation for a class taught by Weston. Kretch stated that Weston advised them that they were proceeding through their presentation to fast and needed to slow down. Weston then advised the group that their project could be done for a lot less money and a client would never purchase the item. Kretch stated that Weston spoke about vehicle headlights being used to look at license plates and get into people's eyes. Kretch stated that Weston spoke about previous vendor's making headlights like the one being presented. Kretch stated that the headlights were brand new for 2016 and no previous vendor was available. Kretch stated that he left class and informed Chevalier of Weston's behavior toward the class and group. Kretch stated that he has never seen Weston act in this manner before and he did not feel

comfortable with him acting that way.

After Kretch, I spoke with Adam Sims. Sims stated that he sat in on a group presentation and observed unusual behavior by Weston. I asked Sims what behavior he observed. He stated that Weston made references to headlights reading license plates and looking at people's faces. Sims stated the Weston continued on speaking of non relevant issues making the presentation hard to follow. Sims stated that Weston eventually returned to normal composure and complimented the group. Sims stated that he had spoke with Weston the previous day but saw no signs of unusual behavior until this class.

Peterson, Wagoner, Kreeb, Kretch and Sims all agreed to provide a written statement of what they observed. Voluntary statement forms were completed and are attached to this report. At approximately 1217 hours, I collected the written statements and returned to the SIU Police Department.

Weston was then distracted by a student who was on their cell phone and told them to put it away. Weston then was distracted by another student who had their cell phone out and told them to put it away or he was going to break it. Weston then went on talking about respect and consequences. Weston stated that there are consequences. He stated that when you fall down the stairs bloodying your nose is a consequence. Weston then stated he did not understand why pencils had sides because they left a dent in his finger. Weston then went on about how they are taking cursive writing out of schools and how people who write in block letters are block heads. Weston then began talking about class related materials but got distracted by "mols" (molecules). He then went to talk about moles (the animal) and how they dig holes under our feet and we burn or trap them and can hear them screaming. He then stated how he did not like that because we are digging tunnels under the ground and are collapsing our cities. Weston then began talking about how an air planes net worth is zero unless it has electronic devices in it. These electronics are like bombs and bombs kill people and that is sad. 



Affiant states that he has probable cause to believe that the aforementioned person(s) has committed the aforementioned offense(s) which belief is based upon the following facts:




