IMPORTANT REMINDERS

- NO SECOND INSTALLMENT NOTICE WILL BE MAILED
- NO PERSONAL, COMPANY CHECKS, CREDIT/DEBIT CARDS ACCEPTED 30 DAYS PRIOR TO TAX SALE
- ALL PAYMENTS MADE AFTER THE DUE DATES MUST INCLUDE THE PENALTY
- NO PARTIAL PAYMENTS ACCEPTED
- PAYMENTS FOR INCORRECT AMOUNT WILL BE RETURNED
- ILLINOIS LAW PROVIDED THAT ALL TAXES NOT PAID BY DUE DATE SHALL HAVE INTEREST ADDED AT THE RATE OF 1 1/2% PER MONTH UNTIL PAID OR SOLD AT TAX SALE
- COSTS OF \$10.00 PER PARCEL WILL BE ADDED FOR CERTIFIED MAILING AND PUBLICATION OF DELINQUENT TAXES IF BOTH INSTALLMENTS ARE NOT PAID BY THE CERTIFIED DATE.

ENVELOPE MUST BE POSTMARKED ON OR BEFORE DUE DATES TO AVOID INTEREST PENALTY. DO NOT SEND POST DATED CHECKS OR CASH IN THE MAIL. YOUR CANCELLED CHECK IS YOUR RECEIPT. IF YOU WANT A RECEIPT, YOU MUST SEND THE ENTIRE BILL WITH YOUR PAYMENT.

PLEASE INCLUDE YOUR PHONE NUMBER ON THE CHECK OR INSTALLMENT STUB IN CASE THERE ARE ANY QUESTIONS REGARDING YOUR PAYMENT

PAY ONLINE: DEBIT/CREDIT CARD AND E-CHECK PAYMENTS ARE ACCEPTED ONLINE. CONVENIENCE FEES WILL BE CHARGED BY THE PAYMENT SERVICE AND LATE FEES CALCULATED AT CHECKOUT IF NOT PAID BY THE DUE DATES.

PAY AT BANK: MOST LOCAL BANKS ACCEPT PAYMENTS ON OR BEFORE THE DUE DATES. LATE PAYMENTS ARE NOT ACCEPTED AT ANY BANK. BANKS CAN ONLY ACCEPT CURRENT INSTALLMENT DUE AND CANNOT ACCEPT LATE INSTALLMENT PAYMENTS.

PAY IN PERSON: CASH, CHECK, MONEY ORDER, OR DEBIT/CREDIT CARD PAYMENTS ARE ACCEPTED. CONVENIENCE FEES APPLY FOR DEBIT/CREDIT CARD PAYMENTS. BRING YOUR TAX BILL WITH YOU.

PAY BY DROP-BOX: THE DROP BOX IS LOCATED ON THE WEST SIDE OF THE BUILDING NEXT TO THE DRIVE-THRU. DO NOT PUT CASH IN THE DROP-BOX. PLEASE PLACE PAYMENT IN ENVELOPE. PLEASE INCLUDE YOUR PHONE NUMBER ON THE CHECK OR INSTALLMENT STUB IN CASE THERE ARE ANY QUESTIONS REGARDING YOUR PAYMENT.


