AMENDED COMPLAINT/INFORMATION

COMES NOW, Amy Norton, Assistant Saline County Attorney, for and on behalf of the State of Kansas, and gives the Court to understand and be informed that:

COUNT 1

That on or about the 27th day of July, 2016 and the 1st day of August, 2016, in Saline County, Kansas, Xavier Everett Lewis, then and there being present did unlawfully, feloniously, and intentionally agree with another person, to wit: Alex Bryan Karcher and Xavier Lee McCray, to commit or assist in the commission of the crime of Capital Murder, and an overt act, to wit: travelling from Saline County, Kansas to Jackson County, Illinois, in furtherance of the conspiracy was committed by Xavier Lee McCray, Alex Bryan Karcher and/or Xavier Everett Lewis. Capital Murder is to unlawfully, feloniously, intentionally and with premeditation kill human beings, to wit: Darrien Williams-Wright, Judios Kizeart and Robert Harris, pursuant to a contract or agreement to kill such person pursuant to which such person is killed.

Conspiracy to Commit Capital Murder - In violation of K.S.A. 21-5401(a)(2) and K.S.A. 21-5302, a Level 2 Person felony (Penalty: from a minimum of 109 months to a maximum of 493 months in prison and a fine of up to \$300,000; Postrelease supervision term of 36 months)

All of said acts then and there committed being contrary to the statutes in such cases made and provided and against the peace and dignity of the State of Kansas.

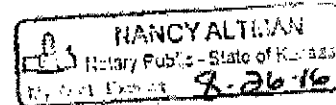
