Background:

In April 2022, in preparation for an application to the RISE grant program, staff issued a Request for Proposal for a contractor to lead the development of the Citys economic development strategic plan in order to accelerate economic recovery from the COVID-19 pandemic. BusinessFlare LLC was chosen from the seven proposals received. BusinessFlare accepted the Citys Professional Services Agreement contingent upon award of the grant application.

During this time, City staff also developed a public outreach strategy and a list of stakeholders that would contribute to the Economic Recovery Plan. These individuals provided letters of support expressing interest in serving on a Steering Committee that would provide guidance during the development of the Economic Recovery Plan. These parties included representatives of Economic development organizations, members of the business community, labor unions or other individuals/organizations

representing workers, residents, non-profit agencies and community organizations, and local or regional workforce training organizations.

In May 2022, Council approved a Resolution Authorizing the City Manager to Enter a Professional Services Agreement Contingent upon Award of a Research in Illinois to Spur Economic Recovery (RISE) Grant to Fund the Update of the Citys Economic Development Strategic Plan.

In March 2023, after receiving a fully executed grant agreement, City staff began working with consulting firm BusinessFlare LLC, providing a large number of studies, plans and other data over a period of many weeks. The Existing Conditions Report, a summation of all of the consultants research and review of existing data, can be found in Appendix A of the attached final draft Carbondale Economic Development Strategic Plan 2024 06 11.pdf.

During the week of September 11, 2023, the BusinessFlare team initiated their community engagement plan. Over the course of three weeks, BusinessFlare team members met with over 70 stakeholders about their ideas for economic development and prosperity in the City of Carbondale. These included elected officials, residents, steering committee members, economic development partners, student housing owners, large and small businesses, non-profit leaders, City staff, mobility partners, tourism and event partners, SIU students, and leadership at both SIU and SIH, among others. Their listening sessions included small groups, a community open house, individual meetings, a survey, and video calls. During their time in Carbondale, they also toured many parts of the City and region both day and night. A summation of the findings from these community engagement activities can be found in Exhibit B of the attached final draft Carbondale Economic Development Strategic Plan 2024 06 11.pdf.

After extensive review and feedback from the Steering Committee, along with input from City staff, the final draft of the plan has been completed. See Carbondale Economic Development Strategic Plan 2024 06 11.pdf.

It is recommended that the City Council hear a presentation of the Carbondale Economic Development Strategic Plan to Accelerate Recovery from the COVID Pandemic.

Background:

City staff applied for a 2021 Illinois Transportation Enhancement Program(ITEP) grant that was subsequently awarded for the purpose of extending a multi-use path from Old Highway 13 to Wood Road. This project is 100% funded (\$2,000,000) through the grant which included costs related to engineering design (\$300,000) and Construction (\$1,700,000). This project was bid by IDOT and the low bid came in at \$2,139,255.84. Since this project is administered by IDOT, the City is required to complete Phase 3 resident engineering (RE). This means that an IDOT-certified City representative is required to be present during the duration of the project to ensure that all construction and materials meet the proposed project design. The full scope of RE includes inspecting all work completed, documenting all material quantities on approved IDOT forms, completing on-site testing of all earthwork and construction materials, completing daily logs and weekly reports, inspecting erosion control measures, approving shop drawings, processing pay applications and change orders, and coordinating project closeout with IDOT. In short, these requirements necessitate the placement of a full-time resident engineer during the duration of the project to include post-construction activities.

Current City staffing isn't available to meet IDOT's Phase 3 RE requirements. As such, Staff has contacted civil engineering firms to assist with this portion of the work. Hutchison Engineering is a local engineering firm certified with IDOT for Phase III engineering work; their Carbondale office Director is a retired IDOT administrator and is fluent with the project requirements. As such, Hutchison is well-qualified to complete this work.

The approved 5-year CIP includes \$200,00 for RE for this project.

The contracting for professional services is an exception to the formal bidding process,1-16-13(E)(2) of the CRC.

Background:

In late fiscal year 2024, the Police Department applied for and was awarded a grant through the Illinois Attorney Generals Office that provides reimbursements for equipment and investigative services agreements for the purpose of deterring retail crime and other criminal activity. The grant provided a total of \$80,000 in funding, all of which will be spent in the FY 2025 Police Protection budget. The final grant was awarded after the FY 2025 budget was finalized and without the authorization for the additional grant revenue. As such, an increase in

the overall budget will be used for the expenditures that include additional video surveillance cameras in the business district, software upgrades, and ongoing investigative services; utilizing these grant funds will ensure that these expenditures will not require the use of City funds.

Background:

On May 14, 2024, the City Council approved Resolution No. 202-R-21 authorizing \$506,460 of Motor Fuel Tax (MFT) funds for street maintenance for Fiscal Year 2025. This amount falls within the City's approved Motor Fuel Tax Operations and Maintenance budget (41013). The MFT maintenance materials included in this bid utilize only a portion of the previously approved funds. This bid also includes 2,000 tons of CA-10 and CA-11 rock to be used by the Water and Sewer Divisions. That use is ineligible for MFT funds and will be purchased through the Water and Sewer inventory account and charged to the respective divisions.

The bid specifications for the MFT Maintenance Materials were prepared and the bid was advertised in the Southern Illinoisanon Saturday, May 25, 2024, and in the IDOT Bulletin. Thirteen (13) bid packets were sent to the firms listed on the attached Certificate as well as to five (5) plan houses. Background:

On March 3, 2022, the Illinois Department of Commerce and Economic Opportunity (DCEO) released a Notice of Funding Opportunity for the Research in Illinois to Spur Economic Recovery (RISE) grant program. Funds from this program were to be awarded to local governments and regional economic development organizations to create or update local or regional plans to accelerate economic recovery from the COVID-19 pandemic.

On April 6, 2022, in preparation for an application to the RISE grant program, staff issued a Request for Proposal for a contractor to lead the development of the Citys economic development strategic plan in order to accelerate economic recovery from the COVID-19 pandemic. Seven proposals were received, and after evaluation, the \$63,000 proposal submitted by BusinessFlare LLC was selected (see CarbondaleED_RFP_BusinessFlare 2024 06 11.pdf attached). BusinessFlare accepted the Citys Professional Services Agreement that was contingent upon the award of the grant application

On May 9, 2022, City staff submitted an application to the RISE Grant program requesting \$75,000. The grant budget was broken into two categories (No matching funds were required in this grant program):

- \$63,000 for a consultant to lead the Plan development process
- \$12,000 to reimburse for staff time administering the process

On May 24, 2022, the Council approved a Resolution Authorizing the City Manager to Enter a Professional Services Agreement Contingent upon Award of a Research in Illinois to Spur Economic Recovery (RISE) Grant to Fund the Update of the Citys Economic Development Strategic Plan.

On September 14, 2022, the City received notification from DCEO of the RISE grant award.

On March 13, 2023, the City received a fully executed grant agreement.

On March 22, 2023, City staff began its working relationship with consulting firm BusinessFlare LLC, providing a large number of studies, plans and other data over a period of many weeks. A weekly call schedule between City staff and the consultants was determined at this time as well. The Existing Conditions Report, a summation of all of the consultants research and review of existing data, can be found in Appendix A of the attached final draft Carbondale Economic Development Strategic Plan 2024 06 11.pdf.

During the week of September 11, 2023, the BusinessFlare team initiated their community engagement plan. Over the course of three weeks, BusinessFlare team members met with over 70 stakeholders about their ideas for economic development and prosperity in the City of Carbondale. These included elected officials, residents, steering committee members, economic development partners, student housing owners, large and small businesses, non-profit leaders, City staff, mobility partners, tourism and event partners, SIU students, and

leadership at both SIU and SIH, among others. Their listening sessions included small groups, a community open house, individual meetings, a survey, and video calls. During their time in Carbondale, they also toured many parts of the City and region both day and night. A summation of the findings from these community engagement activities can be found in Exhibit B of the attached final draft Carbondale Economic Development Strategic Plan 2024 06 11.pdf.

On December 12, 2023, staff received the first draft of the Carbondale Economic Development Strategic Plan, and on June 3, 2024, the final draft of the plan was completed and made available to Council members for their review. See Carbondale Economic Development Strategic Plan 2024 06 11.pdf.

It is recommended that the City Council adopt a Resolution Adopting the Carbondale Economic Development Strategic Plan to Accelerate Recovery from the COVID Pandemic.
