

1. On Tuesday, June 7, 2022, I, Detective Sergeant Donald MacLean of the Mansfield Police Department, received a call at approximately 3pm from Deputy Chief Ellsworth who advised me of a possible verbal threat that was made against Town of Mansfield officials. Deputy Chief Ellsworth informed me that he was in the process of collecting more information and would call me back.
2. At approximately 4:45pm, Deputy Chief Ellsworth called to inform me that Select Board Chairman Michael Trowbridge had just learned about a video of a person who had made threats to "hunt" him and his family down. The video also contained threats toward Town Manager Kevin Dumas. The video was seen by who immediately reported it Deputy Chief Ellsworth advised me to interview and begin an investigation.
3. I called and introduced myself and said was expecting my call. I asked to tell me about the video. In the town of Mansfield and was at work on June 7 th when a client, entered the shop. It told that should watch a video that had on phone. Watched the video and heard a recording of Police Chief Ronald Sellon yelling about this town the liberal piece of shit", "Fuck you "Fuck Kevin Dumas and Fuck Mike Trowbridge that pile of fucking shit, I'm going to hunt them and their children". I asked find the video. It said that could not but that knew it was him by his voice. I thanked for time and advised I would speak with
4. Detective Patrick Pennie and I drove to We were met at the front door by who informed me that was was walking the dog and that be right back. then asked me if we were at home for "the video" to which I replied that we were. A short time later, arrived home saying that was expecting me. I told that we needed to investigate matters like the video threats. said that understood and forwarded the video that showed earlier to Detective Pennie's work cell phone. I asked how it was that had come into possession of the video. said that friend sent it to him. I thanked cooperation in the matter and left.
5. I returned to the station and called arrived at the station and I brought into the interview room off the front lobby. I advised that the interview would be recorded and thanked me for telling said that on May 10, 2022 after the town elections around 9:25pm, heard



6. The Nest camera is . A review of the Nest video revealed on the evening of May 10th a white sport utility vehicle (SUV) was traveling northbound on Stearns Avenue. Sellon owns a white SUV. The SUV pulled into the driveway of 154 Stearns Avenue which is known to me as the residence of Ronald Sellon. The SUV pulled into the driveway and towards the detached garage located on the left side of the house. The garage door opened and a light turns on inside the garage. Once the vehicle is parked inside the garage a banging noise can be heard. It appears it is coming from the garage as there is no other movement in the video. A male voice can be heard yelling, "Fuck You". The same male voice can be heard yelling, "This fucking sucks! Fuck this town! Fuck Mansfield! You fucking pack of fucking useless bullshit". At this point in the video a faint voice of a female can be heard. The male voice yells, "You bunch of useless fucks, You're a bunch of useless liberal fucks. Fuck you Fuck Kevin Dumas that fucking piece of shit! Fuck Mike Trowbridge that pile of useless piece of garbage. Fuck all of them and you know what? Fuck em! I'm going to haunt them and their fucking children pieces of shit". At this point you do not hear anymore yelling but sounds of banging again coming from the garage. The voice I heard yelling is that of Chief Ronald Sellon.
