RE: NOTICE OF NON-COMPLIANCE

Dear Mr. Davis,

On March 20, 2026, the Office of the Governor's Public Safety Office (PSO) was made aware that a jury found Fort Bend County Judge, KP George, guilty of money laundering.

PSO has 27 active grant awards with Fort Bend County. Upon acceptance of those awards, Fort Bend County agreed to "immediately notify the Office of the Governor (OOG) in writing if a project or project personnel become involved in any litigation, whether civil or criminal," and "immediately forward a copy of any demand, notices, subpoenas, lawsuits, or indictments to OOG." The OOG has identified Judge KP George as the current Authorized Official on all 27 active awards (see Attachment 1).

Effective immediately, OOG is hereby exercising its authority under Section 1.8 of the Grantee Standard Conditions and Responsibilities by temporarily placing all active awards on financial hold. Please provide the following within 10 calendar days:

- Submission of any demands, notices, subpoenas, lawsuits, or indictments;
- A written response explaining the extent to which OOG funds were involved in any alleged criminal acts, and
- Submission of a new resolution identifying a new Authorized Official for all active awards.

We appreciate your prompt attention to this matter.
