7/10/2025	The State failed to indict the defendant within the 90 day deadline, pursuant CCP Art. 17.151. The Court made inquiry as to why the State failed to indict the defendant in the 90 day period, the State could not provide the Court with any valid reason. The State simply informed the Court, "it just didn't get done." The Court took judicial notice of the fact that at any given time there are five grand juries sworn in, per term, and the State of Texas has hundreds of prosecutors and support staff. Yet, the State could not provide a sufficient reason as to why they failed to indict the Defendant. The Court also made inquiry to the defense as to why they failed to inform the Court that the State failed to indict the Defendant within the 90 day timeline. Pursuant to Article 17.151 the Court was duty bound to grant a PR bond and/or make inquiry as to what bond the Defendant could afford. Upon a proffer in open court, the Defense informed the Court that 1. the Defendant is indigent, and 2. The Defendant can only afford a \$100.00 bond. The Court informed the parties that due to the State's failure to indict the case within the 90 day time period and the Defendant having been consistently confined for over 90 days, the Court imposed a bond of \$100,000.00, (one hundred thousand dollars), PR BOND, pursuant to the mandatory law.
