Coos Bay Scholastic Chess Player Wins Gold at Nationals

Five current and previous South Coast scholastic chess players took on the challenge of competing in the K-12 National Chess Championships held for the first time in twenty years on the West Coast. It was only a ten-hour drive to attend the Championships held in Spokane Washington. They joined 1400 scholastic players who braved the tough competition.

Misha von Dassow (10th Grade) from Coos Bay attended early to participate in the Blitz tournament, and then took on Grandmaster Magesh Panchanathem in a twenty-person simultaneous event. Then it was on to the three day, seven rounds of chess with time control. Each player had 90 minutes with a ten second delay for each move, allowing games to last up to four hours. Von Dassow was joined by Skyler White-Ross (8th Grade) from Port

Orford, Matrim Tew (5th Grade) formerly from Bandon, Ruth Scott (4th Grade) from Coquille and Rand Tew (3rd Grade) formerly from Bandon. The schedule was grueling and the competition was tough against some of the best grade level players from across the nation.

Misha von Dassow won four out of seven games and earned a medal as he won first place for 10th Grade rated U-1700 Class. He found the event motivating and

hopes to improve his skills to compete in more National events.

Although the other four did not win any prizes, they did manage some game wins against the toughest players of the nation and found the experience invaluable. They did find some time to explore the exciting Spokane Riverfront, meet some new people from across the nation, and learned a lot.

Merkley, Wyden, Colleagues Urge Trump Administration to End Staffing Crisis at Fish and Wildlife Service, Warn of Devastating Impacts to Ecosystems and Public Lands

Washington, D.C. - U.S. Senator Jeff Merkley (D-OR)—the top Democrat overseeing funding for the U.S. Fish and Wildlife Service (FWS)—and U.S. Senator Ron Wyden (D-OR)—former chairman and current senior member of the Senate Committee on Energy and Natural Resources—joined their colleagues in urging the administration to immediately address and reverse the staffing crisis at the FWS, which has lost the capacity to properly manage most of America's wildlife refuges, putting in jeopardy the ability to protect endangered wildlife species under the Service's care.

In a letter to U.S. Secretary of the Interior Doug Burgum and FWS Director Brian Nesvik, the Senators highlight the direct impacts cuts in staffing are having on the 573 national wildlife refuges across the country—with almost 60 percent of them lacking the resources and staff needed to fulfill their missions. According to public reports, Oregon and Washington have lost a combined 50 senior level scientists and staff.

"Americans of all backgrounds love their public lands, and protecting wildlife refuges is a bipartisan cause that brings together environmentalists, sportsmen, and all who enjoy the outdoor recreation opportunities provided by America's National Wildlife Refuge System. The Refuge System is the only federal network of public lands that is primarily dedicated to the conservation, management, and restoration of fish, wildlife, and plant

SNAP recipients in Coos County have more time to replace food lost during recent storms From the Oregon Dept. of Human Services

If you live in one of 19 Oregon counties and lost food bought with Supplemental Nutrition Assistance Program (SNAP) benefits because of recent storms and power outages, you now have more time to ask for replacement benefits.

The Oregon Department of Human Services (ODHS) has extended the deadline to 30 days for people whose food was lost or spoiled due to power outages Dec. 17, 2025.

Households in Coos County have until Jan. 16, 2026, to report food losses and request replacement SNAP benefits.

How to request SNAP replacement benefits

If your food was lost because of

the storms or power outages, you can request replacement benefits in any of these ways:

Once approved, replacement benefits are added to the household's existing Electronic Benefits Transfer (EBT) card. The maximum replacement amount is the cost of the food lost, not to exceed the household's normal monthly SNAP benefit.

Jan. 16, 2026.

After that date, the 10-day reporting rule will apply again.

Administered by ODHS, SNAP is a federal program that provides food assistance to approximately 1 in 5 eligible, low-income families and individuals in Oregon, including many older adults and people with disabilities. Individuals in need can apply for benefits, including SNAP, child care, cash assistance and Medicaid.



Christmas Quiz: The Sounds of the Season

We hear them from one Yuletide after another, the sounds of the season we've known and loved for decades. Just how much do you know about classic Christmas songs? Test your knowledge with this short, fun

1. Now a favorite of children, "Jingle Bells" was originally consid-

- ered to be what? A: A fraternity song
 - B: A church hymn
 - C: A tribute to horses D: A drinking song

Answer: D. When "Jingle Bells" was first published in September 1857, it was originally considered a drinking song. Yuletide revelers would clink their drinking glasses to mimic sleighbells. Its lyrics about a young, unmarried couple sleighing together without a chaperone were also considered racy for the mid-19th century.

2. Singing cowboy Gene Autry reluctantly recorded a kids' Christmas song on June 27, 1949. What

was it?

- A: "Frosty the Snowman" B: "Have a Holly, Jolly Christmas"
- C: "Rudolph the Red-Nosed
- Reindeer' D: "Jingle Bell Rock"

Answer: C. Popular singers like Bing Crosby, Perry Como and Dinah Shore had passed on the song about the plucky little reindeer with the crimson snout. Autry only recorded it so his wife, Ina, would stop hounding him about it. Even then, it was on the "B" side of the record. Yet, it became the No. 1 song in the United States for Christmas week 1949.

3. Not only is this Christmas song the biggest-selling holiday track of all time, but it is estimated by Guinness World Records to be the

biggest-selling song ever.

- A: "White Christmas" B: "Santa Claus Is Coming to

Answer: A. Mariah Carey's megahit "All I Want for Christmas Is You" may have just broken the record for

the most weeks at No. 1 on the Billboard charts (20), but it can't touch the 1942 Bing Crosby classic. It has sold 100 million copies worldwide.

4. The iconic "Silent Night" was first publicly performed on Christmas Eve 1818, with which

instrument?

- A: Violin B: Piano
- C: Organ
- D: Guitar

Answer: D. The first performance was at the tiny Nikolauskirche church in Obendorf, Austria. However, the church's organ was broken, so a guitar accompanied the choir.

5. What was the first Christmas song ever broadcast?

- A: "O Little Town of Bethlehem"
- B: "O Come All Ye Faithful" C: "O Holy Night"
- D: "O Christmas Tree"

Answer: C. Inventor Reginald Fessenden played the song on his violin on a Christmas Eve radio broadcast from Brant Rock, Mass., in 1906. A passage from the Book of Luke was

also read. Ship operators along the

Atlantic Coast heard it, making it the first time a human voice and music were transmitted by radio.

6. For two centuries, the classic "O Tannenbaum" (which led to today's "O Christmas Tree") has been a staple at Christmastime. However, in the early 19th century, its melody was used for what

non-holiday purpose?

- A: Political protests
- B: Spirituals

Answer: A. Because it was widely popular and easy to sing, its words were written for versions that stressed nationalist protest themes in Germany, especially during the liberal Revolutions of 1848 that swept across much of central Europe.

Answer: D. Featured in the MGM classic movie "Meet Me In St. Louis," Judy Garland sang it to her little co-star Margaret O'Brien. However, she absolutely refused to sing the words "it could be your last." With World War II raging at the time, Garland believed the line was just too morbid for moviegoers who were struggling to keep morale high.

I live in Coos Bay, and I have grave concerns over the proposed container port. I have attended several presentations about it and just read an excellent article from the Oregon Journalism Project. This project is going to be a disaster. Why are the powers that be so adamant about supporting it? It will waste billions of dollars that could be better spent to build up the local fishing industry, encourage more tourism, or help the hospital survive.

My biggest fear is that the port will be built, and flop, but the damage will be done. The bay will have been ruined for promoting the spawning of Dungeness crab and other marine life. The debris from the dredging will have been dumped in areas that too will be ruined. There will be no coming back.

And what of the facility? Will it be left to rot on the North spit, ruining the bay, the view and possibly polluting the waters? Will there be a plan to dismantle it and remove it? Everything I've heard or read says we do not need more container ports. There are enough already and shipping to Coos Bay would cost too much by comparison. The upgrades to the railroad line will be ridiculously expensive but do little to help tie them into the major lines. And, once operational, it would pretty much destroy commercial fishing not to

I live near the Hollering Place. I have a beautiful view. And while the powers that be think that of no concern, it is to me. What about pollution? Can you guarantee there will be no air, water and especially noise pollution? Sound carries a great distance over water, and I already sometimes hear the facility that is on the spit. A 24-hour-a-day operation would be horrible. This will tank property values of all homes on the west side of Coos Bay and North Bend.

Why have you not had an independent feasibility study done? There are many in Coos Bay and North Bend who are against this project. When do we get a say?



species and their habitats," the Senators wrote.

"This downward trend did not begin under the Trump administration. Yet the current administration has not only shown an unwillingness to address the problem—it has made the situation far worse. The President's Fiscal Year 26 budget request slashed funding for FWS's overall

Resource Management account, which included a proposed 22 percent cut to the National Wildlife Refuge System. Moreover, the administration has indicated that it is planning more firings for public land agencies," the Senators continued.

The Senators also emphasized that operating with few or no employees has also hurt disaster resilience because FWS employees carry out projects to control

flooding and prevent catastrophic wildfires.

The open letter states: "We write to sound the alarm on the U.S. Fish and Wildlife Service's (FWS) staffing crisis, which is causing particular harm to the National Wildlife Refuge System. A startling amount of staff and expertise needed to manage the Refuge System and protect America's wildlife have been lost due to the administration's firings,

early retirement programs, and other efforts to push staff out of FWS."

"The agency is losing the capacity to manage America's wildlife refuges and struggling to even keep them open. We ask that you provide Congress with your plan to address FWS's staffing crisis and immediately act to ensure that FWS and the Refuge System have the staff and resources needed to guarantee a safe, quality

experience for visitors to the Refuge System and to protect the invaluable wildlife species under the agency's care."

The letter was led by U.S. Senator Adam Schiff (D-Calif.), Ranking Member of the Senate Environment and Public Works (EPW) Subcommittee on Fisheries, Water, and Wildlife, and was also signed by U.S. Senators Angela Alsobrooks (D-Md.), Michael Bennet (D-Co-

lo.), Richard Blumenthal (D-Conn.), Chris Coons (D-Del.), Dick Durbin (D-Ill.), Mazie Hirono (D-Hawai'i), Edward Markey (D-Mass.), Catherine Cortez Masto (D-Nev.), Patty Murray (D-Wash.), Alex Padilla (D-Calif.), Jack Reed (D-R.I.), Jacky Rosen (D-Nev.), Bernie Sanders (I-Vt.), Brian Schatz (D-Hawai'i), Chris Van Hollen (D-Md.), Peter Welch (D-Vt.), and Sheldon Whitehouse (D-R.I.).

As I See It

By Mary Schamehorn



"Puts City Park in Fine Shape" is the headline in the May, 31, 1934, Western World. "With the opening of the beach activities and the base ball season, the city park is becoming the center of considerable interest and is attracting people, particularly for camping and picnic parties.

"The park (first picture) is in excellent condition. It was taken over several months ago by J.H. McDiarmid, who out of purely civic loyalty and with no hope of getting paid for his work, cleaned up the entire grounds, sawed all the dead trees up for firewood to be used there, repaired and rebuilt the grandstand and the fence around the ball park, started to build a tennis court, and in every way possible without the expenditure of the city's money got the place in condition to be attractive to home folks and visitors.

"He has plans for a horseshoe court, swings for the children, and other amusement features. Grass seed and flowers have been planted, including a number of lily bulbs donated by the Bandon Women's Civic Club."

It's hard to believe that the property for the second "new" hospital on the bluff overlooking the river was donated by the city in 1946 ... for a hospital that did not open until 1960. But an item in the June 13, 1946, paper bears that out. "The choice plot of land near 4th and Edison (Coast Guard Hill), known as the 'Boak' property, has been chosen as the site for Bandon's new 15-bed hospital (second photo). This location is near the bluff of the hill north of 4th street and west of Edison Avenue, commanding a broad view of the harbor entrance and the area north to Whiskey Run.

"The property was owned by the city, and Mayor K.I. Franklin and the city council showed sound foresight and concern for the welfare of the community by donating the land to the hospital association.. The deed to the property was received by Mrs. John Devereux, a director, at the council meeting. "The pre

"The present hospital (third photo) is running smoothly, according to Mrs. Devereux, and has been on a paying basis since last opening on April 1," referring to the R.V. Leep Memorial Hospital, which was located on First Street, across from the boat basin on land that remains vacant today. After the new hospital was built at Fourth and Edison, the Leep hospital building served as office space and later living quarters before its condition required that it be torn down. The photo was taken in April 1978 during a fire in the attic, long after it had stopped being a hospital. The building at right is the back of what is now the Wheelhouse and Crow's Nest. The hospital on the hill was

closed in 1999 when the present hospital was built, and the property was sold by the hospital district for a million dollars. Today, the site on the bluff is one of several parcels in the area, including the former Edgewater's Restaurant building, that is for sale by the Picerne Group for \$15.5 million dollars. Lately the area along Fourth has been fenced off as necessary repairs are made to the sidewalk and branches cut from overhanging trees at the request of the City.

When I tell people, in casual conversation, that I have been advocating for housing in Bandon for 45 years, it turns out I was telling the truth. I recently found an article in the Feb. 11, 1981, that bears out what I have been saying.

I joined the city council in August of 1977, and the issue in 1981 was whether to allow a man to build a house on Fillmore avenue, which was not yet fully improved.

Then City Attorney Myron Spady cautioned: "If the City of Bandon keeps making exceptions to the requirements we have on streets, we're never going to have streets."

The article adds: "Spady's caution was countered though when Councilwoman Mary Schamehorn

questioned whether the Council should maintain a 'hard line policy.' If we try to enact a hard line policy of not allowing houses to build unless there's a paved street, which adds another \$6,000 to the cost of the house, then instead of five or ten percent of the people in the United States being able to afford a house, it will be more like two percent." Sadly, the housing situation has only gotten worse as the cost of property, high interest rates, vacation rental dwellings and second homes have impacted the availability of a single family house in ways that we never envisioned possible 45 years ago.

Just to give my readers an idea of how frustrating it is to deal with the same perpetrator repeatedly, I will share a bit about an arrest in North Bend in November that followed extensive property damage to city vehicles and facilities. A concerned citizen witnessed the incident and promptly notified the police. They arrived quickly and located Jeffery Allen Hill, 41, a transient, who was taken into custody and charged with six counts of criminal mischief after damaging eight city vehicles and multiple windows at the North Bend Public Works building. But here's the kicker: "Hill is well-known to law enforcement with 1,092 police contacts recorded in the countywide shared database. Since July 1, 2025, he has been arrested 31 times within the City of North Bend alone. Unfortunately this type of destructive and disorderly behavior has not only targeted City property

to deal with the disruption and damage caused by Hill's actions."
So much for "three strikes and you're out."
In Coos County where a lack of jail space is well known, property crimes like this seldom result in a jail sentence or if they do, it's not for long before the bed is needed for a more serious violation.



Because I am sending my column early this week, it will be next week before I print the letter from Jon Sullivan, who resigned from the Bandon School Board this week, effective immediately, because he felt it was important to "put my own and my family's safety first. The escalating vitriol in this community is counter to







our collective goals," Sullivan said.

Turmoil in the school district resulted in a lengthy report on Jefferson Public Radio, which came out late this week. There is a link on Bandon.tv to the article, or you can go to www.ijpr.org/education/2025-12-18/turmoil-at-bandon-school-district-leads-to-resignations-parental-concern.

I keep forgetting to mention the Bandon Chamber of Commerce's TV ads which I see nightly on NBC, and are paid for with TOT (transient occupancy tax) dollars. They are some of the most beautiful ads I have ever seen advertising Bandon.

I introduced the new chamber executive director, Nalia Brewster, several months ago and promised to tell you more about her when I could.

Originally from North Dakota, Nalia (pronounced na-leea) has called Bandon home since 2019. She loves the small-town charm, local sports teams, beaches, restaurants and small shops, as well as all of the unique experiences Bandon has to offer -- from crabbing off the docks to fishing locally. With years of experience in the corporate world and as a business owner, she has gained valuable insight into small business operations and sales. In addition she managed the front office of the business of her husband, Scott, for several years. She is a past president of the Bandon Pool Board, and has two children who are involved in local sports.

Chris Dudley, who ran against John Kitzhaber for Governor in 2010, is once again looking at running in the Republican primary for the state's top office.

He contends, as many of us do, that "absolute power corrupts absolutely. One

party rule is not healthy for the state, regardless of who holds the power. You need a healthy tension and balance."

He points out that Oregon is in the bottom percentile of educational results (he says 49th), and Portland is ranked 80 of 81 in cities across the country in terms of attractiveness to investors. "We're at the bottom economically as a place to do business. For access to treatment for drug addiction, we're 50th. I'm not sure there's any stats where we are in the top half of the country," Dudley said in a recent interview in the Oregonian.

Raincoast Arts in Langlois posted on Facebook Tuesday that "this afternoon someone came into our building while we were having a late lunch. They got upstairs, took a few things which they tossed outside after a neighbor scared them off. They were driving a white Yukon Denali with a blue passenger side front fender. One Portland man says he wants to shake up the way Oregon governance works, and he has filed 11 initiatives aimed at the 2026 ballot.

One, IP60, would mandate a 10-year sunset on all state taxes and fees, and IP67 would require a two-thirds majority vote to raise taxes through ballot measures. another would require judges to appoint public defenders rather than release or dismiss charges. 

He has been commuting between Bandon and his Elk river ranch, but with tires getting worn he has decided to make the family car last as long as possible by eliminating his daily trips. Mrs. Sweet and other members of the family are living at the ranch where Bill Sweet, Jr., has taken charge of operations." In another article in the same issue the names of people in the county who were able to purchase one, and sometimes two, tires made the news!

Marian Crumley

June 14, 1932 – December 6, 2025

Marian Joy Bodeen was born to Florence Cornelia Bodeen and Gerald Oscar Bodeen on June 14th of 1932. The happy event took place on the farm of Jack and Bertha Rugh with whom the Bodeens were living at the time. Florence's sister Bertha (Aunt Bert) acted as midwife. The farm was near Coal Valley Illinois, in Henry County.

Marian thrived in this extended family of farmers. Growing up she was active in 4H and the rifle club at school and survived scarlet fever. She attributed the latter with the progressive loss of her hearing as an adult.

Graduating from Galesberg High School, Marian had hoped to become a Veterinarian. The Veterinary school was not accepting women at the time, so she enrolled at the University of Iowa for their Bachelors of Science in Nursing progam. There she met her future husband, David James Crumley II.

In June of 1954, Marian graduated with her BSN, turned 22, married her beloved Dave and started her first job as a fully fledged RN. The marriage took place on June 14th, her birthday. The job was in the polio

ward of the University of Iowa Hospital. This was not long before the release of Dr. Salk's new vaccine, part of Marian's job was compiling data for Dr. Salk's research. Fortunately, polio wards became a part of history and Marian transitioned through many different facets of floor nursing in her career. Along the way she and Dave had three children. When her hearing began to fail she pivoted to nurse education at Blessing Hospital School of Nursing in Quincy, Illinois and then into management roles. She finished her career managing the extended care wing at Lower Umpqua Hospital in Reedsport.

Upon retirement, she and Dave threw themselves into volunteer work and philanthropy. They had already been part of a public campaign to keep Lower Umpqua Hospital from being closed down. They spent many years raising funds for The Coquille Elks scholarship fund. Marian volunteered for what was then called the Women's Crisis Service. When the need for larger facilities became apparent and land was donated for the purpose, Dave and Marian spearheaded a years-long cam-



paign to fund construction. This became Coddington Place, operated by what is now known as The SAFE Project. That last project earned them the 6th annual Lilah Bidwell Human Dignity Award 2010, awarded by the Human Rights Advocates of Coos County. Her favorite way of introducing herself to new people was, "I am a proud, card carrying, bleeding heart liberal.'

Marian was preceded in death by her husband Dave and elder sister Ruth. She is survived by her children Gerald, Asialee and James; her sisters Carol and Kathy, her sister-inlaw Jan, brother-in-law Lee, and many grandchildren, great grandchildren, nieces and nephews and their descendants as well. At Marian's request, no formal service will be held. The family will be spreading ashes at a future time.

Lester Vernon Simons

December 24, 1930-December 19, 2025

Lester Vernon Simons of Myrtle Point, born December 24, 1930, in Lebanon, Oregon, passed away on December 19, 2025, in Coquille. He was the son of William and Edna Simons. At his request, no services will be held.

Lester grew up in Lebanon and graduated from Lebanon High School in 1948. He earned his Bachelor of Science degree in 1952, followed by a Master of Music degree in 1963. He later pursued advanced study at the Institute for Arts & Humanities, deepening the foundation for what would become a lifelong devotion to music and education.

On March 22, 1952, he married Marvin Jo Simons, beginning a 57 year partnership marked by love, family, and shared

purpose. A gifted and highly accomplished clarinetist, Lester dedicated more than three decades to music education as Music Teacher and Supervisor at Myrtle Point High School (1952-1985). He also taught and directed the University of Oregon High School Summer Music Sessions, inspiring countless young musicians. His

leadership extended statewide through his service as Chairman of District 7 of the Oregon Music Educators Association (1955-1956, 1959–1960). In 1988, he received the Distinguished Music Educator Award from the Northwest Bandmasters Association, a testament to his profound impact on music education in Oregon.

After retiring from teaching, Lester founded LS Music, continuing to support school and community music programs with the same dedication that defined his career. South Coast Seed Community 2025 Recap


Founded in 2012, as the Coquille Valley Seed Library, the non-profit organization became the Coquille Valley Seed Community (CVSC) in 2017, and are under the umbrella of the Seven Fires Foundation. To be more inclusive of our members and partners in Bandon, Coos Bay, North Bend, Port Orford, and those living in the south coast region, the CVSC became the South Coast Seed Community (SCSC) in April 2025.

True to the original mission, SCSC's continues to preserve a diverse gene pool of Open-Pollinated, Heirloom, Pure, Natural, and Non-GMO seeds to promote local food security, by inspiring, engaging and educating our community to grow and share locally adapted seeds from our gardens that will thrive in the southern Oregon coastal region for the best resilience and productivity.

The Seed Community is a critical part of our food security system that is evolving along the south Oregon coastal region.

Our annual Seed Swap last March was a huge success with about 200 people attending and we sent more than 20,200 FREE seeds out into the community! We once again participated at the Master Gardener's Fertilize Your Mind event last April, sending out another 9,000 FREE seeds to local households. Conservation groups urge Oregon

to reduce whale deaths from crab fishing gear

After at least four humpback whales were entangled this year in Oregon commercial Dungeness crab fishing gear, conservation groups are petitioning the Oregon Fish and Wildlife Commission to adopt measures to reduce the amount of fishing gear during whale feeding and

migration seasons.

after a young entangled humpback whale was found stranded on a beach north of Yachats. Veterinarians euthanized the whale after unsuccessful attempts to free it on Nov. 17. The Oregon Department of Fish and Wildlife is investigating the entanglement.

The department on Dec. 5 issued a fleet advisory, urging fishers to be vigilant and take precautions to avoid entanglements. The advisory doesn't include enforcement measures, but it says the department is strongly considering further regulatory action to reduce entanglement risk.

"The latest dead humpback whale should be a wake-up call that entanglements in Oregon crab gear are a major problem," stated Ben Enticknap, fisheries director at Oceana. "Oregon fishery managers should act quickly to strengthen conservation measures to reduce whale entanglements"

entanglements."

The number of entanglements in Oregon commercial Dungeness crab gear this year is likely higher than just the four confirmed by the Oregon Department of Fish and Wildlife. The National Oceanic and Atmospheric Administration in September released preliminary results showing that there may have been as many as 20 entangled whales.

0 entangled whales. Entanglements can cause starvation, infections, amputations, strangulation as well as impact a whale's ability to reproduce, according to NOAA.

"The four humpback whales found tragically entangled in Oregon crab gear are a signal of a much greater entanglement problem, as only a small fraction of them are ever detected," said Francine Kershaw, a senior scientist at Natural Resources Defense Council. "The state should take swift, science-based management action to effectively protect endangered whales in Oregon waters."

State law requires the commission to respond to the petition in writing within 90 days and either deny it or begin rulemaking proceedings.
