

# Shooting Suspect Held on Unrelated Charges Following Homicide, Investigation Ongoing

FROM THE CBPD

A person is in custody following a homicide that occurred in a local business parking lot.

On December 28, 2025, at approximately 1:55 p.m., the North Coos 911 Center (NC911) received reports of a shooting in the parking lot of Staples, 1995 Newmark Ave., Coos Bay. Callers were able to provide dispatch a description and license plate for the suspect vehicle, which was immediately relayed to the responding Coos Bay Police Department (CBPD) officers.

With that information, officers responded to the Staples shooting scene and immediately began the search for the suspect vehicle.

CBPD officers arrived at the Staples parking lot around 2:00 p.m. and attempted to provide medical aid to the shooting victim, identified as 39-year-old David Orr of Coos Bay. Medical personnel also responded, but Mr. Orr was declared deceased at the scene.

At 2:05 p.m., a North Bend Police Department (NBPD) officer located the suspect vehicle, parked outside a residence near 33rd St. and Vine Ave. in Coos Bay. CBPD officers arrived shortly after, detained both occupants of the vehicle, and arrested the suspected shooter.

The Coos County Major Crime Team was activated to assist with the investigation, which is still ongoing. Due to this, the identity of the suspected

shooter will not be released until their arraignment later this week. The suspect is currently being held at the Coos County Jail on unrelated charges.

The CBPD appreciates the assistance provided by members of the Coos County Major Crime Team, including the Oregon State Police (OSP), North Bend Police Department (NBPD), South Coast Interagency Narcotics Team (SCINT), Confederated Tribes of Coos, Lower Umpqua, and Siuslaw Indian Tribal Police, Coos County District Attorney's Office, Coos County Medical Examiner, and Coos County Parole and Probation, along with the assistance provided on scene from the Coos Bay Fire Department (CBFD) and Bay Cities Ambulance (BCA).



# Oregon saw at least 1,100 immigration arrests in 2025

Arrests in Oregon in 2025  
almost 10 times as high as previous year

Federal immigration agents arrested at least 1,100 people in Oregon this year, immigration experts estimate — a surge from the 113 arrests recorded in all of 2024.

In August, the Trump administration said it would “come after” states like Oregon with laws preventing local law enforcement from coordinating with federal immigration officials. Since then, Oregon’s been at the forefront of President Donald Trump’s renewed immigration enforcement efforts.


From Trump’s attempt to deploy Oregon National Guard troops to Portland in the spring, to the state’s largest Latino labor union and a Portland immigration law firm suing his administration alleging it is blocking attorneys from accessing detained clients — the Beaver State in 2025 repeatedly drew the administration’s attention. Oregon now ranks among the top five states with the largest year-over-year

# Deadly Crash on Transpacific Highway Leads to Charges

On December 24th, 2025, at around 10:45pm, Coos County Sheriff’s Office Deputies were dispatched to the area of Transpacific Parkway and Jordan Cove Road in North Bend, to the report of a motor vehicle crash. Sgt. Boswell located the vehicle, and observed that one passenger, a 19-year-old male, was deceased, and another passenger was injured while trapped inside the vehicle. Fire and Medical personnel were able to successfully rescue the trapped passenger and transport them to the hospital for further treatment. Deputy MR Smith, along with Troopers from the Oregon State Police, also arrived on scene to assist in the


investigation. As a result of the investigation, Deputy MR Smith arrested the driver of the vehicle, Reef Michael Berry (22). On December 30th, 2025, Reef Michael Berry was indicted on the charges of: Manslaughter in the First Degree, Manslaughter in the Second Degree, Assault in the Third Degree, Driving Under the Influence of Intoxicants, Recklessly Endangering Another Person (x2), Reckless Driving, and Driving While Suspended or Revoked (Misdemeanor).

increases in ICE arrests, Stateline reported. The Oregon Capital Chronicle analyzed data from Deportation Data Project, a database run by lawyers and academics who collected national ICE arrest data from public records requests between Sept. 1, 2023 and Oct. 15, 2025, as well as data from immigration advocates to understand what federal immigration enforcement looked like in Oregon by the numbers. Oregon saw surge in arrests in summer and fall ICE agents arrested 660 people in Oregon in the first ten months of 2025, according to the Deportation Data Project. The project’s dataset doesn’t include arrests after mid-October, but U.S. Border Patrol Chief Michael Banks said on the social media platform X that federal agents arrested more than 560 people in Portland in October alone. Immigration experts assume his estimate is accurate, and the Portland Immigration Rights Coalition, which became a statewide hotline this year for Oregonians to report ICE sightings, confirmed with the Oregon Capital Chronicle that it’s had more than 1,000 arrests reported to the hotline this year. Oregon for All, a coalition of organizations advocating for immigrants rights, reported 1,900 arrests, coalition spokesperson Diane Goodwin told the Capital Chronicle. Detentions peaked in July, October and November, according to Stephen Manning, the director of Innovation Law Lab, a Portland-based law firm focused on immigration. The rise came after Trump in the spring raised the national daily ICE arrest quota from 1,000 to 3,000 per day. Regional director Cammilla Wamsley, responsible for ICE operations in Oregon, Washington and Alaska, also set an internal goal of 30 arrests per day for the region —

double the daily goal the regional agency had in 2024. ICE did not respond to the Capital Chronicle’s request for comment. “The data shows arbitrary quotas were imposed by Trump in June 2025 and apprehensions spiked and then in September 2025, they spiked again, and on October 15, 2025 they surged off the chart,” Manning told the Capital Chronicle. While ICE has claimed its crackdowns are catching criminals, the data shows that only 32% of people arrested in 2025 had criminal convictions. That’s down from 45% of the people ICE arrested in Oregon in 2024, according to the Deportation Data Project. People arrested by ICE came from at least 45 different countries, with the most people coming from Mexico, followed by Honduras, Venezuela, Guatemala and China. About 84% of those arrested in the first 10 months of the year were male. Roughly two-thirds of people detained were between the ages 19 and 40. The youngest person detained was 4-years-old. Cities, counties respond to ICE action in Oregon Portland Immigrants Rights Coalition Coordinator Alyssa Walker Keller said there will be “many hard months” ahead. The group anticipates a looming eviction and hunger crisis for families who lost their breadwinners. “It will be important for local and state governments to invest in stabilizing, for mutual aid groups to supplement that support, and for all of us to be thinking about strategies of how to stabilize these families whose entire worlds have been rocked by their loved one being stolen away,” she told the Capital Chronicle. Cities and counties including Portland, Salem, Forest Grove, Woodburn and Multnomah and Washington counties have responded to ICE’s increased presence in their communities by declaring local emergencies, ordering training for local staff on how to follow Oregon’s sanc-

## Coquille girls win Bandon Dunes tourney

Coquille held off host Bandon to win the girls title in the annual Bandon Dunes Holiday Invitational on Saturday. Coquille topped the Tigers 41-28 in a battle of two traditionally strong programs. The Red Devils built a 10-point halftime lead by holding Bandon to 13 first-half points and then saw that lead trimmed to just one point in the third quarter before pulling away for the win. Coquille reached the tournament final by beating Brookings-Harbor 41-29 and topping Umpqua Valley Christian 54-35. The Red Devils finish their preseason schedule this week with a home game

Umpqua Valley Christian beat Glide 55-30 in the third-place game and Brookings-Harbor topped Waldport 41-30 in the consolation final. Siuslaw beat South Umpqua 39-31 in the seventh-place game. In the boys portion of the tournament, Bandon finished fifth, falling to Siuslaw 45-35 in the third-place game. The Bulldogs beat Coquille 64-33 but lost in the semifinals to Elmira 51-35. Bandon hosts Central Linn on Friday and Monroe on Saturday before opening Sunset Conference play against Illinois Valley next Tuesday. Del Norte of Crescent City, Calif., won

the tournament, beating Elmira 49-39 in the championship game. Brookings-Harbor edged Umpqua Valley Christian 75-72 in the consolation final. Coquille lost all three of its games in the tournament and remains winless on the season. After losing to Bandon, the Red Devils fell to Brookings-Harbor 65-52 and to South Umpqua 73-47 in the seventh-place game. Coquille hosts Brookings-Harbor on Wednesday and is at Creswell on Saturday before staring Far West League play at Douglas on Jan. 16.

## SWOCC squads beat Mount Hood in region opener

The Southwestern Oregon Community College men's and women's basketball teams both easily beat Mount Hood on Saturday in the NWAC South Region opener for the schools. The men had six players finish in double figures and beat the visiting Saints 90-70. Kaison Hermann led the Lakers with 17 points and Connor Wilson had 16 as SWOCC improved to 13-1 on the season. Quinton Christman hit four 3-pointers and scored 14 points, while Stockton Young had 13 and Jett Lundberg and Brighton Palmer 11 each. The Lakers did a great job sharing the ball, with Christman and Lundberg having six assists each and Palmer four, to go with a team-high eight rebounds. The Lak-

ers had 27 assists on 32 total baskets and shot 50 percent overall for the game. Leyton Nield had 25 points and Oliha Loyuk 23 for the Saints. This week, SWOCC is at Lane on Wednesday and hosts Clark on Saturday. # ODFW seeks nominees to represent Oregon on Pacific Fisheries Management Council



ODFW is accepting nominations for a seat on the Pacific Fishery Management Council (Council). The three-year term for this Oregon at-large seat begins Aug. 11, 2026.

The Oregon at-large seat currently is held by Brad Pettinger who is not eligible for re-appointment to another three-year term, since he has completed his full allotment of terms. ODFW will send all nominations to the Governor who will then forward the names of at least three candidates to the National Marine Fisheries Service (in the U.S. Department of

Commerce) for consideration. Successful appointees must pass an extensive FBI background check.

The Council manages fisheries for approximately 119 species of salmon, groundfish (rockfish, flounders, whiting), coastal pelagic species (sardines, anchovies, and mackerel) and highly migratory species (tunas, sharks, and swordfish) off the coasts of Oregon, Washington, and California. It includes 14 voting members representing tribal and state fish and wildlife agencies, and private citizens knowledgeable about sport fishing, commercial fishing, and/or marine conservation.

The ideal candidate would be knowledgeable about fishery resource conservation and management in marine waters off the U.S. West Coast. Specific knowledge of and experience in management issues

and fisheries is important as is a strong conservation ethic.

The successful candidate works collectively with other Council members, often making difficult decisions to fulfill the standards set forth by the Magnuson-Stevens Act. Members make a substantial time commitment to fully participate in Council business and related activities.

The Pacific Fishery Management Council is one of eight regional fishery management councils established by the Magnuson-Stevens Fishery Conservation and Management Act to manage fisheries from three to 200 miles offshore of the United States coastline. The Pacific Council is responsible for fisheries off the coasts of California, Oregon and Washington.



## South Slough Visitor Center Entrance Improvement Project Begins January 2026

CHARLESTON, Ore. – The South Slough Reserve will begin construction on a major entrance improvement project at its Visitor Center this January. Originally built in 1985, the Visitor Center receives over 3,000 visitors a year from school groups and community members.

The improvements will alleviate traffic issues, create needed space for school buses, and improve pedestrian paths. In addition, electric vehicle (EV) charging stations, bioswales for stormwater management, and native plant landscaping will be added to support sustainability and habitat restoration.

The project is funded by a \$1.62 million NOAA Procurement, Acquisition and Construction (PAC) grant, and will be led by Morello Construction.

“This project is a critical investment in the future of the Reserve,” said Reserve Manager Patricia Fox. “It will make the Visitor Center safer and more accessible for all.”


Construction will run through May 2026, with initial work starting in January. Visitors should expect changing parking locations, selective tree removal, and temporary one-lane access. Trails remain open daily from dawn to dusk and the

Visitor Center will remain open Tues-Sat 10-4 pm.

The first of 30 National Estuarine Research Reserves around the nation, South Slough Reserve is a leader in improving understanding of estuaries and coastal watersheds. The Reserve manages and studies nearly 7,000 acres of natural area, including open water channels, tidal and freshwater wetlands, riparian areas, and forested lands. A portion of this area includes waterways, trails, and a visitor center that are open to the public.





# As I See It

The Oct. 31, 1957, Western World was full of photos and a long story about the long-awaited dedication of the Harbor Lights Junior High School and the Bandon High School gymnasium (first photo). Among those on the stage were members of the school board, Elmer Gant, William Pullen, Jr., John Goodwin, Ruth Prahar and Ralph Swenston; Superintendent Roland L. Parks, high school principal Alvin Mullikin, junior high principal Loren Steiner, former school board members L.D. Felsheim, W.J. Sweet, Fred Moore, Howard Tucker, John Goodwin and George Chappell, BHS studentbody president Don Asay and Harbor Lights president Art "Mike" Dobney, Jr. Guest speaker was Winston Purvine, president of Oregon Technical Institute of Klamath Falls, who praised the school board for adding 23,000 square feet of floor space at a cost of \$9.86 a foot, when present school buildings were costing as much as \$14 and \$16 a foot. "In presenting the keys, Mrs. Prahar said that the gym was the solution of the citizens' planning committee and the school board to urgent problems, problems of deterioration and inadequate size of the 50-year-old gym; of its poor location (in east Bandon) necessitating expenditure of money and physical education class time for student transportation; of the need for a building large enough for community programs, and the lack of hot-lunch facilities for upper-class youngsters. "The keys to the Harbor Lights school were presented by Ralph Swenston, school board chairman, to Principal Loren Steiner and to Art Dobney Jr., first president of the junior high studentbody (second photo). Principal Mullikin (at the mic in the first photo) was the master of ceremonies which began with a presentation of the colors by Bandon Explorer Scouts, Larry Gerber, Color bearer; George Sweet and Dayton Turner, color guards, who

led the flag salute. The BHS band, under the direction of L.E. Wright, then played the 'Star Spangled Banner.' "Specially honored were Mrs. Mabel Howard (third photo), who has a grandchild in every grade of the Bandon schools, and Mrs. D.P. Jenkins, introduced as the 'dean of Oregon school board members.'"

I mentioned last week that Jon Sullivan, who has been on the Bandon school board since September 2024 has resigned from the board, saying the experience of doing the job has not been easy. I will share his resignation letter in part.

“During this time, I have been targeted by people inside and outside the district over a period of months going back to June of this year. False accusations have been raised against both me and my family -- including my daughter, a 7th grader at Harbor Lights when the accusation was made. I raised my concerns about these interactions in writing to two board chairs for support with navigating this situation and received none. I have had board members engage unprofessionally with me both verbally and in writing; at times making false accusations to me directly and at times repeating the same false accusations made by others, again with no proof. Despite this I have not once made any public comments about my experience on the board as I was worried it would add to the tensions that have come to plague our district. A full report of these issues, with documentation, is being submitted to the board as an official complaint.

“I want to be clear: the issues within our district are serious, pervasive, and will remain after my departure. The current response to our district’s parents and its workforce is not normal, nor is it healthy. Every school district in the state, Bandon included, will face serious decisions that need to be made in the coming years due to funding cuts at the state and federal level.

Each day we do not address the issues that community members have been raising for months is a day that we can't spend rebuilding the trust and mutual understanding between staff, district leadership, and community members that will be needed to survive difficult decisions that will be made in the years ahead. "I would also like to briefly address the allegations that have been made against me on social media. They are baseless, inaccurate, and have been presented without any evidence. What is real, though, is the escalating threat that appears to be focused on my family. At this moment, I must put my own and my family's safety first. The escalating vitriol in this community is counter to our collective goals. It has negatively impacted my health and my family's safety in real ways that I can no longer ignore," said Sullivan.

So sorry to learn of the Christmas Eve wreck on the Trans Pacific Highway north of North Bend, which took the life of a 19-year-old Bandon man and resulted in the arrest of the driver.

Lila and Bobby Quarisa posted on Facebook that a Celebration of Life was to be held Sunday, Dec. 28, for their son, Austin, who died in the wreck. The driver, 22-year-old Reef Berry of Bandon, was taken into custody on initial charges of second-degree manslaughter, as well as other charges.

People are reminded of an informative presentation, Dying to Know, which will be presented at the Bandon Community Center/The Barn on Friday, Jan. 30, from 1 to 4 p.m., sponsored by Community Health and Wellness and the Bandon Public Library. Dying to Know can include topics related to death, from the process to legal concerns, and there will be at least three presentations from local organizations about their knowledge about death, according to Lualhati Anderson, with Community Health and Wellness. A person can do a Google search on "dying to know Bandon" or on an Eventbrite website for the registration page for the event. People can also call Anderson at 541-751-5024 to register.

scheduled for Wednesday, Jan. 21, from 5 to 7 at the Veterans of Foreign Wars post on Bates Road. The February mixer will be hosted by Columbia Bank (formerly Umpqua Bank) on Wednesday, Feb. 18, from 5 to 7.

I've heard that there is a sale pending sign on the former Minute Cafe building on Second Street in Old Town, but I have not been able to find out who is buying the building. My usual source says he has an NDA (non disclosure agreement) and could not share the information.

Other commercial properties for sale include Shooting Star Motel, \$1,350,000; the former Shindler Drug Store building adjacent to McKay's, \$399,000; the Broken Anchor business, \$519,000; Lord Bennett's, \$2.2 million; the former Italian restaurant building south of town, \$1.1 million; LaKris Motel, \$1,550,000; Billy Smoothboars, \$985,000; and the former coffee shop building on Second Street, \$450,000.

I spent much of the past week at Southern Coos Hospital with my sister, Molly Dufort, who was diagnosed with cat scratch fever after suffering a number of puncture wounds while holding her cat, who was having a seizure. As I write this, she has already been in the hospital five days, undergoing IV antibiotics, but is hoping to be released on the 29th. She has received wonderful care from Dr. Doug Crane and the staff, but it's not how any of us planned to spend the Christmas holiday. She's had lots of company from her siblings and friends. Earlier my friend Kay Hardin went to the emergency room after her cat injured her while she was trying to put him in a cage to take to the vet. Although the infection had

begun to spread up her arm, antibiotics caught it in time so she did not end up in the hospital.

I've learned that there has been a serious outcropping of fruit flies in various sections of the city. One friend told me she has had swarms of them come into her house, and has killed literally hundreds of them. She Googled what to do and learned that spraying Raid ant and roach killer down the drains at night seems to work, as do various kinds of fly traps. We agreed this is not normal for this time of year.

Someone reported seeing a carport blowing down 11th street at the height of the wind storm last week, but a friend told me it was actually a greenhouse that had blown out of a fenced backyard and down Elmira, without knocking down the fence.

During the storm, someone posted on Facebook that Bandon Fire and Bay Cities Ambulance had been called to milepost 228 for a vehicle that hydroplaned and was on its side. The information was relayed from ODOT employees who were in the area placing high water signs at Four Mile. The driver appeared to be out of the vehicle and was being transported by ambulance to the hospital.

Another posted; "It's too bad that all of the work they did over the summer still didn't fix the (flooding) problem." We all remember that the main highway south of Bandon was closed from Friday night to Sunday night as ODOT worked to replace a huge culvert in that area.

By now most have probably heard that Turning Point USA has rented the Egyptian Theater for a rally/town hall gathering in late January. Someone made a thoughtful post about the issue: “As Turning Point USA arrives and as local protesters gather, the question before us is not which side we agree with. The question is whether we still believe in the rule that protects them both (referring to the First Amendment). If we do, then our path is clear. We let people speak. We let people protest. And we insist that everyone does so peacefully.”

People are reminded that the new quarterly art show at Southern Coos Hospital is titled "Black & White & Gray," with a reception scheduled for Sunday, Jan. 11, from 2 to 4 p.m. in the hospital lobby. People can deliver their art on Sunday, Jan. 4, from 2 to 4, although they would prefer you bring your work before 3 p.m., and it must be ready to hang.
