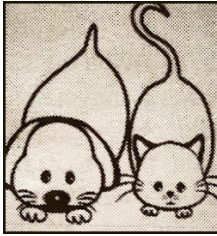

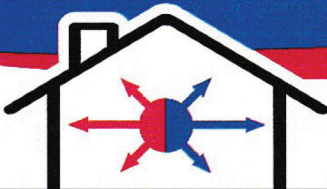

First, a grateful thank you to our donors & moral supporters.

- **Why the Coffee Break?** 1) 8.2020 **City Attorney (CA) Carleton** told the City Council (CC) to not have contact with us, 2) City's online mtgs. allow public exclusions, 3) Rules of Council violations, 4) the use of police bouncers, & 5) **the mendacity**. Why is the City **violating the 1st Amendment**? City of Bandon has chosen to have no contact with us since 1.26.2021, **City Manager (CM) Chandler's litigation threat**.
- **12.13.21 The municipality, the City of Bandon**, defamed Bremmer & O'Dea, & posted lies on its Facebook & City website. Under your advisement **CA Shala Kudlac**?
- **Bain Insurance Agency/CIS Agent of Record**, "accident" claim CIS File # GBLAN 2021089718 is resolved? Is a letter from CIS about the **12.13.2021 new "accident"** coming? The one you "like" on Facebook. Does this all fall under the **"Excessive Crime Coverage Declarations"**?
- **CM Chandler's contract** protects him **personally & professionally**. OK'd by Mayor (M), CC, & CA Kudlac. Ratepayers will pay to defend Chandler & pay his victims.

Thank you City of Bandon, CM, CC, M, & CA for the recent useful exhibits.

- Councilor Braun admitted guilt for violating **ORS 244.040(1)**. When will he step down? Protected for yrs. by M & CC... **no record of payment for the ~\$7,000 debt...no lien** on his Council stipend. Yet, **the City filed a \$1,5000 lien against an elderly Bandon woman for gorse clean up**. Was she offered a payment plan?

A Tale of Two... Hearings (Part 1)

Out of State Billionaire Developer, (how everyone should be treated):

- **Private meetings** with CM, M, & Planning Director prior to entering into procedures leading to development. **Public & private** contact when necessary during the permitting process.
- **Deference** to the developer & his agents when questions arose. Polite, respectful treatment during the public meetings and hearings; no threats, no rude interruption of speakers, & no police bouncers.
- Granted adequate time to present the project and answer questions (4.2018-4.2021); **extension** of time was given **without penalty**.

Elderly Bandon woman, (how no one should be treated):

- Complex legal problems of a local elderly woman were brought into a public hearing about gorse abatement. Without the woman present, the M & CC made no attempt to delay & held the hearing without her.
- The M & CC were provided with 45 pages of legal documents delineating the complexities of the hearing before them (see docs & video for the CC mtg. 7.6.2020). The size of the doc file begs the question as to whether the M & CC **read & understood** the issues **before** they sat in judgment... incl. the code compliance **officer's missing files**, the **threat of a lien**, an **unclear property title**, a trustee scam against the woman, & the **possibility of her losing her home** and self-sufficiency, all over a gorse issue. **City property gorse-free?**
- When the woman appeared in the chamber, the M allowed her to speak for **3 min.**, **but not uninterrupted**. One of the more **unethical & unprofessional actions demonstrated by M & CC** was their conduct toward the woman. See what derisive, badgering, bullying, threatening, & downright rude words these "City Leaders" snarled at the woman...ending with **M directing police to remove her** from the chamber.

Who is steering Bandon? Steer Bandon LLC? South Coast Housing LLC? Same out-of-state billionaire developer? Who is paying for the impact on public infrastructure? How about Bandon partnering with its ratepayers to steer Bandon? Remember ORS 244.040 (1).
