# **Feds** prep 1.2 M acres for wildfire season

With peak wildfire activity predicted in the coming months, the Department of the Interior (DOI) has been working tirelessly to implement preventative measures to limit the size and scope of wildfires, treat current wildfires already underway, and protect wildfire-prone areas to best safeguard people and their communities.

"As stewards of one-fifth of the country's public lands, primarily in the West, we know that our ability to be prepared for wildfires and reduce their severity is paramount to protecting communities and saving lives, said U.S. Secretary of the Interior David Bernhardt. "In collaboration with local, state, and other federal partners, we are using everything in our arsenal to prepare for wildfires this year, treating more than one million acres.'

As a part of the DOI, the Bureau of Land Management (BLM), the Bureau of Indian Affairs (BIA), the National Park Service (NPS), and the U.S. Fish and Wildlife Service (FWS) contribute to a total workforce of 4,500 firefighting personnel, 500 tribal firefighters, 151 smokejumpers, 18 interagency hotshot crews and 4 Tribal hotshot crews

These firefighters will have over 600 pieces of specialized equipment available for use, including engines, water tenders, dozers, and other equipment. Aviation assets also play a

# Suspected ammonia leak sparks HAZMAT response, evacuation

**Headlight Report** 

HAZMAT teams have cleared the location of a possible ammonia leak in Tillamook County.

Tillamook 911 was notified of a possible ammonia leak from storage tanks around 5:52 a.m. Tuesday, Aug. 27, at 31595 Sandlake Road near Cape Kiwanda.

Tillamook County Sheriff's Office said in a press release that two large, older commercial tanks around 300-gallons in size were reported to be at the location, part of an old mink farm from about 50 years ago. The ammonia was used as a refrigerant in the cooling system.

The caller, Dan Krueger, reported that he could smell ammonia in the area of the buildings.

Nestucca Rural Fire Protection District units responded, notifying the Oregon State Fire Marshal as well as the Oregon Emergency Response System, which dispatched hazardous materials and decontamination teams from Salem and

Tualatin Fire and Rescue to assist.

Two nearby residences were evacuated, according to the Sheriff's Office.

At around 10:13 a.m., response crews arrived and located the buildings and storage tanks, which were evaluated and found to be clear of any gasses. At around 11:35 a.m. the scene was declared

free of any hazard.

Emergency response crews were dispatched from Nestucca Rural Fire Protection District, Tillamook County Sheriff's Office, Tillamook County Emergency Management, Tillamook Adventist Ambulance, Salem Fire HAZMAT, and Tualatin Valley Fire and Rescue.

# Manzanita council to add \$6.5M bond to ballot

The Manzanita City Council meeting met on August 7, at 7 p.m. at Manzanita City Hall. This meeting discussed the City Hall Project and offered a general update on the new city hall, as well as acting to place a bond measure on the Novem-

Randy Kugler, former city council manager, began by reading his latest presentation about the ongoing water budget issue. Kugler writes that at the July 10 meeting, the mayor attempted to explain how the city water utility operated in order to justify excessive salary payments from the water fund for the city manager and assistant city manager. Mayor Scott had stated, "If the water system was a separate business, it would have its own manager and board of directors."

"The city water system is not a separate 'business'," said Kugler. "It is a utility owned by the citizens of Manzanita, operated and managed by employees of the City, under the ultimate authority of the elected City Council who enjoys some discretion

# Old Oregon Smokehouse known for fish & chips and more

If you ask around in Tillamook County, Old Oregon Smokehouse has a solid reputation for serving up some of the best dishes around. An Oregonian article recently awarded two top slots to the Smokehouse for best fish and chips on the coast, one for each location, adding to a long list of accolades that includes a nod from USA Today for best seafood.

With locations in Rockaway Beach and Tillamook, it's likely you've seen the restaurants before. One is directly across from the Tillamook Creamery, the other is tucked away on the main drag in Rockaway. Both spots offer a surprisingly diverse menu that is highlighted by wide array of seafood, too much to list here. There is quite a bit choose from for taking home, too.

Harold, Cindy and Adam Brecht own the Old Oregon Smokehouses. They run the restaurants themselves along with manager Sandy Dix-

son and a staff of around a dozen between both locations. They're particularly proud of the fish and chips, hand-breaded with a dry batter and fried to perfection. The clam chowder is acclaimed as well, and the crab dishes are among the most popular. They scour the Pacific Northwest coast for the best to fill out the menu.

It's not uncommon to find a line outside the Rockaway Beach location at opening time. Hundreds of rave reviews on Yelp and strong local following keep the cozy spot packed year-round. During the Kite Festival this year, the line stretched down the sidewalk to the corner, dozens and dozens of people eager for a taste. Old Oregon Smokehouse is said to be the longest running restaurant with the same owners in the community.

Harold ran his own logging company before an injury forced his retirement, leading the Brechts to the seafood market and later the restaurant business in Scappoose around 25 years ago. It was a natural fallback after growing up around

his mom's restaurant. The Rockaway Beach Old Oregon Smokehouse opened seventeen years ago and hasn't slowed down since. Around a decade ago, they opened the Tillamook location. The secret to their success is working for it.

"If you want to be successful,

you've got to work hard," Harold said. It's paying off. The past four years have seen significant increases in business for the Brechts. As locals hear the good word and tourists flock to the shores, they expect to keep seeing crowds line up to check

# 6.3 quake felt off Oregon Coast

The U.S. Geological Survey (USGS) reported the quake at about 8:07 a.m. in the Pacific Ocean with a depth of 3.3 miles. USGS stated they have received over 100 reports of people feeling the shake but there is not a threat of a tsunami from this earthquake.

No immediate damage or injuries have been reported at this time.

"The earthquake is on the Blanco Fracture Zone and this is where you have the Juan De Fuca Plate sliding against the Pacific Plate," said Althea Rizzo, Oregon Emergency Management


Geological Hazards Program Coordinator.

Rizzo said the area gets lots of earthquakes such as this larger one, but they are so far away from the coast they don't have any impact other than reminding us that earthquakes can happen at any time.

"There is no relation between this area and the Subduction Zone," Rizzo said. "They are on opposite sides of the Juan De Fuca Plate."

"This is a great opportunity to spend some time this weekend talking to your family about emergency preparedness," Rizzo said. "Make a plan do something this weekend while you have the extra time to be better prepared. it could be buying extra bottled water, extra food and practicing your tsunami evacuation route.' For more informa-

tion about disaster preparedness, visit the Federal Emergency Management Agency website at ready.gov. Rizzo also recommends that you contact your local fire department to find out if there is an active Community Emergency Response Team group in your city of town and how to get involved.

of directors," said Kugler.

One of the other main topics that were discussed at the meeting was the Underhill project. The city council has been doing weekly questions and answers with the community and will continue to do so as long as people show up. These meetings are at 4 p.m. at the city hall or fire station.

The council announced that in this meeting, they would act to place a bond measure before Manzanita voters. If the council approves, voters can still appeal the ballot title. September 5 is the deadline for the city to submit the measure.

One of the mandates for the measure is to get a sense of the cost involved. The city council explained that the bond would be an addition to property taxes for Manzanita voters. It would be a \$0.50 increase per thousand dollars of assessed valuation.

"We believe this is a feasible number, but it could be less, if needed," said City Manager, Cynthia Alamillo.

The bond measure won't be any more than 6.5 million, said the council. The bond

measure includes construction of a city emergency hub, police office, administrative and workspaces, multi-purpose room, and a kitchenette with storage spaces. The funds are expected to pay for demolition and construction. The bond may be issued at multiple series.

Alamillo says that the tax will be for a term of up to 31 years for the citizens of Manzanita. They think they will be able to get some grants from outside sources, which would reduce the tax cost. Once the bond is approved, it could take one year for them to be issued. Everything has to meet the Secretary of State standards.

Citizens of Manzanita will have the first week of September to challenge the language of the bond. A citizen asks if the \$6.5 million includes interest. The city council says that it does and that they are hoping to lower the amount by getting outside

A member of the audience, Gerald Wineinger, says that there is a hidden \$3 million.

"To calculate the \$0.50 per thousand valuation, they had

to know the total including an assumed interest, which is really upward of \$9.5 million with interest and issuance fees," said Wineinger. "They separate the land costs and everything else, which a guess is this project will cost totally more than double \$6.5

million." The city council says that the loan for the land is paid with other city funds and is not included in the bond.

Another citizen points out that the Public Facilities Advisory Committee spent a year investigating grant possibilities and found none. Grants are competitive and other communities are vying for that money. According to the council, the USDA has suggested that there are available funds. The council hopes to retire bonds faster than 31 years. A motion was made for placing the bond on the November ballot and was passed by the council. The next step is for the City of Manzanita to submit a notice. Anyone in Manzanita can appeal the ballot title. They can go through a process through Tillamook

critical role in efforts to manage wildfires as the DOI will have access to 23 single engine air tankers, 6 water scoopers, 41 Type 1, 2 and 3 helicopters, and a number of other aviation resources.

The Trump Administration has prioritized active management of the nation's public lands as provided in the President's Executive Order 13855 and Secretary's Order 3372, which establish a meaningful and coordinated framework for

ensuring the protection of people, communities, and natural resources. Implementation of both Orders is a priority for reducing the risks of deadly and destruc-

tive wildfires.

This year, the BLM began analyzing a significant, 11,000-mile stretch of strategic fuel breaks to combat wildfires in the Great Basin, which includes portions of Idaho, Oregon, Washington, California, Nevada, and Utah. This large-scale, collaborative project could serve as a means to better control wildfires within a 223-million-acre area. The environmental impact of the proposal is still being evaluated.

# 4th annual Oktoberfest returns Saturday

The 4th annual Oktoberfest will be held on Saturday, September 7 from 12 p.m. to 6 p.m. at Second Street Plaza in Tillamook.

In 2014, a group of community leaders came together with a goal in mind: they wanted to recreate the celebration of Swiss music and culture that was such a huge part of their childhood.

"A lot of us grew up with Swiss dances, festivals, reunions, and music being a huge part of our lives," said Adam Schwend, one of the original organizers, in a press release. "We felt that there would be those in the community who would love to relive those days, and others who never had a chance to experience them to have the ability to see what people were talking about when someone talked about a 'Swiss Stomp'.'

The group struggled with a lot of questions about what the event should look like, who should sponsor it, when and where it should be and how it would be paid for. Eventually, they decided to take a step back and encourage an individual organization to take the event on as a fundraiser rather than create a new organization. The Monday Musical Club of Tillamook saw it as a great way to celebrate local music and local music history, as well as raise funds for their Cultural Events concert series.

"It just seemed like a good fit," said Schwend in the release. "Monday Musical has non-profit status, can accept donations, and had a little bit of seed money to get started. It made sense and it's worked well.'

Like any first-year event, there were struggles. "Oh Lord, the first year was a mess," said Schwend. "The stage didn't show up on time, we held it in the evening and it got windy and cold, we didn't have enough volunteers.

I thought for sure no one would ever want to come back. But people came to me afterwards and said how much they loved it and how they couldn't wait for next year. I couldn't believe

The next year, the event moved to its current location, Second Street Plaza in Tillamook. An event committee was formed to handle a lot of the details, and Chef Nelia Seratista of Pacific Restaurant took control of

"It was exactly what we needed and it was a big hit," said Schwend.

What hasn't changed is the entertainment. A mixture of local talent, formerly local talent and talent from the Portland Metro area with again be on stage, especially featuring The Fabulous Polkatones, a polka band with its roots in Tillamook. Schwend's great-uncle, Al Schwend, founded the band in Tillamook in the 1970s and took it over on the road all over the western United States. When Al passed away in 1997, the band continued on and does so to this day.

Dancing is also a huge part of Oktoberfest and Tillamook will be graced with both local and imported talent. The dancers from Oregon Coast Dance Center will again take part in the event, as well as the Tirolean Dancers of Oregon, a troop of professional dancers from Portland.

Tickets for Oktoberfest in the Dairylands are \$10 and include a commemorative mug (while supplies last). Tickets can be purchased at the Tillamook Chamber of Commerce Visitors Center, at the Monday Musical Club website, www.mondaymusicalclub.com, on Monday Musical Club's Facebook page, or at the gate on the day of the event.

# Tillamook hunter wins national honor

William L. Larson of Tillamook, OR, was recently honored by the Boone and Crockett Club, the nation's most prestigious conservation and big game hunting organization. William was presented a Third Award for his typical Coues' whitetail at the

Boone and Crockett Club's 30th Big Game Awards Banquet in Springfield, Missouri on August 3, 2019.

Every three years, the finest North American big game trophies accepted into Boone and Crockett Club's big game records-keeping program are assembled for public display followed by a banquet and award presentations. A Judges Panel comprised of Boone and Crockett Official Measurers verified each trophy's final score, which is the sum total of a comprehensive series of measurements taken of antlers, horns, skulls, and tusks, depending on the species. Trophy size is a direct reflection of habitat quality,

The Boone and Crockett system of scoring big game trophies originated in 1906 as

means of recording details on species thought to be disappearing because of rampant habitat loss, market hunting, and unregulated harvest. Sciencebased conservation efforts led and funded by license-buying hunters brought those species from vanishing to flourishing.


The existence of large male specimens remains a classic gauge of successful game management and conservation strategies.

In addition to its prestigious history and tradition, the Boone and Crockett Club's records program is strongly associated with the highest tenets of Fair Chase and ethical hunting.

William's typical Coues' whitetail scored 123-7/8 Boone and Crockett points and ranks number 36 all-time for that species. It will be listed; along with 4,462 other outstanding trophies in the Boone and Crockett Club's 30th Big Game Awards.

### Reply to Chip Greening on the bbq post regarding the City Hall Underhill project

The City's current low property tax rate is the result of history and has nothing to do with the fiscal responsibility of this or any other City Council. When Oregon voters approved Measure 47 and then Measure 50 putting a limit on property tax rates, the

State stepped in and calculated all Oregon cities including Manzanita's present property tax rate in 1996 and made it the permanent tax rate. This calculation was based on the fiscal and budgetary operating conditions of the City at the time of the calculation. Then, as today short term rental monies were the major source of General Fund revenue with property taxes a distant second. While Manzanita's population was higher in 1996 than today, the City operated with less than half the number

all of the services that citizens It's ironic that you ac-

of employees and provided

knowledge how the City has managed to operate with such a low tax rate and without benefit of property taxes by using water utility revenue. This is the point that I have been raising to citizens and how water utility revenues are funding General Fund positions like the City Manager and Assistant City Manager through absurd overhead allocations from our water utility. The General Fund was not able to fund the salaries and benefits of this employee growth since 1996 and forced City officials to find creative ways to justify tapping the cash cow Water Fund to pay for these new employees. If anything, it is the fiscal irresponsibility of this City Council that has further stressed the General Fund and its ability to remain solvent by adding payments from the General Fund to repay the loan on the Underhill property.

I haven't seen anyone accuse the Council of being in violation of Public Meeting law during negotiations for the purchase of the Underhill property. As to the mystery developer, who was this and what was he/she going to do with the property? It doesn't really matter what a private developer wants to spend for a property using their own money. Public officials are held to a different standard when spending the public's money including basic due diligence like getting an appraisal and letting your appraiser know that you are only interested in the property for the land. The City bought the property using the seller's appraisal which concluded that to remove asbestos and demolish the buildings it would only cost \$20,000. After the purchase, the City's consultants now estimate those cost to be approximately \$400,000. How about removing this controversy from this discussion and have the City do an appraisal and see if they could sell the property today for what they paid for it with what is now known about the

property? What structural engineering experts are you referring to that condemned the school? The licensed structural engineer who produced a 127 page report and said during his 2 hour presentation with the City Council that the

buildings could be reused, could be brought to a Class 3 seismic rating, could have the interior reconfigured for other uses based on its simplistic construction design, provided costs for repair and structural remediation totaling \$1.3 million dollars etc. Or the expert who the City brought in who gave a 3 minute presentation to the City Council, gave an opinion that the building should be demolished with the Council not asking not a single question? When this expert delivered his 2 page "report" 3 months later for the Council and citizens to finally read, it was discovered that he is not even a licensed structural engineer. Please go listen to the tapes of both meeting to confirm what I have just said.

No one is against preparing for future natural disasters in our community. I and others are against turning what was supposed to be building a new City Hall and Police Station outside of the tsunami zone into a regional evacuation site that Manzanita taxpayers will exclusively pay for. If the goal is to now make emergency preparedness the main goal, do it the right way so that all surrounding communities that will benefit will also pay their fair share of the

facility costs. Finally, please stop the scare tactics that suggest that if you do not vote for this bond there are no other options or more financially equitable opportunities to prepare for a natural disaster.



# Governor signs expanded tuition assistance for Guard

With the signing of House Bill 2817 by Democratic Gov. Kate Brown, members of the Oregon National Guard will be able to receive tuition assistance at Oregon Health and Science University (OHSU) and private institutions in addition to community colleges and public higher education

institutions. This law will expand higher education grants to qualified members of the **Oregon National Guard** by permitting grant(s) to be used for undergraduate degree program at OHSU or qualifying private postsecondary institutions or for program or curriculum designed to lead to certificate of completion at community college, public university, OHSU or qualifying private post-secondary institution.

The law states that "grants provided under this section shall be awarded to a qualified student for up to 90 credit hours at a community college; or 180 credit hours at a public university and now 180 credit hours at a qualifying private institution; or 180 credit hours at OHSU.

This benefit will be available for the 2020-21 academic year. The provision of House Bill 2817 helps expand on House Bill 4035 signed by Brown on April 3,

2018 that established Tuition Assistance to members of the Oregon National Guard to attend public universities and community colleges, and began during the 2018-19 academic year.

Both laws require student to be in "good standing" with a cumulative grade point average of 2.0 or higher at OHSU or qualifying private and public intuitions at which they are enrolled.



# Nehalem Valley Historical Society installs civil war medallions at local cemetery

The Nehalem Valley Historical Society (NVHS) installed several civil war medallions at the Historic Nehalem American Legion Cemetery on Tuesday, August 13 at 5:30 p.m.

Val Vines Magee has led NVHS cemetery beautification efforts. She started out by seeking grant money for the project through the Oregon Department of Parks and Recreation/ Oregon Heritage



Commission. She has been brining people to the cemetery for a few years now and has had the support of the City of Nehalem.

In 2018, NVHS sponsored a program in which Manzanita's mayor, Mike Scott, spoke about Oregon's role in the American Civil War. 'He asked questions of our

society about civil war vets that are buried there," said Tom Campbell, President of NVHS. "Lyla Hendrickson and Val answered his questions and Mike did some work of his own and we learned about those civil war vets that are interred there."

Magee has since won the Sally Donovan Award for Historic Cemetery Beautification. The award also came from the Oregon Heritage Commission. The grant money funded a new split rail fence around the cemetery. This year, Eileen Nordquist

came up with the idea to have the special grave markers added to the cemetery. Nordquist priced out the markers and sought funding through the City of Nehalem. The city council agreed to pay the amount and the NVHS ordered them. These medallions are star-shaped and were placed on eight civil war vets' graves. The city halls of Manzanita and Nehalem were notified of this event.

The classes are free, and the radios are \$45 each. The radios come with the extended battery, extended and stubby antennas, programming specific to the Rockaway Beach area and have an 8-watt transmitting power. For amateur radio operators, the radios can be programmed with the HAM channels.

You are committing to sign-up for both classes, a week or two apart, which are held on a Saturday for your convenience. Practice call-ins are conducted on Sundays at 6 p.m. which are designed to give you the skills that you will need to operate your radio in an emergency or disaster. The organizers are short of funds so please make sure if you sign-up that you plan on attending because they cannot afford to carry an inventory of radios.

When an emergency or disaster of significance hits our area, chances are that cell or landline service will not be available. The radio will assist you on getting help for yourself, your family and your neighbors. The classes are not difficult. If you can operate a cell phone, you will be able to use a radio.





# Hike Netarts: Bay birds and migrating visitors



oin Oregon State Park Rang-Jers, Friends of Netarts Bay WEBS, and Portland Audubon for a 3-mile guided walk at Cape Lookout State Park on August 29 from 9am to 11:30am. Home to a variety of wildlife, join us as we explore the dynamic and ever changing Netarts Spit. Search for shorebirds and learn about the challenges facing Oregon's snowy plover population. This installment of the Hike Netarts series will focus on Bay Birds and Migrating Visitors. This is a family friendly, easy hike along the beach. Don't worry the bay is full of many beautiful and stunning birds. Also, we will only be exploring a section of the spit. The round-trip hike to the end of the spit from the Cape Lookout day use area is ~11 miles.



Mt Hebo Air Force Station was noted for its severe winds and snows. The main radome (bubble protecting the 85.5 ton rotating antenna) was blown off

the hill during the October 12, 1962 Columbus Day storm and two other times. The wind speed gauge was blown off at 125 mph and the total wind speed was estimated at 175 mph. The antenna was damaged as well. Each replacement was designed to withstand the extreme winds with state of the art engineering. One time the radome panels were hexagons sandwiched around five inch thick cardboard honeycombs like found in hollow core closet

doors. Another time the panels were triangles and trapezoids with every side a different length to eliminate harmonic vibrations which tore apart Galloping Gertie, the Tacoma Narrows Bridge. On the final replacement the large model 24 radome was reduced in size to the smaller model 27 radome. Above ground eight foot diameter corrugated galvanized steel tunnels were constructed to protect the airmen walking between the administration building, Bachelor Officer

# Nehalem scenic waterway committee to meet

The Nehalem Scenic Waterway Rules Advisory Committee will meet 5:30 – 7:30 p.m. Sept. 5 in the kitchen meeting room at the North County Recreation District Community Center, 36155 9th St., Nehalem. The meeting is open the public, however there will not be an opportunity for public comment.

On the agenda: a committee discussion of proposed rules for regulating the new waterway.

The Nehalem River Scenic Waterway was designed by Gov. Brown in June. Oregon Parks and Recreation Department (OPRD) manages the scenic waterways program; part of that management involves adding specific rules for waterway use into Oregon Administrative Rule.

The Nehalem Scenic Waterway Rules Advisory Committee is tasked with reviewing proposed waterway rules and recommending them to the Oregon State Parks and Recreation Commission. The advisory committee is staffed by volunteers and includes local land owners and representatives from local governments, state agencies and nonprofits.

The commission will hear the proposed Nehalem Scenic Waterway rules at their next meeting mid-September.



The rules will then be open to a public comment period, including a public meeting in Nehalem later this year. The commission will review the comments and make a final decision on the proposed rules by the end of the year.

The Nehalem Scenic Waterway is a 17.5-mile segment that runs through Clatsop and Tillamook Counties. It begins at Henry Rierson Spruce Run campground and ends at the confluence of Cook Creek, near Cougar Valley State Park.

The waterway's designation recognizes the outstanding scenic, natural and recreational values of the river segment. It's the 23rd waterway designated under the program.

Quarters (rounded corrugated steel building), bowling alley/ snack bar, Bachelor Airmen Barracks, Gym, Dining Hall, and the Operations Buildings. The tunnels were anchored to the ground similarly to the way mobile homes are anchored to the ground these days, less the tunnels be blown away as well.

Initially, the radars were used to spot airplanes and F-106s stationed at McCord AFB near Seattle would intercept potentially unfriendly aircraft. During the years Mt Hebo AFS was operational, 1957 to 1979, Russia changed from airplanes carrying atomic bombs and flying horizontally and relatively slowly to ballistic missiles launched vertically very quickly from submarines. Our radar adapted to meet the new threat. After the missile completed its short propulsion burn, it flew ballistically like a baseball after leaving the bat. When our radar pinpointed exactly where the missile was twice, the computer would draw the rest of the parabola and tell us where it would land and when. There were no antiballistic missiles in those days. The radars could only provide warning.

While awaiting the radar's modification, Ronald Watson was assigned Assistant Boy Scout Master of the Hebo troop and he married the lo-

cal Beaver, Oregon pastor's daughter/ public school teacher Linda King. With no wedding reception hall at the church at that time, the whole group including second graders, church people and Air Force personnel and dependents walked together along busy Hwy 101 on Friday evening down to the corner where the Shell station is, and crossed as a group to get to the Beaver Fire Hall where the trucks were rolled out and the reception took place. Traffic was stopped on Hwy 101 by Air Force officers in their white mess dress uniwhile everyone crossed safely.






