## Tillamook County moves to Moderate Risk as cases increase

Tillamook County moved into Moderate Risk Friday, March 12, through March 25. Tillamook County Health Department reported 31 new confirmed and presumptive cases from Feb. 21 through March 6.

Emergency Coordinator Ed Colson said the next movement day will be Friday, March 26. If cases increase above 45, the county would move to High Risk.

"Indoor social gathering size decreases to eight with no more than two households," Colson said

of Moderate Risk. "Outdoor social gatherings are limited to 10 people."

Colson said cases are increasing in Tillamook County. The majority of the cases look to be from close family members.

"From Friday, March 5, through Thursday, March 11, we have 21 new confirmed cases," Colson said. "We have 16 positive and 5 presumptive."

The health department is monitoring over 50 cases. There are no COVID-19 hospitalizations in Tillamook County this week.

Oregon Health Authority reports a total of 437 positive cumulative tests, as of Thursday, March 11.

COVID-19 testing is still available through the health center's acute clinic, Colson added. To make an appointment, call 503-842-3900.

Vaccines administered this week by the health department and vaccine partners include 733 primary doses and 420 booster shots. A total of 1,947 Phase 1A booster doses have been administered since the vaccine was made available. A total of 5,113 primary vaccines have been administered in the county so far.

Colson said when being called to schedule a vaccine appointment, vaccine partners will try calling three times and leave a voicemail. After

the third time, they will put you back on the list if they were not able to reach you.

When arriving for a vaccine, if you arrive early, wait in the car until your vaccine appointment time, Colson added. Rescheduling or canceling your appointment makes it difficult to administer doses, so commit to your appointment.

Those 65 and older are encouraged to fill out the online eligibility form at <https://tillamookchc.org/coronavirus/vaccines/>

Adventist Health Tillamook President Eric Swanson said for Region 1 hospitals – which includes

Tillamook, Clatsop, Clackamas, Columbia, Multnomah and Washington counties – 70 adult ICU beds are available. A total of 121 people are hospitalized with COVID-19 across Oregon.

"In Oregon, we have 772 ventilators available today," Swanson said.

Almost 60 percent of Adventist Health Tillamook's staff has been vaccinated. The hospital is working on bringing its volunteers back after those who wish to volunteer have been vaccinated.

## Patricia Croman-Scott celebrates 100th birthday on St. Paddy's Day

Today we celebrate Patricia-Croman Scott's 100th birthday.

The first of three siblings, she was born on Saint Patrick's Day in London, England in 1921 and attended Catholic primary and convent schools. At an early age she developed her prominent traits: love of God, love of family, and an eccentric sense of humor. Pat graces every soul she meets with an infectious smile and a hug with her favorite inspirational saying, "You know God loves you!" Known as "Tutu" to her grandchildren, "Mom" to her kids, and "Silly Patty Venes" to her mother, Pat relied on her Catholic faith to guide her through her tumultuous life.

During World War II, she enlisted in the Women's Royal Navy. Her unit provided staff support for D-Day, and she remembers

hearing the bombers taking off in the early hours. She later traveled to Australia on an aircraft carrier to join a WRN group providing support for the planned invasion of Japan. Just before D-Day, she met William Croman (an American Navy Intelligence Specialist), at the "Donut Dugout" near Portland, England. When Bill returned to the States, the two corresponded until he proposed by mail. They married in 1945 in Vancouver, British Columbia and settled in Vanport, Oregon where they started a family. After Bill's graduation from University of Portland in 1951, they moved briefly to Washington, D.C., where Bill served during the Korean War. By 1953 they had relocated to Linda Mar, CA, (now Pacifica) where they settled in a new subdivision with other post-war families.

In Linda Mar, Pat was active in her local parish and relished being the "rummage queen" in charge

of the church's annual rummage sale. She co-founded the Teapots, a social club for British war brides, and also tried her hand at selling Tupperware. The ultimate multitasker, Pat took on a position as a journalist after the arrival of their fourth child. While working for the Pacific Tribune, a small local newspaper, she wrote a weekly column contributing tidbits of Linda Mar news. Her work at the Tribune evolved into a larger part-time role, with Pat becoming the newspaper's first "woman's editor". She was then among the first women admitted to the San Francisco press corps.

In 1965, the Croman family, now with six children, moved to Lake Oswego, Oregon when Bill was promoted by his company. After Bill's sudden heart attack, Pat saw the necessity to begin a

## NKN schools return to class in hybrid model

Neah-Kah-Nie School District students return to class Monday, March 15, in a hybrid model. The school district provided an update on the model during a board meeting Monday, March 8.

Garibaldi Grade School Principal Janmarie Nugent said the school had K-3 students back for onsite Feb. 16. The school had half of fourth and fifth grades two days a week and the other half the other two days.

"We have 95 kids that will be back onsite on Monday and 20 that will remain in CDL," Nugent said.

The school has made some tweaks to arrival and dismissal of students, Nugent added. P.E. and music classes will be held in the gym.

Nehalem Elementary School Principal Kristi Woika said the school is planning right along to begin simultaneous learning. Teachers will be instructing students in person and online at the same time, with cameras set up in the classroom.

"It was really important for us as a building to support students and maintain those relationships with kids we've built all school year long," Woika

said. "The biggest class is I think 15 onsite and two online."

The school will have 120 onsite students Monday through Thursday and about 25 online students, Woika said.

Neah-Kah-Nie Middle School Principal Lori Dilbeck said a sixth grade orientation, held throughout the last three weeks, allowed for students to come into the school during what would be their normal hybrid days. Each cohort came two days, Monday and Wednesday or Tuesday and Thursday, Dilbeck added.

"The teachers went over safety protocols, showed them the building, because most of them hadn't been in the building," Dilbeck said. "That was a huge success."

The middle school is now looking forward to starting the hybrid model March 15.

"We surveyed families and out of our 188 students, 125 families chose to be in hybrid," Dilbeck said.

The other families have chosen to continue comprehensive distance learning at this time. Under Gov. Kate Brown's executive order regarding returning students to school through in-person learning or a hybrid model, individual students or parents

who want to remain in comprehensive distance learning, or who have health needs, may do so.

Dilbeck said all students would have the opportunity to leave the classroom to go to P.E. If a student is taking a band or choir class, they will be able to leave their classroom for that class as well. As for other classes, the kids will stay in one classroom while the teachers move.

"We've been planning for a long time, just like everybody else," Neah-Kah-Nie High School Principal Heidi Buckmaster said. "The most recent changes in our hybrid plan are that we went from 12 safe secure cohorts down to 11."

Buckmaster said teachers would be rotating classrooms instead of students. Students will transition to the welding lab, gym, and band and choir classes outside of the classrooms. Staff has figured out one-way traffic patterns and staggered exit times. The school has been practicing the entry routine during limited in-person learning.

"We're going to be eating meals in the classrooms as well," Buckmaster said. "We've got those routines worked out."

## Vaccines continue for 65 plus category

Tillamook County Health Department addressed the recent increasing COVID-19 cases in the county during a Tillamook County Board of Commissioners meeting Wednesday, March 10. As of March 10, Oregon Health Authority reports a total of 433 positive cumulative cases in the county.

"Limit your travel, wear a mask, stay six feet away from those not in your household, wash your hands or disinfect them frequently, as well as taking care of those surfaces you touch frequently," Administrator Marlene Putman said.

Putman said the health center continues to provide COVID-19 testing at their acute clinic, located at 2111 8th Street in Tillamook, at no cost. To schedule an appointment, call 503-842-3900.

With the number of positive cases, Tillamook County has moved to Moderate Risk, effective Friday, March 12.

## Meredith Lodging files lawsuit against Vacasa

Meredith Lodging filed a complaint Wednesday, March 3, with the US District Court of Oregon against Vacasa.

Meredith Lodging claims Vacasa has embarked on a smear campaign, contacting Meredith Lodgings homeowners and

spreading false and misleading statements about the company.

In the lawsuit, Meredith Lodging brings a false advertising claim under the federal Lanham Act, as well as defamation and trade libel claims under state law. The complaint states over the last two months, Vacasa's sales representatives have contacted homeowners who Vacasa knows are under contract with Meredith Lodging, and spreading false and misleading statements about the company, including that it "suffers from lack of cleanliness," "has problems with its housekeeping crews," and does not have "A manager to manage negative online reviews."

Annie Robertson, chief legal officer of Meredith Lodging, said

these statements are false and misleading.

"Meredith Lodging is standing up for its homeowners who have been disturbed by unwelcomed solicitation calls," Robertson said. "We are asking the court to require Vacasa to stop making these calls, falsely defaming a business."

Robertson said Meredith Lodging, on behalf of its own business and for all of the other locally operated vacation rental property management companies, is also protecting its business from untoward business practices.

Meredith Lodging is a family owned business with regional headquarters in Lincoln City and Bend, and additional offices along the

coast and Central Oregon, manages more than 700 homes exclusively in Oregon. Vacasa, based in Portland, provides property management services to over 25,000 vacation rentals in the U.S., Europe, Central and South America, and South Africa.

"We did not want to have to resort to this lawsuit," Robertson said. "Unfortunately, after sending Vacasa a letter and requesting they stop, they did not agree, and so now, we are taking a stand."

Vacasa has not responded to request for comment at the time this article was published.

# Longtime board member resigns from Neah-Kah-Nie School District

Longtime Neah-Kah-Nie School District board member Terry Kelly will not seek re-election this year, Neah-Kah-Nie School District Superintendent Paul Erlebach announced Tuesday, March 2. Kelly served from 2003-2009 and from 2013 to present, representing Zone 1 (Manzanita). His term ends June 30.

Kelly has been on the school board for 14 years. Him and his wife have three children. He wanted to be an active participant in the school district and joined the board while his kids were in school.

"When my youngest graduated last year in 2020, I felt that my mission was complete," Kelly said. "I thought about staying on because of how long I have been on and some things coming up, but I realized that it was selfish of me to stay on the board and

not have any children in the district."

Kelly said the school board currently has several members who are active parent but with him and Pat Ryan both resigning after their terms ends in June, only one of the board members remaining will have kids in the district.

"I really wanted to step aside and let somebody that was an active parent to have a chance to do what I was able to accomplish for my children," Kelly said.

Kelly's favorite part of being on the board was the sense of accomplishment in what was completed over the years. During his time, a brand new middle school was built. The board campaigned for that and had

community open meetings. The board got a bond together and passed it.

Other accomplishments included keeping up with technology by giving access to Chromebooks for every student and redoing the

track and field project, Kelly added.

The board also attended conventions in Portland, where they would spend three days and meet with other school district board members across the state.

"I will miss the people I have formed bonds with over the years," Kelly said.

Kelly and his family have lived in the area for over 26 years. Kelly works in the produce department at Manzanita Fresh Foods.

"Being in such a public forum at the produce department, a lot of parents would come to me and express their concerns on which way I should be thinking in regards to this COVID thing," Kelly said.

Kelly said these interactions also pulled him in the direction to resign.

He said after his term ends, he will "fade into the sunset" and continue to support the Neah-Kah-Nie Pirates. He encourages any parent who lives in Zone 1 – Tohl Road north, Manzanita and Bayside Gardens area – who wants to be heard, to run for the school board.

The filing period opened Feb. 6 and ends March 18 for the May 2021 ballot. Tillamook County has information for filing for a four-year school board position at <https://www.co.tillamook.or.us/gov/Clerk/default.htm>

Changes from Lower Risk to Moderate Risk include limiting gathering size to eight for indoors and 10 people for outdoors, indoor capacity for churches and funeral homes are 50 percent or 150 people total and 250 people for outdoor services, offices are recommended to implement remote work if able, and outdoor recreation and fitness establishments and outdoor entertainment establishments have a max of 150 people.

"If cases decrease below 30 for the next two weeks, we'd be eligible to move back to Lower Risk," Putman said. "Let's hope for that. It puts a lot of stress on our community, on our businesses, our restaurants, and the like."

If cases decrease, Tillamook County may move down in risk level March 26.

As of March 5, 16.9 percent of the county's population has been vaccinated for COVID-19, Putman said.

This is one of the higher rates in the state.

"The vaccine partners – that includes the health center, Adventist Health, Rinehart Clinic, and Nehalem Bay Fire District – continue to provide vaccinations weekly for all those who are eligible," Putman said. "[Those eligible include] Phase 1A – that's a whole bunch of people, including medical, people who are in group homes, people who have developmental disabilities, those types of things – and also Phase 1B, which is people 65 plus."

Vaccine partners continue to provide vaccinations. They will start scheduling people 65 and older Monday, March 15.

"We are limited by the number of vaccine we have," Putman said. "We have got a couple thousand people still in that 1B category of 65 plus."

Staff from the health

department or one of the vaccine partners will call those who have filled out the online eligibility form and get those people scheduled as soon as a vaccine is available. Putman said the best vaccine is the only that is most available. The county has been receiving the Moderna vaccine and recently received a small allocation of 100 doses of the Johnson & Johnson vaccine.

For help filling out the eligibility form, call the health department's vaccine line at 503-842-3914, available 8 a.m. to 5 p.m. Monday through Friday.

career in real estate where she won a trophy as a top listing agent awarded by the nascent Portland Multiple Listing Service. Over a period of five years, she worked for Frazier Realty and Lake Oswego Properties. Shortly after receiving her broker's designation, she opened L.C. Properties in Aurora, Oregon with partner, Mary Lockwood. In 1971 the family relocated to Butteville, Oregon when Pat and Bill spotted an 1884 Victorian riverfront home "with a lot of character". During that period, Pat also founded a social group called the "Tea Cozies" (a group of British war brides) and was an honorary member throughout her life. After Bill's death in 1978, she devoted her

time supporting her kids and helped raise grandchildren. As a volunteer, Pat spent a year working for an orphanage in Cuernavaca, Mexico. The following summer, she cooked potatoes "all day long" while working in a Baptist church camp in Alaska. During the days of no cell phones, her kids would always call each other asking, "where's Mom?" Eventually, she'd surface. She had either attended a "Father Hampsch Seminar," was at some social event; or, as her son Billy would famously quip, "Chasing a geezer".

Pat loved traveling and spending winters in Yuma enjoying sunshine, social activities, and her favorite sport - tennis. She and her former friend Lavelle Kelly (Rockaway Beach) gained local acclaim finishing as regional contenders in a national tennis tournament for the "above 80 doubles

bracket". Despite her traveling and socializing, Pat had a deep yearning to remarry, and spent 22 years searching for her perfect soulmate. In 1988, Pat purchased a vintage "fixer upper" just off the beach in (then) Rockaway, Oregon. She eventually relocated to Rockaway Beach after an extensive remodel to her home. During that time, her daughter Ann arranged a blind date with a friend's dad who was a widower. In 2001, Pat and Richard Scott married in Chehalis, Washington and lived there until he sold his house in 2004. Pat and Richard decided that the best plan was to move back to Rockaway Beach into her "fixed up" beach house. Once settled, the two immersed themselves into the community. For nearly 15 happy years, they attended local events, joined the Lions Club, and were full-time parishioners at St. Mary by the Sea Catholic Church. Pat & Dick currently reside in a one-level home in Rockaway Beach where they occasionally ride along as passengers with their caregivers doing day trips around Tillamook County. Pat & Dick still attend St. Mary's Catholic Church where Pat leads the "Amen Prayer" at the end of mass.

# GARDENING MATTERS

## Signs of Spring

**A** note before I start: Regular readers might have been puzzled by the title of my March 2nd column. When I first started writing this column in the early 2000's, my editor would come up with some pretty creative titles for me. So I have tried to carry on Mike's witticisms. Except an "R" was left off the "your," making it read "What's in you bucket?" What I was aiming for was a take-off on the "what's in your wallet?" campaign by a national credit card company. Reality made it sound like I was addressing the bucket. Sorry.

I love the beginning of spring when, in a single day, the gardens go from dormant to sprouting. The wind starts to shift from the south to coming from the north. The robins arrive from their winter break, and the leaf buds on Japanese maples – as well as all the other deciduous trees – start to swell. In a few more weeks, they will go from being the size of squirrels' ears to full-blown leaves.

It has been a mild enough winter that I had a rose blooming in late January and another is already forming flower buds. I had pruned my roses as usual in early October but with relatively mild temperatures this year so far, they never went fully dormant. That's okay. I will still prune them again this month even if I lose a few buds. That way the growth will go back into the stems, making a sturdier bush. This is important because of the winds we get at the coast. The wind can really do a lot of damage on rose stems that are

too thin. Which is why, when I prune in spring, I remove all the stems that are smaller than a pencil.

I have discovered a new and easier way to spring prune roses. And this is for those of us who never got around to fall pruning and now have an unruly bush or two or three. The first cuts are to take the plants back to about half or two-thirds their winter size. These shearing cuts don't need to be angled or precise as we will go back and tidy things up in a bit. But this allows us to see what is going on in the heart of the bush and check on its health. You may be taking some early leaf and bud growth off, but that's okay, too. It will grow back. I remove the debris of dead leaves and twigs, and tidy up the area around the bushes.

Now I can go back and take off those thin, weak branches. I like to start at the base of the plant and work upward. I also take off crossing stems and anything that looks dead or diseased. Because roses have thorns along their stalks, this becomes especially important as the thorns will damage other stems and even buds if allowed to whip around in the wind.

The next step is to go back to the plant and tidy up the shearing cuts. This is when we prune to 45 degree-angles just above outward growing buds. This gives the bush an open center. That keeps fungal diseases down.

If we are past the last hard freeze (and by now we should be!), we can add a little fertilizer around the drip line of the bushes. I like to use a three-in-one fertilizer that also has insecticide and fungicide in with the fertilizer. There are now several brands available. I like to use about one-and-a-quarter cups and place it just about where the leaves will branch out to. No need to put it close to the base of the plant as it will be absorbed when the spring rains come. Try not to put too

much on any one area for if we do get heavy rains, the fertilizer will wash away.

We have become very used to sanitizing our homes and work spaces, but we also need to continue to be diligent about sanitizing our pruning tools. Which is why I carry a container of bleach or sanitizing wipes in my bucket. I used to wipe the pruner blades down between each cut, then I realized that if I wiped them between rose bushes that would be enough. If a rose has blackspot, it will most likely have it all over the plant. By wiping between each bush, I keep it from spreading to other plants. This is true all over the garden, not just for roses. 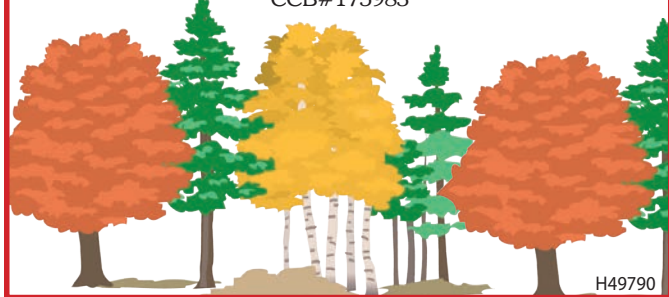

Some sad news last month about a couple drowning in Netarts Bay after their boat capsized in an outgoing tide. The truly tragic part is that they were not wearing life jackets. First responders found the couple about a mile out to sea and brought them to shore, but lifesaving efforts failed to revive them. Please wear your life jackets when boating and, for young children, even when fishing off the dock on Cape Meares Lake. Disaster can strike in an instant.

Fishing in Cape Meares Lake is on my radar because we soon can have the kids and grandkids down to visit again. By the end of spring break, we Steens will be fully vaccinated and ready to entertain again. Here's hoping all of you are making progress on the vaccine front.

While we were out on a beach walk, a message came in from neighbor Rod Pelson. He reported having heard a varied thrush when out on his walk; he says that means "spring has sprung." Varied thrushes are shaped like robins, with an orange eye stripe, orange wing-bars, and a black band across a rusty breast. Their call sounds like a low-pitched referee's whistle: a long, quavering sound followed by a pause, then another call at a higher or lower pitch. These birds winter here, but we don't usually hear them until their mating season begins in spring.

Spring whale migration kicks off in late March and will last into June, but the whale watching experience will look different this year due to the pandemic. Oregon Parks and Recreation Department (OPRD) canceled its 2021 spring Whale Watch Week program, traditionally held during spring break, meaning volunteers won't be stationed at whale watching sites. In addition, the Whale Watch Center in Depoe Bay is closed.

Some 25,000 Gray whales will pass by Oregon's shores from late March to June on

their way to cool Alaskan waters. Many will be accompanied by their calves, born during the winter in the warm lagoons off the coast of Baja, Mexico.

Visitors may still enjoy this spring tradition on their own, while following statewide COVID-19 guidelines for safe travel and physical distancing. Most viewing sites managed by OPRD are open, with reduced services in some locations due to limited resources. A map of whale watching sites is available online. Google "whale watch spoken here" for information.

"We urge visitors to explore parks close to their homes and to respect the communities they visit," said OPRD director Lisa Sumpston. "Please, wear face coverings and give plenty of space to other visitors. If a park is crowded, consider visiting another whale watching site or returning later."

As we go to press, there are

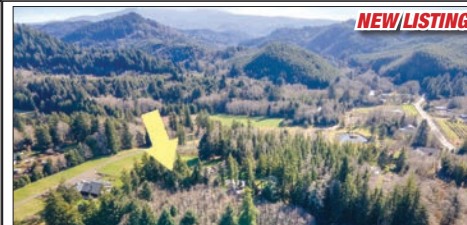

## TBCC CONNECTIONS

### Free college classes for high school students

As we gear up for Spring term here at TBCC, we are nearing the one-year mark of when the pandemic changed what college would look like for so many students. When that happened last spring, we stepped up to help our local high school students by offering free college courses to all juniors and seniors. We continued with the free classes during fall term, then the winter term, and have made the decision to again provide them in the upcoming spring term. Over 100 students each term have taken advantage of the free college classes. It is a way to help these students stay on track during an incredibly difficult and uncertain year for many.

In non-pandemic years, we have been grateful for our strong partnerships with the three school districts to ensure that high school students can earn college credit in other ways. Typically, college credit is earned in one of two ways: through Dual Credit and Expanded Options.

Expanded Options provides current high school students, who are 16 years of age or older, the ability to take college classes on their own at a reduced tuition rate. These classes are taught by



TBCC faculty at TBCC or the high school.

Dual Credit college classes are offered free to high school students. These are classes that are taught in the high school by high school instructors during regular school hours. They typically include the key foundational classes that are required in almost all college degree programs. There are also skill-building options in Career-Technical education. Students can graduate high school with a certificate in welding, healthcare basics, accounting, and more. All Dual Credit courses show on a student's transcript as full college classes and are totally free. In 2019-20, TBCC served 370 high school students and saved families over \$342,000 in future tuition costs.

TBCC is continuing to grow the number of dual credit classes to provide even more opportunities for high school students to earn

college credits. This can even lead to high school students earning enough college credits to complete one year of college or even a full two-year associate degree. Prior to 2020, TBCC had awarded one associate degree to a student graduating from Tillamook High School. In 2020, Jacob Waldron from Neah-Kah-Nie High School, graduated from TBCC and the high school at the same time. There are now two more Neah-Kah-Nie High School students that will be completing their TBCC associate degree and high school degree at the same time this year. This saves the families two years of college tuition and fees along with giving them a huge head start toward a bachelor's degree.

TBCC will continue to grow the dual credit program so any high school student can take advantage of this opportunity. Not only does it save families money, but it gives students the confidence to know they can take college level classes and be successful, hopefully encouraging them to continue on for more college.

As Nelson Mandela once said, "Education is the most powerful weapon which you can use to change the world." We truly believe this at TBCC, and want to see all young people continue their education beyond high school.

## TALES FROM THE LIBRARY

Kids say the darndest things! Way back in the time when librarians used to be able to conduct school visits with children, part of my presentation was to ask the kids for the one word they thought of when they heard the word "librarian". The five top responses usually revolved around the following words: books, old lady, mean lady, glasses, and shhhhhh! I suppose part of their answers were just looking to get a reaction from me, but I would not doubt they were serious about most of them. That would give me the opportunity to talk about another word: stereotypes!

The stereotypical image of librarians is easily supported by conducting a Google Im-



ages search for "librarian". You will likely see pictures of an old lady in a cardigan sweater, bun on the top of the head and a stern expression on her face. If that is your picture of a librarian, you need to stop into the Tillamook County Library and meet some of our staff. We do not have ANYONE that would fit that stereotype. In fact, we have a dance instructor, a roller derby queen, and a professional photographer (me) on staff!

In school discussions, I always end up bringing the conversation around to reveal that there was a time when librarians may have been a bit stern and perhaps they liked to keep things quiet and orderly. But that vision expired decades ago. Now, we are still about the books, but we are even more about the people. We want to provide information and inspiration, not just in book form, but in any format that gets our point across best. Whether it be a book, a database, a video, a program...you name it! The key ingredient is providing information and that has always been our specialty.

I admit, not everyone agrees with us branching out beyond just providing books. When I was leading library ukulele jams, I had a few people ask me why in the world I was offering something as frivolous and noisy as ukulele lessons in a library. What I tried to help them understand is the library is all

about learning, and learning comes in many shapes and forms. Encouraging and coaching a bunch of people on ukulele is not just about making noise. It is about developing a talent, expanding the mind, encouraging finger dexterity, practicing memory skills, building teamwork mentality...and so more.

Programming has become a big part of what most libraries offer, and we hope to get back to that soon. But if you think ukulele lessons are wild, you should hear what some libraries across the county offer. There are a few progressive libraries that have a "library of people" in which you can book a session with someone with a different belief/ethnicity/profession than yours to discuss their perspectives. You can check out a Buddhist, an artist, a person with autism, a refugee, a homeless person... and the list goes on. These conversations are likely to help people gain much more insight than just reading a dry text on the topic.

Some libraries have lightboxes to combat Seasonal Affective Disorder. Others have fitness bikes set up so you can pedal while you read. I have seen libraries that have full kitchens in their facilities so they can have cooking classes. Other events I have seen in libraries around the world include table tennis tournaments, comic conventions, video game competitions, a "silent disco" where people get together and dance to their own tunes wearing headphones, and one I am jealous of...a how-to-beer brewing class in which their motto was "keeping the pub in public library!"

So, stop by and check us out. You might spot one of us in a cardigan, but that is far as we go with the old-fashioned librarian stereotype!

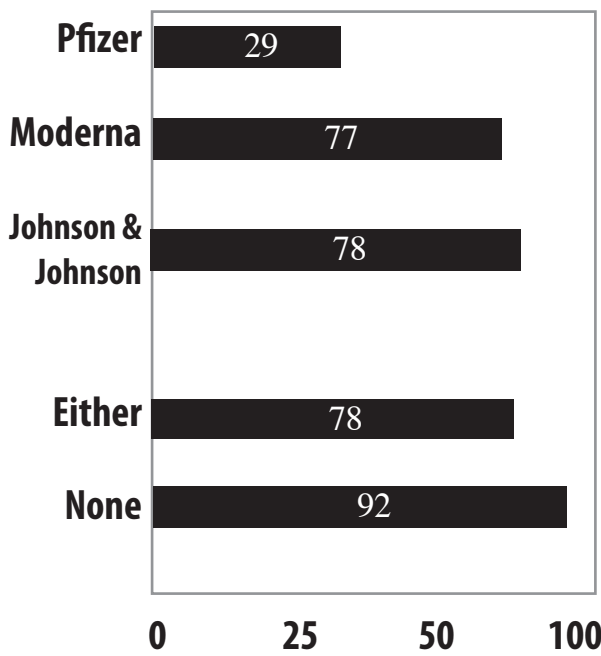

**FENCEPOSTS**

Greetings Bay City! Has this not been the longest winter? That's how it felt to me; long and sad. But as I write the Fencepost today, the sun is shining, my cherry trees are starting to bloom, and the sky is blue. Spring has sprung, and hope, renewal and healing always come with spring.

The ongoing process to update Bay City's land use regulations and Bay City Development Ordinance #374 is giving our town the opportunity to determine what we will look like and how liveable the town will be in the future. Recommendations in the action plan were presented at a special meeting of the Bay City Council and Planning Committee on March 8th. The meeting was to take questions before adoption of the final action plan. Decisions are being made that will affect businesses, housing, transportation (including bike paths, sidewalks, etc.) and the appearance of the town core; so if you have ideas or concerns, now is the time to get involved. A few of the actions being considered include:

- Establish a percentage of street-facing facades that must be covered in windows/glazing for commercial buildings.
- Require weather protection (e.g. canopies and



overhangs).

- Clarify buffering and landscaping or fence screening standards to define what constitutes buffering clearly and under what conditions it is required.
- Reevaluate the requirement for uses surrounding historic structures to be architecturally compatible with existing historic structures.

Numerous comments from community members suggested it is not important for the City to regulate architectural elements such as style, building materials, and color. Some comments suggested that existing buildings are not exemplary and should not be the basis for architectural design. Survey responses showed weak support for architectural design requirements (i.e. color palate, building materials, etc.). As a designer I would agree that some of the existing buildings are not exemplary design and should not be the basis for future design projects. However it is very important that we recognize that Bay City's future projects cannot ignore existing structures, and that existing structures need to be improved. When you have a cohesive plan for building materials, color, and architectural design for the old and the

new, the look of the community ages well.

Music lovers take note (pun intended)! The Bay City radio station, KAYN 92.9 FM, is now airing locally produced music shows as well as two syndicated shows each week; this in addition to their 24-hour "Mystery Mix", so aptly named by Charlie Woodridge. Today's programs were "Forgotten Estuary" with Ryan Goldsmith, and "Daisy Chains" by Hope Montgomery. Other programs were Mop Tops and the King" with Steve Chlemsford, "Calling all Cowboys" with Chuckaroo the Buckaroo, "Treasure Chest", and my favorite program "Dan's Story Hour".

Rob Russell, the KAYN station manager, has added a new show, "Music of My Grandparent's Generation" with Mark Harvey. It's so new you won't see it listed on the newly released program schedule. It airs on Thursdays at 1:00 PM and Fridays at 10:00 PM. BCAC was awarded a generous TLT grant from the city of Bay City which will allow KAYN to live stream all over the world via Live365 starting May 1st. The Arts Center has just put Bay City on the world map!

I will follow up next week with more information on the Arts Center's programs and their plans to improve their communications and outreach in our community. 

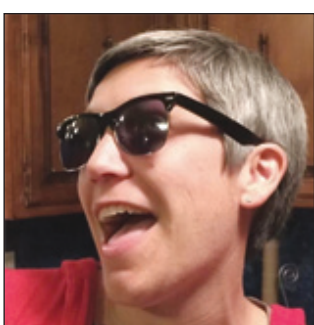

for just the perfect item to add to her little home.

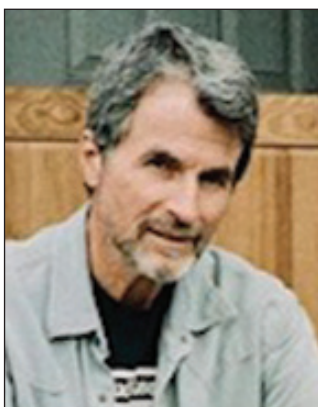

"I'm just really happy that we're able to have everyone out on the field today playing soccer again," said Snow Roberts. "We're just very happy to be able to play this season and I'm so happy to have all of my girls back on the field together, so that was good to see. Our goalkeeper Gabriella did a great job today. It's been a difficult season, but I'm very happy that our seniors get to play again. Everyone was really looking forward to playing soccer and I'm just glad that things worked out so well for

us."

The Cheesemakers played at home versus the Banks Braves (1-1) Thursday at 6 p.m. (results unavailable), which is followed by road games Mar. 15 at Rainier/Clatskanie and Mar. 17 at home versus Astoria.

Midway through the first half, it was a scoreless game as Tillamook played solid defensively, led by talented sophomore goalkeeper Gabriella Garcia (12 saves) and defenders Daisy Valencia, Kelcey Garcia, Athena Smith, Angelica Valencia, Marissa Velazquez Villa and Joselin Delatorre. Gabriella Garcia made numerous leaping and diving saves to the ground while displaying her talented athletic ability in front of the net.

"It was a very fun game, but we were missing six starters, who were unable to play because of injuries, which made it a really difficult situation for us," Angelica Valencia. "We'll play them again in a couple of weeks (Mar. 25) at home and we hope to have everyone back for that game. I played goalkeeper for the first time ever in my soccer career, to that was

really fun."

The Mooks battled the Valiants tough for 20 of the first 40 minutes of the first half. However, the Valiants, a 2019 state playoff squad, scored a goal in the 21st minute on a hard shot that Gabriella Garcia was unable to stop for a 1-0 advantage. Valley Catholic then went up 2-0 in the 25th minute.

"I'm really glad that we're able to have play soccer because I was worried that we might not have been able to play this season," said Leslie Marquez. "I knew that our school would do something special for us, especially for the seniors so that we could have a season this year."

Marquez is one of six seniors on the Lady Mooks squad that also includes, Daisy Valencia, Kim Gomez Mendez, Angelica Valencia, Marissa Velazquez Villa and Crystal Hernandez.

"We're a young team and we have five freshmen on our team too, so we're kind of getting used to playing with them," said Daisy Valencia. "We're still trying to figure out each other and we're trying to work on our communication too. I think when we get everyone healthy and back on the field playing, we'll have a chance to beat them (Valiants) when we play them again."

The Mooks were unable to stop the impressive Valiants offensive attack as Valley Catholic then scored three more goals in the next 11 minutes to build a 5-0 lead with four minutes remaining in the first half.

Tillamook responded with strong effort in the second half while playing more aggressively on defense and stopping Valley Catholic's potent offense. The Mooks only allowed one second half goal on a Valiant shot five minutes into the second half that and Mooks backup goalkeeper Angelica Valencia made a diving save attempt onto the ground, but she was just unable to stop the ball from going into the net. Angelica Valencia was substituted into the game at the start of the second half to replace starting keeper Gabriella Garcia.

That was the only time the Valiants scored in the second half, but the 6-0 lead was certainly insurmountable, particularly for the shorthanded Mooks, who were playing without six starters, who were unable to play.

The Mooks had their best scoring opportunity in the 57th minute. Following a Valley Catholic foul, Tillamook received a free kick from 21 yards out. Mooks sophomore midfielder Katherine Manderson hammered the kick towards the goal on a solid shot, but Valiant senior goalkeeper Josie Napoli was in position to make the save to help preserve Valley Catholic's shutout.

So, it's spring break time and naturally you are wanting a break! You want to get outside, have some fun, and do some exploring. But, you also know COVID-19 doesn't take a break. How can you enjoy your break and still prevent yourself and loved ones from getting COVID-19?

As much as we'd like to be saying to one another, "We can finally travel without worry- people are getting vaccinated! It's finally over!", we just can't say that yet. The truth is, worldwide we are still in the very early stages of vaccinating, and COVID-19 is still spreading. The same things we did to protect ourselves last year will be useful precautions for us all to take now, especially during Spring Break.

Just as with the Holiday Season, the absolute safest way to spend your Spring Break is to stay home. Try

planning a staycation, see those parts of town that you haven't visited in a while, spending time with those in your household.

Whether you do decide to travel, or stay in your home area, here are some practical Do's and Don'ts for planning safe and responsible adventures:

1. Don't fly, take a train or bus if at all possible.

Instead, DO drive! Using your personal vehicle to get from place to place is the safest way to travel.

If you don't have your own vehicle, consider alternative options like biking or walking. If using public transportation or sharing a ride, wear a face mask and pick a seat that is 6ft or more apart.

### Easy Manicotti

Number of servings: 14 filled shells  
Time for preparation (including preparation & cooking): 40 minutes

#### Ingredients

- 1 package (8 ounces) manicotti shells (14 shells)
- 1 egg
- 1 carton (15 ounces) low-fat ricotta or cottage cheese
- 6 ounces shredded mozzarella cheese (about 1 1/2 cups)
- 1/2 cup fresh parsley, minced, or 3 tablespoons dried parsley
- 1/4 teaspoon salt
- 1/4 teaspoon pepper
- 1 Tablespoon italian seasoning
- 1/2 teaspoon garlic powder or 2 cloves garlic, minced
- 1 jar (24 to 26 ounces) pasta sauce

#### Directions

1. Preheat oven to 350 degrees.
2. Cook pasta according to package directions and drain.
3. While pasta is cooking, beat egg in medium bowl. Add ricotta or cottage cheese, mozzarella cheese, parsley, salt, pepper, Italian seasoning and garlic powder. Mix well.
4. Pour a little of the pasta sauce in the bottom of a rectangular baking pan to

prevent pasta from sticking.

5. Stuff shells with filling (about 2-3 rounded teaspoons per shell). Arrange stuffed shells in pan. Pour remaining sauce evenly over pasta.
6. Bake for 10 to 15 minutes or until bubbly throughout.
7. Let rest 10 minutes outside of oven before serving.
8. Refrigerate leftovers within 2 hours.

#### Notes

- Add Parmesan cheese to the filling mixture.
- Add your favorite spices to sauce for additional flavor.

## "WE'VE ALWAYS HAD TO ADAPT TO CHANGE."

It's no secret. Business owners have had to make extraordinary adjustments to stay afloat during the pandemic. Government officials tell them to simply "pivot". But of course, in reality, it's a far more difficult process.

This is a story about a pair of Lincoln City entrepreneurs who have adjusted to harsh market changes for decades. How? Bruce and Lisa Polvi never complain. When faced with obstacles, they look for new opportunities and adapt. As a result, even during the pandemic, the Polvi's business ventures have emerged stronger than ever.

The son of Oregonians, Bruce was born in Montana. Despite having more than forty OSU Beavers in his family, Bruce chose Washington State University, where he graduated with a degree in Business Administration. He then studied electrical engineering before moving to Salem with the intention of attending law school. During high school and college, he had worked for Radio Shack. In 1990, when a Radio Shack franchise became available in Lincoln City, Bruce decided to forgo law school and buy it.

Lisa grew up in Elmira, in fact her parents still live there. She earned a degree in Physics and Computer Science at the University of Oregon. She then worked as a surveyor for ODOT and in engineering for David Evans and Associates. After dating long-distance for more than five years, Lisa and Bruce were married in 2003. For her, it was quite an adjustment. Becoming an entrepreneur, retailer and landlord was totally different than the world of engineering. But those changes and the marriage have certainly been successful.

If you reread that last paragraph, the most important word is "landlord". That's because from the very beginning, Bruce understood that although his businesses would constantly battle changing conditions, he could build long-term assets by acquiring the real estate that housed his ventures. And by renting to others, he could multiply that advantage.

In 1991, Bruce purchased the former Oregon Willamette Lumber building and land, a prime location on Highway 101 in Lincoln City. By 1992, he'd leased part of that land to a new Burger King franchise. Recently Burger King signed on for a new 25-year lease.

But Burger King isn't their sole tenant. Today, 22 separate businesses lease space in the Polvi's 26,000 square foot Mid City Plaza and 9000 square foot Mid City Center. In addition, Bruce and his brother are currently developing Stetson Business Park in Colorado Springs and have already sold four of the project's thirteen sites.

As we mentioned earlier, the Polvi's ventures have faced some serious hurdles along the way. In 2015, the corporation that operated Radio Shack was facing bankruptcy. Although their local store was still thriving, the Polvi's made the difficult decision to sever their 25-year relationship as a Radio Shack franchisee and rebrand as Lincoln City Sporting Goods and Electronics.

"We've always had to adapt to change," explains Bruce. "Cell phones used to be a huge part of our business - we activated more than 25,000 for Verizon and AT&T. Several years later, they decided to cut out the local franchisees and open their own stores. That was a huge blow. Another example is that after we had sold and serviced thousands of DISH and Direct TV systems, both of those companies changed their dealership models. Again, we had to adapt."

"These days we carry electronics that you can't find elsewhere and we're very well stocked with electronics for emergency preparedness, which is important here at that coast," says Bruce. With a wealth of knowledge gained from his electrical engineering background and more than 40 years of serving customers, Bruce is a great resource, answering a steady stream of electronics questions from his customers each day.

For decades, Bruce had ordered firearms for law enforcement agencies. About ten years ago, he decided that his store's emphasis should switch to sporting goods. Lincoln City Sporting Goods is a federally licensed dealer for some of the most in-demand firearms manufacturers in the industry including Ruger, Smith & Wesson, Sig Sauer, Kimber, Glock, Springfield and EO Tech. The store also stocks and supports Oregon manufacturers like Leupold, Tannerite and White's Metal Detectors.

Lincoln City Sporting Goods is affiliated with local gun safety instructors, performs background checks, and does private party gun transfers, something the chain stores typically refuse to do. "A gun store can be a valuable service to the community," points out Lisa. "We safely sell and transfer firearms for people who no longer need them, such as when spouses pass away, when people go into elder care, or when guns are left at motels."

An interesting aspect of the pandemic is that many people have felt the need to acquire firearms for personal protection. "We've always done a brisk business in guns for hunting and target shooting, but this year, state background checks are up about 35%," explains Lisa. "Those are folks concerned with their safety. 2020 was Lincoln City Sporting Goods' highest volume year ever." Part of that increase was skyrocketing demand for emergency preparedness supplies like dehydrated food, emergency blankets, ponchos, 5-day backpacks and mylar sleeping bags. "Regardless of the pandemic, when you live in a tsunami zone, like most of us do, stocking up for emergencies is always a smart idea," adds Bruce.

The 8-person staff of Lincoln City Sporting Goods and Electronics has more than 150 cumulative years in the firearms industry. "This is a service and knowledge-based business", mentions Bruce. "Our customers choose our store because we can answer their questions and recommend the right products for them." New to the store's staff in recent years are the Polvi's children, Logan and Skyler, who seem to have learned from their parents' work ethic.

It was because of the pandemic that the Polvi's reexamined their banking relationship. "We'd banked elsewhere for decades," explains Bruce. "Yet when we asked our old bank to submit a PPP loan to keep our staff employed during the shutdowns, they were unable to produce. Through his hard work, Jedd, who manages the Oregon Coast Bank office here in town, was able to get our PPP loan done in just a few days. He also successfully guided us through the reimbursement process. We were so grateful that we eventually moved over all of our accounts. Jedd and Oregon Coast Bank earned our business."



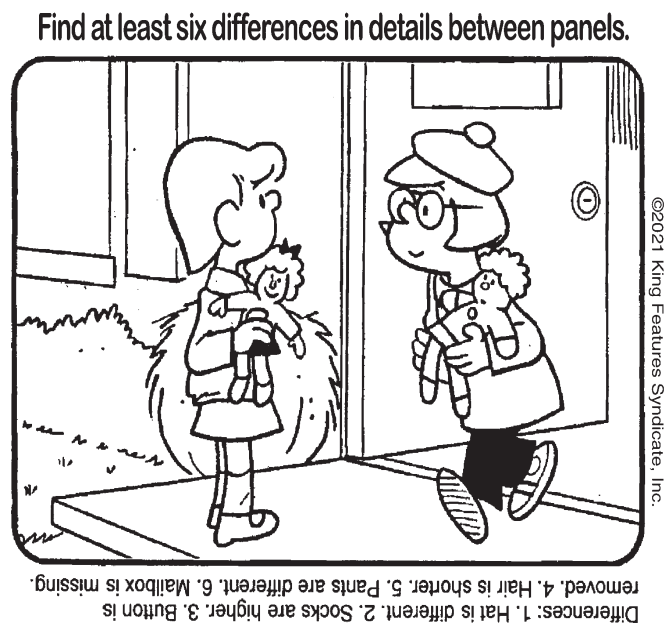
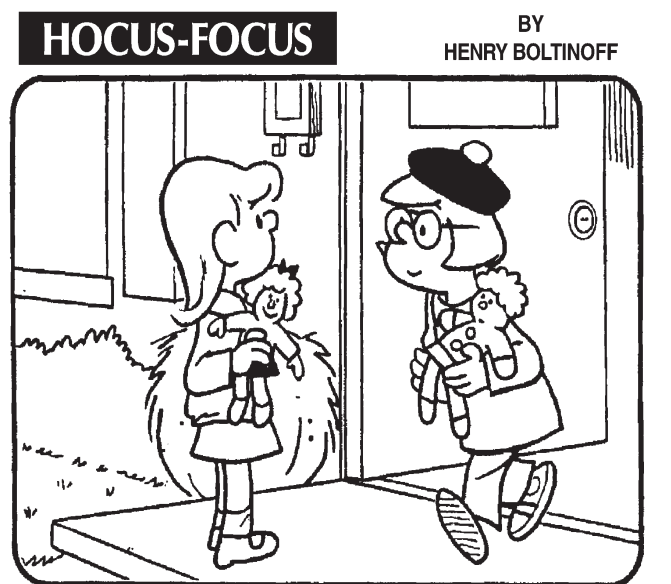

The funds received were spent on various projects within the district such as, but not limited to, façade improvements, renovations to several buildings in the downtown area, assistance with new commercial construction, various sidewalk projects, and several other private and public projects.

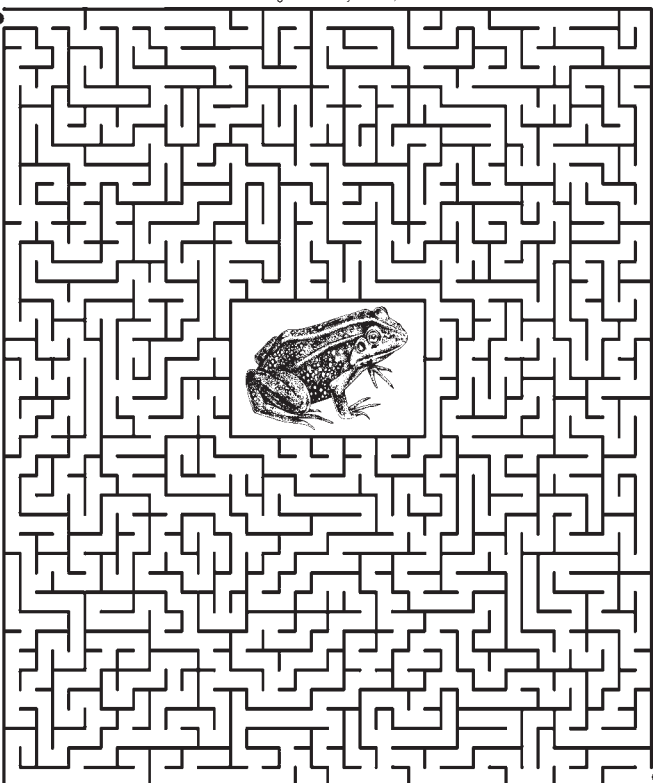

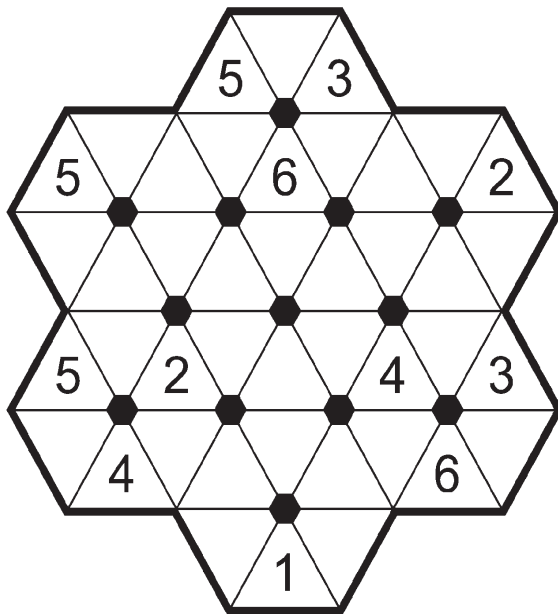

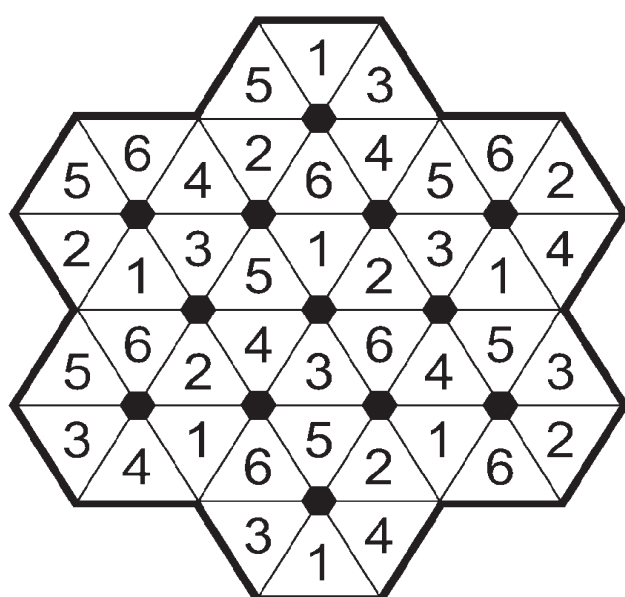
