## Election day is approaching; Vote by Nov. 3

The presidential general election is Tuesday, Nov. 3. The last day for new Oregon voters to register to vote for the election was Tuesday, Oct. 13.

Oregon is Vote-By-Mail. You do not need to request an Absentee Ballot unless you will not be at your home address between Oct. 14 and Nov. 3. Check the status of your voter registration now with the county clerk or online at www.oregonvotes.gov – My Vote.

Ballots cannot be forwarded. The county clerk's office starts addressing envelopes for insertion ahead of deadlines, so the sooner you update the more likely you will receive your ballot timely. Ballots will be mailed to all local active registered voters beginning Oct. 14. If you have not received a ballot by Oct. 23, call the county clerk's office.

Voted ballots are due in the County Clerk's office or in an Official Ballot Drop Box by 8 p.m. Election Day, Nov. 3. Postmarks do not count. Vote early. You do not have to wait until Election Day to vote.

If you are concerned with mailing your ballot back through the Postal Service or if you wait until the last week before the election to vote, use an Official Ballot Drop Box. Do not mail after Tuesday, Oct. 27 – Use an Official Ballot Drop Box.

If you have questions or concerns, call the County Clerk's Office at 503-842-3402 for an official answer. Do not believe everything you see or hear. Ask the local office in charge.

### Why are you running for subdivision 1 on the Tillamook PUD Board?

To continue aggressive planning and oversight of projects underway and scheduled for the next few years. To position TPUD to accommodate various forms of renewable energy. To maintain affordable rates while keeping TPUD financially strong. To continue a robust response to COVID-19 and prepare for future unknowns.

### What experience/skills do you have that makes you the best candidate?

Education, business experience, and utility industry knowledge. Strong analytic and problem-solving skills. Significant experience with local government and community groups including budgets, personnel matters, strategic and long-term planning, community engagement and common sense. I have been preparing and analyzing budgets for 40 years. I have also owned and operated my own business for over 20 years.

As a native Oregonian from a small town, I understand rural Oregon, our current political climate, the economics of Oregon and how to get things done. I'm the current chair of the Tillamook County Budget Committee and understand the relationships among governments at all levels.

What is the PUD's biggest challenge

### and how will you work to overcome that challenge?

TPUD has excellent staff, solid management and is financially strong. The challenges include:

First, TPUD must continue and strengthen its robust vegetation management to prevent wildfires.

Second, TPUD must continue an aggressive plan to replace aging infrastructure (poles, wires, transformers) much of which is over 40 years old. With our strong storms, salt air and high winds, newer equipment will accommodate renewable power options, reduce maintenance requirements, and increase safety for consumers and employees.

Third, TPUD must plan for the longerterm future, including sources of power generation. Nearly all utilities served by the Bonneville Power Administration have power supply contracts expiring in 2028. Many larger utilities may find alternate open market sources of electricity placing the burden of large capital costs in the Federal Columbia River System on smaller utilities. TPUD must develop options to meet local demand requirements while controlling costs.

I will aggressively work toward those goals.

#### Why are you running for Tillamook PUD Subdivision 3?



As for Internet access, PUD is one of three members of a consortium to operate Tillamook Lightwave, an intergovernmental agency designed to improve the county's overall connectivity and with distance learning and telemedicine a necessity right now, the need for reliable internet in poorly serviced areas is essential. I promise to work with the Port of Tillamook Bay and Tillamook County to provide Tillamook Lightwave access to all customers of PUD.

#### NCRD bond is about who we are as a community

We ask for your support and do so with the compete understanding that timing is never quite right and for some we are asking a lot ....

The good news is that the NCRD Pool is Ninety Years Old ..... the bad news is that the NCRD Pool is Ninety Years Old - the second oldest pool in the United States in continuous operation. That fact speaks volumes about who we are!

We have to put the value and quality of people's lives over the costs of ordinary things. It is about a community's 90 year history of insuring its children's quality of life is enhanced by being taught to swim. Just come to the Annual Poolathon and see. It is also about providing a means for its older citizens to confront

their twilight years in such a way that ensures the dignity of the individual and their ability to not be a burden to their family, friends or society by maintaining their health both physically and mentally.

Our tiny pool receives more than 31,000 visits per year .....Plus, we have taught over 10,000 children to swim and many of those former students have save other lives.....including our own Jim Mudd...... And no one taught to swim at NCRD has ever drowned.....in 90 years! What other Community can point to that?

But nothing lasts forever. The new pool will cost around \$9.2mm. The pool itself (hole in the ground) costs less than \$1mm but the building, UV water purification system, solar heating, prevailing wage requirements, ADA and environmental requirements make up the rest of

the costs. This is not a Taj Mahal but a pool for the next 90 years.

We have been forced to pursue the Loan/Bond course of action and we have contracted SDAO -Special Districts of Oregon to provide technical advise. We have ZERO debt and impeccable audited financials.

The dilemma we face is that philanthropic support has changed and building costs continue to spiral upwards. No longer are philanthropies providing start up money but instead want to see 50% in our bank (we have \$2mm and that is why we are borrowing \$3,000,000mm) before even considering the merits of our project. Plus, we will set aside money annually for an "endowment" fund to ensure the pools future maintenance and upkeep. And we will always continue to fund raise.

BCC is known L throughout Tillamook County to provide quality higher education opportunities to people wanting to improve their lives and reach a career goal. But many of you might not know that the College also works closely with small businesses throughout the county to help them get started or remain successful. We do this through our Small Business Development Center (SBDC) which is run by Arlene Soto, our SBDC Director. She has 26 years' experience running SBDC programs in Oregon and Wyoming, and has done amazing work with our small businesses since coming to TBCC almost three years ago.

The work done to help businesses through the pandemic over the past seven months is a great example of the value of the Oregon Small Business Development Center network (OSBDCN) in Oregon. Businesses in Tillamook County have been through a lot since mid-March. With the outbreak of COVID-19, the OSBDCN jumped into helping businesses statewide to access the CARES Act resources. Since the start of the pandemic, the TBCC SBDC office has assisted 79 businesses countywide with finding answers to questions about

When wildfires broke out statewide, the SBDC jumped in to help. The network developed tools and resources that help guide small businesses as they make decisions about when, where and how to reopen. To access those tools go to www.OregonS-BDC.org/natural-disasters. Year-to-date the Tillamook SBDC office has advised 141 small businesses. In a normal year, the SBDC office serves 115-125 businesses. Business advising is free and confidential. Our local center has trained an additional 128 businesses throughout the year with low cost classes. New classes and training programs are being developed constantly based on the needs expressed by businesses in the area.







### **Tales from the Library**

NEW LIBRARY DI-RECTOR UPDATE! This week, we are interviewing three candidates in the search for the next director of the Tillamook County Library. Check out the finalists' information on our website at http://tillabook. org/About-Us/Employment and join us on Zoom for the public sessions. But hurry, these interviews are taking place this week!

The rest of the library column this week is going to be a big love-fest for the library as I discuss the results of the annual public survey. Since 2016, the library has conducted a yearly survey that residents fill out in person or online. Given the changes and challenges COVID-19 has brought us, we decided to discontinue some old questions this year and added others that seemed more pertinent to the issues at hand. However, the eight questions that are outcomebased and linked into our strategic plan have remained intact every year.

We normally have some surprises when we tally the results, but this year was exceptional! For some reason, we had nearly a 50% increase in the number of surveys completed! Is this because people had more "at home" time due to CO-VID? Or did more people feel the need to comment



on our services because of our temporary closure? Whatever the reason, it was wonderful to receive nearly 600 responses! To put the cherry on top, we had 97% of the respondents say the library "provides a good value to the community". That is a higher rating than any past results!

My favorite part of the survey comes at the end when we ask, "What

didn't we ask about the library that you would like to tell us?" Results were scattered far and wide, but most comments gave us a special insight into what our patrons appreciate and what they thought could be improved. And because everyone has their own opinions, these comments often conflicted with what other people were telling us. For instance, we had people praising us for waving fines during COVID, while others told us we should raise fines higher to get materials back faster. There were others who provided some negative comments, but the overall tone was very positive this year.

Another comment we appreciated was, "Since

the pandemic, we went from using the library once a month, to picking up materials weekly." This is just one example of how COVID restrictions made many people realize the true value of the library. Another said, "It has meant so much for me and my husband to be able to check out books and magazines during the pandemic. I want to say thank you for going above and beyond to keep access to books open. Libraries are necessary in every community. We are lucky to be living in Tillamook County! :-)" Some gave shout-outs

to their favorite librarians. Others wanted to rally support for bringing back the ukulele program or storytimes. And I am proud to say quite a few people mentioned how much they enjoy the Tales from the Library column every week in the Headlight Herald! (I'm blushing now.)

I will close with one last happy comment. What gives us the biggest lump in the throat is when a patron really gets us and can verbalize the reason we all love working in a library. "Thank you! The library services have made this pandemic time survivable by providing access to books and online content for intellectual, emotional, and social growth opportunities! An essential service for the well-being of our community."

### Adrian Roberts



Adrian Roberts—scientist, manager, devoted husband and father, lover of chardonnay, opera and the football club Manchester United—passed away on October 12, 2020 at the age of 76 years.

For over 50 years, Adrian was pivotal in developing the technology life cycle—first as a scientist, then as an executive—in both public and private R&D organizations. He played a significant role in major scientific and technological advancements, including energy conservation and the remediation of nuclear waste.

Born in Norwich, England to working-class parents, Adrian earned a PhD in Metallurgy from the University of Manchester in 1968 before emigrat-

#### ing with his wife and two children to the United States. He came for a job at Argonne National Labs where his starting salary of \$3,000 per year was touted in his hometown Chester's newspaper as "more that the Prime Minister makes!".

In 1975, he moved his family to California to join EPRI (the Electric Power Research Institute) where he worked on major energy projects across the U.S., Europe and Asia. In 1979, as an expert in materials used in nuclear reactors, Adrian was recruited to help contain the damage at the Three Mile Island Nuclear Generating Station. In 1985, Adrian joined Battelle where he served in a variety of upper management positions including interim laboratory director at the Pacific Northwest National Laboratory in Richland, Washington.

Adrian served on the boards of numerous organizations, encouraging entrepreneurship in science and technology.

He is survived by his wife of 55 years, Susan, daughter Amanda, son Stephen, four grandchildren and three great-grandchildren.

From your police force, we received kind and thorough attention from Officers Barichio and Lamb as well as a concerned drive by from 2 of the area ambulances. Fortunately, we did not need their services.

#### Schlip's letter

I am writing in response to Jeff Schlip's letter of October 14 concerning the Construction Excise Tax (CET). The Neah-Kah-Nie School Board reviewed the usage of the tax at our October 12, 2020 meeting. Mark Sybots, NKN business manager, provided us with historical information as well as a list of expenditures we have made using this important revenue.

The CET was initially levied in 2008 and it has been an essential revenue source since then. All three school districts in Tillamook County rely on the CET. The CET is limited to a one-time construction excise tax on new residential and commercial building, with many identified exemptions. Although the state allows for yearly tax increases, the NKN School District's rate has remained the same since its inception. The amount collected in CET varies each year, from \$74,500 in 2009 to \$140,500 last year.

Many projects in the district have been partially or wholly funded by the CET, including new security doors, roof replacements, construction of a welding shop, chemistry lab remodel, wheelchair lift replacement, community track and field, fencing, and a gym floor. Currently a portion of the CET is being used to build covered outdoor play structures at both elementary schools. These are necessary expenditures that have allowed the district to maintain and enhance facilities for students, staff, and the community. We are proud to be responsible stewards of school district facilities and recognize the value of the CET.

As school board members, we are responsible for the financial stability of the school district. The board agreed to unanimously support the continued inclusion of the CET as part of our revenue stream. Providing an excellent education for more than 800 students served by Neah-Kah-Nie schools is the board's main goal. The CET assists the school district in reaching this goal.

### **Guest Columns** Reject the lies, fund education first

#### Suzanne Weber Candidate State Rep. Dist. 32

Politics can be tough. In the most intense parts of a political campaign, candidates are broadcasting why voters should elect them, and why they shouldn't elect their opponent. The lines between fact and fiction can begin to blur as politicians push the limits of what is true.

In my campaign for State Representative, I am proud that we have kept only to the facts. I've pointed to my 50 years living in the district, my 30 years as a public school teacher, my 15 years as a small business owner, my 18 years as a nonpartisan city councilor and mayor. Yes, I've also pointed out what I believe are my opponent's shortcomings. The support she received or continues to receive from organizations who want to defund or abolish rural police departments. Her calling a \$2 Billion tax increase on small businesses "a great start", the support she receives from extreme environmental organizations who want to put our loggers, mill workers and truck drivers out of business. These are all facts. Over my decades of experience, you may not have always liked what I've told you, but you can rest assured it was always the truth.

My opponent in this race, partisan activist Debbie Boothe-Schmidt does not seem to be as bound by the truth as I am. Campaigns are always hard fought with nuanced messaging, but should always be based in fact. That's why it was so troubling when I was alerted to a commercial that Ms. Boothe-Schmidt was running claiming that I had "cut billions of dollars of funding to education." I have never served in the legislature, nor have I ever held a position that would allow me to cast such a vote. Ironically, one supporter saw this ad while Ms. Boothe-Schmidt was at a candidates forum claiming that all of her campaign material was fact-checked for accuracy. Her lies were caught and she was forced to remove her misleading, inaccurate commercial.

Where did my opponent come up with such an egregious lie? It's because I have publicly opposed the Tax on Oregon Sales, a gross receipts tax that unfairly burdens small businesses and working families, while exempting big corporations. Let's call it what it is: corporate welfare.

In 2019, the legislature proposed imposing \$2 billion in new taxes on businesses who grossed over \$1 million in sales (gross sales, not profits), supposedly to be new funds for schools. Upon hearing about this new tax, big corporations rushed their lobbyists to Salem. These big corporations cut a back-room deal with politicians, assuring that they would remain neutral or support the bill as long as they were exempt from it. That left the small appliance store, the hardware store, the family trucking company, the local feed store and other small businesses to pay billions in new taxes, supposedly for schools (most, if not all of our rural districts have yet to see a penny), while big

corporations got off scot free. How convenient.

I oppose this funding mechanism because it isn't fair to rural Oregon. A local hardware store reported a \$90,000 tax bill. That's \$90,000 being sent to Salem without a penny coming back. Debbie Boothe-Schmidt calls this tax on sales, "a great start", while lambasting me for fighting for our small businesses. She claims I want to cut \$1 billion from our schools. That is a lie. What I want to do is make sure that our schools are fully funded by making them the very first thing we fund during budget-writing, rather than crippling small businesses in new taxes because political elites, the same political elites who recruited Debbie Boothe-Schmidt to run, sold out small businesses. Right now, our schools are almost always the last thing that is funded, because politicians like Debbie Boothe-Schmidt want to use them as a political football.

Don't believe the lies coming from Debbie Boothe-Schmidt. You have a choice right now between me, a 30-year public school teacher who wants to fully fund education by making it the very first thing we fund, or Debbie Boothe-Schmidt, a political activist with no experience in public education who wants to use our children as pawns to raise billions of dollars of taxes on small business while handing out corporate welfare to big businesses. Please join me in making the common sense choice and rejecting Debbie Boothe-Schmidt's lies.

### Setting the record straight

The North Coast has been my home for almost 30 years. I've raised my kids here, run a small business in Astoria with my husband, and appreciate that we are a tight knit community who looks out for one another.

Suzanne Weber will have you believe that I want to defund the police, but if you look closely you'll realize she's using scare tactics and easily fact-checked lies to deceive voters. Just ask the District Attorney of Clatsop County and my former boss who endorsed my campaign, Ron Brown.

In times of crisis and distress, we need our leaders to step up and move past partisan politics. I have been dismayed at how leaders have responded to the unrest to gain political points. Over in Portland, I have watched how Portland's Mayor Ted Wheeler's inaction resulted in chaos and violence in the streets. On the national side. President Trump has only added fuel to the flames with his partisan rhetoric and fearmongering campaign ads.

I'm disappointed that my opponent, Suzanne Weber, has also stooped to this level. At a time of heightened unrest around the country, Suzanne Weber and her campaign are taking a crisis and using it for their own political gain. Suzanne Weber is exploiting unassuming voters who likely do not have the time to research every political claim. That's just not the way elected officials should behave.

These attacks are not only false but they are distracting from the actual choice voters have this fall. I am running for state representative to be a voice for all of our rural constituents and make sure the Coast is never left behind. I will fight for investments in our public schools and local community colleges. I'll fight to make healthcare, including mental health, more accessible and affordable so no one has to drive to Portland to get the care they need. And I'll fight for our local small businesses because I know firsthand what support they need to recover from the pandemic. That's why I have a broad and diverse coalition of endorsers behind me, including over 40 community leaders like small business owners, healthcare providers, local elected officials, and educators, as well as trusted organizations like the Oregon Nurse Association, Oregon Education Association, Stand for Children,

Basic Rights Oregon, and dozens more. As state representative, I will bridge the partisan gap that is dividing our community, because I know when we look past our differences we will find many shared values with our neighbors.
