

Four arrested for drugrelated charges

On July 31 at approximately 9:30 a.m., Tillamook Narcotics Team detectives along with Tillamook County Sheriff patrol deputies and Tillamook City police officers served a drug related search warrant at 813 4th Street in Tillamook. Detectives contacted four adults: Jason Huddleston, age 44; Shawna Gomez, age 43; Nicolas Mobley, age 34; and Skyler Winfrey, age 29; and one juvenile at the location.

The sheriff's office said during the search, methamphetamine, oxycodone and cash was located, along with evidence of narcotic sales. The minor was turned over to his parents. The adults were arrested and taken to the Tillamook County Jail on the following charges:

Huddleston was charged with alleged unlawful possession of methamphetamine, unlawful delivery of methamphetamine, frequenting a place where drugs are sold, endangering the welfare of a minor, unlawful delivery of oxycodone, and unlawful possession of oxycodone.

Gomez was charged with alleged unlawful possession of methamphetamine, unlawful delivery of methamphetamine,

Tillamook tradition since A1925, the Pig N' Fords race was packed with spectators again this year – some said the most ever. Marty Walker took home the top honors this year in his No. 13 Model T. He's a returning champion with numerous previous wins.

The one-of-a-kind race has the drivers snatch up a pig from the starting line, rush to their Model T, crank it up while clutching the oinker, and speed off for a lap. They swap in a fresh pig for the second lap, crank that engine up again and they're off. It's a three-

The spectacle was born after Tillamook County farmers who were transporting pigs had one get loose. They had so much fun chasing the escaped pig around in their Model T Ford that it became a fair event.

Parry Hurliman, who owns the No. 18 car driven by Nick Hurliman, said in the old days anybody could get into the race. In the early 1950s, a 10-franchise racing association was formed. The race was divided into two heats with five

finale champions. Kenny McDonald took the first championship win in 1952 in the No. 10 car. An exhibition race was added for fun around a decade ago.

"You can't afford to screw up or miss a crank or you're toast,' Hurliman said of the intense competition. The champion wins a revolving trophy engraved with all the past winners' names and bragging rights until next year.

In a mudslinging finale this past year, first-time winner Jake Martin unseated then-reigning champion Ben Salo, who came in second. Walker finished third in 2018.

# Sonic boom shakes Tillamook Coast Monday

Residents and visitors in Tillamook County took to social media on Monday with questions about a boom that shook homes along the coast from the areas of Netarts to Sandlake.

While some suspected an explosion or earthquake was responsible, the majority consensus was the sound and shaking were caused by military aircraft. The 142nd Fighter Wing of the Oregon Air National Guard is currently hosting training with FA-18F Super Hornets from the VFA-41 Squadron out of Naval Air Station Lemoore, California.

The jets are conducting dissimilar air combat training, executing realistic scenarios that use advanced aerial tactics to prepare for actual warfare. The training, considered essential to military readiness in support of the Portland Air National Guard Base's national and state missions, was slated for Aug. 11-23.

Gordon's Tillamook Weather Center, a popular

local social media page run by Tillamook County Sheriff's Office Lt. Gordon McCraw (who also serves as the county emergency manager), reported that callers began asking about sonic booms around 10 a.m. on Monday, Aug. 12.

McCraw later posted a refresher of an explanation he gave in June regarding sonic booms. He noted that the jets aren't zooming and booming above Tillamook towns, rather they're over the ocean just off the coast, adding that how far and fast sonic booms travel is affected by the atmosphere. He said when it's warmer and wetter the sound travels more.

"Obviously, we are warmer and more muggy these days, and the winds are westerly, which helps the sound move inland further also," McCraw said.

McCraw wrote that another influence could be temperature inversion, trapping the sound and bounc-

ing it between surface and the inversion level. He said Tillamook County generally has an inversion layer in the morning hours.

'Normally, temperature decreases with height. An inversion is an area where the temperature temporarily rises with height," McCraw wrote. "Watch the smoke

stacks in the morning. If the smoke climbs then stops and spreads out, that is where the inversion is. If it keeps climbing, no inversion is present."

The 142nd Fighter Wing flies F-15 Eagle fighter jets, guarding the Pacific Northwest skies from northern California to the Canadian border on a 24-hour alert as part of Air Combat Command and the North American Aerospace Defense Command.

The training flights will depart from and land at the Portland International Airport daily after 8 a.m. and will conclude before 4 p.m.

# City doing roadwork on Third; expect delays in both directions

The City of Tillamook will be repairing and paving Third Street from about the railroad tracks to Pine Avenue. Work began on Monday. All businesses are open during the work. The work includes road base repair on the section in front of Hampton Lumber's driveway. The City plans to dig out the failed road base and re-base this

section prior to paving. The City received a Small

Cities Allotment Grant from the Oregon Department of Transportation to help pay for this road repair. The work is estimated to take seven to eight working days. SC Paving will perform the base repair and paving. Angels Flagging will be assisting the City with traffic control. Expect delays on Third Street. The City has been work-

ing with the businesses in the area and says it has developed a phased approach to reduce the impacts to the businesses. The City appreciates traveler's patience during this work. Remember to slow down in work zones to protect workers and the traveling public.

On the surface, Hoquorton Park in downtown Tillamook appears to be a well-maintained, mild walking trail that winds along the slough through grass pastures and native plants with several viewing platforms allowing patrons to enjoy the water. However, not that long ago the Hoquorton Slough frontage was a bustling port and industrial center.

Up until the late 1950s, the slough served as a water route to the City of Tillamook for supply, passenger, and fishing boats entering Tillamook Bay from the Pacific Ocean. Before Pioneer settlement, Native Americans hunted and fished in and around the

slough's rich natural environment.

The Hoquarton Interpretive Trail was built in a cooperative effort between the city, volunteers and a number of granting agencies. In 2000, a partnership was formed by the city and the Tillamook Estuaries Partnership (TEP) along with other organizations and individuals to help clear the area of invasive species and bring back the native vegetation.

On August 17th, you can enjoy a guided walking tour of Hoquarton Slough that will highlight the unique ecology, cultural history, and significance of this iconic waterway. Led by staff and volunteers from TEP, the Tillamook County Historical Society, and the Bay City Art Center, this Explore Nature event will help attendees Discover Tillamook County's estuaries in person.

"It's a wonderful opportunity to come experience the estuary and see for yourself what a special place it is," said Claudine Rehn, the Deputy Director at TEP.

"A healthy estuary is at the heart of a community,' she added. "Without that, we aren't going to have a healthy economy or a healthy community. Our estuaries are these touchstones for everyone who lives here because in some way you are impacted by the health of one of our five estuaries. We love being able to share the stories of our estuaries with people."

The journey will be about a 2-mile round-trip walk along the Hoquarton Interpretive Trail and primitive trail along Hoquarton Slough. Part of the trail is paved and ADA accessible, but a portion of this tour will include hiking along an unimproved section of trail atop a dike. Participants should wear close-toed shoes or hiking boots.

The park is located along the banks of the slough just

# **Re:current owner focuses** on sustainable fashion

Kelly Raynor believes buying secondhand is a conscious decision.

"It's really important to use what we have," Raynor said. So, when the Phoenix Exchange in Tillamook was listed for sale, Raynor felt that

the secondhand clothing store model lined up with her ethics. "I have been wanted to be

a small business owner for a while. I had written up a couple business plans and nothing seemed to fit," Raynor said. "I had been in [the Phoenix Exchange] once or twice before, and met the previous owners at Food Roots' Pie Days.'

Raynor purchased the business this past March and renamed it Re:current.

"I like Re:current with the colon because it's something that continues to be current

and you can make your own fashion," Raynor said. "Plus, it's a play on water which seems appropriate for the area."

Before moving to Tillamook County, Raynor was working within the sustainable clothing market in Portland. She's passionate about the industry as wearing secondhand finds can cut down on water pollution created by the textile industry.

But, how can you be stylish in secondhand clothes?

'Develop an individual style, don't worry about what's trending," Raynor advised. "Fashionable and trendy are not the same thing. Fashionable comes from within, and trendy is following the crowd."

Raynor is currently curating the inventory in the store and says she is working hard to get clothes moving in and out of

the shop. She plans to continue taking things on consignment, and is especially looking to expand her furniture selection.

Re:current's building also received renovations including the addition of multiple dressing rooms, and thanks to a Tillamook Urban Renewal Agency grant, the exterior of the building will receive a new coat of paint.

With two employees, Re:current is open seven days a week through the summer: 10 a.m. - 7 p.m. Wednesday-Saturday and noon-5 p.m. Sunday-Tuesday.

"I'm open long hours for people to come in before and after work," Raynor said.

Raynor hopes to offer workshops about sustainable fashion in the future.





#### Shifting to plant based eating will save our planet

#### Dear Editor,

"Climate Change Threatens World Food Supply" is the headline wake-up alarm being sounded by leading newspapers. It was prompted by the release of a summary report by the United Nations Intergovernmental Panel on Climate Change (IPCC), staffed by more than 100 experts from 52 countries.

The report details how

climate change is threatening our world's food and water supplies - turning arable land to desert, degrading soil, and raising the frequency of devastating weather conditions. It concludes that avoiding wholesale starvation and mass migrations requires fundamental changes in current animal agriculture and land management practices, which account for 23 percent of human-caused greenhouse gas emissions.

The conclusions of the IPCC report match closely those by Oxford Univrsity in 2017 and by Chatham House in 2015. A 2010

United Nations report blames animal agriculture for 19% of greenhouse gas emissions, 70% of freshwater use, and 38% of land use. All reports recommend a massive shift to plantbased eating.

In an environmentally sustainable world, meat and dairy products in our diet must be replaced by vegetables, fruits, and grains, just as fossil fuels are replaced by wind, solar, and other pollution-free energy sources. Our next visit to the supermarket provides a superb starting point.





The North County Food Bank (NCFB) will host their annual 24th Fish Fry fundraiser at the St. Mary's by the Sea Catholics Church in Rockaway Beach on Sunday, August 18 from 12-6 p.m. Come to the Parish Hall at St. Mary's for a great meal that benefits a great cause. The meal includes fresh pan fired rockfish, corn on the cob, coleslaw, French bread, coffee, tea, and soft drinks. Tickets are \$10 and kids 5 and under get in for free. Tickets are available in advance from NCFB volunteers or are available at the door.

The Fish Fry is an annual event that many local residents and area visitors look

Nehalem Valley. Last year, the NCFB provided food assistance to 608 adults and 252 children in 278 households and distributed 94,714 pounds

of food. The NCFB offers food to anyone in need in their service area. The NCFB has been serving North Tillamook County for over 25 years. The Food Bank is open from 1-3 p.m. every Tuesday and continues to operate from its usual location in the lower level of the Old Wheeler Hospital Building across the parking lot from the Rinehart Clinic in Wheeler.

On Friday, August 2, at approximately 8:32 p.m., Tillamook 911 received a report of three men being pulled further out into the ocean from near the Nehalem Bay State Park. They were reported to not be wearing wet suits, but they were wearing shorts. Law Enforcement, Fire Personnel, and USCG were all dispatched. Manzanita Police arrived on scene at about 8:40 p.m. Upon his arrival, he reported that all subjects were out of the water, but one was unconscious, and CPR was in progress.

The man, later identified as Vladimir Kravchenko, 38, of Vancouver, Washington, was transported by Tillamook Adventist Ambulance to Adventist Hospital where he was declared deceased. This victim's family, who were staying at the Nehalem Bay State Park, were at the hospital. A friend of Kravchenko advised Sheriff's Office personnel that they had been

swimming in the surf about

Vancouver man drown near Nehalem Bay State Park 50-100 yards out when they began to get pulled further out. They all decided to swim back to shore. The friend said that he tried to help Kravchenko but began to get extremely tired, so started to swim out of the rip current. Other swimmers assisted in retrieving Kravchenko and began the CPR.

Since January of this year, Tillamook County First Responders have been called out to 27 water rescues. At least 22 percent of these were related to people being pulled out in rip currents. A rip current is a relatively narrow, fast moving current in the beach surf zone that moves away from the beach. Some of these are very strong and fast and can also have undertows. They occur along the beaches of the west and east coast. When you combine these currents with the cooler water

swimmers can find themselves in trouble.

Lt. Gordon McCraw, Tillamook County Emergency Manager, offered these safety tips. If you find yourself in a rip current, first, stay calm, don't try to swim against the current. Swim parallel to the coastline until you get out of the current. Once you are free of the current, you can swim back to shore. If you are unable to escape the current, just float or tread the water. If you need help, face the beach, yell, and wave your arms and continue to float or tread the water. Never swim alone. Have someone designated to watch from the beach and consider wearing a life vest. This year, through July 24, the National Weather Service shows 29 rip current-related drowning incidents.

Responding agencies included Manzanita Police, Tillamook County Sheriff's Office, Nehalem Fire and Rescue, U.S. Coast Guard, and Tillamook Adventist Ambulance.

# Local market owner awarded for donation during Oceanside water contamination

On July 18, the Oceanside Water District was notified by the Tillamook Police Department that an individual whose vehicle was found near our main reservoirs indicated that an attempt was made to contaminate Oceanside's water system. The person was arrested on charges from another case and was taken to the hospital for psychological evaluation. During that process, the man revealed to one of the nurses that he had poisoned the water sources.

The Oceanside Water District had to shut the water down and put out a nonconsumption notice to the public about the possible contamination. A man who owns Bayside Market & Deli, Neveen, heard about the contamination and immediately donated every bottle of water he had in his store, said David Norman, District Manager of Oceanside Water District.

Neveen contacted the fire department next door to his store to pick up the water for the community.

"We wanted to make sure he was publicly thanked for this," said Norman. Norman says that

Neveen bought the store just a few years ago from the previous owners and is a welcome addition to the community.

'We never expected this kind of generosity of such a small store," said Norman. "I've seen this guy here struggling to just make it month to month. For him to make a donation like that, during the busiest time of year, was above and beyond."



# GARDENING MATTERS An aphid invasion



ast week I received ⊿an email from Evelynn Von Feldt, one of the long-time Master Gardeners, and she thought I should do a column on a problem the Tillamook County Master Gardeners have been working on for the last few months. Upon reading the email, I realized this is something I should write about as it seems to be affecting spruce trees in Oceanside and other parts of the county.

Apparently, local Sitka spruce needles have been turning brown and dropping their needles. This gives the appearance they are dead. The damage was diagnosed by Joy Jones, former OSU Extension Office Agent for Horticulture, as being Spruce aphids. It is so much of a problem in coastal Spruce forests that the Oregon Department of Forestry is now looking into the matter and monitoring the damage. Dr. Christine Buhl, one of the Forest Entomologists from ODF came out to the coast to see what is going on. She reports that the problem is so severe that ODF has issued a Forest Health Pest Alert that explains the infestation and the ways to manage it.

Spruce aphids (Elatobium abietinum) are non-native insects that have been evident in west coast forests since the 1920's. They feed voraciously on the sap in needles of its favorite food source, the spruce. They like Sitka spruce but also will feed on Colorado Blue Spruce that many gardeners like to plant in their yards. Aphids feeding causes spruce needles to turn brown or prematurely shed. The damage is seen first at the beginning of spring in February and March when the aphids have their peak feeding season. Older needles and those lower in the tree's canopy are the first targets. The aphids do not affect the trees' buds and new needles will open and flush out during the same growing season. This is true even on trees that



seem to be irrevocably harmed. The population of the Spruce aphids declines during the summer due to natural enemies and lack of nutritious foliage for them to eat. But by May and June, the affected needles will turn brown and drop off the branches.

The Spruce aphid infestation can eventually cause trees to lose height and diameter as the growth slows. Since the trees still put out new growth, they can survive aphids unless the favorable-for-the-aphids weather conditions continue for several years, in which case the trees become so stressed they will eventually die.

So, what can we do about Spruce aphids? The thing most ODF publications suggest is to wait out the aphids. A colder winter, natural enemies and loss of food will decrease populations. Of course, we have no control over the weather, but we can refrain from fertilizing the spruce trees as the aphids love the nitrogen-rich trees. Once the nitrogen levels drop off in the summer, the aphids will drop off, too. A blast of strong water

A blast of strong water from a hose may also dislodge many of the aphids. Chemical sprays aren't





The magazine recommends mounting PVC pipe onto a block of wood and inserting the spiked end (where the units are jabbed into the earth outside to charge by day) into the PVC to light indoor spaces by night. advised because spraying an entire forest with insecticides is prohibitively expensive and will affect other desirable insects. But smaller ornamental trees may be sprayed. To be most effective, this should be done in late March or early April, before the affected needles have dropped. Be sure and read the labels on the insecticides to be sure they can be safely used on spruce and are effective against aphids. And always follow the label directions to the T!

Soil drenches and tree in-

jections of insecticides may be a last resort. ODF suggests contacting one of their entomologists to discuss treatment and monitoring options. They also have a website with information on forests and how to contact ODF. Find it at: http://tinyurl.com/ ODF-ForestHealth. Dr. Buhl also lists her contact info on the Pest Alert, so I feel I can give you that info, too: christine.j.buhl@oregon. gov with her phone number 503.945.7396.

As to the piles of fallen needles, well they will take years to decompose. If you find them around acid-loving plants – like the spruce trees - you can probably leave them. If they have been blown and blanketed

around more alkaline plants, you might want to rake them up for the compost pile. We don't have many native plants that don't like acid, so this would only be an issue around ornamental trees and shrubs.

In short, this seems to be a potential problem only if our winters continue to be mild and not cold enough to keep the aphids under control. But this is something worth monitoring and looking for if you have spruce trees.

Thanks to Evelynn for making me aware of this issue so I could share the potential problem with my readers. I also thank Evelynn for these photos that she took of some damage along Route 131 this spring.




